HUNGARIAN STUDENTS BEGIN GUERRILLA WARFARE ON JEWISH STUDENTS

**New Incidents at Technical Institute
May Lead to Its Closing**
(Jewish Telegraphic Agency)

Budapest, Nov. 24—Prevented from carrying on an open warfare by agreements entered into with the authorities, the Nationalistic Hungarian students who cannot tolerate the presence of a few Jewish students in their classes, have apparently embarked upon a guerrilla war.

In addition to the attack from under cover, perpetrated upon a group of Jewish students of the veterinary institute yesterday, in a neighboring park, five Jewish students of the technical institute were attacked in the corridor and cruelly beaten. The assailants fled. The Senate of the technical institute again posted an announcement that in case of a repetition of such attacks, the institute will be closed.

PROSELYTE AGAIN TURNS COSSACK WHEN WIFE DIES

Warsaw, Nov. 24—The call of his Cossack blood, seldom, if ever, peaceful and tolerant and in particular in reference to Jews, was given as the reason for Stefan Gorkotschenko's inability to tolerate his Jewish mother-in-law and his stepson after his Jewish wife died.

Gorkotschenko, a former member of the Petlura pogrom bands, settled in Warsaw five years ago, when he embraced Judaism and married a Jewish widow, who was the provider of the family, earning her living in a grocery store. During the five years of his marital life, Gorkotschenko severed all connections with his past, being a peaceful husband, and a pious observer of Jewish traditions and customs.

Now, when his wife died, the proselyte declared that his Cossack blood has reawakened and for this reason he cannot longer bear the presence of his Jewish mother-in-law, an aged woman, and a young stepson. He summarily ejected them from his household. The story is made the most of in the daily chronicles of the Warsaw Yiddish press.

WARSAW KEHILLAH SEEKS MONOPOLY ON MONUMENTS

Warsaw, Nov. 24—A monopoly on monuments set up in the Jewish cemetery is sought by the Warsaw Kehillah Executive Committee as a means of increasing the Kehillah's revenue.

The stonecutters, informed of the decision, have protested against the Kehillah's going into business. Some of the stonecutters have threatened terroristic measures in case the Kehillah interferes with their trade.

ROUMANIAN LIBERAL PARTY DENIES IT PURSUES ANTI-SEMITIC CAMPAIGN

**Union of Roumanian Jews Renews
Election Alliance with Liberal Party**
(Jewish Telegraphic Agency)

Bucharest, Nov. 24—An official denial of the rumors current throughout the country that the Liberal party, now ousted from power by the Peasant National Party under the leadership of Julius Maniu, is pursuing an anti-Semitic campaign of propaganda to embarrass the new government, was issued by the party headquarters here.

The denial terms as malicious the reports that the Liberal party is engaged in anti-Semitic activities in Northern Moldavia, Bessarabia and Bukovina. It is nonsense, declares the official statement, to assume that the Liberal party is doing this kind of thing, since the party has never pursued a course of anti-Semitism which it considers dangerous to the State. Besides, the steadfast political relations of the Liberal party with Roumanian Jews are well known.

Close upon the publication of this denial came the news that the Union of Roumanian Jews of Bucharest, headed by Dr. William Filderman, has decided to renew its election alliance with the Liberal party. This decision was said to have been taken following the conclusion of the Union's negotiations with the present government party. The government party was said to have been willing to grant the Union of Roumanian Jews only two mandates in Greater Roumania, preferring to give a preponderance to the Zionist groups.

In official circles it was declared that the Maniu government is displeased with the split within Roumanian Jewry, which will no doubt have its repercussion in the elections. The lack of a united front at this hour creates many complications, as many Jewish groups, unco-ordinated and unorientated, change positions daily being anxious to secure their candidates inclusion either on the government list, on separate lists or in combination with other groups.

ANDRE SPIRE, JEWISH WRITER, ATTAINS SIXTIETH BIRTHDAY

Paris, Nov. 24—Andre Spire, noted French Jewish writer, was the recipient of many congratulatory messages on the occasion of his sixtieth birthday. The World Zionist Organization despatched a message of felicitations to the noted writer.

The World Zionist Organization also sent congratulatory messages to Isaac Naiditch and Hillel Zlatopolsky on the occasion of their sixtieth birthdays. The two Zionist leaders were feted last week at a banquet given in celebration of their anniversaries.

ZIONIST REVISIONISTS HOLD TO ORIGINAL PLAN OF CONFERENCE IN VIENNA

**Authorities Promise Protection; Ha-
kenkreuzler Press Threats Cease**
(Jewish Telegraphic Agency)

Vienna, Nov. 24—The conference of the League of Zionist Revisionists will be held here the end of December, according to schedule, the arrangements committee decided.

Following the threats in the Hakenkreuzler press that this conference would receive a welcome similar to that accorded the Zionist Congress several years ago, uncertainty prevailed as to whether the conference would be held here. The Vienna police, however, following a consultation with the government, gave an assurance to the arrangements committee that complete order and security for the arriving delegates will be maintained. Simultaneously the threats in the Hakenkreuzler press have been discontinued.

JEWISH PETROLEUM DEALERS' OPPOSITION SPLITS TRUST

Warsaw, Nov. 24—A split in the petroleum trust recently formed in Poland with a view of dominating the market by a policy of eliminating the retailers by refusing to sell them, is the dim hope of a large number of Jewish petroleum dealers in Polish towns and villages, in order that they may maintain their economic position.

After the establishment of the trust combining larger and smaller refineries for the sale of their product, the Jewish petroleum retail dealers formed a nationwide association to counteract the danger threatening to their interests. The activities of the association have already shown some effect, which was reflected in the demand of the smaller refineries, members of the combine, to revise the combine's previous decision not to sell the retailers. The two leading petroleum concerns, Standard, and Nobel, insist, however, on the original decision, threatening the smaller concerns with leaving the combine in case the demand is pressed. The matter will come up for final decision in January 1929.

It is stated here that the majority of shareholders of the Standard and Nobel concerns are French and Austrian Jews.

LATVIA GRANTS SUBSIDY TO AGRICULTURAL SCHOOLS

Riga, Nov. 24—Permission to open the Jewish Agricultural School was granted by the Latvian government. A stipulation was placed that the school transfer its activities to the land not later than March of next year.

A subsidy of \$3,000 was granted by the government for the school.

Copyrighted**PAINTS GLOOMY PICTURE
OF RUSSIAN JEWS**

(Jewish Telegraphic Agency)

Berlin, Nov. 24—Expressing full credit to the work of American Jews through the Agrojoint, the colonization agency of the American Joint Distribution Committee, for saving many thousands of Russian Jews by placing them on the land, Paul Scheffer, Moscow correspondent of "Das Berliner Tageblatt," paints a most gloomy picture of the fate of Russian Jewry in what apparently is a series of uncensored despatches from Moscow.

The correspondent, who just returned from a trip to the Ukraine, makes the statement that one million Jews out of the two and a half million Russian Jews are gradually being crushed in the mills of the grinding Communist process. The misery and the hopelessness of the situation of the Jewish communities in the towns and villages is a grim reality, he states which is made harder by the closing in of the Communist policy. As to the situation in the colonies, Herr Scheffer states that neither in the old nor the new Jewish settlements has he observed any optimism for the future. The huge taxes rob the settlers of their hope, he states.

**YESHIVAH STUDENTS' GROUP
ARRIVES IN WARSAW**

Warsaw, Nov. 24—A delegation of the students of the Yeshiva in Minsk, White Russia, arrived here.

According to the reports of the delegation, a number of the Minsk Yeshiva students have escaped from Russia and are now in Pinsk, Poland. They are without food or shelter.

**N. Y. SEPHARDIC COMMUNITY
ISSUES MONTHLY BULLETIN**

The first issue of "The Sephardic Bulletin," a monthly publication of the Sephardic Jewish community of New York, made its appearance Friday. The "Bulletin" is published in English and Ladino.

In explaining the purposes of the "Bulletin," John H. Levy, president of the community, writes in the first issue: "The Sephardic Community of New York, Inc., has been organized in its present form for a little over four years. The Board of Directors has now decided to publish a monthly bulletin in order to acquaint our people with the activities of our Community. Mr. Marco Shemaria, a member of the Board, has been appointed chairman of the Committee to supervise the new publication."

"There are now twelve societies affiliated with the Community and it is believed that this new bulletin will prove of value in helping the members of these societies as well as the increasing number of members at large to obtain correct information concerning our work."

"The chairman of the several committees to which are delegated specific activities of the Community, as well as other contributors, will furnish the resumes of the month's activities as well as contribute articles of general and timely interest. Thus, the readers will keep in constant touch with our work in the following fields, namely, synagogue, Talmud Torah, social service, club activities, social and educational features, entertainments, etc. The Women's Division will likewise report on its work. Periodic reports by the officers of the Community will chronicle the progress that is being made and outline the program of future activities."

In short, everything concerning the Community's work and affecting our People's welfare will be summarized in our Bulletin."

**NEW ARCHAEOLOGICAL
DISCOVERIES NEAR ATHLIT**

Jerusalem, Nov. 24—New discoveries were made by the Antiquities Department of the Palestine Government in excavations being conducted in and around a large cave near Athlit.

Stone constructions containing numerous burial places were unearthed. Flints of the palaeolithic and transitional periods were found. Sherds near the surface show that the site was occupied during the Roman or Byzantine period.

FOR HOOVER'S CABINET**

Mr. Frank was defeated in the Republican primary for Senator. The name of Congressman Nathan Frank of St. Louis supporting Mr. Frank for the post has been mentioned. Mr. Frank served in Congress in 1889.

LATEST DESECRATION OF JEWISH CEMETERY AROUSES GERMAN PUBLIC OPINION

Rewards Offered for Apprehension of
the Culprits

Berlin, Nov. 24.—The sixty-sixth case of cemetery desecration in Germany has aroused wide-spread indignation, as the metropolitan press published details of the vandalism wrought in the Jewish cemetery near Koepenick, near Berlin.

Awards totalling 1,220 Marks for the apprehension of the culprits were announced by the Central Union of German Citizens of the Jewish Faith, the Association of Jewish War Veterans and by the Berlin police praesidium.

Vice-president of the Berlin police, Dr. Weiss, accompanied by several high officials in the department of justice, visited the cemetery yesterday. Suspicion centers on a fifteen year old boy, a member of a nationalistic youth organization.

VALDEMARAS EXPRESSES SYMPATHY FOR ZIONISM

Kovno, Nov. 24.—The people of the Republic of Lithuania are in full accord with the aims of the Zionist movement for the rebuilding of Palestine and the revival of the Hebrew language, declared Prime Minister Valdemaras in a audience granted to Dr. Alexander Goldstein, representative of the Zionist Executive in London who is on a visit here in the interests of the Keren Hayesod.

The Prime Minister and other members of the government attended the public lecture given by Dr. Goldstein in the evening on the situation of the Zionist movement.

PLANNED FOUNDATIONS FOR IOWA SCHOOL OF RELIGION

Iowa City, Nov. 24.—Plans for providing a permanent foundation for the school of religion at the University of Iowa were discussed at a meeting of the trustees of the school. A committee, headed by E. P. Adler of Davenport, Iowa, was appointed to work out the plans.

The school of religion here, founded in 1925, was the first university school of its kind. Since its establishment, other universities have opened similar schools. Trustees of the school include men prominent in the Protestant, the Catholic and the Jewish faiths.

WISE'S SON AUTHOR OF BOOK CRITICIZING LEADERS

James Waterman Wise, son of Rabbi Stephen S. Wise, is author of the book "Jews Are Like That," it was announced yesterday by Brentano's, the publishers, in response to demands for the author's name by some of the subjects of the book. It was published under the pseudonym of Analyticus.

Rabbi Wise is one of nine American Jews whose careers are sketched in the book.

Unmasking the Klan in N. Y. State

Albany, Nov. 24.—The decision by the United States Supreme Court upholding the New York State law compelling authorities information as to their composition and membership may have an secret organizations to file with the immediate effect on the unmasking of the Ku Klux Klan in the state of New York.

District attorneys in every county may have the task of unmasking the Ku Klux Klan in their districts by forcing the organization to comply with the law that requires secret organizations to file copies of their constitutions, by-laws, rules, oath of membership and roster of members with the Secretary of State.

The question was put before the county prosecuting officers in a letter from Secretary of State Robert Moses in which he told the officials that the enforcement of the Walker law, under which secret societies and corporations are compelled to file copies of their oaths and members, rested with them. He further pointed out that the department of State is without power to dissolve a corporation or direct its activities.

The records of the corporation bureau of the State Department as they relate to the "Knights and Women of the Ku Klux Klan, Inc." were outlined by the Secretary in his letter to the county prosecutors. The attention of the district attorneys is called also to the fact that the United States Supreme Court has upheld the Walker law and declared that Article V of the civil rights law was constitutional.

Secretary Moses said that his department has no way of knowing whether or not the "Knights and Women of the Ku Klux Klan, Inc." requires an oath as a condition of membership or whether or not it is, in other respects, a corporation of the kind required by Article V to file a copy of its constitution, by-laws, rules, oath of membership and list of members. Nevertheless, he states, the fact remains that no such papers have been filed by this corporation or by any unincorporated association with a name containing the words "Ku Klux Klan."

"I am furnishing the desired information in order that you may take such action as you think proper, if you have reason to believe that the provisions of the article of the civil rights law mentioned are being violated in your county," Mr. Moses wrote the district attorneys.

Similar information has been placed before Attorney General Albert Ottinger by Mr. Moses, who pointed out to the head of the legal department of the State that Alpha Pi Sigma, Inc., was incorporated in 1923 and changed its name to "Knights and Women of the Ku Klux Klan, Inc." in 1925.

In a statement accompanying the letters, Secretary Moses called attention

JEWISH WOMEN'S COUNCIL PREPARES FOR ITS TRIENNIAL CONVENTION

Board of Managers Holds Sessions in New York

Plans for the twelfth triennial convention of the National Council of Jewish Women at Los Angeles in November, 1929, were announced to the Board of Managers which concluded its sessions Friday at the Waldorf Astoria, New York City. Mrs. Joseph E. Friend of New Orleans, President, stated that Mrs. Ignace J. Reis of Chicago has been appointed Chairman on Program for the convention and Mrs. Irving Bettman of St. Louis, Chairman on Transportation. It is anticipated that this convention will be the largest in the history of the organization. Delegates representing the 52,000 members of the Council in the United States and Canada will attend.

Through a report presented by the Committee on Deaf, the Board of Managers was informed that there are today three million children in the United States with defective hearing. The National Council, through its Committee, is now engaged in distributing throughout the country leaflets on the prevention of deafness. Special attention is being accorded to the testing of school children. The Committee on Deaf has compiled the existing laws of each State on the subject of the deaf, as a basis for recommending better and more adequate legislation in this field.

Mrs. Sidney J. Freiberg of Cincinnati, Chairman of the Department of Extension and Field Service, reported that a membership drive will be launched in January.

Mrs. Estelle M. Sternberger, Executive Secretary of the National Council of Jewish Women, announced that a series of addresses on the program of the National Council of Jewish Women is being broadcasted every Wednesday evening over Station WMSG. The next address will be determined by the Executive Secretary.

The establishment of the first Jewish Camp for Country Children was reported by Mrs. Elmer Eckhouse, National Chairman of the Council's Department of Farm and Rural Work. Children from rural communities in the eastern states are enrolled in this camp which aims to build up the health of undervalued boys and girls.

RIGA HEARS OF ANTI-JEWISH POGROMS IN WHITE RUSSIA

Riga, Nov. 24.—Alarming but unconfirmed reports from White Russia were received here today.

According to these reports, anti-Jewish pogroms occurred in many villages in White Russia, where many Jews were killed and injured. Shops were plundered and demolished.

The Soviet government has ordered a number of arrests, states the report.

Another report received here deals with the suicide of a Jewish student, Maisel, at Voronezh, Russia. Maisel is said to have committed suicide because of the anti-Semitic persecution at the hands of his professors. An investigation was ordered.

EDUCATION LEAGUE FOR SOCIAL GUIDANCE

(Communication to the Editor)

Sir:

Apologies of the Sub Commission's report on the cause and effects of crime, which appeared in the "World" on Sunday, November 18, may I not call your attention to the Educational League for Social Guidance, which has anticipated the Sub Commission's report and has for the past year been functioning along the very lines which the Commission recommends to be undertaken as a public function and a part of the city's educational system.

The outstanding feature of the Commission's report, it is important to point out, the establishment within school systems of clinics, for medical, psychological and psychiatric study, has for the past year been a fait accompli, thanks to the Educational League for Social Guidance.

Its activities are today carried on through private funds raised by a group of women, headed by the writer. The supreme importance of corrective environmental influences, as a crime preventive, which led to the League's organization, and the necessity for a process of mental hygiene were made apparent to the writer and founder of the League through her many years' experience in the Domestic Relations Court, as the representative of the Council of Jewish Women. This program is now being carried out in several public schools of the city, by a highly specialized staff of psychiatrists, physicians and psychiatric workers. Although our organization is now only entering upon the second year of its activity, the results obtained are of such a high order, they not only justify the vision of the pioneers of this movement but provide effective stimulus to an expansion of our activities.

The League in all its activities lays emphasis upon prevention. Prevention, experience has taught us, must apply not only to the child delinquent but in the majority of cases to the parent as well. Existing delinquency is due in a very large measure to the lack of education of parent or guardian. We operate on the belief that if the mother is met and discerned before it has time to penetrate the inner consciousness, the individual can by re-education and conscientiousness be led back to the path of normalcy. The League has not been content to adjust the individual to his environment, but has concerned itself with adjusting the environment as well. Individual cases have been studied with emphasis on mental capacity, psychological reaction, home environment and the like. On the basis of these studies many boys and girls have been saved from crime and delinquency and restored to a normal position in the community.

May we say that we have anticipated the Commission in still one other phase. Our program of rehabilitation includes the family as well as the delinquent himself. Mother's clubs are an essential part of our program, lectures being offered and an attempt made to bring about a mental adjustment to home life. Such a course is now being conducted by Dr. Leon and Blumgart.

I may say that in addition to intensive study, other phases of normal development are not neglected. Dancing classes and dramatic clubs offer a proper background for recreation and outlet. These activities very often have an immediate effect upon the problems of children. Abnormal shyne, often due to a feeling of inferiority, is corrected and the child's status in the community frequently restored.

Taking parents into our confidence, the League finds that many times a small adjustment in a parent's attitude toward a child as well as home environment has given the child a finer conception of home life.

May I point out that the work which this group is doing has not only the endorsement but the participation of the following distinguished personalities who form our Advisory Board: Dr. Alfred Adler, Dr. A. A. Brill, Mrs. Sydney C. Borg, head of the Jewish Board of Guardians, Dr. A. J. Levin, head of the School of Social Research, Dr. M. M. Kaplan, of the Society for the Advancement of Judaism, Dr. Helen Montague, Children's Court, Psychiatrist, M. J. Karpf, head of the Jewish Social Service Bureau, Judge D. Levy, Magistrate, Ian H. Norris, Everett D. Martin, Dean of the People's Institute.

In view of the fact that some inquiries indicate that there is a misapprehension as to the powers of the Secretary of State over such corporations, Mr. Moses points out that the head of the State Department is required by law to examine and file certificates of incorporation, if they conform to the statute, and that he has no power or control over their activities and no authority to dissolve them.
