MANIU THREATENS SEVERE MEASURES AS ANTI-JEWISH AGITATION RISES IN ROUMANIA

Jewish Newspaperman Named Press Attache to Legation in Washington

(Jewish Telegraphic Agency)

Bucharest, Nov. 30-As the signs of a rising anti-Jewish agitation in various parts of Roumania in connection with the political excitement of the approaching elections are accumulating, severe measures of a preventive and punitive nature are announced by the

At a conference with newspaper rep-resentatives, Prime Minister Maniu Maniu stated in unmistakable terms that his government will not tolerate the anti-Semitic demonstrations planned for

The official press bureau at Czernowitz issued a communique stating that the authorities are taking measures against the renewed anti-Semitic campaign carried on by the followers of Alexander Cuza in Bukowina. It is charged that the Cuzists have received financial support from the Averescu partisans for the distribution of antisemitic pamphlets in which Roumanian Christians are urged to vote against the government list because it contains the names of Jewish candidates.

Bucharest, Nov. 30—A Jewish newspaperman, Mr. I. Rosenthal, was appointed by the Maniu government as press attache to the Roumanian Lega-

tion in Washington. tion in wasnington.

Mr. Rosenthal was injured several years ago when he was attacked by anti-Semitic hooligans.

Bucharest, Nov. 30—Jewish leaders in various parts of Roumania are greatly divided on the forthcoming election issue. The division finds expression in bitter controversies which are raging in the press and in public meetings.

PALESTINE JEWRY DEMANDS LARGER REPRESENTATION ON JEWISH AGENCY

Wants 10 Percent of Total Non-Zionist Two Jewish Settlements in Pokrowsk Representation

Jerusalem, Nov. 30-The question as to how many representatives Palestine

Jewry is entitled to have on the Council of the Jewish Agency soon to be formed has been put on the agenda.

The Zionist Executive in a commu-nication to the Vaad Leumi, National Council of Palestine Jews, invited that body to delegate two representatives to the Jewish Agency Council. upon this proposal the Vaad Leumi today adopted a resolution confirming its previous decision to participate in the Jewish Agency. The resolution, how-ever, expresses dissatisfaction with the number of representatives allocated to Palestine Jewry and insists that Pales-tine should be given a representation equal to ten per cent of the total num-ber of non-Zionist representatives who are to serve on the Jewish Agency Council.

GRUENBAUM'S CRITICISM OF POLISH GOVERNMENT UNJUST. SAYS MINISTER OF INTERIOR Says Pilsudski Government Gave 600,-

000 Jews Citizenship Status (Jewish Telegraphic Agency)

Warsaw, Nov. 30-The criticism levelled against the present Polish government by Deputy Isaac Greunbaum for its attitude toward the problems of the Jewish population in Poland and for alleged failure to take action for the solution of these problems is without foundation.

This view was stressed by General Skladkowski, Minister of the Interior, who took the floor at the Sejm budget commission to reply to the criticism of Deputy Gruenhaum at a previous session when the two clashed on this point. The present Government feels obliged to combat the jingoism of both the Polish and the Jewish nationalism, he stated. It is quite understandable why Deputy Gruenbaum, an oppositionist, bases his argument on many trivialities. He should not, however, permit himself to stress an untruth that the Government has done nothing to alleviate the condition of the Jews.

Two years ago there were in the Eastern Provinces of the Republic hundreds of thousands of Jews who were legally in the position of men without a country, and, in accordance with prevalent regulations they were liable to deportation to Soviet Russia. ANTI-JEWISH ATTACKS AGAIN REPORTED FROM UKRAINE REGION

Region Terrorized and Plundered (Tewish Telegraphic Agency)

Riga, Nov. 30-Confirmation of recent reports that an anti-Jewish agitation is current in certain parts of the Ukraine was seen here in a report published in the Communist Yiddish daily of Charkoff, "Der Stern," received here

today.

According to the report of the Communist daily, an anti-Jewish agitation is raging in the region of Pokrowsk. Two Jewish colonies, Kalinin and Uspenska, were attacked by neighbor-ing Ukrainian peasants. The attack oc-curred in the middle of the day. Houses were plundered and the entire livestock and machinery were taken away. The local authorities took no measures against the attacking peasants although the Jewish settlements asked the militia for protection. Now, the district committee instituted an investigation, which resulted in the removal of the district chairman, Lemeschko, and the chief of the district militia, Tkatschenko.

"Der Stern" criticizes severely the local Communist organization, accusing it of indifference. The relations between the Jews and the Ukrainian peasants are highly strained, the paper

Riga, Nov. 30-An attack on a Jew-ish colony in White Russia is reported here in despatches from Moscow.

The Jewish colony, Aleksejewka, in the district of Bobruisk, White Russia, was attacked by neighboring peasants. Four Jewish houses were demolished. An investigation made by the authorities led to the arrest of seven of the hooligans.

COLONIZATION ON FIRM BASIS IN RUSSIA, HYMAN SAYS

(Jewish Telegraphic Agency)

Moscow, Nov. 30-Despite the attendant difficulties, the Jewish colonization work in Soviet Russia is established on a firm basis, declared Joseph C. Hyman, Secretary of the American Jewish Joint Distribution Committee, who left today for the United States after an extended visit here.

To the representative of the Jewish Telegraph Agency, Mr. Hyman de-clared that the achievements of the Jewish settlers is remarkable. The colonists who are on the land for three or four years are firmly established. They are contented and have full confidence in Dr. Joseph A. Rosen and the Agro-joint. Some will soon begin to repay their debts to the Agrojoint.

SEE NEW ENTHUSIASM IN COLLECTIONS FOR UNITED PALESTINE APPEAL

Almost a quarter of a million dollars has been raised by the United Palestine Appeal between October 1st and the end of November, which is \$50,000 more than was raised during the corresponding period last year, according to a report made public by Dr. I. M. Rubinow, Executive Director of the Appeal, who has been visiting various parts of the country, helping to prepare for campaigns and launching local drives.

The first result of the National Conference on Palestine held in Boston on November 11th has been a series of meetings throughout the country, at which local United Palestine Appeal committees have been adopting definite plans for their campaigns and setting aside quotas toward which they will work in the forthcoming drives. Reports of these meetings, held in all parts of the country, indicate, Dr. Ru-binow stated, that an extraordinary spirit of enthusiasm has dominated the local workers. There is the general feeling that this year's campaign will be the most successful in the history of the Appeal. It is agreed that the union of all forces in American Jewry and the prospect of a united effort for Palestine has done much toward stimulating activity.

Although a majority of the cam-paigns will be held after January, a number of them are now in full progress, particularly the large campaign in Boston, which has been making substantial progress during the past few weeks. The Northern New England territory, of which Boston is a part, has given a total of \$51,000 during the past two months.

Another territory which has been active in collections during recent weeks is the Eastern Pennsylvania Region, of which Mr. Benjamin L. Rubinsohn is Chairman.

The financial report issued by Dr. Rubinow shows the Ohio Region of the Appeal third with a total of al-most \$24,000 remitted. The men who have led the efforts in this Region are George J. Klein, Chairman of the United Palestine Appeal in Cleveland; Oscar Berman, Chairman of the Appeal in Cincinnati, and Edwin Shanfarber, Chairman of the Appeal in Columbus.

Since October 1st, the Pacific Coast Region, which includes California and Washington, has remitted the total of \$26,250; \$17,000 of this amount was the result of the efforts exerted in the San Francisco community, in which Leo J. Rabinowitz is Chairman of the United Palestine Appeal Committee. Mr. Rabinowitz is credited with much of the success that has been achieved in this locality.

A series of campaigns is now being conducted in the State of New York. and present indications are that these drives will be extremely successful. (Continued from Page 1) Peasant Party, now in power, attack the leaders of the Union of Roumanian Jews of Bucharest, headed by Dr. William Filderman for concluding an al-liance with the Liberal party. The Liberal party, they contend, is responsible for the anti-Jewish attacks which occurred while it was in power.

On the other hand, those Jewish leaders who are affiliated with the Liberal party and with the Lupa party contend that because of the fact that the Maniu government had included on its lists only such Jewish candidates as are affiliated with the Zionists and other nationalistic groups, non-Zionists were excluded and the number of Jewish representatives in parliament will thus be greatly reduced. They were, there-fore, compelled to align themselves with the Liberal party and the Lupa party, until the contemplated election reform is enacted when it will be possible to consider the creation of a unified Jewish election bloc.

JEWISH LAYMEN DEMAND RELIGION IN DAILY LIFE

A majority of 1,222 Jewish laymen who answered a questionnaire submitted by the National Federation of Temple Brotherhoods would like to see religious teachings applied to everyday life, Roger W. Straus, president, announced.

The questionnaire was sent to 17,-500 men, and answers were received from 7 per cent, living in 103 communities and representing 124 congregations.

Voting on suggested sermon subjects, 20 per cent of those replying expressed a preference for Jewish problems. 18 per cent for Jewish movements, 14 per cent for spiritual matters. Il per cent for Jewish history and 10 per cent for social problems.

WHITE PAPER MADE WAILING WALL SITUATION WORSE SAYS LONDON "JEWISH CHRONICLE" Says Government Prejudiced Mutual

Agreement by Weight Given Moslems (Jewish Telegraphic Agency)

London, Nov. 30-The publication of the British White Paper on the Wailing Wall issue has made the situation in this Arab-Jewish dispute much worse than it was before, is the view expressed by the London "Jewish Chronicle" commenting in today's issue on the

The suggestion of the White Paper that Jews and Arabs reach a mutual agreement with regard to this matter is to be welcomed. The Government, however, has prejudiced such a possibility by the heavy weight given in the document to the Moslem position. The action of the British Government is reminiscent of the famous Lincoln story that his wife wanted a room painted green while he favored red. They finally compromised by painting

the room green.

The explanation of the Government which makes the Jews appear as hav-ing a concession from the Moslems is severely limiting the right of the Jews to pray at the Wall. Palestine is no longer a Turkish province. A radical overhauling of the Wall regulations must be effected in the spirit and terms of the Palestine Mandate. The interpretation given by the Government is contradictory. The reasoning of the Palestine Government that the Wall is a purely Moslem sacred shrine is obviously wrong in view of the ancient Jewish rights to the Wall. The present ruling is deplorable, since it makes the repetiton of similar incidents not only possible but unavoidable, states the naner.

London, Nov. 30-A reply to the question of Lieut. Commander Kenworthy as to whether the British Gov-ernment is aware of the structure crected by the Moslems on the top of the Western Wall was made on Wednesday by Col. Leopold H. Amery, Sec-

retary for the Colonies.

The Government is not satisfied that the Moslems infringed the status quo of the Wall by building over the Wall.

American University at Beirut Does Not Bar Hebrew High School Graduates

By Our Beirut Correspondent

Beirut, Nov. 7-The American University at Beirut does not discriminate against the graduates of the Gymnasia Ivrith, the Hebrew high school of Tel Aviv, declared President Bayard Dodge of the University in reply to an inquiry of the "Jewish Daily Bulletin". A report published in the "Doar Halyom," Palestine Hebrew daily, had stated that the American University at Beirut has discontinued to admit graduates of the Gymnasia Ivrith.

Only a lack of knowledge of the English language would keep graduates of the Tel Aviv high school from being admitted to the University, the

President stated.

1. Let me assure you that the University is most anxious to do everything that it can to encourage high schools in this part of the world, President Dodge declared in his statement. We have kept up the fees and standards of the preparatory school an-nexed to our institution so as to avoid competition with other schools around us. Our diplomas are authorized by the Regents of the State of New York, and the Regents have been most sympathetic in allowing us the right to accept students who pass government examinations and to give full credit to certificates provided by the principals of well-known schools. Furthermore, we have sent many of our best teachers to other schools at considerable sacrifice to our own secondary work. We feel that whenever a boy can have the advantage of secondary schooling in his own locality, it is much better for him to be brought up there in his home atmosphere and close to his parents. Accordingly we have encouraged schools in the district around us and have always advised parents to keep their sons as near to home as possible for their preliminary education.

2. A Board for Higher Studies has been trying to organize the secondary educational work in Palestine in close cooperation with the Government Department of Education. This Board has conducted matriculation examinations. It has been clearly understood that students passing these examinations may enter sophomore year of our University with certain definite conditions.

They must pass what is known as Schedule A English in the examination, or else prove to our Faculty that they know enough English to read the reference books and understand the lectures of our sophomore class.

b. If they are to fit themselves for engineering, they must have passed off certain courses in mathematics before being eligible to enter sophomore year.
c. If they wish to enter medicine or

dentistry, they must have passed off certain courses in chemistry and biology before being allowed to enter sophomore year.

STEAL HISTORIC DOCUMENTS OF CHASSIDIC MOVEMENT IN WEDDING EXCITEMENT

Enthusiastic Reception for Lubawitscher Rebbe Who Comes to Marry Off Daughter

Warsaw, Nov. 30-Important historic

documents throwing light on the origin of the Chassidic movement were stolen in the excitement at the wedding of the daughter of Rabbi Jacob Joseph Schneursohn, the Lubawitscher Rebbe who came from Riga for the marriage cere-

Large numbers of Chassidim welcomed the scion of the famous Chas-sidic dynasty of Schneursohn on his arrival at the Warsaw depot. He returned today to Riga, his present abode, following his exile from Russia, to celebrate on Sunday, December 2, the Chabbad holiday, the 19th of Kisley, which is commemorated annually as the date when his grandfather was re-leased from the Petro-Pawlowsk prison.

Hundreds of the Lubawitscher Rebbe's followers attended the wedding ceremony which was held in a Yeshiva hall. Many wedding gifts were show-ered upon the couple. Congratulatory messages were received from the United States, Egypt, Palestine and other countries, including one from Chief Rabbi A. J. Kook of Jerusalem.

In the excitement which reigned during the exerciscint which registed uni-ing the festivities a package of manu-scripts, said to have contained letters written by the Baal Shem Tov, the founder of the Chassidic movement, in his own handwriting, and of Rabbi Schneur Zalman, the grandfather of the Lubawitscher Rebbe and the founder of the Chabbad Chassidic school, disappeared. The documents, prized highly because of their rarity, were brought by the bridegroom's grandiather as a wedding gift.

have the same rights as other students in Palestine in connection with these Palestine Matriculation Examinations.

3. Many schools in Palestine have not attempted to fit students for the Matriculation examinations as they have not got proper teaching material for such advanced work. During the past years, a number of these schools have been permitted to grant certificates to students and the University has allowed these students to enter freshman class without further examination. On the other hand, it has always been clearly understood that these students must know enough English to do the work of our Freshman year. It is not likely that this permission for stu-dents to enter the University upon certificate without examination will continue much longer, and of course any privilege given to other schools will be granted to the Gymnasia Ivrith. At the present time, the Gymnasia Ivrith has had a certain advantage over the other schools, namely, students from the eighth year of the Gymnasia, who know English, are often admitted to classes higher than freshman. Students of the Gymnasia who wish to enter our Med-(Continued on Page 4)

(Continued from Page 1) number of minor anti-Semitic incidents which were immediately quelled. The government has intervened in the attempt to distribute in Posen a picture purporting to show a ritual murder. It also intervened against the agitation of the "Sabbath Courier," anti-Semitic pa-per of Bromberg. Deputy Gruenbaum, however, failed to mention the new understanding between Poles and Jews along economic lines, which has recently found expression in the elections held in the chambers of commerce and

artisans associations.

The government has regulated the status of the Kehillahs. Deputy Gruenbaum charged that because of government measures to introduce modern machinery in bakeries in the Brest region, Jewish bakers have suffered. The fact of the matter is, however, that the same regulations were applied in the provinces of Posen and Upper Silesia where there are no Jewish bakeries. It cannot then be charged that the regulations have the purpose

of hurting Jews.
Deputy Gruenbaum replied to the Minister's remarks. He stated he was in doubt whether the statement that 600,000 Jews in the Eastern provinces were granted citizenship, as there are not so many Jews in that region. The situation of the Jewish population in Poland may be improved only through action, not by words alone. Until now we have heard only words, Deputy Gruenbaum asserted.

ical School and who are able to pass examinations in English, Botany and General Chemistry are permitted to enter the final year of the pre-medical course. Students from all other secondary schools in Palestine must take two years of pre-medical work before entering medicine or dentistry, and do not have this privilege of presenting themselves for examinations with the possibility of qualifying to enter so as to spend one year of work in pre-medicine. This special privilege has been granted to the Gymnasia Ivrith because we realized that its work in science is better than the work of other schools in Palestine.

4. Some years ago, the standards of our work, specially in medicine, were very much lower than they are at the present time. We have not "discon-tinued" admitting graduates of the Gymnasia Ivrith except as we have raised our standards and obliged all of the schools in this part of the world either to raise their own standards or to send their students to classes lower than the ones which the boys were allowed to enter during the war. The only disadvantage which the Gymnasia Ivrith has is the fact that so much of the work is done in Hebrew that many of the students do not know English well enough to follow our courses unless they have had special lessons in English. Our University conducts a summer school in the mountains of Lebanon where students of the Gymnasia are free to spend the summer if they wish to perfect themselves in English, and in that way to enter our higher classes.

5. I might say that we are making special arrangements for Jewish students as they are free from classes on Saturdays provided they make up the work. They are not obliged to attend any of our religious services and may attend their own synagogue meetings. A special Kosher restaurant is conducted in connection with our refectory, in their behalf; and one of our Jewish teachers has organized the Kadima Society to keep alive an interest in Hebrew culture, President Dodge concluded.

The Congregation Adas Israel, of Elizabeth, N. J., filed articles of incorporation with the county clerk for the purpose of establishing and maintaining a synagogue and a Hebrew school.

Benjamin L. Stein, Paterson lawyer, was among the members elected to the New Jersey State Assembly, representing Passaic County.

WHITE PAPER MADE WAILING WALL SITUATION WORSE SAYS LONDON "JEWISH CHRONICLE"

(Continued from Page 3) According to the latest report, it appears that a small wall was constructed upon buildings surmounting a portion of the Wall. Thus is an integral part of the structure begun many months ago. At that time nobody suggested that the construction involved an infringement of the status quo, the Secretary declared.

The White Paper issued by the British Government concerning the Western Wall issue is a one-sided document and aims obviously at justifying the action of the Palestine police which interfered with the Jewish worshippers on Atonement Day.

This comment was made by Dr. David Yellin, former vice-mayor of Jerusalem who is on a visit to the United States in the interests of the Hebrew Teachers Seminary of Jerusalem.

If it is true that the Jewish worshippers have infringed upon the status quo by the erection of a temporary screen on Atonement day, it is equally true that the local authorities could have found other ways and means to remove the screen in a peaceful manner, without insult to Jewish sentiment and without making more acute the relations between the Arabs and the Jews, Dr. Yellin stated.
