

## GERMAN NON-ZIONISTS STATE CONDITIONS FOR ENTERING AGENCY

Leader of Liberal Jews Formulates  
Platform for Agreement  
(Jewish Telegraphic Agency)

Berlin, Dec. 14.—What may be regarded as the conditions which will be insisted upon by an influential group of non-Zionists in Germany as a part of the agreement on their entering the Jewish Agency for Palestine, was formulated by one of the influential leaders of the group.

Landesgerichtsrat Lienthaler-Schneider, leader of the Association of Liberal Jews in Germany, in an article which is to appear this week in the "Juedische Liberale Zeitung," communicated to the Jewish Telegraphic Agency in advance by the Association, sets forth the following conditions which will be asked by his group before they can enter an agreement to work with the Zionists in the Jewish Agency for the rebuilding of Palestine.

1. The Liberal or Reform Jews must be placed in such a position as to have an influence on the Palestine work.
2. That the attitude of the Liberal Jews toward the Palestine work, as well as towards other questions in relation to the outside world, be respected by the Zionists.
3. That the joint work of the Zionists and non-Zionists in Palestine be shorn of its political character, notably that immigration to the country is to proceed in accordance with the country's capacity for economic absorption and that friendly relations with the Arabs be aimed at.
4. That the agreement on Palestine

## SEEK TO SETTLE MARRIAGE LAW DISPUTE OUT OF COURT

(Jewish Daily Bulletin)

Boston, Dec. 14.—A meeting of prominent leaders has been called for Saturday night with a view to settling the dispute between rabbis and cantors on the right to perform marriages.

It is not likely that the matter will be taken out of the courts unless quick action is taken before next Wednesday when twelve cantors have been summoned to appear before Judge Bolster on the charge of illegally performing marriages.

Rabbi Landau, secretary of the Union of Orthodox Congregations, declined to comment on the situation. Moses Mishel, president of Temple Mishkan Tefilah, and president of the Associated Jewish Congregations of Boston stated to the correspondent of the "Jewish Daily Bulletin" that his organization had no part in the summoning of the twelve cantors to court. Mr. Mishel termed the action taken as unwarranted.

## CHARGE POLISH FOREIGN OFFICE PERMITTED SPREAD OF ANTI-SEMITIC TALES ABROAD

Vice-Minister Says Foreign Office Unaware of Such Acts; Promises Investigation  
(Jewish Telegraphic Agency)

Warsaw, Dec. 14.—Charges that the press service emanating from the Polish Foreign Office has been used to disseminate propaganda against Polish Jews were brought before the Budget Commission of the Polish Sejm during the discussion on the estimates of the Foreign Office.

Deputy Rozmarin, speaking on behalf of the Club of Jewish Deputies, quoted a release issued under the auspices of the Foreign Office for the use of the foreign press, in which it was asserted that Polish Jewry consists of three parts, the first being a majority of Communists, the second, a majority of Jews, the second, the Zionist, nationalistic group, similarly termed unloyal; and third, a small group of loyal Polish citizens. Polish Jewry, economically, is a parasitic element, the release added.

The Zionists, the propaganda material further stated, aim to retain the ghetto life of Polish Jewry. The agitation carried on abroad by Polish Jews was the cause for the growth of anti-Semitism in the country. Following the Pilsudski revolution of May 1926, the Orthodox Jews, ignoring the agitation of the Zionist leaders, fought together with the Polish workers on Pilsudski's side. The Zionists, the release further stated, make it impossible for Polish Jews to merge with the Polish people, since they continually exhibit and emphasize a national separatism.

Deputy Rozmarin stated he was doubtful as to whether such propaganda is of any good to Poland's prestige and expressed his opinion that most likely the baptized Jews who are in the service of the Foreign Office are attempting to offer proof of their hyper-patriotism by disseminating such anti-Jewish propaganda. He also asked why the press department of the Foreign Office consistently ignores the Jewish press representatives at the

## JEWISH CANDIDATES ON GOVERNMENT LISTS WIN

Bucharest, Dec. 14.—The Jewish candidates on the lists of the Roumanian National Peasant Party were elected.

An official announcement declares today that the three government lists were victorious.

Reports from Czernowitz state that in the bi-elections in Bukovina, out of the four Jewish candidates, only one was elected. Dr. Jacob Eristiner, member of the Jewish labor party Bund was victorious.

## BITTIS FIRM TO EX- PLOIT TRANSJORDANIA PHOSPHATE MINERALS

Price Reduction on Artificial Fertilizers Will Result  
(Jewish Telegraphic Agency)

Jerusalem, Dec. 14.—The British firm, Gough's General Distributing Co. Ltd., received a concession to exploit the phosphate minerals of Transjordan, it was learned here today.

A representative of the company, Captain de Valde who is now here, is proceeding to London to prepare plans for starting the work next spring. Captain de Valde, the report states, has investigated the resources and came to the conclusion that Transjordan possesses millions of tons of the best phosphates. The first shipment which is expected shortly after operations begin, may reach an amount of 100,000 tons. The result of the exploitation of the Transjordanian phosphates will be, it was declared, a reduction in the prices of artificial fertilizers in Palestine and on the world market. It was estimated that the Transjordanian phosphates can be sold at half the price of other fertilizers.

## PALESTINE TEACHERS HOLD BIENNIAL CONFERENCE

Jerusalem, Dec. 14.—The second biennial conference of the Palestine Teachers Association was held at the orphans' village, Ben Shemen, with the participation of 130 delegates.

The introduction into the schools of the study of modern Palestine ideals for redemption of the soil was considered at the conference.

M. M. Ussishkin urged that the Jewish National Fund principles be the foundation for national education. Chaim Nachman Bialik in his address urged the teachers to relate all instruction to the high national, religious and social ideals of the Jewish people.

Jerusalem, Dec. 14.—The village Sunam, mentioned in the Bible, has been acquired by the Jewish National Fund. The village, occupying 7,500 dunams, is located near the colony of Merchavia.

The Jewish National Fund also purchased 1,650 dunams at Mejdol near Jeddah, for enlarging the Hapoel Ha'Mizrachi settlement there.

## JAMES H. BECKER ENROUTE TO U. S.

London, Dec. 14.—James H. Becker of Chicago, member of the Committee of Seven appointed by Louis Marshall to designate the American non-Zionist representation on the Jewish Agency, sailed today for the United States on the steamer Leviathan. ## YESHIVA COLLEGE DINNER ADDS TO BUILDING AND ENDOWMENT FUNDS

Dinner Attended by 1,400 Guests Will  
Net Institution \$700,000

Fourteen hundred men and women, paying \$1,000 per couple, attended the Yeshiva College dedication dinner held at the Astor Hotel Thursday evening.

Samuel Levy, Chairman of the Yeshiva College Campaign Committee, was the toastmaster. Mayor Walker, wearing a skull cap, as did all the men guests, delivered his second address on the significance of the Yeshiva College for the life of the city, his first address having been made at the dedication exercises on Sunday afternoon. The other speakers were Judge Otto A. Rosalsky, Dr. James Sullivan, Commissioner of Education of the New York State University; Dr. Bernard Revel, President of the Faculty of the Yeshiva College; Rabbi Joseph Luckstein, Rabbi Herbert S. Goldstein. Morris White, who was chairman of the dinner committee, introduced the toastmaster.

Samuel C. Lamport during his speech read a statement dictated by his late father, Nathan Lamport, who was the president of the Rabbi Isaac Elchanan Theological Seminary and who contributed \$200,000 toward the Yeshiva College project, in his last days, to be read at the then expected dedication exercises. The statement of Mr. Lamport's father expressed the hope that Orthodox Jewry will rally to the support of the Yeshiva College in a dignified and permanent manner.

No appeal was made for funds, nor were contributions announced, it being understood that the proceeds of the \$500 per plate will net \$700,000 to the fund. Payments of the \$1,000 subscriptions may be made by the donors over a period of four years.

Judge Rosalsky urged the guests to support the College. Next year its budget will be \$500,000.

## LEO SMOLENSKIN

## DIES IN VIENNA

Leo Smolenskin was co-editor with his brother of the "Ha' Schachar," the Hebrew magazine published in Vienna, which played a dominant role in the enlightenment movement of East European Jewry in the latter half of the nineteenth century.

## "MANCHESTER GUARDIAN" COMMENTS ON ANTI-SEMITISM IN SOVIET RUSSIA

Barshay Affair Focused Public's Attention to Situation

London, Dec. 14.—The Barshay affair focused popular attention on the present stage of anti-Semitism in Soviet Russia, resulting in the disclosure of anti-Semitic outbursts in White Russia, at the University of Voronezh, and the persecutions of Jewish workers in the mining districts, states the correspondent of the "Manchester Guardian" in a despatch from Moscow published in that paper.

The correspondent writes that flashes of anti-Semitism due to prejudice stimulated during the Czarist regime are not surprising. However, these cannot be compared with the present excesses which do not reach beyond the maltreatment of individuals or small groups. The persistence of racial antagonism causes concern to the Communist leaders, the correspondent declares, because anti-Semitism is growing not only among the former wealthy classes, but even the young Communists, due to the intense class consciousness cultivated in them, show anti-Semitic hatred because they regard the Jews as the trading class.

A further factor contributing to the increase of anti-Semitism is that new Communists join the party without changing their old ideas. While the growth of the Communist party indicates a strengthening support among the masses, it temporarily carries with it an infiltration of popular prejudice.

The correspondent cites the case of the Chief Military Guard at the Bransk mines who, although a member of the Communist party, declared: "I hate the Jews and think it wrong of the party not to permit pogroms."

The Soviet Government endeavors to curb anti-Semitism, the correspondent points out, by eliminating the legal basis for racial discrimination and imposing special punishment for those found guilty of anti-Semitic acts.

## NEW BOOKS OUT BY JEWISH AUTHORS

Three new books by Jewish authors have been published by Harper & Brothers this season. They are "My Life is in Your Hands," Eddie Cantor's book, as told to David Freedman; author of a novel "Mendel Marantz"; "The Terrible Siren," by Eranie Sachs and "Behind Your Front," by James Oppenheim.

Mr. Cantor's royalties from the book will go to the Eddie Cantor Camp Committee, a fund to provide East Side boys with vacations in the country.

Mr. Oppenheim's book "Behind Your Front" is a popular book on psychoanalysis. "The Terrible Siren," by Mrs. Sachs, is a biography of Victoria Clafin Woodhull.

David Kaufman of Elizabeth, N. J., died on Thursday in New York at the age of 78. Mr. Kaufman was the head of a large firm of metal reclaimers. He was a founder of Congress B'nai Israel, of which he had been president for 25 years. He was a liberal donor to charities.

## GOOD WILL MEETING EMPHASIZES COMMON IDEALS OF BOTH FAITHS

800 Representatives of Jewish, Protestant and Catholic Faiths Attend

Eight hundred leading representatives of the Jewish, Protestant, and Catholic faiths, meeting Thursday evening, affirmed that Jew and Gentile can meet in amity. Called by the Men's Club of Temple Emanu-El, and held in the Temple, the meeting heard a pledge of good will from leaders of the Christian Churches in America, as well as prominent laymen, and a plea on the part of Jewish spokesmen that deeds should follow words in the creation of good will.

The Knights of Columbus, the Independent Order Bnai Brith and the Masonic Order were represented at the meeting.

The keynote sounded by Dr. S. Parkes Cadman and reiterated by all the speakers was that all faiths, despite their differences, have one common goal. And that all faiths, with due appreciation for the merits of each, can achieve fraternity by uniting against the common foe—the enemies of progress, light and justice. Christian and Jewish leaders alike referred to Jacob Schiff as an eminent example of loyalty to his own faith and good will to fellow men, and as an excellent model to follow. Spokesmen of all faiths emphasized that the work of good will is not undertaken in no patronizing spirit, if it hopes to be successful.

Those who participated in the exercises were: Dr. S. Parkes Cadman, Honorary President of America's Good Will Union, the Very Rev. Howard Chandler Robbins, Dean of the Cathedral of St. John the Divine, Hon. John G. Agar, Chairman of the Board of America's Good Will Union, the Rev. Edward L. Hunt, Director of America's Good Will Union, Rabbi David De Sola Pool of Congregation Shearith Israel, Rabbi Samuel Schulman and Rabbi Nathan Krass, Rabbin of Temple Emanu-El. Judge Myron Sulzberger, President of the Men's Club, presided. The exercises, held in the home of the largest Jewish Congregation in New York City, were opened and closed with prayer by two Christian clergymen, Rev. Dr. Albert Parker Fitch of the Park Avenue Presbyterian Church and the Rev. Dr. Henry Mottet of the Church of the Holy Communion.

Deprecating uniformity of outlook and practice as inevitably leading to mediocrity, Dr. Cadman declared that it would have been a great misfortune to the world if the Jew had been built like other people. Thanks to its difference it has given a contribution to civilization that is great beyond words. "To the House of Israel we owe the moral conception of God, as the creator of the Universe, and the conception of how we shall worship that God. We will never be able to pay the debt we owe to your little nation," he said. "Let us continue to march under the banners inscribed with our victories,

## J. D. B. NEWS LETTER

### South African Notes

By Our Johannesburg Correspondent

Johannesburg, Nov. 9.—The question of the title of Chief Rabbi as applied to Dr. J. L. Landau, which was raised in a letter from the Cape Town Hebrew Congregation, was discussed at the last meeting of the South African Jewish Board of Deputies here. S. Raphaely, the president, being in the chair.

The minutes of a special meeting of the Executive and of a joint meeting of the Executives of the Board and of the United Hebrew Congregation of Johannesburg were read, at which it was unanimously agreed that the following recommendation be made by the Executive Committee: "That a statement be issued to the constituent bodies and the Jewish press to the effect that Dr. J. L. Landau is the Chief Rabbi of the United Hebrew Congregation of Johannesburg and of the Federation of Synagogues of the Witwatersrand."

This announcement happily ends a controversy which at one time threatened a disruption of the otherwise harmonious relations which have existed among the several Jewish communities of South Africa, the "South African Jewish Chronicle" comments in an editorial.

"The communique," it says, "contains the welcome news that an official pronouncement has been made with reference to the correct designation of the spiritual head of the Johannesburg Jewish community. When we referred to this matter in a leading article a few weeks ago, we did so in an attempt to bring the controversy to an end and to remove an obstacle to perfect unity and harmony between the different communities in the country. We saw that unless something was done, there was grave danger of a schism in South African Jewry that would cause incalculable harm to Jewish communal interests. In the Cape Town community—the Mother Community of the sub-continent—particularly, feelings ran high whenever the question was referred to. This paper particularly welcomes the news which heralds a new era of cooperation in South African Jewish life. The leaders of Jewish population can now go forward with a united front, and take in hand the many problems which await solution in a virile and growing community such as ours.

"As hitherto, we shall cooperate with our leaders in maintaining the peace of the community and furthering the progress of all communal endeavors, secure in the belief that the goal can only be reached by esprit de corps, with team work and a solid front, and by setting principles and the interests of the community before personalities. The time hitherto devoted to the airing of grievances, real or imaginary, can now be fearlessly applied to con-

## EMIL LUDWIG HONORED IN COPENHAGEN DESPITE ACTION OF GERMAN AMBASSADOR

Son-in-law of Von Tirpitz Caused  
Lecture Cancellation  
(Jewish Telegraphic Agency)

Berlin, Dec. 14.—Emil Ludwig, popular German Jewish biographer, is the center of a storm in the German press due to an incident which occurred in Copenhagen this week.

The noted author was scheduled to deliver a lecture at the University of Copenhagen. Due to the intervention of the German Minister, Herr Hassell, a son-in-law of former Admiral von Tirpitz, leader of Germany's submarine campaign during the World War, the lecture was cancelled. The German Minister contended that Ludwig is not a profound research scholar.

When the details of the incident became known, indignation was manifested in the Danish academic world. At the initiative of Copenhagen's leading daily, "Politiken," a reception in honor of Herr Ludwig was given. Representatives of the diplomatic corps and leading Danish artists and scientists were present. Professor Bupl who delivered the principal address praising Herr Ludwig, stressed the point that in the biographer's work the research spirit is predominant. The German Minister, Herr Hassell, was conspicuous by his absence.

## SOCIAL WORK TRAINING SCHOOL TO EXTEND TERM

A decision to extend the course of studies of the Training School for Jewish Social Work from fifteen months to two full academic years was taken at the semi-annual meeting of the trustees held Thursday afternoon at the school, 71 West Forty-seventh Street, New York. An application will be made to the University of the State of New York for a permanent charter for the school, it was declared.

Felix M. Warburg, chairman of the executive committee, presided in the absence of Louis Kirstein of Boston, the president.

The compensating features of Jewish social work as a profession were discussed by Maurice J. Karpf, director of the Training School for Jewish Social Work at reunion of the school's alumni held in the Federation Building. The reunion was held in conjunction with the school's Chanukah celebration and was attended by the present student body and faculty.

"Jewish social work offers many compensating features, not the least of which is the opportunity to participate in the development of a profession which is dedicated to human betterment," Mr. Karpf declared. "It offers also unusual opportunities for leadership. Persons of vision, ability and courage can forge ahead in social work with unparalleled rapidity and are given recognition and opportunities for leadership such as are rarely equalled in other professions. In addition, Jewish social work offers opportunities for stimulating professional contacts and for companionship with outstanding and intellectually alert persons."

and the same time attack the enemies of progress, light and justice," he urged.

The work of unification, he pointed out, should be carried on in a wise, sane, statesmanlike fashion, and should affect no patronizing tone.

"Co-operation to the farthest point that our respective faiths and disciplines permit in the maintenance of ideals which are common to both faiths," should be the goal of the partisans of good will, is the point of view advanced by Dean Robbins. "Good will between Jews and Christians has long since passed the stage of co-operation in philanthropic enterprises. Our allegiance to the God we have in common is threatened today by a common enemy, materialism, that is laying waste things sacred to both Jews and Christians."

Doubt that good will was in existence and the belief that the Good-Will Union was a mechanism erected to disguise the void was expressed by Rabbi Nathan Krass. Preaching a good sermon, he said, is not enough to create good will. Preaching a sermon that will do good, is the important thing. "The Society for Good Will is not an unmix blessing, he declared. "Its very existence is an indication of poverty, pointing to the fact that good will is not a realization in the Kingdom of men."

While genuine good will is still a distant ideal, efforts to promote it may generate that virtue in future generations, he maintained.

He criticized those members of the Jewish faith who seek good will by "smuggling in through the back door, sending in their cards with transfigured names." He urged them to follow in the path of Jacob Schiff, who "proved his Judaism, not by shouting it, but by living it."

In its campaign for good will, he urged the Christian Church to begin a policy of conversion, not among the heathens or the Jews, but among the Christians.

Turning to Ralph Waldo Emerson for a text, Rabbi Schulman said: "The soul answers never in words, always in the things inquired after. If we wish good will, we must practice it."

The wish that "some of our Gentiles would offer us good will in a less irritating manner," was voiced by Dr De Sola Pool. Dr. Pool referred in particular to the missionary spirit which he stated animates some of the good will emissaries.

Jew and Gentile alike could find no better example to follow than that great personality, Jacob Schiff, declared Hon. John G. Agar.

The program was concluded with the presentation of an American flag to Dr. Edward L. Hunt, Director of America's Good Will Union. The gift of George MacDonald, a paper chamberlain and of Frederick W. Kavanaugh, an Episcopalian and 32nd degree Mason, the flag was presented by

structure work so necessary in the upbuilding of an united South African Jewry. We tender our congratulations to the learned spiritual chief of the Johannesburg community, to the Board of Deputies and to the United Hebrew Congregation on the happy removal of an old misunderstanding, and to the Jewish community of South Africa on its entry into a new epoch of peace, harmony, mutual trust and better understanding."

A dinner in honor of Sir Ernest and Lady Oppenheimer was given by the Jewish Guild here. In his address, Sir Ernest, who is a member of the Legislative Assembly, and a leading power in the world of South African mining and finance, declared:

"This is the first visit I have made to the Jewish Guild. I have so far not been connected with Jewish institutions in South Africa, having always devoted myself to public affairs of the country. I have, however, always taken a keen interest in the Jewish Guild and you will remember that I was one of the contributors to the original fund."

"I am glad of the name of the Jewish Guild War Memorial Hall. With regard to the word 'Jewish,' I am pleased that we can boldly declare it is a Jewish institution in a free country. The word 'War' indicates that South African Jews had been ready to do their duty in defending their country and the British Empire."

"I would like," added Sir Ernest, "to be a leader of South Africans of the Jewish faith. How could I lead? Not in the synagogue. I am not in favor of that prayer where we express our gratitude that we are men and not women. Nor could I lead in Zionism. I deeply respect the Palestine of the Bible. I am also in sympathy with the idea of Palestine becoming the spiritual center for the Jews, but there my adherence and sympathy end. On one subject I am totally keen to help—to lead our people so that we become finer South Africans of the Jewish faith. The Jewish Guild can play a great part in increasing this love of our country and of the British Empire. Give me an opportunity to lead in this direction!"

Mrs. Archibald Silverman of Providence, R. I., member of the Administrative Committee of the Zionist Organization of America will be the principal speaker at the meeting of the Women's League for Palestine, to be held tonight, Sunday, at the Ritz-Carlton Hotel, New York.

The Women's League for Palestine, of which Mrs. Richard Gottheil is President, and Mrs. Ida Danger, Secretary, is preparing to launch a campaign for a sum to support the special enterprises which it has founded in Palestine.

press conferences. While the representatives of the Persian, Turkish and Afghanistan newspapers are given every consideration, such an important factor as the Jewish press in the United States is ignored.

Vice-Minister Wyszocki, replying to the remarks of Deputy Rozmarin, declared he was unaware of the release referred to and expressed the conviction that the Foreign Office has not issued such material. The distribution of such information concerning Polish citizens of the Mosaic faith does not correspond with the policy of the Foreign Office, he declared, asking Deputy Rozmarin to submit to him a copy of the release, whereupon he will order a thorough investigation.

Deputy Rozmarin stated he will present the material within twenty-four hours.
