Sharp Memorandum Complains Against Infringement of Numerus Clausus

No Reason to Abandon Jewish Na-tional Territorial Unit, Resolution Says (Jewish Telegraphic Agency)

Budapest, Dec. 28-The authorities of the University of Budapest preto Minister of Education, Count Kle-belsberg, on the question of the admission of Jewish students to the univer-sities. The memorandum complains against the infringement of the numerus clausus and the autonomy of the university, by the Minister's ordering the admittance of Jewish students over the quota.

The students particularly object, the memorandum states, to the increase of the number of Jewish students in some universities from 6 percent to 23 percent. Measures taken by the government against the students, ordering their clubs to be closed and withdrawing allowances which are granted to some is stirring up excitement. Full re-inforcement of the numerus clausus and restoration of students' rights is demanded in the memorandum

ZIONIST REVISIONISTS DIVIDED ON PROGRAM

TO BE FOLLOWED Establish in London Society to Pro-tect Jewish Rights in Palestine (Jewish Telegraphic Agency)

Vienna, Dec. 28-The seventy delegates representing various Zionist Revisionist groups in the Zionist constituencies in European countries are divided on the question of what program the League of Zionist Revisionists is to adopt to make its oppositional policies effective.

In the discussion which developed at their third annual conference in session here, following the political report of Vladimir Jabotinsky, two tendencies were manifest. Spokesmen for the exwere maniest. Spokesmen for the ex-treme wing within Zionist Revisionism urged the adoption of a program of an economic and political action inde-pendent of the Zionist Executive, while spokesmen for the moderate group were opposed to such action. Vladimir Jabotinsky, leader of the movement, urged a middle course. According to his proposal, Palestine Jews and the Zionist Revisionists are to seek the cal program, which would not, nonetheless, interfere with the prerogatives of the Zionist Executive.

The central point in the political discussion was the idea recently advanced by Col. Josiah Wedgwood, British labor M. P., in his book, "The Seventh Dominion." Col. Wedgwood advocates that Great Britain and the

WAHABIS' KING MAKES PEACE WITH IRAO, TRANSJORDANIA (Tewish Telegraphic Agency)

Jerusalem, Dec. 28-A pact to maintain peaceful relations with Iraq and Transjordania was concluded by Ibn Saud, King of Hedjas and Nejd and leader of the Wahabis, at a recent con-ference held at Riyad, it was officially announced here today.

The pact confirms the full rights of Ibn Saud to control the Moslem holy sites at Mecca and Medina.

SAYS FIGHT AGAINST ANTI-SEMITISM MUST BE JOINED TO WAR ON JEWISH NATIONALISM "Emes" Says Jewish Chauvinim Is Weapon of Jewish Nepmen

Moscow, Dec. 28-The fight against anti-Semitism in Soviet Russia must be accompanied by a simultaneous intensive campaign against Jewish national-ism, urges the "Emes," Yiddish Communist daily. Tewish chauvinism is the weapon of

the Jewish nepmen, who are the enemies of the Soviet regime and the same class enemy as the anti-Semite. must be crushed, the paper says.

The executive committee of the Communist party in Kiev excluded from its membership the Communist worker, Dowgon, for anti-Semitic agitation. A Russian worker, Resnykow, who was found guilty of anti-Semitic agitation in the factory "Red Prog-ress" at Melitopol, was sentenced to two years imprisonment.

GOGA PLANS NEW ROUMANIAN PARTY

(Jewish Telegraphic Agency) Bucharest, Dec. 28-Octavian Goga, former Minister of the Interior in the Averescu cabinet, poet, and anti-Semitic agitator, is planning to create a new Roumanian party, it was learned today.

The party is to be named the New Christian Economic League. It was stated that Goga has approached Alexander Cuza, leader of the anti-Semitic student movement, to join him in his effort

SENTENCE ATTACKERS OF JEWISH COLONY TO PRISON

(Jewish Telegraphic Agency) Riga, Dec. 28-The trial of the ringleaders in the attack on the Jewish col-

ony Alexejewka, White Russia, was concluded yesterday in Rogatschow. The leader of the hooligan band was sentenced to ten years imprisonment at hard labor. The chairman of the local town Soviet, as well as two members of the militia were sentenced to one year imprisonment for failure to take action in defense of the Jewish colonists.

ALIEN QUESTION IS AGAIN BROUGHT UP

(Jewish Daily Bulletin) Washington, Dec. 28-Congressman Hoch of Kansas, author of the pro-posed amendment to the Constitution to change the method of congressional representation eliminating aliens from being computed in the basis of representation, again started a discussion of the issue on the floor of the

House by commenting on the action of Congressman Schafer of Wisconsin reading a letter from W. H. Anderson, former Superintendent of the Anti-Saloon League of New York, regarding the proposed amendment. Congressman Hoch charged that Schafer was trying to inject "The wet and dry issue and the religious question."

"I do not think that the apportionment question has anything to do with the wet and dry question or with the question of religion. Here we have in the State of New York, by way of illus-tration, four electoral votes, and in Massachusetts two votes cast upon the election of the President of the United States solely because there are several million aliens in those States. And so with the other States where the seven or eight million aliens in America principally reside," Mr. Hoch stated.

Hch declared that upon the basis of the 1920 census the reapportionment. excluding aliens from the count, would mean a shifting of nine electoral votes from five states and that if aliens had beel excluded from the basis of representation in any of these given states it would have changed the result of the last Presidential election.

"Is it reasonable, is it right, that the electorial vote of any State in this Union in the election of the President of the United States should be in-creased solely by the fact that there are within that State a great body of aliens, that is, unnaturalized foreign born?" Congressman Hoch asked.

TURKEY FROM AIDED IN URUGUAY Hias Harbin Office Reports on Work in Far East

The problem of receiving and taking care of Jewish refugees from Turkey

who are going to Uruguay has taxed the strength of the Jewish Immigrant Aid Society at Montevideo, Uruguay, according to a report received by the Hebrew Sheltering and Immigrant Aid Society (Hias). Most of these refugees are families, middle aged men, usual aid given by the Society to Tewish immigrants was not sufficient in these cases.

The women and children during the first ten days of their stay were shelhrst ten days of their stay were sher-tered at the Society's home, after which they were taken care of in the immigrant hotel maintained by the government. Throughout all time they received special food from the Society. At the expiration of the period during which the government sheltered them, each family was es-tablished in living quarters. Most of these refugees have now adjusted themselves to local conditions but some have still to be aided.

The report further states that non-Jewish immigrants are also being helped, receiving information and such other aid as they may stand in need of.

The Central Information Bureau for Jewish wanderers in the Far East at Harbin, has reported to the Hias on the work being done to aid Jewish wanderers.

"We have been notified by the American Consul here that he has received from the American Consul in Riga who controls the issuance of visas for emigrants from Russia, 30 additional visas charged to the Russian quota. These visas will be granted to women and children of declarants according to the new American

immigration law. "These visas are in addition to the former 20 visas for the preferred class. Immediately upon the receipt of the notification, we informed the women who are registered in our office and we are preparing the necessary docu-

ments for them. "For ordinary emigrants charged to the Polish quota, we have not this year received any visas from the control office in Warsaw. Only emigrants in preferred classes receive visas and in every instance a visa number has to be produced. For those born here, we already have received 62 visas which have been distributed over the first ten months."

"REFORM ADVOCATE" OBJECTS YESHIVA COLLEGE AS TREND TO SECTIONALISM Parochial Schools in New York Face Liquidation, Rabbi's Survey Shows "The Jewish community as a whole,

though there must be exceptions or else the Yeshivah College would never have gotten as far as it did even in have gotten as tar as it did even in the dedication of a part of its con-templated structure, is not in favor of parochial schools," states an editorial by Rabbi Gerson B. Levi, editor, in the "Reform Advocate" of Chicago. "The Jew in America to whom the public schools are open without let or hindrance sees the immense possibilities of the public school system. He has the feeling that if prejudices are in any measure to be worn down by education, he ought not to do anything that would weaken or cripple the public school system. There is an attitude of this mind that they must have who while the public schools must voluntarily tax themselves in addition, for the support of the secular schools that they have

set up and joined on to the church bodies. The expected tendency of such people is to fight to keep the taxation for public school purposes as low as they possibly can. It would be interesting to make a survey of the taxes levied for school purposes in communities where the parochial system is not in vogue and compare them with those levied in communities where the parochial system is urged and where it has been established. And we are of a mind in advance of any such survey to risk the statement that the public schools are treated in very niggardly fashion in the latter communities. Jews do not feel that they ought to do anything to endanger the public school system.
"And then we have a feeling that some subjects can be taught as well in the public schools as they can be taught in the parochial schools. And surely we have the feeling that it is

useless to argue that certain subjects can be taught better in the parochial schools just because of the atmosphere around the whole institution. Chemistry is dependent on the adequacy of the teaching staff and on the completeness of laboratory equipment and not on the fact that the teachers wear little caps on their heads while they are ex-plaining chemical formulae. Where the difference might be is that under the parochial system of secular studies it might happen that certain subjects will not be taught at all, or if taught, will be taught only by halves. It is conceivable that in a Catholic parochial school, the philosophies that came after the scholastic period-or what modern philosophy calls the scholastic period-will not be taught at all. That section of philosophic thinking will be dealt with as if it were non-existent. Jews cannot think that way at all. Jews will study modern philosophy though they may have their choice of

REVISIONISTS CLAIM ZIONIST **DECISION ON JEWISH AGENCY** AGREEMENT ILLEGAL

Will Await Congress Action Before Decision to Withdraw from Z. O. (Jewish Telegraphic Agency)

Vienna, Dec. 28-The assertion that the decision by the Zionist General Council ratifying the Weizmann-Marshall agreement on the extension of the Jewish Agency was illegal, was made by Richard Lichtheim, former member of the Zionist Executive, now a Revisionist leader, in a report on the Jewish Agency question submitted to the conference today.

The Jewish Agency pact requires the introduction of a change into the text of the Palestine Mandate, trans-ferring the rights of the Zionist Organization to the extended Jewish Agency. This can be decided upon only by the Zionist Congress and not by the Actions Committee. The Jewish Agency pact also contains this evil that it perpetuates the division of Jews into Zionists and non-Zionists. This will ultimately destroy the Zionist Organization, since what reason will there be for a Jew to join the Zionist Organization if it is sufficient to be sympathetically inclined toward the rebuilding of Palestine while remaining a non-Zionist? Mr. Lichtheim asked

As to the course of action to be decided upon by the Zionist-Revisionists, the speaker said the Revisionists should wait until the Zionist Congress says its last word on the Jewish Agency pact. Then they will decide as to whether they are to remain within the Organization or withdraw. Until the Congress, however, the League of Zionist-Revisionists will conduct an extensive campaign, pointing out the dangers to the Zionist movement from the Jewish Agency extension plan, he declared.

Anglo-Jewish Board of Deputies Urges Rabbinical Action on Divorce Problems

By Our London Correspondent London, Dec. 16-The convening of an authoritative conference of Orthodox Rabbis to solve the problem of divorce and other problems affecting the position of Jewish women was urged by the Board of Jewish Deputies in a resolution adopted at its meeting here today, under the chairmanship of O. E. d'Avigdor Goldsmid, president.

After a discussion on the question of "Gett," the Board adopted the following motion: "That this Board is of the opinion that, having regard to the divorce and other problems affecting the position of Jewish women, the London Beth Din should seriously consider the desirability of taking steps to secure the convening of an authoritative Conference of Orthodox Rabbis."

On the occasion of the change of Government in Roumania there has been a friendly correspondence between the Joint Foreign Committee and leading members of the new Cabinet, says the report of the Joint Foreign Com-mittee by the Board, M. Madgearu, on behalf of his colleagues, it states, has assured the Committee of its intention to realize the most harmonious relations with all the minorities in the

kingdom. The Committee is still in correspondence with the Roumanian Government! on the subject of the decree relating to aliens which was promulgated in Oc-

Further correspondence has passed between the Committee on the one hand and the Foreign Office and the Secretary-General of the League of Nations on the other, relative to the restricted right of petition to the Council of the League enjoyed by national as distinct from international organizations. So far, the correspondence has proved hopeful. On November 15th, Sir Eric Drummond informed the Committee that while under the existing rules the petition of the Committee could not be presented to the Council, he was of the opinion that it raised points which could be usefully submitted to the Council, and he added, "this I intend to do at its forthcoming session." communications received from His Majesty's Government on the same subject are equally encouraging.

The alleged persecution of Judaism in Russia which has been almost uninterruptedly before the Committee during the last three years was further considered. A confidential correspondence was laid before the Committee in which the best means of coming to the assistance of the Russian Iews was discussed. The question is full of difficulties and it is not yet possible for the Committee to make any definite statement as to the exact situation in Russia or the most appropriate remedial measures.

B'NAI BRITH ORPHANAGE IN ERIE RECEIVES BEQUEST OF \$50,000

Lodges Throughout Country Report Activities to Cincinnati (Yewish Daily Bulletin)

Cincinnati, Dec. 28-A bequest of \$50,000 for the B'nai Brith Orphanage and Home for Friendless Children at Erie, Pa., was contained in the will of Samuel M. Braunstein, who died in Atlantic City in November, a statement from the headquarters here of the Independent B'nai Brith announces. Braunstein's will disposed of charitable bequests amounting to \$375,000.

Facilities for Jewish education will be increased in Denver, Colorado, through the efforts of the B'nai Brith lodge there. A program has been plan-ned by the Committee on Jewish Education, which will cooperate with all Jewish agencies of that city to extend opportunities for Jewish education to all Jewish children.

The B'nai Brith lodge in Passaic, N. J., is directing activities toward the erection of a Tewish Community Center in that city, reports received at headquarters state. Meetings in con-nection with furthering the plan for the Center are being held at the lodge meetings rooms there and the B'nai Brith is working with other organizations for bringing the plans to a successful conclusion.

Under the auspices of Gilead Lodge, Wisconsin Milwaukee, the Foundation took the affirmative side in roundation cook the anirmative side in a debate with the Milwaukee Menorah Society on the question: "Prejudice Against the Jew in the United States is Inevitable." When the same Hillel team debated this subject recently in Chicago, 1500 persons attended.

Of the 15 songs in this year's University of Michigan Opera, "Rainbow's End," cleven were written by Edward M. Heyman, former chairman of the Dramatics Committee at the Michigan Hillel Foundation. The pro-duction toured New York, Chicago, Cleveland and Detroit.

BUCHAREST UNIVERSITY TO EXPEL ANTI-SEMITIC STUDENT

Dr. Wolfgang to tited the reasons for the acceptance by the Zionists of the "Seventh Dominion" idea. He advised, however, to postpone definite action until "official English proposals are forth-coming." In the meantime, he stated, Revisionists would do well to propagate the idea by the establishment of "Seventh Dominion Leagues."

In the discussion which developed on this point, it was brought out that the concensus of opinion was against the adoption of a resolution accepting the "Seventh Dominion" policy. It appeared likely that the conference will adopt a resolution stating merely that the "Seventh Dominion" idea is in no conflict with the idea of a Jewish state in Palestine and will welcome the ef-forts of Col. Wedgwood.

That the Zionist Revisionists have established in London a Society for the Protection of Jewish Rights in Palestine was announced by Mr. Jabotinsky in his political report. A similar soci-ety under the name Sechutenu (our right) is in existence in Jerusalem, he

stated. The reasons why anti-Zionist tendencies grow in the Palestine administration lie in the circumstance that Palestine Jewry offers no resistance. Fifty per cent of the infringements of Jewish rights by the Palestine government could be improved by legal action brought in the English courts, he stated. It is highly necessary to provide Palestine Jewry with the political facilities to defend its rights, he declared. After all, the Zionism of the Diaspora is merely moral, while Palestine Jewry suffers physically. The influence of the Zionist Executive is nil, and often it is a negative influence, since the Executive, he asserted, has abandoned in principle the doctrine of fighting for rights. Revisionism finds it incumbent upon itself to complete what the Zionist Executive fails to do. The recent incidents at the Wailing Wall resulted in the issuance of another unfortunate White Paper, which, it is feared, will lead to new trouble.

on causes that all are willing to attend to. The cause of Jewish education in this country is neglected enough. The amount of money for the support of congregations and schools is little enough. We ought to be jealous about the using of the money and not spend any of it for purposes that would be taken care of without our particular section of the Jewish community," the editorial states.

The assertion that all Jewish parochial schools in Greater New York, called the "small yeshivas," face liquidation because of insufficient financial support, is made by Rabbi Reuben Livovitz, in an appeal he published in the "Jewish Morning Journal."

Rabbi Livovitz states that after a survey made by him, he learned that all parochial schools are in great financial difficulties and that there is no "real hope for a remedy." The institutions are being kept up by the sacri-fices of the principals and teaching staff who continue their work without receiving their salaries for ten and twelve weeks at a stretch.

Rabbi Livovitz appeals to the Union of Orthodox Rabbis of the United States and Canada to intervene in this matter by creating a body which would assume control of the parochial parochial schools and provide for their maintenance. Such a body should be a sort of "Central Relief Committee for parochial schools."

The difficulties in the situation are growing, due to the fact that the number of these parochial is multiplying, due to the friction which frequently develops in the boards, leading to the establishment of new and competing institutions, Rabbi Livovitz states.

Metropolitan critics were of the opinion that in his previous appearance Yehudi gave a greater per-formance, although his great talent is not minimized. This year he used a full size violin, while previously he had played on a specially constructed smaller instrument.
