WARNS OF DANGER IN HITLER AGITATION AMONG GERMAN PEASANTS German Newspaper Warns Hitler Pro-paganda Will Lead to Violence

(Jewish Telegraphic Agency) Berlin, Dec. 31-A warning that if not checked, the anti-Semitic Hitler agitation among German peasants will lead to acts of violence, was sounded today in an article published in the "Welt am Montag."

The writer reports that at a recent meeting of German peasants in Schleswig-Holstein, one of a series where sabotage in the payment of taxes is being advocated, the chairman, Ham-kens, exclaimed: "If we were in pos-session of weapons, we would drive the Jewish traitors out of the country. The audience responded to the chairman's appeal by shouts: "The peasant will rise, with God's grace, against the reign of the Jews."

The article asks the German authorities if they wish to wait until the fire is too large to be extinguished.

JERUSALEM MUNICIPALITY PROHIBITS BEGGING

Jerusalem, Dec. 31—Begging in the streets of the Holy City was prohibited in accordance with a proposal by the Palestine Government. It is still un-certain whether it will affect the beggars at the Western Wall of the Temple, commonly known as the Wailing Wall. The Kehillah of Jerusalem was opposed to the application of the ordinance to the beggars at the Wall.

FIGHT ON ANTI-SEMITISM ISSUE IN THE SOVIET ELECTION CAMPAIGN "Communists Fight Ignorance, Alco-holism and Anti-Semitism,"

Reads Poster

Moscow, Dec. 31-The fight on anti-Semitism has become a campaign issue in the Soviet elections which are now taking place in White Russian towns and villages.

"Communists, fight ignorance, alco-holism and anti-Semitism," reads a poster placarded in the streets of Bo-bruisk. The Communist press devotes much space to the anti-Semitism issue. Similar propaganda is broadcast in other White Russian towns.

Soviet leaders, newspaper editors and Jewish leaders in White Russia are in agreement that anti-Semitism in the district of Bobruisk is on the increase, especially in the factories. The leading source of the anti-Semitic propaganda is the glass factories, where, it is stated, it is being instigated by the Polish master workers, who have been intrenched in the industry for decades and who resent the entrance of Tews.

REVISIONISTS THREATEN BITTER CAMPAIGN AGAINST AGENCY EXTENSION PLAN Claim Actions Decision Illegal and Not Binding on Z. O.

(Jewish Telegraphic Agency)

Vienna, Dec. 31—Claiming that the decision of the Zionist General Council at its recent session in Berlin ratifying the Weizmann-Marshall agreement on the extension of the Jewish Agency is illegal and asserting that the Jewish Agency pact is an attack on the sovereignty of the Zionist Congress in relation to the Palestine work and the Zionist movement, the League of Zionist-Revisionists pledged itself to carry on a bitter campaign of opposition against the final consummation of the Jewish Agency extension plan.

These assertions and threats were contained in a series of resolutions adopted by the League's third annual conference which closed its sessions

Vladimir Jabotinsky, who in his closing address predicted a hard fight during the election of delegates to the forthcoming Zionist Congress, was carried out of the hall on the shoulders of his enthusiastic, youthful followers.

Jabotinsky was reelected president of the League, while Meer Grossman of London and Richard Lichtheim of Berlin were chosen vice-presidents.
To be or not to be, will be the problem faced by the Zionist movement, Jabotinsky stated, exclaiming: "You, Zionist brother, save your Zionism! Save the Zionist Congress. Guard the greatest of our national treasures!" (Continued on Page 4)

POLISH-JEWISH CO-OPERA-TIVE SOCIETIES MEET IN WARSAW CONFERENCE Express Gratitude for Aid Extended by American Jews

(Jewish Telegraphic Agency)

Warsaw, Dec. 31-Progress in the self-aid movement among Polish Jews was reported at the seventh annual convention of the Jewish cooperative societies in the Republic of Poland, which opened here Sunday night at the Nowosci Theatre.

Five hundred delegates, representing 533 cooperative banks, are attending. Ex-Senator Rosenstreich, who is presiding over the sessions, expressed the gratitude of Polish Jewry to American Jews for the aid given in the organization of the cooperative banks. The subsidy of one million dollars made available for the cooperative banks through the Joint-Ica Foundation has made it possible to develop the co-operative banks, which now have a total of \$6,000,000 at their disposal.

A congratulatory message was re-ceived from Dr. Bernard Kahn on behalf of the American Jewish Joint Distribution Committee: Messages were despatched by the convention to President Moscicki and Marshal Pilsudski. Deputy Isaac Gruenbaum, who addressed the delegates in behalf of the Club of Jewish Deputies, stated that a strongly developed Jewish cooperative movement is a powerful in-strument for maintaining the economic position of the Jewish population in the country.

Strife is expected to develop during the proceedings, as several groups are contending for supremacy in the ad-ministration. One hundred and twenty among the delegates are Zionists; fifty delegates come from Galicia.

KING RECEIVES NEW LATVIAN CONSUL FOR BULGARIA (Jewish Telegraphic Agency)

Riga, Dec. 31—The new Latvian Consul for Bulgaria, Mr. Klugman, was officially accepted by the Bulgarian Government and received by King Boris, according to word re-ceived here from Sofia.

On his way to Bulgaria, Mr. Klug-man was honored by the Latvian consulate in Berlin, which arranged a reception in his honor. A Latvian Jew, Mr. Brakeman, has

also been appointed Consul to Portugal.

N. Y. COMMUNITY TRUST ADMINISTERS FUNDS TOTALLING \$4,500,000 Seventeen Funds Include Memorial to Jacob Schiff

The New York Community Trust administers seventeen funds varying in size from \$1,000 to \$2,000,000, according to a summary of its resources published for the first time. Their total exceeds four and a quarter mil-lions. The income from approximately a million and a quarter is now being devoted to charitable purposes; the proceeds from the remainder will be process from the remainder will be similarly applied at the expiration of "life uses" presently in force. In the Westchester Welfare Foundation, a division of The Community Trust, funds aggregating \$153,780 are in hand. The larger funds of the Trust in-

The larger funds of the Trust include a half-million dollar Memorial to the late Jacob H. Schiff established by his daughter and applied in furtherance of visiting nursing service, and a trust of \$500,000 founded by Mr. and a trust of \$500,000 founded by Mr. and Mrs. Felix M. Warburg, primarily for the benefit of the University of Jerusalem.

Twenty-five banks and trust companies are associated in the Community Trust as eligible custodians of its funds and a central Distribution Committee, containing members named by the Senior Judge of the Federal Circuit Court of Appeals and the Presidents of the Bar Association, Academy of Medicine, Chamber of Commerce and Brooklyn Institute of Arts and Sciences, supervises all disbursements of income. The Distribution Committee is empowered to amend the purposes for which any fund is employed in case originally designated objects should become impractical or obsolete.

LEOPOLD STERN, PIONEER JEWELER AND B'NAI BRITH, LEADER, DIES AT AGE OF 80

Was Active in Many Philanthropic Undertakings

Leopold Stern, founder of the firm Stern Brothers & Company, New York, one of the pioneer, commercial, diamond-cutting firms in this city and honorary vice-president of the Monte-fiore Hospital, died on Saturday at the age of eighty.

The funeral was held Monday morning from Temple Emanu-El. Burial was in the family mausoleum in Beth-El Cemetery. Dr. Samuel Schulman, rabbi of Temple Emanu-El, officiated. The honorary pallbearers were Chief Justice Benjamin M. Cardoza of the Gourt of Appeals; August Oppenheimer, Charles Straus, William N. Rosendale, S. G. Rosenbaum, Samuel Sridel, William Goldman, Otto Wormster and Harry Lar-

Mr. Stern was born in Monzingen, Germany, on April 19, 1848, where he received his education. He came to this country in 1863 and was followed the next year by other members of the family, who joined him in Philadelphia, where they were engaged in the manufacture of jewelry for eight years. In 1871 he came to New York City and, with his father, Nathan, and a brother, Isidor, opened the firm of Stern Brothers & Co.

The firm was at first devoted to the manufacture of jewelry, but at the death of his brother, Isidor, in 1907, Mr. Stern sold the manufacturing branch of the business, and since then the firm has been engaged in the importation and cutting of diamonds.

Mr. Stern was much interested in the work of the hospitals in New York. He was a director of the Montefiore Hospital for twenty-five years and was later made a vice-president. He also was a member of the board of trustees of Bellevue and Allied Hospitals for twenty-three years and a member of the board of the United Hospital Fund.

Mr. Stern was active in Republican politics and voted as a Republican elector for President McKinley and again for President Taft. At one time he was appointed as a member of the commission for the revision of the banking laws of the State of New York. He was a member of the Re-publican Club of New York for many

He was a member of the Bankers Club and a director of the Market and Fulton Bank and the Maiden Lane Savings Bank. He was president of the Savings Dails. He was president of the Manhattan Lodge of the Independent Order of B'nai B'rith and president of the Jewelers' Board of Trade for many

"He is therefore sending Mr. and Mrs. Holmes to Palestine and, in addition, has given to the Community Church a gift large enough to cover the services of a supply pastor during Mr. Holmes's absence."

N.Y.U. INTRODUCES COURSES ON RELIGIOUS EDUCATION

Beginning February 4, 1929, a department for religious education will be in-troduced in the School of Education of New York University. An announcement to this effect was made by Dr. John W. Withers, dean of the school. Samuel L. Hamilton, formerly of the New Jersey Council of Religious Edu-cation, will head the new department.

Five courses will be offered. The courses are: 1. Introduction to religious education; 2. Principles of reli-gious education; 3. Leadership in religious education; 5. Leadersnip in ren-gious education; 4. Organization and administration; 5. Determination of the curriculum in religious education.

In explaining the purposes of the new department, Dean Withers said: "The university has started this department in the belief that the next great forward movement of the churches is in the field of religious education. We believe that systematic education in religion is an urgent need of our country at this time. Our unparalleled advance in science and industry and in material growth, we think, must be matched by advance in the moral and spiritual character of the people. New York University wishes to help meet this great need."

WORKERS ORGANIZATION LAUNCHES \$300,000 DRIVE FOR PALESTINE SETTLERS

Palestine Is Open for New Immigration, Tel Aviv Mayor Reports With the unanmious consent of 586

With the unanmious consent of \$86 delegates, representing 34 states and 6 provinces in Canada, the National Jewish Workers Alliance, meeting in its fourth annual convention, pledged itself to raise the sum of \$300,000, in the course of the year 1929.

At a mass meeting and reception Sunday evening at the Manhattan Opera House, in honor of the Palestine Labor Delegation, bringing to a close the convention which opened on Saturday evening, the campaign was officially launched and the sum of \$75,000

raised. The organization which has one thousand affiliated groups, and has in the last seven years raised \$435,000 for use of Palestine workers, voted to constitute itself a permanent body, functioning between campaigns and to en-

roll a contributors' group of 30,000.

The convention voted to establish a Technical Institute in Palestine in memory of the late Max Pine.

The convention went on record as favoring greater immigration into Palestine. It stated its unequivocal opposition to land speculation and its belief in the principle of land ownership as exemplified by the Jewish National Fund. The recent clash between the right and left Labor Wings in Tel Aviv on the Yiddish-Hebrew, question, was criticized, the Convention declaring it cannot sanction physical means to settle questions of principle.

An optimistic report on present conditions in Palestine was brought by David Bloch, Mayor of Tel Aviv, and Israel Meriminsky. Secretary of the Palestine Labor Federation. Despite the economic crisis, declared Mayor Bloch, industry has been strengthened in Palestine. Palestine is open for new immigration, he stated, appealing to American workers for support.

Unemployment has virtually ceased in Palestine, said Mr. Meriminsky. Organized labor, he said, now counts 32,000 workers in its ranks. are made by Representative Albert
Johnson, of Washington, chairman of
the House Committee on Immigration

1924, in a statement which appears in

"No one acquainted with the fundamental truth of genetics as applied to humanity in eugenics can oppose the principle of immigration restrictions, Mr. Johnson says in opening his statement. "No one wants to see his country made the dumping ground for the weak and unfit of other peoples. I am now of the opinion that we are rapidly approaching the time when a suspension of immigration will be demanded. Exemption will be made only for the closest relatives. Should the national origins provision be put into effect the situation will be made more acute, and more groups in the United States will call for relatives.

"For instance, in Norway there are now standing in line waiting for visas 3,000 wives and children of alien hasbands who have entered the United States since 1924 under Norway's annual quotas. Proposals to restrict immigration from Mexico, South America and Canada cannot be made on the same basis. To restrict from Mexico on 2 per cent of the 1924 Mexican population in the United States will not fit in with the national origins plan. We need no labor except domestic servants, and we cannot hope to help the future of the United States with the arrival of a continuous line of servants of all degrees. The country wants more and more restrictions."

"The various elements of New York Jewry from which this year's campaign leaders have been recruited indicates the new attitude that has been adopted by American Jewry toward the work of rebuilding Palestine, as a result of the Non-Zionist Conference which was held in New York City in October. Differences, of opinion with regard to the necessity for reconstructing the land of Jewish origin and the land of the Jewish future, have been forgotten in a common desire to enrich Jewry's contribution to civilization.

"Orthodox, conservative and reform Jews are now uniting on a program of rebuilding work in Palestine which is destined to do more in Palestine within the next few years than the very great achievements that were recorded

there during the last decade.

A special conference on Palestine to be attended by rabbis and laymen of New York City's Reform congregations, will be held at the Hotel Ambassador, New York, on Sunday afternoon, January 13, according to an invitation issued by Judge Rosalsky.

BULGARIA MAKES GRANT FOR QUAKE VICTIMS (Jewish Telegraphic Agency)

Philippopolis, Dec. 31—A grant of half a million levas was made by the Reconstruction Commission to the Revish Schools Council of Philippopolis. The funds were allotted for repairs of the Jewish schools which surfered damage in the earthquake which rocked Bulgaria on April 18, 1928.

Threatening letters have been received by a number of Jewish merchants here. The letters warn the merchants to remove immediately all Jewish signs outside their shops. An investigation has been promised by the police authorities.

The resolution adopted by the conference with regard to the Jewish Agency pact declares that the decis-ion of the Zionist General Council ratifying it was "illegal" and contrary to the decision of the Zionist Congress. All further steps which will be taken by the Zionist Executive toward the realization of the Jewish Agenry ex-tension will therefore be illegal and not binding for the Zionist Organization, the resolution states, adding that the Revisionists will undertake an extensive campaign to prevent the consummation of the Jewish Agency plan. In case the Zionist Congress will finally ratify the plan, the Revisionists will continue their fight for "the restoration of the sovereignty of the Zionist Congress, which is the only body having the function of the Jewish

Agency."
The Saturday night session of the conference was held behind closed doors, as a discussion on the differences within the League of Zionist-Revisionists was in progress. It is understood that the division is principally centered around the conflict between Vladimir Jabotinsky and Meer Grossman as to the principles and tactics of the Revisionist party. No vote was taken on this question, as a com-mittee of five was charged with set-tling the differences temporarily. The result of the compromise was that the Palestine branch of the League of Zionist-Revisionists was granted a limited autonomy and that the slogan demanding independent political rep-resentation for Palestine Jews was for the present maintained.

A resolution was also adopted with regard to Col. Josiah Wedgwood's Seventh Domnion idea. It states that the Seventh Dominion principle is in no conflict with the Revisionists' aim of a Jewish state in Palestine. The resolution does not commit the League to Col. Wedgwood's plan. It merely welcomes Col. Wedgwood's efforts and states that they are the best basis for an undertsanding.

Another resolution adopted deals with the capital and labor question in Palestine. Arbitration of labor disputes by national organizations is declared to be of prime importance during the state building period.

Acceptance of plans for the new eight-story department store for Abraham & Straus, to be erected on the present site in Brooklyn, at an estimated cost of \$7,000,000, has been announced by E. C. Blum, First Vice-President.

(Continued from Page 2) \$1,000 in the custody of the United States Mortgage and Trust Company on February 4, 1924. In June and January of each subsequent year, the net income of this fund, in accordance with the wish of its founder, has been transmitted to the Principal of Public School No. 9 for the making of scholastic awards in the name of Teresa E. Bernholz.

The sum of \$500,000 was entrusted to the United States Mortgage and Trust Company, as Trustee for the Community Trust, on November 6, 1924, by Mrs. Frieda Schiff Warburg in memory of her father, the late Jacob H. Schiff. "It is the desire of the founder," the trust agreement states, "that the income shall at all times be used in some manner for the relief of individual distress" and, more specifi-cally, "for the support and mainten-ance of the Nursing Service of the Henry Street Settlement." The Dis-tribution Committee has carried out

this statement of purpose.

Mr. and Mrs. Felix M. Warburg, as a memorial to the parents of Mr. Warburg, established a fund of \$500,000 on September 24, 1925, in the custody of the United States Mortgage and Trust Company, for administration through the Community Trust. The preferred beneficiary designated by the trust agreement is the University of Jerusalem.
