BUDAPEST CITY COUNCIL LENDS SUPPORT TO ANTI-SEMITIC ORGANIZATIONS Stringent Press Law Urged in Hun.

Budapest, Feb. 18—The city government of the Hungarian capital is lending direct support to anti-Semitic organizations in the country, it was
charged by members of the Opposition
party at a stormy session of the City
Council Saturday.

The charge was made and confirmed by members of the Christian Socialist Party that the administration of the Budapest street cars officially collects from its employees membership dues for the Awakening Magyars, anti-Semitic groups.

The members of the Christian Socialist Party stated that this practice will be continued.

Simultaneously, a heated fight is going on in Parliament over a bill which, if passed, will silence all critics of the government in power. A bill introduced concerning new press regulations would make unlawful the publication by-the newspapers of even parliamentreports which may be considered "improper." This refers, in particular to the reproduction of remarks made by members of parliament during debates.

KOLENBERG RELEASED FROM MOSCOW JAIL

Moscow, Feb. 18—Kolenberg, the Jewish young man who slew General Slaschoff in revenge for his brother's death
at the hands of Slaschoff's troops, has
just been released from prison on ball,
it became known here.

According to rumor, which is believed to be correct but could not be definitely verified, Kolenerg will not be brought to trial for his act.

It is stated that the government is marrassed and fears that the trial of Kolenberg might be a repetition of the Schwartzbard case and bring out the facts of General Slaschoff's condoning anti-Jewish massacres by his troops while a commander in the White Army. This might place the Soviet government, which accepted General Slaschoff following his return to Russia, in an unpleasant situation.

SENTENCED FOR HOLDING COMMUNIST MEETING

London, Feb. 18—British Jewry in as far as it is represented in the Board of Jewish Deputies at its monthly session Sunday went on record as favoring speedy action for the organization of the extended Jewish Agency for Palestine, which is to be created under the agreement between Dr. Chaim Weizmann and Louis Marshall.

The Board decided to take upon itself the initiative of convening a representative Anglo-Jewish conference where arrangements will be completed for the appointment of representatives of the Anglo-Jewish community on the governing body to the community on the governing body to the community on the governing body to the governing the Board of Jewish Deputies will be appointed to be the Board's spokesmen at the forthcoming conference, Mr. D'Avigor Goldsmid, chairman of the Board's stated.

The Board adopted the recommendation of its Law and Parliamentary Committee concerning the Jewish Agency, acting on the invitation of the Zionist Executive, to take the initiative in convening the conference, in order to demonstrate the desire of the Anglo-Jewish community the British Anglo-Jewish community the British Anglo-Jewish communities in catering the communities in entering the extended Jewish Agency.

During the discussion an opinion was expressed that the contemplated conference be postponed until after the Zionist Congress this Summer will have finally ratified the plan for the extension of the Agency. It was further

Overlooks Leap Year in the Jewish Calendar

(Jewish Telegraphic Agency)

London, Feb. 18—On March 31, for the first time in the past 347 years, Easter Sunday will be celebrated by all Christians during the Jewish Pass-over, because the Synod of the Orthodox Church, assembled at Bucharest, has decided to advance by 14 days their Easter date, bringing it to the Gregorian Calendar's Easter Sunday, states the International Fixed Calendar League.

That decision, it says, heals the cleavage made during the Gregorian Reform in 1582, when the Orthodox Churches declined to leave out the Gregorian decreed 10 days, for the accumulation of 0 excessive Leap Days caused by Julius Caesar's faulty reckoning of the year's length he decreed as 365½ days, when it was only 365.24 days long. The difference of a one-hundredth parameter of the four more days making the total of the four more days making the total of the days, which the Orthodox Churches are leaving out of their Calendar from Easter 1929.

CO-OPERATE WITH LEAGUE COMMITTEE TO AID REFUGEES

Geneva, Feb. 18-Several Jewish organizations were represented at the session of the advisory committee of the League's High Commissioner on refugee problems which met Friday in the headquarters of the International Labor Office.

The advisory committee elected six experts to represent it at the forthcoming governmental conference to deal with refugee problems. Lucien Wolf, secretary of the Joint Foreign Com-mittee of the Anglo-Jewish Associa-tion and the Board of Jewish Deputies, was one of the six chosen.

COMMENTS ON FATE OF LEON TROTSKY

Says Jewish Socialists Do Not Regret Local Soviets Supplying Seeds to the Commenting on Leon Trotsky's exile

to Turkey, the "Jewish Daily Forward," Socialist Jewish organ, terms the event "the greatest irony of fate imaginable."

"Trotsky, the former leader of the Communist world revolution, is now compelled to seek a haven of refuge in a capitalistic country under the protection of the capitalist law. The fact that during his period of power he did not succeed in transforming the other countries into a Communist 'paradise' is now fortunate for him, for where could he have gone if the Communists would have reigned not only in Russia but also in other countries?

The paper continues: "We are the last to regret Trotsky's end. We know very well that he, perhaps more than anybody else outside of Lenin, is responsible for Russia's miseries and for rivers of innocent blood which were shed there. We know, too, that if sned there. We know, too, that it Trotsky would have had an oppor-tunity to carry out his present pro-gram, it would have been a new misfortune both for Russia and the world at large. Trotsky has now fallen a victim of the system which he himself created. He fell into the grave he dug

"His political career is now probably ended. The only thing he can accomplish abroad is to help increase the splits in the Communist groups abroad and to demonstrate to the world through his own person the moral bankruptcy of the Communist dictatorship which has declared the chief hero of the Bolshevik revolution a traitor and has driven him into exile just because he demands freedom of opinion merely for the members of the Com-munist party," the paper declares.

RUSSIAN JEWISH COLONIES PREPARE FOR EXPANSION IN SPRING SEASON

(Jewish Telegraphic Agency)

Moscow, Feb. 18-Preparations for the spring seeding are being made in the Jewish colonies. These preparations are progressing well, according to reports received by the Agrojoint, the Ort and the Ica. The local Soviets are supplying seeds to the colonists.

At Kalinindorf the seeding area is being extended this year from 13,000 to 19,500 hectares. The colonists will get 36 tractors. In the Krivoy Rog region, representatives of 1,500 new colonists' families are expected. Forty-nine tractors will be supplied them. Because of the shortage of seeds, an order has been issued that settlers arriving after March 15 will not receive seeds.

The Ort colonies in the Odessa region are preparing 110 hectares for vine cultivation. The Ort colonies report that only 12% of those who came have left the settlements.

JOINT FOREIGN COMMITTEE STATES VIEWS ON STATUS OF RUSSIAN JEWRY

Finds Soviet Laws, Though Intending No Discrimination, Affect Jews Most (Jewish Telegraphic Agency)

London, Feb. 18-The Soviet laws in the fields of economics and religion. though they are not intended to bring about discrimination against the Jewish population in the Union of Socialist Soviet Republics, affect Russian Jewry worse than any other group of the

This is the burden of the report submitted by the Joint Foreign Committee, the body representing the Anglo-Jewish Association and the Board of Jewish Deputies in matters pertaining to the defense of Jewish rights, at the monthly session Sunday of the Board of Jewish Deputies.

The allegation that the civil, political and religious rights of the Jews under the Soviet regime are disadvantageous compared with that of other religions, led the Committee to send a mission to Russia in order to obtain information and relief, the report states. Although the inquiry shows that the law operating in Soviet Russia does not recognize any distinction between races and creeds, nevertheless, it is a fact that these laws operate more oppressively against the Jews than against any other group. This is due to the fact that the Jews belong mostly to an economically disadvantageous class under the Soviet rule. Under the gen-eral religious restrictions, the law affords certain possibility for religious education, but the impoverishment of the Jewish communities and the atheistic fanaticism of the Tewish section of the Communist party, the Yevsektzia, render this facility useless to the Jews, the Joint Foreign Committee de-

The recently appearing anti-Semitism is a serious phenomenon, the report goes on, particularly among the Communist working classes. Although the government is sternly repressing this agitation, its presence is already effective, since it makes it difficult for Jewish artisans to retain employment in national factories. Foreign intervention would be futile and might only aggravate the sufferings of the Jews.

The only possibility for help consists in strengthening and extending the remedial agencies already established. These agencies concentrate at present on Jewish agricultural work, whereas it is necessary also to increase the support of the communal institutions such as hospitals, kitchens, day

Washington Acts to Honor Memory of Oscar S. Straus

By Our Washington Correspondent

Washington, Feb. 16-During the course of the hearing in the House Library Committee, when a resolution was favorably reported authorizing the erection of a memorial in Washington to the late Oscar S. Straus, it was suggested that the monument to Mr. Straus take the form of a fountain instead of a statue, in view of the fact that statues already predominate in Washington. Congressman Celler assured the Committee that this suggestion would be taken into consideration.

Congressman Celler, in the course of his remarks, reminded the Committee that Oscar Straus "was born out of this country and therefore was a citizen by choice," and added further: "We hear much in connection with immigration and immigrants. Here is a man who embraced citizenship in our land and reached the highest pinnacle of power. Surely, his history, his efforts and strivings, his humanitarian service and his great patriotism would be a great inspiration to those who come from foreign parts and I am sure would be a beacon light that would guide and encourage those who sought refuge or, for other reasons than religion or politics, came to the United States."

Mr. Celler also read from a statement made by President Roosevelt, an acknowledgment that "Mr. Straus was one of the two or three men who first set my mind, after I came in as President. in the direction of doing everything that could be done for the Hague Tribunal, as that seemed to be the best way to turn for arbitration."

At one point during the hearing, Congressman Gilbert of Kentucky asked Congressman Celler: "What part did

Mr. Straus play in the great Jewish movement 'Back to Palestine'?"

Mr. Celler replied: "Mr. Straus died before the idea of Palestine as a homeland for the Jews had reached a real momentum. That movement had not reached the strength it now possesses. Mr. Straus, I believe-and it is only my personal opinion gathered from his writings and works-had not reached a conclusion that such a movement was the proper step for Jews to take. I do not believe he thought the Jews should return to Palestine in the mode and manner and fashion that the Balfour Declaration prescribes. I would not want to vouchsafe any opinion, directly or indirectly or remotely, as to what Mr. Straus's attitude on that problem would

olent attitude toward the Palestinian movement; but he helped in an immeasurable degree the plight of his coreligionists the world over. The report of the Library Committee,

HOUSE PASSES JOHNSON DEPORTATION BILL; NOW GOES TO THE SENATE

Defeat Sabath and La Guardia Amendments to Bill

(Tewish Daily Bulletin)

Washington, Feb. 18-The House of Representatives late Saturday passed the Johnson Deportation bill, without a record vote, after defeating a motion of Congressman La Guardia to recommit the bill to the House Immigration Committee. A Committee amendment to the bill was adopted for the deportation of any alien who is convicted of selling or transporting intoxicating liquor and sentenced to imprisonment therefor for a term of one year or a number of lesser terms aggregating a total of one year or more. Another amendment was previously adopted making gunmen and bomb carriers deportable.

The debate preceding the vote lasted about an hour and a half, consideration of the bill having been resumed where it had been left off on Friday. Congressman Sabath continued his fight to amend various alleged defective and objectionable features of the bill, to which he called attention in the minority report which he filed several days ago. The effort of La Guardia to amend the bill so as to make only those aliens deportable who are convicted of a crime involving moral turpitude was also defeated. Congressman La Guardia denounced what he termed some of the excessively stringent provisions of the bill.

This bill, as well as the Free bill for placing expert technicians in the preference quota class and the Box bill, excluding aliens as temporary visitors who seek to enter for employment, both of which were passed on Friday, now go to the Senate where early action on them is expected.

IS JEWISH OATH MINUS HAT VALID?—QUERY BEFORE RABBIS (Tewish Telegraphic Agency)

Warsaw, Feb. 18-Must a Jewish religious oath, rendered in court for legal purposes, be made by the individual with his hat on?

To answer this question a full session of the Warsaw Rabbinate was called. The matter, it was explained, has legal importance in view of a case which recently occurred in the War-saw courts. A Jew who appeared as a witness in taking oath refused to wear his hat. The court was in doubt whether a Jewish religious oath, made by the person with his hat off, is valid. The President of the Peace Court directed an inquiry to the Warsaw Rabbinate.

in its praise of Straus. It read as follows:

"Oscar S. Straus was a statesman, diplomat, adviser of Presidents, champion of industrial harmony, advocate for universal peace. He had the distinction of serving under four administrations. He was minister to Turkey under Presidents Cleveland and McKinley, Secretary of Commerce and Labor under President Rosevetl, and ambassador to Turkey under President Taft. "He was a 'citizen by choice,' having

he was a citizen by choice, having been born in Bavaria, December 23, 1850. He was brought by his father, Lazarus, to America two years later and the family settled in Talbotton, Ga, subsequently moving to Columbus, Ga.

"The boy, Oscar, received his educa-

"The boy. Oscar, received his education at Collinsworth Institute, Georgia,
and afterwards graduated from Columbia College and Columbia Law School.
His started or the columbia Law School
His started or the columbia Law School
at the suggestion of Henry Ward
Beecher that President Cleveland appointed him as minister to Turkey. As
such he distinguished himself by his
vigorous protection of Robert College
and of mission schools in Turkey,
Egypt and Syria.

"In the course of his second mission to Turkey he was enabled, through his influence with the Sultan, to prevent an insurrection of the Mohammedans in the Philippine Islands, thus saving the United States at least 20,000 soldiers in the field, and much loss of life. "In 1902, President Roosevelt ap-

"In 1902, President Roosevelt appointed him as a member of the Permanent Court of Arbitration at the Hague, to which post he was reappointed in 1908 by Mr. Roosevelt and in 1912 and 1920 by President Wilson.

"He was mainly instrumental in our breaking diplomatic relations with Russit because of her outrageous treatment of our citizens and proscription of them by reason of religion. No man has contributed more than he to American humanitarian diplomacy.

"Similarly, he influenced the drafting and the sending of the famous Hay note to the powers signatory to the treaty of Berlin in September of 1902 concerning barbarous treatment of religious minorities in Koumania, and thereby made Roumania realize the indignation and resentment of the civilized world at the wretched conditions prevailing in that country, conditions now, happily removed.

"Straus rendered yeoman service in the promotion of industrial peace as a member of the National Civic Federation and as its vice president and furthermore as chairman of a New York Public Service Commission he frequently adjusted labor difficulties and prevented many important strikes.

During the discussion, it was emphasized that Mohammedans and Baptists enjoy more religious rights in Soviet Russia than the Jews. A suggestion was made to ask the Trade Union Con-

gress to intervene.

When a suggestion was made at the session that an appeal be issued to the Jewish community in England on behalf of Russian Jewry, the chairman emphasized that before an appeal could be issued, the Committee must be satisfied that the funds will reach the people intact, a matter which presents many practical difficulties. Political intervention is quite impossible and would only be harmful, he added.
