SALONICA JEWS TO PARTICIPATE IN GREEK SENATE ELECTIONS

Scrap Policy of Abstention as Protest Against Separate Electoral College

(Jewish Telegraphic Agency)

Salonica, Feb. 27-The policy of Jewish abstention from the elections to the Greek Senate as a protest against the segregration of the Jewish voters in a separate Jewish Electoral College has broken down and the Jewish population has decided to take an active part in the elections. M. Asher Mallah, President of the Greek Zionist Federation and a leading member of the Salonica Jewish Community, is nominated as the candidate of the Venizelos (Government) party. The Communist party has chosen the former Jewish Deputy Soulam as its candidate.

The elections to the Senate, the first in Greece since 1862, are fixed for March 3rd. The Jews of Salonica, voting in their Electoral College, will form a separate constituency, with the right

of electing one Senator.

The abstention movement was launched by the Jewish anti-Venizelists and the Communists. All the members of the Jewish Communal Council, how-ever, were opposed to abjention, fear-ing that it would be detimental to the interests of the Jews of Salonica, by repeating the experience of the elections of 1923, when the Jewish separate Elec-toral College was first created. Although the absention was almost complete, 25 votes cast in the Jewish Electoral College were sufficient to return to the Chamber four candidates who represented no organized body of opinion.

MOSLEMS DESTROY WALL ADJOINING WAILING WALL

(Jewish Telegraphic Agency) Jerusalem, Feb. 27-A part of the wall adjoining the Western Wall of the Temple, commonly known as the Wailing Wall, over which Moslems and Jews in Palestine were in conflict, was destroyed by Moslems vesterday The wall destroyed was at the left side of the Wailing Wall.

The Jewish community of Jerusalem lodged a protest with the authorities

against the action.

FIRE CAUSES DAMAGE TO JEWISH MERCHANTS

(Jewish Telegraphic Agency) Bucharest, Feb. 27-A fire which broke out at night in the center of the town Buhusi, caused much damage to a great number of Jewish merchants and property owners, it is reported in a

despatch to the "Dirdincarza."

Details have not yet been received, but it is estimated that the damage was very great. A wind incompeted the area affected by the fire and prevented efforts to extinguish it.

AGUDAH CLAIMS 16,205 PALESTINE JEWS FAVOR SEPARATE COMMUNITIES Vaad Leumi Says Figures Must Be

Examined (Jewish Telegraphic Agency)

Jerusalem, Feb. 27 - Uncertainty seems to prevail in regard to the number of Palestine Jews who, under the leadership of the ultra-Orthodox Agudath Israel, went on record as favoring separate Communities, indepen-dent of the Vaad Leumi, National Council of Palestine Jews, which is recognized under the Palestine Communities Ordinance as the official repre-sentative of Palestine Jewry.

The registration closed yesterday. The headquarters of the Jerusalem Agudath Israel informed the Jewish Telegraphic Agency correspondent that the original figure of 7,000 for the separatists was inaccurate and that 16,205 had indicated their approval of he Agudah program. According to the Agudah program. According to the Agudath Israel 10,917 Jews in Jeru-salem registered for separate commu-nities, 1,766 in Tiberias, 1,195 in Tel Aviv, 823 in Safed, 490 in Haifa and 533 in Petach Tikvah.

When informed of the contention of the Agudath Israel, the Vaad Leumi stated that these figures must be thoroughly examined, because they undoubtedly contain the names of many minors and absentees.

RUMOR BERNARD KAHN WILL BE DIRECTOR OF PALESTINE WORK UNDER AGENCY

Warsaw, Feb. 27-Dr. Bernard Kahn, European director of the American Jewish Joint Distribution Committee, arrived here from Berlin for a five

days stay. During his visit Dr. Kahn will inspect the Jewish institutions in Poland

which receive subsidies and support from the J. D. C. Following his return to Berlin, Dr. Kahn will leave for Palestine It is rumored here that his trip to Palestine is in connection with his possible appointment as director of the Pales, tine work under the Jewish Agency.

GERMAN ANTI-SEMITIC BANKER CONVICTED FOR FRAUD (Jewish Telegraphic Agency)

Berlin, Feb. 27-Willy Bruss, banker and member of the anti-Semitic Voelkische party, was sentenced today to one year imprisonment after he was found guilty of defrauding 20,000 de-positors in his bank.

The victims were mainly small traders and artisans who were induced to make deposits in his bank after he had launched a campaign propagating the doctrine that "German capital must be free from Jewish influence."

SEVENTH DOMINION LEAGUE, TO PROPAGATE IDEA, FORMED IN LONDON Commander Kenworthy Hopes U. S. Jews Will Assume Friendly

Attitude (Jewish Telegraphic Agency)

London, Feb. 27-Sir Martin Conway, Conservative member of the House of Commons, presided over a meeting held here last night to launch the Seventh Dominion idea aiming to create in Palestine such conditions faorable to the development of the Jewish National Home, so that after the expiration of the Mandate, the country will voluntarily decide to become a part of the British Empire as its Seventh Dominion.

Col. Josiah Wedgwood, the origina-tor of the movement, Lieutenant-Commander Kenworthy, Sir Robert Hamilton, Liberal M. P., and Joseph Cowen, Zionist, were among the speakers. Sir Martin Conway, as chairman, emphasized that the movement will not be hostile to the Arabs. The Seventh Dominion League will even expect

Arab support, he stated.

Other speakers emphasized that the creation of the Seventh Dominion in Palestine is not motivated by an im-perialistic idea. What is intended is merely that Palestine become a free and indpendent country under the protection of the British fleet.

Mr. Cowen drew attention to the difficulty which will be encountered by non-British Zionists who could not support the idea. Commander Ken-worthy in replying to this remark, expressed his belief that American Jewry, recognizing Great Britain as the Mandatory Power over Palestine, will take

a friendly attitude towards the means for achieving the Zionist aim.

YESHIVAS IN EASTERN EUROPE FACE LIQUIDATION RABBIS DECLARE

74 Academies Have 9,185 Students: American Support Discontinued Since January 1 (Jewish Telegraphic Agency)

Warsaw, Feb. 27—Seventy-four Yeshivas, Talmudic academies, with an enrollment of 9,185 students, in Congress Poland, Wohlynia and Polish Lithuania are threatened with liquidation, American support having been discontinued since January 1.

An appeal to rescue these institu-tions was made by the Warsaw Rabbinate in conjunction with Rabbis in other parts of the country, in a state-ment made at a Jewish press conference today. It was explained that until January 1, the American Jewish Central Relief Committee, through the Joint Distribution Committee, covered one-fourth of the budget of these in-stitutions. Due to the withdrawal of this support, the unusual cold and the general crisis in the country, the local support for the Yeshivas has dropped to its lowest point. The students

PALESTINE COMPANY SIGNS RE-INSURANCE TREATY WITH SWISS COMPANY Expect Period of Unusual Development as Result of New Agreement

(Tewish Telegraphic Agency) Jerusalem, Feb. 27-The Judea Insurance Company, Ltd., announced the signing of a re-insurance treaty between the Judea Insurance Company, Ltd. and the Swiss Reinsurance Company of Zurich, according to which the Judea is empowered to write larger insurance policies, which in turn will be reinsured by the Swiss Reinsurance Company.

According to the treaty, the Swiss Reinsurance Company agrees to invest in Palestine all reserves as well as premiums resulting from the additional sums in reinsurance, which the Judea Life Insurance Company writes in its new policies. "A period of unusual development may now be expected" pected," the announcement declared, since the Swiss Reinsurance Company, ranking as one of the world's largest companies, has by its recogni-tion of the sound status of the Judea Insurance Company, made it possible to take the larger risks which hitherto we have been unable to accept.'

WOMEN'S WORLD CONFERENCE TO REPRESENT 14 LANDS (Jewish Telegraphic Agency)

Berlin, Feb. 27-Fourteen countries will send representatives to the quinquennial convention of the World Congress of Jewish Women, according to acceptances which are being received here at the headquarters of the Juedischer Frauenbund, Congress of Jewish Women. Mrs. Alexander Ko-hut of New York, author of "My Portion," is president of the international organization and Madame Anita Mueller-Cohen of Vienna, secretary.

The convention, which will be in session June 4th and 5th in Hamburg. will have on its agenda matters relative to immigration, white slave traffic. woman in industry and commerce, Jewish religious and education questions, Jewish laws of marriage and divorce, and conflicts with civil law, how to counteract missionary activities. Mrs. Kohut, president of the World Congress of Jewish Women, will present to the sessions reports on women in the world of industry and com-merce and a survey of immigration legislation in various lands.

DEMANDS REMOVAL OF DISPARAGEMENT AGAINST JEWS IN NICAEA DECREE Director of International Fixed Cales. dar League Demands Justice for Jewi

(Jewish Telegraphic Agency) London, Feb. 27—"Remove injustice to the Jews," Moses B. Cotsworth, Di-rector of the International Fixed Calendar League, urged in a letter to the Archbishop of Dublin on the Fixed

Easter question. "During a conference I was privileged to have today with Archbishos Germanos of Thysteira, who is the official spokesman for the Orthodox Churches," Mr. Cotsworth said "we discussed the question of the need for removing the now unjust aspersions cast upon present-day Jews through-out the world every Easter, through the unfortunate clause in the Decree the unfortunate clause in the Decret of Nicaea in 325 A. D., which reads: 'Should the fourteenth day of the moon, which is regarded as the "full moon" happen on a Sunday, Easter Sunday is deferred to the following Sunday—to avoid concurrence with the Jews and other heretics.'

"It is evident," he proceeds, "that no fixed date for Easter can be established until these words are withdrawn by separate Occumenical Councils of both the Holy See and the Orthodox Churches. While we may not know the full weight of the reasons why these words were emphasized in the Decree, it is very respectfully submitted that it is unjust to apply them to the now living Jews, who are not to blame for mistakes made by any ancestors 1,600 years ago."

SUNDAY CLOSING LAW INTRODUCED IN PARLIAMENT (Jewish Telegraphic Agency)

London, Feb. 27-No shop in England and Wales shall open on Sunday, except in a few trades which are to be exempt, and a few others in which exemption orders may be made, if a Bill which has been introduced into the House of Commons by Sir Frank San-derson (Conservative) with the support of Sir Herbert Nield, Sir Arthur Shirley Benn, and Colonel Freemantle (Conservative), Mr. Ammon (Labor), Mr. Robert Morrison (Co-operative), and Major Crawfurd (Liberal) is passed

The exempted trades are for the sale of intoxicants, refreshments for consumption on premises, motor-cycle and aircraft supplies, newspapers and periodicals, medicines. Trades for which exemption orders might be made are: Bakers and confectioners, butchers, chemists, dairymen, fishmongers, greengrocers, fruiterers and florists, grocers, sweetstuff sellers, tobacconists.

Most of these, if granted exemption.

would be allowed to open only from 8 a. m. to 10 a. m., but dairymen would have from 7.30 a. m. to 9.30 a. m., and sweet shops and tobacconists from 6 p. m. to 8 p. m., in addition to the two morning hours.

Trading elsewhere than in shops would be prohibited. The penalties provided are: 1st offense £1, 2nd offense £2, 3rd or subsequent offense £10.

PARTICIPATION IN AGENCY GIVES U. S. JEWRY WORLD LEADERSHIP, SOKOLOW SAYS Comments on 10th Anniversary of Hearing at Peace Conference

Arriving Wednesday on the steamer Aguitania, just ten years after he, to-gether with Dr. Chaim Weizmann, president of the World Zionist Orga-nization, and M. M. Ussischkin, president of the Jewish National Fund, appeared in a delegation before the Peace Conference at Versailles sucsuccessfully to plead the claim of the Jewish people to Palestine, Nahum So-kolow, chairman of the World Zionist Executive, declared that the most important development in Jewish history in the past decade has been the success of Zionism. Mr. Sokolow, who is known as the

historian of the Zionist movement, pointed to the growing strength of the Zionist organization, and to the achievements in Palestine during the last ten years. Referring to the Jewish Agency, Mr. Sokolow said that by its action in being the first to endorse this idea, American Jewry had taken the leadership in world Jewish affairs.

"Heretofore, American Jewry has furnished the money for various Jewish enterprises abroad. But now the lews of America have definitely established themselves in a position of leadership for world Jewry, by their action in being the first to sponsor the idea of joint action by Zionists and non-Zionists in the rebuilding of Palestine. Great credit is due to Mr. Louis Marshall and his associates for the part they have played in enlisting the interest of the non-Zionists for the most important enterprise that has engaged (Continued on Page 4)

The Agency Discussion in the English Board of Deputies

By Our London Correspondent

London, Feb. 17-The Board of Deputies of British Jews, at its meeting here this morning, accepted nem con, in accordance with the recommendation of its Law and Parliamentary Committee, the invitation of the Zionist Executive to take the initiative in convening a representative Anglo-Jewish Conference to demonstrate the desire of the Anglo-Tewish Community to play its part in giving effect to the British Mandate to Palestine, and to associate it-self with other important Jewish communities in entering the Jewish Agency, and to make arrangements for the appointment of the Anglo-Jewish Com-munity on the Governing body of the Agency. The President, Vice-Presidents and Treasurer were empowered to make all arrangements for the Conference.

In the course of the discussion, Mr. Herwald asked whether the Conference would elect the delegates to the Agency or whether the Boaard would elect the delegates.

O. E. d'Avigdor Goldsmid, the President of the Boaard, replied: "As I see it, the object is twofold: 1. To show the world at large that the whole of the Anglo-Jewish Community is united in its desire to take part in the Agency, and 2. to settle which body or bodies are to appoint the English, that is the Anglo-Jewish representatives, on the Agency. The Conference would, I believe, be representative of every shade of opinion in the country, and one of its functions would be to fix on whom the responsibility should lie for electing the members of the Agency. That is the position as I see it."

Morris Meyer pointed out that it was not for the Board to decide whether the Agency should be formed or not formed. If the Agency is formed, he said, the point is whether the Anglo-Jewish Community is to be represented or not. On that there could not be two opinions. It was the duty of Anglo-Jewry to be represented.

Percy Cohen said that some time ago, the Board was promised full informa-tion as to what the Jewish Agency was. What was its function? He wanted to ask for information as to what the Agency was going to do and how it was to be composed.

H. A. Goodman, Secretary of the Political Executive of the Agudath Israel World Organization, said that as the resolution now stood, it was perfectly harmless. There could be no objection to convening a Conference. But information as to the constitution of the Jewish Agency was necessary be-fore they could decide whether they were justified in convening a represent-ative Conference at the invitation of the Zionist Organization.

HOUSE AND SENATE CON-FEREES REACH AGREEMENT ON LEGALIZATION BILL

Yield to Johnson Opposition; Extend Privilege Only to Entrants Prior to July 1, 1921

(Tewish Daily Bulletin)

Washington, Feb. 27-The House and Senate conferces on the Copeland Naturalization Bill met in final session late Tuesday and, in order to break the deadlock caused by the refusal of Congressmen Johnson and Sabath to sign the previous conferees' agreement. the previous conterees agreement, voted to change the bill, legalizing the status of aliens who entered illegaly up to July 1, 1921, instead of up to July 1, 1924, as provided in the original Copeland bill passed by the Senate. Thus Congressman Johnson won the battle which he had been conducting against extending the date to 1924. Johnson threatened, in such an event, to lead a fight for defeat of the measure on the floor of the House. The Senate conferces therefore yielded, accepting the 1921 date rather than risk defeat of the bill altogether. It is understood that the agreement

as changed today eliminates the objectionable registration features, but this could not be confirmed. Congressman Johnson signed the agreement in its changed form and it is expected the bill as amended will be submitted to both the House and the Senate, becoming a law before the end of this week.

Congressman Samuel Dickstein announced that he expects to secure the privilege of the floor in the House and will outline his attitude toward the Copeland Bill as now changed by the conferees.

Leonard Stein, the Political Secretary to the Zionist Executive, who had on behalf of the Zionist Executive signed the letter to the Board containing the invitation, said: I want to make it quite clear that the step which the Board is being asked to take is not in any sense at all a new departure. As far back as six years ago, the matter was first raised in a communication from the Zionist Organization to the Board of Deputies. Article 4 of the Mandate imposes a duty on the Zionist Organization to co-operate with those who are willing to join with them. There is nothing unreasonable in the demand for information as to what is the Agency.

The function of the Agency is set out in Article 4 of the Mandate. As regards the details of the scheme and the exact constitutional machinery of the enlarged Jewish Agency and the distribution of seats, it is only reasonable and natural that the Zionist authorities should desire to consult the Tewish Communities concerned before it goes to the final vote at the Zionist Congress. That is why we propose to consult the Anglo-Jewish community and to ask it to demonstrate its belief in the desirability of the Jewish Agency in a formal and public manner

The Chairman, Mr. d'Avigdor Goldsmid, then said that the Executive had selected twelve persons to represent the Board on the Conference, if the Conference were to be held before the next meeting of the Board. If the Conference was due to take place after the March meeting, the Board would have the opportunity of discussing the suitability of the persons for the posts of representatives.

Mr. Ostrovsky pointed out that there were several Zionists among the twelve persons who had been selected to represent the Board at the Conference. There is no point, he said, in including Zionists, because the Zionists were already included.
