# THOUSANDS OF JEWISH WORKERS LOSE JOBS IN POLISH TEXTILE CENTER 60.000 Workers Hit by Reduction in Production

(Jewish Telegraphic Agency)

Lodz, Apr. 23-Several thousand Jewish textile workers are among the 60,000 workers who were given notice by their employers here.

Seventy per cent of the textile manufacturers resorted to this means of relieving the situation. It was declared that the large plants are preparing to reduce production to a three-day week, while the smaller plants will operate at most on a two-day basis and some will close down entirely. The crisis, it is declared, is due to the manufacturers' inability to dispose of their production in the internal market while the export abroad has also decreased.

The executive committee of the textile workers' union adopted a resolution today protesting against the re-duction and asked the government to

# JERUSALEM ELECTRIC CO. CON-CESSION TO JEWISH WORKERS INSUFFICIENT: PLAN BOYCOTT Future Work Distant and Operations Small; Large Undertakings Now Under Way

(Jewish Telegraphic Agency)

Jerusalem, Apr. 23-The promise of the Jerusalem Electric Company, a non-Jewish company, to employ Jewish labor in its future works, is considered insufficient by Kehillah leaders, following a protest they made that Tewish labor had not been utilized in the present undertaking of electrifying the city of Jerusalem. Upon investigation it was learned that the company will not start new works for several months and that the future undertakings will be small, while the chief works, in which Jews are not employed, are now under

The insistence of the Kehillah leaders that Jewish labor be employed immediately has been without effect. A protest campaign is now being planned. The Hebrew Teachers Association adopted a resolution to boycott electricity from the corporation if Jewish labor is not employed.

# DISTRICT ATTORNEY CONSIDERS STEPS TO PROHIBIT PASSOVER PASSION PLAY PRODUCTION IN NEW YORK

May Prosecute Producer and Theatre Owner If Passion Play Is Presented; Under Section 2074 of New York Penal Law, Personification of Deity Is Prohibited

As a result of the protest voiced by practice. Any violation of this section Louis Marshall against the contemporal ball be a misdemeanor. Any license Dough Addisinal against the contemplated presentation at the Hippodrome of the Freiburg Passion Play by Morris Gest in association with David Belasco, District Attorney J. H. Banbelasco, District Attorney J. H. Ban-ton has taken under consideration the question whether the presentation of the Passion Play is not contrary to the law of the state of New York, the "Jewish Daily Bulletin" learned from reliable sources.

Action on the part of the District Attorney would be based on Section 2074 of the Penal Law of the State of New York which prohibits the presentation of any play in which the "Deity which is worshiped, reverenced, adored or venerated by any religious denomination or sect or class of people pro-fessing a particular and well defined form of religious belief and practice" is personified by a living character.

The District Attorney will make clear his stand on the question in a few days. His decision, it was stated will most likely prevent the presenta-tion of the Freiburg Passion Play to which objections were raised.

Mr. Marshali, as president of the American Jewish Committee, based his objection on two reasons, first, because the presentation of the play may lead to a recrudescence of religious prejudice as was shown by experiences of the past and, secondly, because millions of Christians regard the presentation of such plays as a vulgarization of what they hold as sacred. Mr. Marshall voiced his particular objection to the fact that this presentation is sponsored by Jewish producers.

The violation of this section of the law carries with it a six months prison sentence and a \$500 fine.

Section 2074 of the Penal Law of the State of New York reads as follows:

"No person, association of persons, company or corporation shall in any public or private place, hall, theatre or auditorium, present or enact or suffer to be presented or enacted any exhibition, play, drama, tragedy, opera-comedy or performance in which there shall be a living character representing the Deity or known by any appellation which may by recognized standards of any particular form of religious worship or belief indicates the Deity or is reasonably referable alone to such Deity which is worshipped, reverenced.

## SOVIET CO-OPERATIVES OFFER KOSHER PASSOVER PRODUCTS FOR SALE ABROAD Sealed and Testified as Kosher by Russian Rabbis

Warsaw Apr. 23-An odd light on the anti-religious campaign now being conducted by the Jewish section of the Communist party in Soviet Russia in connection with the Passover festival was thrown by the commercial offer made by the Soviet cooperative representatives here to Jewish merchants and consumers' cooperatives of War-

Kosher goose fat especially prepared for Passover, is greatly in demand in this city on the eve of the festival, for use by Jewish families to be eaten with the matzoth and for preparation of the special dishes during the holiday.

The representative of the Gostorg, the Soviet commercial agency here, has offered for sale goose fat especially prepared for the Passover in accordance with the strict rules of the Orthodox code. The jars of fat, prepared by the Soviet cooperatives of Charkoff, Kiev and Berditcheft, bear the labels
"Kosher L'Pessach" (approved for
Passover). The seal of Rabbi Levi
Halevi Grossman, City of Kiev, is attached to each jar. Certificates of supervising rabbis attesting to the kosher preparation of the fats are also furnished. To make assurance doubly sure, the certificates of approval contain a

# GOVERNMENT INVITES JACOB LANDAU, J.T.A. MANAGING DI-RECTOR, TO VISIT ROUMANIA

Promises There Will Be No Recur-rence of 1927 Incident

(Jewish Telegraphic Agency)

Jerusalem, Apr. 23-An invitation to visit Roumania was extended to Jacob Landau, managing director of the Jewish Telegraphic Agency, who is now on a trip here. The invitation, signed by Gafenco, Secretary General of the Foreign Ministry, assured Mr. Landau that the Roumanian Government "will take necessary measures to facilitate your travel. Any incident is excluded."

The incident referred to occurred

May 10, 1927, when Mr. Landau, on his way back from Palestine, was held at the Roumanian port, Constanza, by the Roumanian authorities and was refused permission to enter the country, in repermission to enter the country, in re-venge for the Jewish Telegraphic Agency's having circulated throughout the world press the reports concerning the continuous anti-Jewish excesses in

Roumania.

Notwithstanding the fact that Mr. Landau had his passport properly vised by the Roumanian authorities, he was refused permission to land and was taken back to the steamer Marie, where he was held practically under arrest, guarded by two soldiers during the enday and through the night. After ng held, Mr. Landau's release was effected through the intervention of William C. Culbertson, then United States Ambassador at Bucharest.

The invitation, sent by telegram to Mr. Landau by the Secretary General of the Foreign Ministry, declared: "We shall be very content if you will kindly visit Roumania also. The Roumanian government will take the necessary measures to facilitate your travel. Any incident is excluded. We ask you to inform us of your arrival."

## DEWISH DAIL! BULLETIN JEWISH LABOR PARTIES IN POLAND PREPARE FOR MAY 1st DEMONSTRATION

Have Program Separate from Polish Labor Groups

(Jewish Telegraphic Agency) Warsaw, Apr. 23-Remembering the clashes which occurred during the May Ist demonstrations of 1928, resulting in many injuries, the Jewish labor parties of Poland have decided this year to observe May Day apart from the Polish labor parties.

labor parties.

It was during the joint demonstration of the Jewish labor parties and the Polish Socialist Party last year that the demonstrations turned into a wholesale attack on Jews. This year the Jewish parties have decided to limit their May

Day demonstrations to the Jewish quarter of Warsaw.

The police in the capital have taken extensive precautions for that day, which has become in recent years an eventful day. The authorities have undertaken raids on suspected organizations. Arrests were made among labor leaders, including many Jews. Rumor has it that the authorities will this year prohibit the holding of street demonstrations, but this report was denied. It was declared that only those organizations whose program is directed against the state will be prohibited from marching.

Warsaw, Apr. 23-Ionas Gruenbaum. 16, the youngest son of Deputy Isaac Gruenbaum, was arrested by the police on the charge of Communist activity. Young Jonas arrest followed the arrest of his older brother, Eliezer, who was similarly charged. In his diary, which was confiscated, there was an entry that Jonas was dismissed from school for Communist agitation.

# DECLARE MORE HILLEL

FOUNDATIONS NEEDED The need of establishing Hillel Foun-

dations at American universities to minister to the spiritual and cultural minister to the spiritual and cultural requirements of the Jewish student was emphasized by speakers at the dinner given Monday night by Assemblyman Maurice Bloch to members of the metropolitan zone of District No. 1, I.O.B.B., of which he is president.

Speakers asserted that the only way to keep the Jewish youth close to their faith, and the only way of preparing them for leadership of American Jewry is to extend to them an abundant knowledge of Jewish history and cul-ture. The Hillel Foundations present the most direct method of meeting this problem, speakers stated, and the establishment of additional Foundations was urged. There are now seven such centers throughout the country, with

two others to be opened in the Fall.

The Wider Scope Committee of the Order, which is responsible for the es-Order, which is responsible for the es-tablishment of these Foundations, is at present engaged in raising funds for this purpose and other phases of its cultural program. Louis Fabricant, treasurer of the Committee, announced the launching of the District's campaign the launching of the District's campaign outside of New York City, with a goal of \$72,000. The drive in the metropolitan zone will be launched in September, itz, and Louis W. Osterweis.

## ANGLO-JEWISH BOARD MOVES TO CHECK ANTI-SCHECHITA CAMPAIGN IN EUROPE

Will Join French and German Jews in Memorandum to Vienna Conference (Jewish Telegraphic Agency)

London, Apr. 23-The danger of an increased propaganda against schechita in European countries was reported at the monthly session of the Board of Jewish Deputies held here on Sunday, April 21. Anti-Semitic agitators are making every effort to utilize the forthcoming conference of the Societies for the Prevention of Cruelty to Animals, to be held in Vienna, to stir prejudice against the schechita.

The agitators intend to exhibit in various European countries a "faked" schechita film produced in 1913.

The Board decided to associate itself

with the memorandum which will be submitted to the Vienna conference submitted to the Vienna conference delegates by German Jewish bodies and by the Jewish Consistory of France.

#### 30 INJURED IN CLASH OF POLISH AND JEWISH STUDENTS (Jewish Telegraphic Agency)

Lemberg, Apr. 23—Thirty persons were injured in a free-for-all fight during which knives and revolvers were used and chairs were hurled in the air. The fight arose between Polish and Jewish residents who were gathered at the restaurant Pohulanka.

The gathering started as a friendly gesture when Jewish students of the so-called assimilationist group invited their Polish fellow-students to leave their own celebration on another floor of the restaurant and join the party of

Jewish students.

Toasts of friendship and brotherhood were made. Suddenly a dispute arose which developed into a fist fight lasting several hours. Several of the party received serious injuries and the restaurant was wrecked. It was not until the police arrived that order was restored and medical aid brought to the victims. What happened to bring about the abrupt cessation of amity is not distinctly known, but it was stated that it was over a "question of honor" that the war broke out. Who insulted whom was not cleared up.

Mosessohn, Joshua KantrowSENATE COMMITTEE REJECTS BILLS TO REPEAL OR POSTPONE NATIONAL ORIGINS CLAUSE Nye to Lead Fight for Action on

Senate Floor (Tewish Daily Bulletin)

Washington, Apr. 23-The Senate Immigration Committee by a vote of four to two today again rejected the bills of Senator Walsh of Massachu-setts and Senator Nye of North Dakota to repeal and postpone respec-tively the National Origins clause. In taking this action the committee reiterated its allegiance to the National Origins clause registered at the last ses-sion. Today's decision of the committee took the technical form of a vote to indefinitely postpone action on both bills which, from the practical stand-point has the same effect as an out-right rejection. Senator Walsh and Senator Nye were not surprised at the committee's action for its support of the National Origins plan and hostility against any effort to interfere with its going into effect was well known, but the procedure of prior action by the committee was a necessary parliamen-tary requirement before action could be taken by the Senate itself. Senator Nye, following the committee's action, today announced that he and Senator King of Utah, Democrat, will ask this afternoon that the committee be dis-charged from consideration of the bill in order that the Senate itself may consider and take action thereon. Senator Nye indicated he expects Senator Reed of Pennsylvania, leader of pro-National Origins forces to precipitate a filibuster against this reanticipated fight to a finish on this great controversial issue is about to begin in real earnest with the Senate floor as the first battleground. Lined up against Senator Reed and his folowers is President Hoover himself who has indicated in no uncertain terms his uncompromising opposition National Origins legislation. Senate's decision on the plan may prove the first test of President Hoover's uthority in Congress. Senator Nye, n addition to the bill for postponement, which was voted on today by committee, also had introduced yesteray a bill to repeal the clause differng somewhat in its terms from that of Senator Walsh. Senator Nye's bill s practically a duplicate of a measure stroduced some time ago by Senator hipstead providing for a new quota lan differing from both the National

## AFGHANISTAN HAS ELEMENT CLAIMING JEWISH DESCENT

British Colonial Minister Reports on Benei Israel Sect (Tewish Telegraphic Agency)

London, Apr. 23-The claim to Jewish descent is alive in the population of Afghanistan, is the revelation made in a despatch from Kabul to the London "Daily Telegraph" by Sir George MacMunn, English soldier and colonial officer

According to Sir George a part of

the Afghanistan population calls itself Benei Israel and claims descent from a grandson of King Saul, named Afghana, who was commander-in-chief of King Solomon's army. The belief is current there that the Afghanistan Benei Israel represent a remnant of the ten lost tribes of Israel. Although there is not the faintest proof in favor of their contention of Jewish origin, Sir George writes, their appearance or deorge writes, then appearance and some of their customs seem to support the claim. The biblical names, Moses, Abraham, Isaac and Jacob, are current among them. It is apparent, the writer concludes, that the Benei Israel came to Afghanistan in the seventh century of the Christian era and immediately adopted the Moslem faith.

The "Chicago Sentinel" in its current issue editorially lauds the stand taken by Louis Marshall on the Pas-sion Play production in New York, declaring

"Mr. Louis Marshall has again risen to the position of eminent leadership which he has long occupied in American Israel. A report was published recently that two Jewish producers, Messrs. David Belasco and Morris Gest, are making arrangements for bringing to this country the Oberam-mergau Passion Play. Upon hearing this news Mr. Marshall immediately lodged a protest with these two gentlemen, explaining to them the inadvisability of their proposed step. The Passion Play depicts the crucifixion of Jesus as it is related in the New Testament, and the harm which such a production is likely to do to American Jewry can be easily seen. The fact that two Jews are contemplating to bring this play to America reflects very little credit upon the good name of our people, to say the least. Originally it was rumored that Mr. Otto Kahn had something to do with this project but we are glad to state that this gentleman has disclaimed any connection with this undertaking. Now that Mr. Marshall has pointed out to Messrs. Gest and Belasco the untold harm which the Passion Play is bound to do to their own brethren we hope that these two theatre magnates will see the wisdom of cancelling the proposed engagement of the Oberammergau production."

ray than to send matzoth to the Jews of Soviet Russia, the Riga Committee for Providing Matzoth for Russian Jewry declares, in replying to the attacks made by the well-known Russian-Jewish journalist, Benzion Katz, who in a number of Yiddish papers in Poland, Latvia and elsewhere, con-demned the movement carried on to send matzoth into Soviet Russia.

It was the Russian Jews living abroad, the Committee says, who contributed the funds for the matzoth. The Ica, the Alliance and the Agro-joint had all reported a shortage of flour in Russia for baking the matzoth inside the country, and for that reason, in spite of the heavy customs tolls, it was better to send matzoth into the Soviet Union than to send money with which to buy flour and bake the matzoth in the country. Owing to the heavy customs tolls, however, it has not been possible to send to Russia as large a quantity of matzoth as had been intended, and only 28 carloads are being sent. If the local committee abroad raises sufficient funds, however, the money will be sent to those Russian towns which are unable to receive matzoth from the consignments coming from abroad, so that they should make purchases inside the country.

Benzion Katz complained that the action of the Soviet authorities in imaction of the Soviet authorities in imposing a fifty kopek duty on the marzoth imports, is an insult to the Jews. "The Soviet authorities are laughing at us," he wrote. "They have given all Jewry, a slap in the face. The report that the Soviet Government will not openit Jews to hake myach in not permit Jews to bake matzoth in Russia must be investigated, and if it is true a protest must be made all over the world. Such a decision would be against the Soviet Constitution. Religious Jews have a right to make with their flour whatever they wish. The Soviet Government is always claiming that it does not interfere with religious convictions. I doubt whether there is such a prohibition, but if there is, and it is for that reason that matzoth are being imported into Russia from abroad, not only religious Jews, but all Jews who respect the principle of religious liberty must raise a protest against it. We must not permit the in-quisitional methods employed against the Jewish religion to pass without vigorous action.
