PALESTINE HEBREW AUTHORS ISSUE CALL TO WORLD JEWRY IN BEHALF OF RUSSIAN JEWS State Soviet Policies Annihilate Jews; Protest Against Brainin Attitude

Tel Aviv, May 24—Claiming to be in opssession of exact information, derived from the most reliable sources in Russa, a group of Hebrew authors in Russa minutural workers, led by Chaim Nachman Bailk, Hebrew poet, today issued a statement here drawing attention of Jewish public opinion throughout the word to "the truth about Russis".

This statement was issued following a meeting of the authors and communal workers presided over by Mr. Bialik. It declares that millions of Russian Jews are facing the danger of annihilation as the result of the despotic and merciless policies of the communists. It urges the Jewish press "that the time has come when it must fulfil its duty to voice vigorous protests daily . Russian Jewry is living in extreme material and moral distress," "The most the statement declares. atrocious terrorization is being applied openly and more so secretly against the Hebrew language, the Hebrew culture, Jewish religion and Zionism in Russia. If world Jewry will not awak-en to save their Russian brethren, so called, this will be a shameful crime, which will never be forgotten," the statement continues.

SCHECHITA PROHIBITION PROPOSAL BEFORE COMMITTEE OF BAVARIAN DIET Ten Societies Submit Petitions Sup-

porting Bill (Jewish Telegraphic Agency)

Munich, May 24—A bill which if enacted would prohibit the schechita, the lewish method of slaughtering animals for food, is now under consideration in the Constitution Committee of the Bavarian Diet.

In the language of the bill staughtering animals without previous stunning would be prohibited. Ten Societies submitted petitions to the Diet in support of the bill. The All German Society for the Prevention of Cruelty to Animals is among the petitioners.

The leaders of the Jewish community in Bavaria submitted a memorandum in opposition to the bill, quoting the opinions of experts to the effect that the schechita method is humane. In the Committee the measure was vigorously supported by the nationalist deputies who demanded the prohibition in accordance with a Diet decision of 1926, while the Social Democrats, joined by the Bavarian Volkspartei Deputies, fought against it.

20 EMIGRANTS, WITH FALSE U. S. VISAS, ARRESTED (Jewish Telegraphic Agency)

VOTES "NO CONFIDENCE" IN
ITS EXECUTIVE COMMITTEE

Warsaw, May 24—The administration of the affairs of the largest Jewish community in Europe, the Warsaw Kehillah, is again facing a crisis, as the result of a vote of "no confidence," passed by the Kehillah Council, a

democratically elected body.

At its session Wednesday evening, the Kehillah Council, with only two dissenting votes, passed the resolution introduced by the representatives of the ultra Orthodox party, Agudath Israel. The motion was supported by the councillors representing the eventual control of the councillors representing the eventual control of the council of the resolution was passed and a commission is to be appointed consisting to

seven members to review the activities

of the executive committee since its

coming into power. The present Kehillah Council has been functioning during the past four years since the last elections. On many previous occasions, motions to express "no confidence" were intro-duced by the spokesmen of the various groups opposing each other, but were never passed. The present vote threatens to throw the affairs of the Kehillah into a chaotic condition. It is likely that both extreme wings, the Socialists and the Orthodox, will recall their representatives from the present administration. The Zionists, against whom the vote was directed, on the other hand, will take no action since they assert that the vote was taken in the absence of a quorum and therefore lacks validity.

NAVAL HONORS TO ATTEND FUNERAL SERVICES FOR REAR ADMIRAL JOSEPHTHAL Service Aboard the Naval Reserve Armory Ship Illinois Today; Body to be Cremated

Naval honors will be accorded Rear Admiral Louis Maurice Josephthal, Commander of the New York State Naval Militia, who died on Thursday, at his home, All View, Premier Point, New Rochelle, N. Y., at the age of sixty-one, after a long illness.

Funeral services will be conducted aboard the Naval Reserve Armory Ship Illinois, this afternoon at 3 P. M., where the body has lain in state since vesterday. A firing squad will fire a salute before the coffin is taken from the Illinois and the minute gun will fire the usual salute. An escort of Naval Militia will accompany the body fire the usual salute. from the Illinois to the crematory at Fresh Pond, Queens, L. I. A firing squad and a bugler will officiate at the crematory.

Beginning his career in the State Naval Militia in 1891 as an ordinary seaman, he rose through successive promotions to the Rear Admiralship to which he was commissioned by Governor Smith on February 27, 1925. He served as naval aide on the staffs of seven Governors. Dix. Sulzer, Glynn, Whitman, Smith, Miller and Roose-

He was a member of the American Legion, Military Order of the United States, and the Order of the United Sons of American Wars.

Admiral Josephthal held a commission as a Reserve Captain in the United States Naval Reserve. He received a medal for thirty-five years of service with the State Militia. The Government of Roumania gave him the grand cross of the military order of Roumania, the highest award within its gift, for his services to that country. For nine years he served as Secre-

ORTHODOX RABBIS AGAIN ASK FOR REPRESENTATION ON JEWISH AGENCY Rabbi Rosenberg Elected Over Refusal,

Unwilling to Serve as President (Tewish Daily Bulletin)

Belmar, N. J., May 24—Has or has not the Union of Orthodox Rab-bis a president? The twenty-sixth annual convention of the Union was concluded here and the members left for their respective homes, asking each other this question, for Rabbi Israel Rosenberg, of Brooklyn, N. Y., who was unanimously re-elected president for a second term, remained adamant in his refusal to serve in that capacity. In his message at the opening of the convention, Rabbi Rosenberg declared he was not a candidate for re-election, but his renomination brought cheers from the rabbis and re-election for him over his protests.

Five honorary presidents were chosen as follows: Rabbi M. S. Margolies, New York; B. L. Levinthal, Philadel-phia; E. Zivick, Pittsburgh; Dr. Ber-nard Revel, New York; and E. Silver, Springfield, Mass.

That the orthodox rabbinate is determined to be represented in the Jewish Agency was evident from one of the resolutions adopted. Although there was no official action on the question of the Agency itself, it was evident from the tone of the resolution that the rabbis favored the unif ing pact, for the resolution specifically had the convention request those of its members who participate in the World Zionist Congress to meet pre-viously with the European rabbis and demand this representation.

Anent Palestine in general, the rab-bis went on record as favoring the support of all religious institutions there, urging their members to visit the country, and registering their pro-test against the Wailing Wall inci-

LEAGUE COMMITTEE REJECTS PLAN TO CHANGE MINORI. TIES COMPLAINT PROCEDURE Question to Come Up at Madrid Session of League Council

The special League of Nations committee of three has rejected the main proposal recently formulated by Ger-many and Canada concerning the protection of minority peoples who number about 40,000,000 in Europe, according to an Associated Press despatch

from Geneva. The committee which met in London, included Sir Austen Chamber-lain, Senor Quinones de Leon of Spain and M. Adatchi of Japan. Their report will be published on the eve of the June council session in Madrid. As the chief German proposals were not approved, it is felt that the Madrid session promises to be lively since Dr. Gustav Stresemann, German Foreign Minister, is almost certain to make a further fight for the acceptance of his ideas.

The committee rejected the suggestion that the League Council should exercise constant surveillance over the interests of minorities, but decided that the council is only empowered to act under the minority treaties when some member of the council reports an infraction of treaties can only be modified by a majority vote of the council or with the consent of the signatories.

Similarly the committee failed to approve a recommendation that if the governments against whom the grievance is directed are unable to satisfy the petitioners, the minorities can frame a new petition and insist that all correspondence be sent to the league. The committee deemed this would be inimical to friendly negotiations between the Minority Committee and the Government in question.

The report then disapproved the Canadian proposal to increase the Minority Committee from three to fourteen, but leaves the door open for an increase of the committee to five members. It respects a recommendation for the appointment of a consultative committee which would collabo-

rate with the Minority Committee.

JEWS APPLAUD HENRY FORD AT TESTIMONIAL DINNER TO DAVID A. BROWN

Former Foe Issues Statement Praising Race; 2,000 Attend; Hoover Sends Message

Henry Ford, one of the guests of honor at a dinner given at the Hotel Commodore on Thursday night by more than 2,000 Jews as a testimonial to David A. Brown, national chairman of the United Tewish Campaign, paid his tribute to Mr. Brown as well as to "the great race which is proud and fortunate to count him among its own." -the race to which Mr. Ford apologized two years ago after repeated anti-Semitic attacks in the "Dearborn Independent," which he controlled.

Mr. Ford's encomiums to Mr. Brown and the Tewish people were contained in a statement which was issued at the dinner, but not read, and most of those present were not aware of its exist-

At the first mention of Mr. Ford's name by one of the early speakers, however, the entire gathering stood and cheered about a minute. Mr. Ford, from his place of honor on the speakers' dais, bowed his acknowledgment. He was referred to several times by later speakers, and some of them told Ford jokes-at which Mr. Ford laughed.

His statement was as follows: "I am happy to come here tonight to pay a tribute of admiration to my good friend David A. Brown, and through hin to the great race which is proud and fortunate to count him among their own.

"David A. Brown is a shining example of the great benevolence of the Jewish people, their philanthropy, their eagerness to make this world better, to educate the untutored to heal the sick; to care for the orphans; their intense and intelligent participation in all that makes for civic righteousness and social justice stamps them a great people—and David A. Brown is one of their greatest and finest sons." The dinner welcomed Mr. Brown,

a result. Persons close to Rabbi Schneursohn, known as the Lubawitcher Rebbe, declared today that the Rabbi, who has many followers in Russia, was in re-ceipt of letters from his friends confirming the reports that the prohibitions of the schechita was degreed in a number of other towns in Russia.

VATICAN FINDS PROFESSOR EINSTEIN IS AN ATHEIST

Rome Organ Upholds Cardinal O'Connell's Attack on Scientist (Jewish Telegraphic Agency)

Vatican City, May 24-Professor Albert Einstein, the famous Jewish scientist and author of the theory of relativity, is regarded by the Catholic Church as an atheist, if the comment of the "Osservatore Romano," usually the mouthpiece of the Vatican for official announcements, is to be taken as the official view of the Pope, Pius XI.

The Papal organ, in an editorial, vesterday, commends Cardinal O'Connell of Boston, who is now on a visit to Rome, for his recent attack on the famous scientist, concerning whose theories he stated that they were "befogged speculation producing universal doubt about God and His creation," and "cloaking the ghastly apparition of atheism." The "Osservatore Romano" declares that the American cardinal was right in his views about Professor Einstein's theories. His the-ories, the paper says, have a "tendency to cut off faith and God from human life. This is authentic atheism even if camouflaged as cosmic pantheism.

"HOUSE CLEANING" OF SOVIET APPARATUS THROWS JEWISH WORKERS OUT OF JOBS

"Emes" and "Octiabr" Complain Postal Authorities Refuse to Deliver Yiddish Papers (Tewish Telegraphic Agency)

Moscow, May 24-The slogan "Clean the Soviet Apparatus," now being put into practice in White Russia, has resulted in the loss of employment by a great number of Jewish workers in the territory.

Reports from Homel, Minsk and Bobruisk state that many lews who have been for years members of the Artisans' Guilds are now unemployed Various reasons are given for their disqualification, one of them being that a number of the workers who were workers in their workshops.

The Yiddish Communist daily, "Octiabr," published in Minsk, complains in its issue of today that the Soviet postal authorities in White Russia refuse to distribute the Yiddish newspapers. During the last month, in the entire city of Homel, only cleven copies of the "Octiabr" were distributed. The Yiddish Communist daily of Moscow. "Emes." likewise complains that its circulation has been reduced due to the negligence of the postal authorities. In the entire territory of White Russia, the "Emes" has a circulation of less than 1,500.

COMMUNIST TEACHERS CONSPIRE TO OUST JEWESS

Unusual interest has been aroused in the election of delegates to this year's Congress because of the importance of the issues which are to be taken The Zurich meeting will definitely give the decision of Zionists on the question of the extension of the Jew-ish Agency and the unifying of Zionists and non-Zionists for the rebuilding of Palestine. It is because of this issue that the American Zionists are aiming to send an unusually large delegation to the Congress.

An announcement issued by the Zionist Organization of America urges all Zionists to vote for the list prepared by the Organization since the candidates on that list are all in favor of the extension of the Jewish Agency and will support the plan when it is taken up at the Zurich Congress.

Minority Committee public. However, it authorized sending the result to every member of the council and expressed the hope that the interested States would approve publishing these results.

At the same time it empowered the League to issue annual reports on the number of minority grievances received. As a further concession to the minorities, the League was empowered to inform petitioners when their peti-tions are deemed for any reason nonreceivable.

The report is considered of the greatest importance to the political situation in Europe, since many observers regard the problem of minorities as a whole to be the greatest potential causes of misunderstandings between the Nations.

The report of the special committee must be rapified by the council which will meet privately in Madrid June 6 for the purpose of discussing it before opening the regular public session on if you are pleased with the "Jewish Daily June 10.
