#### SOVIET GOVERNMENT PLANS METAL INDUSTRY CENTER IN HOMEL

Jewish Workers to Benefit; Project Bail Granted Shapiro on the Request Involves 54,000,000 Rouble Invest- of College Dean ment in Five Years

(Tewish Telegraphic Agency)

Moscow, May 25-New opportunities for employing Jewish workers are expected to result from the establishment in Homel of a metal industry center, if the plans of the Soviet Government, just approved, are carried into operation.

According to the project, 54,000,000 roubles are to be invested during the next five years for the erection in Homel of 28 new factories. Eleven thousand workers would be employed. One of the factories is to be a tractor plant. Other plans are to manufacture glass, matches and paper. It is stated that, like in Kerch, the Jewish workers in White Russia are to be aided in entering the industries.

#### 20 DROWNED WHEN FLOOD SWEEPS EKATERINOSLAV (Jewish Telegraphic Agency)

Moscow, May 25—Twenty persons were drowned and over one hundred houses ruined when a flood, lasting over three hours, swept the city of Ekaterinoslav, today. As the result of the flood the water works burst. The lower part of the city was entirely submerged by water. The damage is estimated in the hundreds of thousands of roubles

All able bodied men were mobilized to clear away the debris. The city authorities have undertaken the organization of relief work for the victims. Many Jewish families are among those

#### JEWESS ELECTED TO UKRAINE GOVERNMENT BODY

(Jewish Telegraphic Agency) Moscow, May 25-Miss Golde Liss was elected a member of the All-Ukrainian Sik, the Central Executive Committee, the governing body in the Soviet system.

Miss Liss, who is thirty years of age, was born in Lodz, Poland, the daughter of a Jewish textile worker. At the age of ten, she settled in Kiev, where she became active in the labor ranks. She is the first Jewish woman to hold such a post.

#### NEW CEMETERY DESECRA-TION IN GERMAN TOWN (Jewish Telegraphic Agency)

Berlin, May 25-Another act of vandalism was perpetrated by anti-Semitic rowdies on the Jewish cemetery of Koethen, near Dessau.

All tombstones were overthrown and some graves were opened. On some of the graves the vandals placed cadavars of animals.

#### RELEASE ON BAIL STUDENT WHO STABBED ANTI-SEMITIC LEADER

(Jewish Telegraphic Agency)

Antwerp, May 25-Upon the request of the Dean of the Agricultural College of Genbloux, Mordecai Shapiro, the lewish student who stabbed the Russian student, Michaelson, was released on bail, set by the court at 20,000 francs.

The Dean requested that he be freed in order to enable Shapiro to take his final examinations, due this month. The Dean further testified to the investigating authorities concerning the relations prevailing among the various student groups. This testimony, it was understood, was distinctly favorable to the Jewish student.

It appears that Michaelson was the leader of the anti-Semitic student organization which includes Russian monarchists, Polish Nationalists and Roumanian Cuzists who are enrolled in the college. Members of this organization on the campus lately wore hatbands with the inscription "Beat the Dirty Jews." Several days before their final quarrel. Shapiro met Michaelson and asked him to discontinue his disgraceful activities to which Michaelson replied, "Sale Juif" (dirty Jew).

Although it is definitely known that Shapiro was a member of the Zionist circle, a Nationalist and an anti-Communist, the charge that he was a Communist is still being made in the Belgian press. It was noted that even the Social Democratic organ, "Peuple," repeated the charge.

In Jewish student circles in Belgium, Shapiro's act, in resorting to violence, is criticized. However, the hope is expressed that the occurrence will draw public attention to the conditions prevailing in the various student organizations in their relation to the Jewish student.

### 513 INDUSTRIAL ESTABLISH-MENTS IN PALESTINE

(Jewish Telegraphic Agency) Jerusalem, May 25-Palestine has at present 513 industrial establishments

employing 5,000 workers. More than one million and one half pounds sterling is invested in these establishments. These figures are the result of a sta-

Hebrew labor daily. This survey does not include the Ruttenberg Works, which employ seven hundred workers.

Only six firms have a capital exceeding twenty thousand pounds. Fifty-nine firms have a capital each of more than 3,000 pounds. All others operate on a capital of less than 3,000 pounds.

#### JUGO-SLAVIAN COURT GIVES PRISON SENTENCE TO TALMUD DEFAMER

n Community Takes Action When Medieval Charges Are Repeated (Jewish Telegraphic Agency)

Belgrade, May 25-Scenes resembling those of the medieval ages when the Talmud was tried and burned in the public market places, were enacted in the Jugoslavian courts when the Jewish community took legal action against a defamer. The court imposed a prison sentence on the man who repeated in writing the old libel. He was sentenced to spend eight days in prison.

The decision was rendered in the case of the Jewish community of Brod versus Attorney Goulubic, who alleged in an article published that the Talmud expressly "permits Jews to abuse and swindle in their dealings with non-be-lievers." The proceedings lasted seven hours, and the state atorney agreed with the Jewish solicitor who declared. speaking on behalf of the entire Jugoslavian Jewry, that Goulubic offended a legally recognized religion. The crowded and stuffy courtroom was reminiscent of the atmosphere of the Middle Ages when clergymen and robed Franciscan priests, on one side, and Rabbis with lay Jewish represent-atives on the other side stood before the Judge to present expert opinion on the subject. The huge volumes of the Talmud and numerous reference works were brought into the court-room. The Catholic experts repeated the old allegations against Rabbinic Judaism. The court disregarded these opinions as unfounded.

#### JACOB GOLDSCHMIDT SEVENTH RICHEST MAN IN GERMANY

(Jewish Telegraphic Agency) Berlin, May 25-Jacob Goldschmidt, the well known German Jewish banker,

is the seventh richest man in Germany. according to figures made public here. Ex-Kaiser Wilhelm is the first richest man in the country, his possessions being estimated at 25,000,000 pounds. Mr. Goldschmidt's wealth amounts to 2,000,000 pounds.

These figures are of special interest in view of the frequent attacks in the anti-Semitic press which asserts that Goldschmidt is the wealthiest "Jew German" who allegedly controls the financial fate of Germany.

#### ADOLPH LEWISOHN MARKS EIGHTIETH BIRTHDAY TODAY

Ceremonies continuing over three days have been arranged in honor of Adolph Lewisohn, philanthropist and music patron, who celebrates his eightieth birthday today. Yesterday Mr. Lewisohn was the guest of the Hebrew Sheltering Guardian Society at Pleasantville, whose president he is Today will be given over to friends and relatives, while on Tuesday he will be honored by the Hebrew Technical School for Girls which he helped found:

He has for years been a leader in prison reform and has contributed large sums to the Mount Sinai Hospital, of which he is a director.

ABANDON HERZL MONUMENT WHEN ZIONISTS OBJECT TO NON-ZIONIST GIFTS TO FUND Associates of Herzl Now Plan Monument Over Vienna Grave After Remains Are Sent to Palestine (Tewish Telegraphic Agency)

Vienna, May 25-The call for funds to erect a Herzl monument in Vienna on the occasion of the twenty-fifth anniversary of his death occurring in July, which was issued recently by the so-called International Herzl Monument Committee, the signatories including men like Professor Einstein, Jacob Wassermann, Franz Werfel, Stefan Zweig, Max Brod, Lesser Ury, and other famous men, mas so response. Not a single list of contributions has yet been published. The Jewish public here, especially the Zionists, have paid no heed to the appeal. The official Zionist movement has, in fact, adopted an antagonistic attitude with regard to the project, on the ground that several of the signatories to the appeal are notorious anti-Zionists, and some are even renegades from Judaism. The scheme appears in consequence to have collapsed.

A new project is being put forward in its place by a number of Zionists who were associated with Dr. Herzl in the Zionist movement, to erect a Herzi memorial in Vienna, over his grave in the Jewish cemetery, but not before his remains have been transferred to Palestine. In this way, they intend to preserve the site of his grave in Vienna, which has been for years a center of pilgrimage for Zionists on the anniversary each year of his death and on other occasions, so that when his remains have been reinterred in Palestine. Vienna will still have a memorial to Herzl in its midst.

SOVIET EDITORS, FIGHTING ANTI-SEMITISM, RECEIVE THREATENING LETTERS Police Official Sentenced to Imprison-

ment for Year for Spreading Ritual Murder Libel (Jewish Telegraphic Agency)

Moscow, May 25-The editors of a number of Soviet newspapers which are carrying on an energetic campaign against anti-Semitism ni the Ukaine are receiving anonymous warnings that in the event they do not discontinue their fight, they will be the victims of violence.

The Moscow press reports that let-ters of such content have been received by Ukrainian editors in Krementchug, Suny and other towns. The letters bear the signature of "Threat-ening Hand," and contain the follow-ing phrase: "The renegades will be killed, as will be the Jews to whom they have sold their minds and souls."

Maxim Adalov, the head of the criminal police, in Chosovirtovsk, near Dagistan, was sentenced to one year imprisonment for spreading rumors during last Passover that "the Jews use blood for Passover." The rumor was started when a local resident, Aliev, missed his four-year-old daughter and came to the police, declaring his belief that the Jews had stolen his child. The police head, Adalov, in-stead of squelching the rumor, encouraged its spread by sending out a police detachment to the Jewish district of the city and ordering a search of all Jewish houses. In the evening the child was found, walking in the fields of a suburb.

Aliev, who was likewise tried by the court, was acquitted, since, the court held, that being ignorant, he may have acted with sincere belief. The head of the police could not be so regarded and his action could not be overlooked.

#### TRANSFER OF ZIONIST MEETING DUE TO WEIZMANN'S ILLNESS

London, May 25—The transfer of the session of the Zionist General Council from London to Berlin was due to change in the health of Dr. Chaim Weizmann, President of the World Zionist Organization.

Providence, May 25-A new devel-University which was recently brought to public attention by the forced dissolution of the Brown chapter of Pi Lambda Phi fraternity, composed principally of Jews, is the announcement by Edward DeV. O'Connor of Providence, president of Phi Kappa, a Catholic fraternity, that plans are underway to change the charter of the organization to put it on a non-sectarian

This announcement followed closely a speech by Dean Otis E. Randall of Brown at New Haven, in which he defended his action in refusing to allow Iews who are students at Brown to organize a fraternity.

The stand was taken, he said, because the primary mission of fraternities is to bring into closer contact people of widely dissimilar viewpoints and that any concentrated homogendous group must inevitably defeat the privilege. He said that any similar group would have met with the same denial, and stated that if he had been dean when the Catholic fraternity was organized. he would have withheld his permission.

President W. H. P. Faunce of Brown has hailed the announcement of Mr. O'Connor of the abandonment of the Roman Catholic character of Phi Kappa as "a step in the breaking down

#### J. D. B. NEWS LETTER

Fighting Anti-Semitism in Germany; Non-Jewish Organization Reports

on Work By Our Berlin Correspondent

Berlin, May 13—The Union for Com-bating Anti-Semitism, a non-Jewish organization, has during the past year been carrying on an extensive activity aiming to show up the falsity of the allegations made by the anti-Semitesnot in order to shield the Jews, but in the interests of truth and justice, the Secretary of the Union, First Lieutenant Dr. Horlacher, reported to the annual meeting of the Union, which kas just been held at Dortmund, under the chairmanship of its President, Dr. Georg Gothein, former member of the Federal Government. There was a big attendance of delegates from Dort-mund, Berlin, Suttgart, Hanover, Muenster, Kiel, Frankfort, and other places.

The Union will continue as in the past twenty years of its existence, Dr. Gothein said, to maintain strict political and religious neutrality and from this broad platform to fight against the shameful and uncivilized manifes-

tation of anti-Semitism.

A big public demonstration was also held in Dortmund in connection with the Conference. Pastor Tribukait, the the Union, said that the day had gone when anti-Semitism could rob their Jewish fellow-citizens of their equal citizenship rights. There was no citizenship rights. longer any danger of that. But it was necessary to fight against anti-Semitism because it was unfair, un-Christian and uncivilized to go about calumniating the Jewish population. It was degrading for a country passing through a period of tribulation for no fault of its own to go about looking

for a whipping-boy.

Dr. Gothein, in tracing the history of anti-Semitism and the motives which had led to the foundation of the Union by Rudolf von Gneist, Heinrich Rick-ert, Theodor Mommsen, Franz von Liszt, Theodor Barth, Gustav Freytag, Hermann Sudermann, and others, said that when the original anti-Semitic movement organized by Stoecker had already ebbed, Germany's defeat in the war had brought a new wave of anti-Semitism. Those very people who had by their exaggerated annexation demands prevented the conclusion of an earlier and more satisfactory peace were now trying to make the Jew the scapegoat for their own mistakes. They had forgotten what the Jewish Germans had contributed to the development of German culture. They had forgotten that 12,000 German Jews had laid down their lives on the battlefield for Germany. The kindred of these Jewish heroes of the war were now being villified, and some people were even demanding that they should be deprived of their Germanism. Such people had apparently forgotten how much the German nation itself has had to suffer from hatred and prejudice.

RELIGIOUS ISSUE IN EASTERN STAR ORDER CONTINUES TO AGITATE N. J. MEMBERS

New Version Says Oath on New Testament for Jewish Members the Issue

(Jewish Daily Bulletin)

Union City, N. J., May 25-More than 10,000 Jewish members of the Order Eastern Star in New Jersey are expected to secede from the New Jersey Chapter, early next month, due to alleged anti-Semitic prejudice, acto alleged anti-scinitic prejudice, according to a story appearing in the "Hudson Dispatch," a daily newspaper in this city, which quotes "a high officer of the organization" whose name it does not mention. The newspaper also quotes the same authority as saving that decision also has been reached not to affiliate with the New York Grand Chapter of the Order, but that 21 chapters in this state which have Iewish members intend to set up a rival body to the New Jersey Grand Chapter.

The paper further quotes this high official as saying that the original version of the conflict which occurred at the convention of the Grand Chapter last week in Atlantic City: namely that Iewish members supposedly objected to the use of the Christian symbol of the Star of Bethlehem in the ritual of the Order, was incorrect. This official claims that the conflict was brought on by the mandatory requirement of the Grand Chapter that all members of the Order must take their oath of office on the Bible turned open at the

New Testament.

According to this paper's informant, Icwish members, in session at the convention last week, submitted a resolu-tion making the Bible opening provision optional, instead of mandatory. The resolution, the paper reports, was voted down, Miss Emma Farrier, the new grand secretary, was hissed and the Jewish delegates walked out in a body.

"The Jewish chapters of the Eastern Star deny that they want to make any changes in the star used as a symbol of the order. In fact, the Jewish and Christian stars are alike. We are content to use the same star as has been used by the order in New Jersey for the last 57 years.

But three years ago, the then grand matron, Lucy Sloat of Orange, introduced a resolution making it mandatory on all chapters to open their Bibles at the New Testament, when they take the oath within the order.

"This is not properly an oath within the tenets of the Jewish faith, but if we had been allowed to take an oath on the Old Testament it would have

been binding on us.

"There has been talk of secession among Jewish chapters for the last year, and the grand officers, in an effort to head off this movement, offered the resolution at the Grand Chapter in Atlantic City last week, which was hissed and thrown out. The grand officers themselves are Christians and they are with us, in spirit, in this fight.

"However, the Grand Chapter is dominated by the chapters of South Jersey and it is well known in this state that South Jersey has a prejudice to Jews, and indeed has a predom-

inant Ku Klux Klan strain.

"There are \$5,000 members of the Eastern Star in New Jersey, of which between 10,000 and 11,000 are Jewish members in 21 chapters, five of which are in Hudson County. The delegates to the Grand Chapter have not reported back to their chapters as yet, but when they do so arrangements will be made for a state meeting of Jewish chapters at which our future course of vaction will be decided upon."

They had to try to rise again by united effort, to raise themselves to a higher cultural level. It was true that Talmudic Judaism was largely alien to Germans, who in contradiction to its over-emphasis on observance placed all stress on grace. the founder of the Christian religion was a Jew, brought up on the Old Covenant, and what they had to do was to practice love and respect, and to elevate the Jewish, the Christian and the German mode of life.

"That's what I want with all my heart. That will mean the breaking down of another barrier. Only during the past year at Brown has there been the case of admission of an Oriental student to one of our fraternities. The barrier between the Occident and the Orient has been broken down. If all such barriers were removed it would be in accord with the ideals and policies of the university.

"What I want," continued President Faunce, "is the removal of all restrictions as to race and religion. Men must be judged on their merit, on their scholarship, personality and individual ability rather than on such narrow

bases.

Mr. O'Connor's announcement was made in commenting on Dean Randall's speech at New Haven. He said that the formation of Phi Kappa had been made at Brown in 1891 because Catholics were not at that time admitted to firsternities. Catholics are permitted to almost all of the fraternities at present, he said.
