## **MADRID CONFERENCE CONSIDERS PROBLEMS OF NATIONAL MINORITIES**

**Wants League Secretariat to Consider Acute Position of Staatenlose**  
 (Jewish Telegraphic Agency)

Madrid, May 27.—The situation of the National Minorities in those European countries where their rights were guaranteed in the International Treaties following the World War will be considered in the open session of the International Conference of the League of Nations Societies Union meeting here.

A set of resolutions dealing with this problem is now being prepared by the Committee on National Minorities, headed by Sir Willoughby Dickinson. In the plenary session, the question of the Staatenlose was taken up. Dr. Leo Motzkin, one of the Jewish delegates, addressed the conference on the subject and pointed out that although the number of the Staatenlose has decreased, the position of those who still remain in that status has become worse. This is in particular true of the great number of Jews in Eastern Europe who find themselves in this category as a result of the geographical changes. He urged the conference to demand that the League of Nations Secretariat give the question greater consideration.

M. Feinberg addressed the conference on Palestine.

## **CHASSIDIC FOUNDER'S GRAVE ENDANGERED IN UKRAINE**

Riga, May 27.—The tomb of the Baal Shem Tov, the founder of Chassidism, located at Miedzob, Ukraine, is now in danger of being destroyed, reports in the Jewish press in Russia state.

The cemetery is now being removed and the tombs around the chapel constructed over the grave of the Chassidic founder have been destroyed. The local Jewish community here is endeavoring to persuade the authorities to save the shrine held sacred by many Chassidic Jews throughout the world.

The Baal Shem Tov died and was buried at Miedzoboz on May 22, 1660.

## **CONSTANTINOPLE JEWS PLAN CENTRAL SYNAGOGUE**

Constantinople, May 27.—A site for the erection of a central synagogue in Pera was selected by the Jewish community. Plans published indicate that the structure would cost 20,000 pounds and will have a seating capacity of 2,000.

Importance is attached to this announcement in view of the fact that the construction of the synagogue will be the first official act of the Jewish community since the revolution.

## **COMMISSION LEAVES MOSCOW TO INVESTIGATE NEW AREA FOR JEWISH COLONIZATION IN CRIMEA**

**40,000 Jewish Families Can Be Settled on Azov Sea Shore After Amelioration Program Is Completed; Project Would Involve Expenditure of from 15,000,000 to 20,000,000 Roubles**

Moscow, May 27.—A commission representing the Agrojoint, the agency of the American Jewish Joint Distribution Committee, and the Comzet, the government department for settling Jews on the land, left Moscow today on its way to Crimea to begin a survey which, if it proves the hopes held by the friends of the back to the land movement in Soviet Russia, would result in settling 40,000 additional Jewish families on the land.

An area of 200,000 hectares of land in the district of Sivash, on the shores of the Azov Sea, will be the object of the survey. The land is now swampy and prior to its cultivation it would have to be drained at a great expense. The settlement of the reclaimed area by declassing Russian Jews would constitute the largest single piece of social constructive relief work. The expenditure of a sum of between 15,000,000 and 20,000,000 roubles would be involved in the enterprise.

Both agencies, the Agrojoint and the Comzet, are interested in the project and have each allotted the amount of 20,000 roubles for the expenses of the survey, which is expected to be concluded during the summer. If the commission brings in a favorable report, actual colonization work may begin next year.

Dr. Joseph Rosen, the head of the Agrojoint, when interviewed today by

the correspondent of the Jewish Telegraphic Agency, declared that the colonization plan in the Sivash region constitutes a part of the program of the Agrojoint, formulated for the next ten years. He disclosed that the Soviet Government has agreed to cover the expenses of the drainage work, while the agency of the American Jewish Joint Distribution Committee will undertake the settlement work after the amelioration is completed.

The territory to be surveyed has many rivers which carry the melted snow from the mountains to the sea. It is projected to build a big water reservoir for irrigation. The region, when drained and irrigated, would be certain of good crops, independent of weather conditions.

Speaking of the importance of the plan, Dr. Rosen expressed the opinion that there is a distinct advantage in settling Jewish on this reclaimed land. It will prove that Russian Jews are prepared to seek unexplored territory and to settle not only on land already prepared and previously the property of the big land owners. It is impossible at this moment to foresee what the survey will recommend and whether the plan has chances of success.

"We will await the report of the survey commission," Dr. Rosen stated. "If the report is favorable, the project will become one of great importance and will open a new page in the history of the new colonization work."

## **JEWISH ARTISANS CONFERENCE OPENS**

Benthin, Upper Silesia, May 27.—A world conference of Jewish artisans' organizations was opened here yesterday in the presence of government representatives who welcomed the delegates.

Delegations from nearly all countries in Europe were present. The agenda includes a discussion of ways and means to aid the Jewish artisan class.

## **JEW DIRECTOR OF STATE THEATRE, DESPITE ANTI-SEMITISM**

Berlin, May 27.—Leopold Jessner will continue in his position as director of the Prussian State Theatre in Berlin, a report in the Berlin press today states.

The contract between the government and Herr Jessner is to expire soon, and the Minister of Culture and Education, Becker, decided to renew the contract notwithstanding the vigorous campaign conducted in the nationalist press against Jessner, the Jew. The newspapers charge Jessner with "Bolshevism in Art."

## **QUERY ROUMANIAN GOVERNMENT ON INSULT TO JEWS**

Bucharest, May 27.—The Rumanian Minister of Religions was asked to explain and apologize for the insult to a Jewish delegation which came to participate in the Rumanian Union celebrations at Buzau.

In an interpellation introduced into the Senate by Chief Rabbi Dr. Niemrower, the details of the event at Buzau where the Rumanian Bishop asked the Jewish delegation to leave the platform because he did not like to sit together with the Jews, were recited. The government was urged to make amends and to inform the Rumanian clergy that the constitutional guarantee of equality is applicable to the Jewish religion as well as to any other authorized cult. The Minister of Religions in his reply stated that the government regrets exceedingly the occurrence at Buzau. The Ministry, he added, would wait until the Senate takes action on the matter.

## FURTHER SYMPTOMS OF ANTI-SEMITIC GROWTH SEEN IN SOVIET RUSSIA

Anti-Semitism Increasing in Red  
Army; 20 Students Expelled for  
Acts Against Jews

(Jewish Telegraphic Agency)

Moscow, May 27—Further symptoms  
of the growth of the anti-Semitic  
movement in the various strata of the  
Soviet regime are reported in the  
Communist press.

The newspaper "Krasny Voin" publishes an article complaining of the growth of anti-Semitism in the Red Army. The soldiers do not attend the meetings where political lectures are delivered by Jewish officers. Anti-Semitism is to be observed in the higher ranks of the officers of the army, the paper states, demanding that strong measures be taken against the growing movement.

Twenty students were excluded from the Chemistry Institute at Odessa after they were found guilty of anti-Semitic propaganda. They were reported as having declared to their comrades that "there are too many Jews in the college" and that it was undesirable to have Jewish instructors. Other Russian students who are charged with the same offense are expected to be expelled from the college, in which 200 communists are enrolled.

A counter-revolutionary organization was discovered several days ago in Odessa. Its members, who were all communists, attended during the day meetings of the Communist Party and were active in the campaign now being waged to clear the Soviet apparatus. At night, however, they were busy with printing proclamations in which the overthrow of the Soviets was urged and the slaughter of the Jews was predicted in order "to save the Ukraine."

## SENATE PASSES BILL GUARANTEEING LIBERTY TO NON-CATHOLIC CULTS

Non-Catholic Marriages Also Recognized in New Law

Rome, May 27—Simultaneously with the vote for the ratification of the Lateran Treaty of accord between the Italian State and the Vatican, the Senate passed the bill regulating non-Catholic marriages in the Kingdom of Italy and guaranteeing the freedom of worship to non-Catholic cults.

The vote on these bills was 283 against 10, while the ratification of the Concordat was effected by a majority of 315 against 6.

On the occasion of the passage of this bill, Mussolini delivered another long address in which he dealt with the recent objections voiced by the Vatican and the agitation concerning the matter in certain Catholic circles. Speaking for the purpose of explaining his first address, which he feared was not fully understood, the burden of Mussolini's argument was that by reason of the Lateran treaties, Italy was not Vaticanized, nor was the Vatican Italianized.

In his first address, the Prime Minister stated that full religious liberty will continue to exist in Italy. The Catholic Church is again proclaimed as the State Church in Italy, but this does not diminish in any way the absolute freedom of individuals as citizens to follow their own religious inclinations. The other authorized religions are to be free to exist in Italy. The sovereignty of the church must not be misunderstood. The church is not really sovereign in the state because it is bound by terms of the Concordat.

An interesting remark made by Mussolini was his reference to Christianity in connection with Palestine. If Christianity had remained in Palestine, instead of coming to Rome, it would have remained merely a Jewish sect, and would have died out, like the sect of the Essenes, he said.

## ADOLPH LEWISOHN GIVES

\$30,000 TO JOHNS HOPKINS

Baltimore, May 27—Adolph Lewisoohn, Jewish philanthropist of New York, celebrated his eightieth birthday on Monday with the presentation of a gift of \$30,000 to endow a fellowship at the William Holland Wilmer Ophthalmological Institute at Johns Hopkins University. The gift will bear the name of its donor, it was announced by Frank I. Goodnow, president of Johns Hopkins University.

Pleasantville, N. Y., May 27—Five

hundred persons attended a reception given here Sunday in honor of Mr. Lewisoohn by the Hebrew Sheltering Guardian Society, of which Mr. Lewisoohn is president. Mr. Lewisoohn's services to the city and state were lauded by Lieutenant-Governor Herbert H. Lehman, Frederick B. Robinson, president of the College of the City of New York, Rabbi Nathan Krass, and Dudley Sicher, president of the Jewish Federation.

## SOVIET PERMITS DUTY FREE IMPORT OF RAW MATERIALS FOR AMERICAN'S RELATIVES

\$20,000 Raised at Tea by Women's Division of Ort Drive

Permission to import raw materials duty-free for individuals the society has set up in industry, has been granted by the Russian Soviet to the Ort, the Society for the Promotion of Agricultural and Technical Trades among the Jews of Eastern Europe, the American Ort announced. The same mail brought the first 21 permits issued by the Russian government to persons recommended by the Ort, allowing them to receive such goods, and authorizing the Ort Tool Supply Company of New York to send them.

The Ort Tool Supply Company, Roman S. Weller, secretary, stated yesterday, will make shipments of thread, cotton, rubber, tin, and other raw materials, and will distribute them from the Ort warehouses in Russia as fast as they receive payment or promise of payment from relatives here.

This organization is the agency through which American residents are enabled to send machines to destitute relatives abroad. It is a credit corporation and is financed by funds of the Ort.

The Ort Campaign for Industrial Reconstruction, under the national chairmanship to Howard S. Cullman, is now raising \$1,000,000 for maintenance of these agencies for the rehabilitation of impoverished Jews abroad. A contribution of \$5,000 from Col. Michael Friedsam was announced.

Contributions amounting to \$20,000 were presented to the Ort, the society for the promotion of Technical and Agricultural Trades among the Jews of Eastern Europe, by the women's committee of the Ort Campaign for Industrial Reconstruction yesterday afternoon at a tea in the home of Mrs. Henry Zuckerman, 135 Central Park West, New York. The gifts included a donation of \$5,000 from Mrs. Jacob Schiff.

## YESHIVA PLACED ON APPROVED COLLEGES LIST

The Yeshiva College has been placed by the State University upon the list of approved colleges for State scholarship holders. The State of New York offers annually in every county, five scholarships for each assembly district, each scholarship amounting to \$100 a year for four years, if the holder is in attendance at an approved college.

The Yeshiva College, now added to the State list of approved colleges, and just completing the work of its first year, is the only college of arts and science in the world, under Jewish auspices, offering approved courses leading to the Baccalaureate degrees. The Yeshiva College at present limits admission to students of the Yeshiva (Rabbi Isaac Elchanan Theological Seminary) of which it is an integral part. In the present Freshman class, seven states of the United States are represented: Dr. B. Revel, president of the faculty, stated.

## BROWN UNIVERSITY MAY PERMIT PI LAMBDA PHI FRAT ON CAMPUS

Extraordinary Calibre of Charter  
Members Believed Responsible  
for Change

(Jewish Daily Bulletin)

Providence, May 27—Brown University will probably have a chapter of Pi Lambda Phi, national Jewish fraternity, by the end of the fall term.

A statement by the Executive Committee of the Brown University Corporation, given to the press through Harold Tanner, its legal counsel, points toward official recognition and approbation of Pi Lambda Phi, provided the petition is presented in the proper manner. It is too late in the present term for any official petition to be acted upon.

Late last fall, nine Jewish students at Brown journeyed to New York and were duly initiated members of Pi Lambda Phi without the knowledge of the university authorities. These men were to be the charter members of a Pi Lambda Phi chapter at Brown, but a university ruling to the effect that no social or fraternal group could be formed on the campus until the corporation had passed on its constitution and granted official permission caused the early death of the newly formed group.

While the Brown Corporation executives no aversion toward strictly sectarian groups, it probably does not relish them. Dr. W. H. P. Faunce, the president of the university and member of the executive committee, had a Catholic fraternity, Phi Kappa, bequeathed to him when he assumed his office. He tolerated, but never cherished it, because he believes that sectarian bodies are likely to emphasize differences not pertinent to academic life. However, Jewish students at Brown are persistent in their demands that there should be an opportunity for them to enjoy Pan-Hellenic fraternities. There are over 200 Jews in the Brown student body and only three of these, through various contingencies, are members of the fraternities.

Another reason why Pi Lambda Phi will probably be accepted at Brown is that the calibre of the nine men who

## WARSAW KEHILLAH IGNORES "NO CONFIDENCE" VOTE

Warsaw, May 27—The executive and the legislative bodies for the administration of the Jewish communal affairs of Warsaw are at war since the executive committee at its session, Sunday, decided to ignore the vote of "no confidence" passed by the Kehillah Council.

The Kehillah executive also declined to agree to the creation of a Control Commission of Seven to review the executive activities as was demanded in the resolution adopted by the Council. The executive based its decision on the contention that the vote was passed in the absence of a quorum and is therefore not binding.

Allentown, Pa., May 27—Aiding Jewish prisoners in penal institutions in Pennsylvania, New Jersey, Delaware and West Virginia, and taking care of orphans in the Erie Orphans Home are two of the outstanding functions of the Independent Order B'nai B'rith, District No. 3, according to the reports presented here yesterday at the twenty-third annual convention of District Grand Lodge No. 3, which opened here yesterday and continues today.

The rehabilitation of criminals while they are still in prison, securing employment for them, gaining their release on parole and then aiding them to reestablish themselves as useful members of society has been the aim of the prison aid committee of District No. 3 and much has been accomplished, it was stated. Visitations are being made to the Western Penitentiary in Pittsburgh, the Eastern Penitentiary in Philadelphia, Hudson County, N. J. jails, Newark prisons and other prisons in the district. That Jewish chaplains be installed at all prisons where there are Jewish prisoners was also recommended. The Federation of Jewish Charities was thanked for its aid to the B'nai B'rith in securing employment for prisoners released on parole and for those whose prison terms have expired. Judge Joseph L. Kun, of Philadelphia, an active member of the Philadelphia lodge, was also thanked for his efforts in behalf of Jewish prisoners in Philadelphia, as he aided many in reestablishing themselves in life.

A plea was made to Jewish business firms to employ former Jewish prisoners who were released through the efforts of the B'nai B'rith.

The Erie Orphan's Home at Erie, Pa., is doing a remarkable piece of work in taking care of many Jewish orphans, according to Isador Sobel, President of the B'nai B'rith Home for Children. Mr. Sobel made a plea for aid from the District stating that the Home should accommodate more children.

According to the report of Joseph Herbach, of Philadelphia, Secretary of District No. 3, the membership in the District is close to 6,000 at the present time and the majority of the lodges are showing increases.

Mr. Herbach also stated that auxiliaries are being organized throughout the District and that the future is encouraging. Mr. Herbach stated that during the past year District No. 3 did great work in helping the Jewish needy.

More than 600 persons attended the banquet at the Hotel Americus last night. The principal speaker was Dr. Boris Bogen, of Cincinnati, Ohio, Secretary of the International Order of B'nai B'rith.

## STRESS SUPPLEMENTARY RELIEF NEED IN POLAND AT FEDERATION CONVENTION

Benj. Winter Re-elected President;  
Seek Affiliation with Galician  
Federation

The need for a program of relief for Polish Jewry, supplementing the aid extended by the J. D. C. was described at the 21st annual convention of the Federation of Polish Jews of America, and an appeal issued to the landsmanschaften to undertake such work for the respective communities which they represent.

Two hundred delegates representing 86 affiliated organizations attended the sessions which opened Sunday evening at the Yorkville Temple and continued throughout the day Sunday.

The principal addresses of the convention were devoted to a description of the desperate plight of Polish Jewry by Dr. Aaron Singalowsky, of the World Ort Executive, Dr. Joshua Gottlieb, Vice-President of the Warsaw Kehillah and Dr. Max Weinreich of the Jewish Scientific Institute of Vilna.

Greetings were brought to the convention by Bernard Deusch, President of the American Jewish Congress; Abraham Herman, President of the Hias; Herman Speier, Secretary of the Federation of Rumanian Jews of America; Dr. Henry Hurwitz, President of the Federation of Lithuanian Jews; Jonah J. Goldstein, Vice-President of the Joint Distribution Committee and Leopold Pilchowski, President of the Federation of Polish Jews of Great Britain.

## NEW SPECTACULAR TRIAL FOR ANTI-SEMITIC WORKER

Minsk, May 27—A new spectacular trial of a communist worker charged with anti-Semitic maltreatment of a fellow Jewish worker is to be held shortly in Bobruisk, White Russia. Stepan Zaruba, a member of the Transport Workers' Union, fifty-eight years old, was arrested on the charge of torturing the Jewish transport worker, Abraham Stolpner. The secretary of the union, in Zhlobin, was dismissed from his post on a similar charge. A preliminary investigation by the district attorney, started at the initiative of the district committee of the Communist Party, disclosed that the Jewish worker was subjected to indignities under the threat of death.

## JEWISH INSTITUTE HOLDS COMMENCEMENT EXERCISES

Five students received degrees last night at the fourth annual commencement exercises of the Jewish Institute of Religion.

Judge Julian W. Mack, chairman of the board of directors, presided. The principal speaker was Dr. David Leikowitz, of Dallas, Texas, who is the vice-president of the Central Conference of American Rabbis.

Rabbi Stephen S. Wise delivered the baccalaureate sermon on Sunday. The preacher whose soul cannot give assent to the fundamental truths of religion should withdraw, Rabbi Wise said. "Not that a man is to withdraw from church or synagogue every time he finds himself in conflict with dogma or ordinance of his religious organization or in collision with the more imperious masters of the church, whether these be lay or clerical! But no man can serve with any degree of acceptance in the ministry unless his soul be charged with enthusiasm for those changeless truths of religion which are the heart of faith."

"The office of the Jewish minister is not so much to iterate verbally the oneness of Israel's God as to enhance the worthwhileness and to show forth the imperishableness of the Jewish people," Dr. Wise declared.

The Business Men's Council of the Federation for the Support of Jewish Philanthropies State will meet at a luncheon today at the Hotel Pennsylvania.

Tygel, Executive Director. Mr. Winter and Sol Rosenfeld, Vice-President of the Federation, presided at the sessions. A telegram of greetings was received from Nahum Sokolow, Chairman of the World Zionist Executive.

Criticism was leveled at the Federation by Dr. Singalowsky. Asking what the Federation of Polish Jews in America has done to justify its name, Dr. Singalowsky charged this body has made pledges which it has failed to honor. He urged the Federation to pledge less and do more.

Z. Tygel, answering Dr. Singalowsky, declared the sum of \$200,000 has been sent abroad in the past year by 62 Landsmanschaften, for which the Federation claimed credit since these groups were called into being largely through the Federation's efforts. He agreed, however, with Dr. Singalowsky that there is a lack of understanding of the meaning of constructive relief and that the funds were used for palliative purposes primarily.

In the resolutions adopted the Federation endorsed the work of the On as well as the United Palestine Appeal and the Hias. It also authorized an effort to bring about an affiliation with all Galician Societies. Other resolutions adopted asked all Jewish organizations and individuals to support the Haym Salomon Monument and make possible its erection by 1930; expressed its opposition to any calendar change which would alter the fixity of the Sabbath; suggested the formation of a Jewish Court of Arbitration. The President was authorized to appoint a committee to decide whether the "Verband" monthly publication, is to be cut down.
