### AGENCY QUESTION CAUSES RIFT IN BERLIN KEHILLAH COUNCIL Liberals Leave Meeting, to Render

Appointment of Representatives to Agency Committee Invalid (Tewish Telegraphic Agency) Berlin, June 14-Not all leaders of

the non-Zionists in Germany have been won over to the Jewish Agency point of view, it became apparent when a vote on the question caused a rift in the Berlin Kehillah Council.

At a meeting of the Council held Wednesday evening, Dr. Ismar Freund announced the decision of the Kehillah Board to delegate two representalah Board to delegate two representa-tives to the special committee now being formed for the purpose of desig-nating German Jewry's representatives on the extended Jewish Agency. The delegates appointed are Gerson Simon, vice-president of the Kehillah Board. and Herr Kleemann, bank director. The liberals, representing the Reform Jewish element in the Council, pro-tested against the decision and, declaring that they were not consulted on the matter before, left the hall, so that the decision might be invalid. Dr. Freund explained that the Ke-

hillah Board took the decision because it considered the question of the lewish Agency as a matter affecting the fate of entire Jewry and the cultural interest of humanity.

JEWISH BODY URGES AUSTRIA TO INTERVENE IN HOTEL AND RESORT DISCRIMINATIONS

Want Government to Withdraw the Licenses of Those Refusing Admit-

tance to Jewish Guests (Jewish Telegraphic Agency)

Vienna. June 14-Government action against anti-Jewish discrimination in Austrian resorts and hotels was urged n a memorandum submitted to the Chancellor's office by the Union of Austrian Jews.

The Union urged the government to declare invalid the anti-constitutional decisions adopted recently at numerous Austrian resorts prohibiting "non-Ar-yans, Jews and Semites" from stop-ping at those places. The memorandum recites the names of the resorts which recently adopted such resolutions and requests the government to issue a general order that the licenses of hotels and innkeepers who refuse admittance to Jewish guests be withdrawn.

### ROUMANIAN JEWISH PARTIES CANNOT AGREE ON JOINT PROGRAM; PROPOSAL FAILS

Union Rejects Move for Unity Among All Parties (Tewish Telegraphic Agency)

Bucharest, June 14-Dr. William Filderman, champion of Jewish emancipation in Roumania, was re-elected president of the Union of Roumanian lews at the organization's annual meeting here several days ago. Other members of the board were re-elected.

Unity among the Jewish parties in Greater Roumania appeared as distant as ever before, when a proposal seeking such unity was rejected by the conference.

Dr. Adolf Stern introduced a motion to the effect that all Jewish parties be invited to agree on a joint program on the understanding that the Jewish population groups in the Old Kingdom and in the new provinces declare themselves an ethnic minority, climinating the expression "national Jewish minority." This proposal was rejected, the conference deciding that the program of the Union of Roumanian Jews is sufficient for the defense of individual as well as collective Jewish interests in the country, as is established in the Constitution of Roumania and in the provisions of the Peace

ROUMANIAN GOVERNMENT AIMS FOR REAL DEMOCRACY: EQUAL OPPORTUNITY TO JEWS Prime Minister Maniu, in Interview

with J. T. A. Managing Director, Describes Policy

(Jewish Telegraphic Agency) Bucharest, June 14-"My government

is endeavoring to inaugurate in Rou-mania an era of real democracy in which Jews, along with the other elements of the population, are to have an opportunity to develop and advance on an equal basis," Juliu Maniu. Prime Minister in the Roumanian government, stated to Jacob Landau, Managing Director of the Jewish Telegraphic Agency, in an interview with

"Free Roumania sends its greetings to free America," the Prime Minister said at the outset of his description of the Cabinet's policy. According to the program proclaimed by the government at the recent Roumanian union celebration held at Alba Julia, a bill for the enactment of a minorities law in Roumania will soon be introduced into parliament. When the law is enacted the opinion of all those, including the Iews, concerned will be sought through a questionnaire, the Prime Minister stated in reply to the question as to whether the Jews in Roumania are regarded as a national or a religious minority. The Jewish leaders are not vet decided among themselves on the question, he said.

Some of the questions which have been agitating Jewish and Roumanian public opinion in recent years were raised during the interview and the Prime Minister expressed his opinion concerning them. Asked about the school situation, with special reference to the action of the previous Liberal government which closed the Jewish schools. Maniu stated that the closing of the Jewish schools by the previous government was not an anti-Semitic act, since all religious and minority schools were closed at the time. If the Jews of Roumania are desirous of opening their own schools they will encounter no difficulties on the part of the government. The government is even prepared to subsidize such schools. An amount of 25,000,000 Lei

has been allotted by the government for all minority schools in the coun-(Continued on Page 4)

#### COURT OF APPEALS SOON TO RENDER DECISION IN

### CASE OF CLEVELAND CENTER To Decide If Orthodox Congregation (Tewish Daily Bulletin)

Cleveland, June 14-A decision in the celebrated Jewish Center case, involving the question as to whether an Orthodox Jewish Congregation, formed as such, may, subsequently, by a later board of directors, be transformed into a Conservative house of worship, is expected soon in the Court of Appeals hore A hearing on the case was held this

week and both sides submitted their arguments. The controversy arose several years ago due to the dissension in the membership of the Jewish Center, some Orthodox members objecting to the inauguration of the Conserva-tive ritualism introduced by Rabbi Solomon Goldman. The question re-volves around the following point: whether a charter and constitution and funds secured for the purpose of fur-thering Orthodox Judaism creates a trust of the property involved and may be used only for such purposes.

### JEWS SECEDE FROM

# EASTERN STAR IN M. J. (Jewish Daily Bulletin)

Newark, N. J., June 14-This city appeared today to be the center of action in the fight that has developed in this state in the Order of the Eastern Star over a ritual amendment adopted three years ago and which the Jewish members claim makes it impossible for them to continue in the Order.

It became known last night that Divinity Chapter of this city, which has been in existence for six years, has broken away from the state chapter and formed a new organization. Its membership by unanimous vote has decided to return the charter to the grand chapter. This is the first step in the secession of the Jewish membership from the Order.

A total of twenty-one lodges is said to be contemplating withdrawal from the Order. It is believed that the nucleus of the new organization will be the All-Around Social Club, an organization of past and present offi-cers in New Jersey, most of them Jews.

Mrs. Rose Meverhoff of Palisades Park stated to the press: "It is their affair and they may do what they wish in the matter," referring to the Jewish membership.

### EDWARD A. FILENE'S APPOINT. MENT TO HOOVER CABINET REPORTED AND DENIED

### "Am Not a Candidate for Political Office," Filene Says in Boston (Jewish Daily Bulletin)

Washington, June 14-The forthcoming appointment of Edward A. Filene, prominent Boston industrialist and philanthropist, interested especially in labor questions, to the Hoover cabinet to succeed Secretary of Labor James I. Davis when the latter retires, was forecast as a certainty in reports current here.

It was declared that under the arrangement between President Hoover and Secretary Davis, Mr. Davis had agreed to remain in his post only for one year and early relief from his duties would be welcomed by him. In other quarters the report of Mr. Davis's forthcoming retirement was denied

The solution of the company's financial problems, which arose following the collapse of the land boom in 1926, was made possible thanks to the intervention of all Zionist bodies working in Falestine and especially due to the aid given by a group of American Zionists headed by David Freiberger, vided a loan of \$250,000 to the American Zion Commonwealth, Mr. via

Vriesland stated.

The special committee in charge of solving the American Zion Commonwealth problems is now proceeding to survey the possessions of the company in Palestine and to parcel out the Commonwealth lands. All those who purchased Commonwealth land will receive their deeds within the least receive their deeds within the least stated. The majority of purchasers are in the United State purchasers are in the United States.

Mr. van Vriesland explained that the company still has an indebtedness of £130,000 Sterling in mortgages and £25,000 to other creditors, which must be paid within three years from the sales of land to purchasers in the United States. "We expect that the company, gradually emerging from its involved state, will inspire confidence in its clients to fulfill their obligations by paying off the past installments on the land purchased. The company is doing everything possible to fulfill its part of the contract." he declared.

FIGHT FOR REPEAL
OF NATIONAL ORIGINS
CLAUSE LOST IN SENATE
To Be Resumed at Regular Congress

Session, Nye Says (Jewish Daily Bulletin) Washington, June 14—The fight for the repeal of the national origins law

was lost in the Senate yesterday by a vote of 43 to 37.

Pursuant to the Presidential proclamation, the law will go into effect on July 1. The vote was taken on the motion of Senator Nye to take up for consideration the bill for the repeal of the national origins law which was previously rejected by the Senate Immigration Committee.

Following the vote, Senator Nye announced his intention of continuing the fight at the next regular session of Congress which will convene in December. The fight will be dropped for the rest af the present special session. He expressed confidence that considering the narrow margin by which his resolution was defeated, repeal will be ultimately carried during the next regular session, if determined efforts are made between now and then by the opponents of the national origins to arouse sentiment against the plan. He. together with others, will devote himself from now on to arousing such sentiment, he said.

LEAGUE COUNCIL COM-PROMISES ON MINORITIES PROTECTION PROCEDURE

Averts Controversy by Increase of Council Members and More Publicity for Minorities Grievances (Jewish Telegraphic Agency)

Madrid June 14—The Council of the League of Nations, in session here, faced with the problem of making real the protection of the rights of the national minorities, one of the League's functions, reached a compromise and averted what threatened to be a scritons difference of opinion which might have affected the prestige of the League in Europe.

Following several private sessions when the report of the Committee of three was considered. the Committee of three was considered the Committee of three the compromise offered by Baron Mineichito Adatchi, Jananese delegate and one of the Committee of Three. The original report of the Committee of Three, consisting of Sir Austin Chamberlain, Baron Adatchi and Senor Quinones de Leon, recommended to the Council to reject the plan sponsored by Senator Raoul Dandurand of Canada and Foreign Minister Stresemann of Germany to give the minorities more direct access to the League Council in the presentation of their grievances and to assure speedy and public handling of the problems.

Under the compromise, the Council agreed to empower its president, in exceptional cases, to increase the membership of the sub-committee to investigate minorities' complaints from three to four. Under the same plan more frequent meetings to deal with the minorities' grievances are to be held by the committee and the publication of the major part of its decisions, thus providing greater publicity, is to be insisted upon. In six points of a minor nature, the procedure was changed by the compromise. No decision was taken on the other proposals, their sponsors being free to bring the mat-

sponsors being free to ter up at a later date.

Senator Dandurand of Canada rec-ommended the acceptance of the Adatchi compromise plan, although admitting that it did not go nearly so far as he would like to have seen it. Dr. Stresemann went on record as accepting the Adatchi plan merely in the character of a temporary substitute for some plan whereby minorities either would have direct access to the Council with their grievances or a plan whereby any complaining minority should be guaranteed a representative present wherever its complaint came up. Nicholas Titulescu, former Foreign Minister of Roumania, August Zaleski, Polish Foreign Minister, and Sir George Grahame, British Ambas-sador to Belgium, all endorsed Baron Adatchi's proposal.

Nicholas Titulescu, in endorsing the compromise stated that his acceptance is based on the understanding that the principles, set forth-in-the London report of the Committee of Three have been recognized. The Council avoided (Continued on Page 4)

try and the Jewish schools may benefit from this fund. The government, however, is unable to undertake the maintenance of the minority schools since the public schools maintained by the government are open to all. Special teachers for religious training in the public schools for the particular group of pupils in attendance may be appointed, he stated.

To the question why the Jewish communities in Roumania receive a subsidy from the government in the amount of 10,000,000 Lei for religious purposes at a time when, in accordance with their proportion to the general population, they are entitled to an allotment of 60,000,000 Lei per annum, the Prime Minister replied: "It all de-pends which principle is applied, whether it is the proportion of the population, the proportion of the budget of the Jewish institutions in comparison with the budgets of other religious communities, or the principle of participation in the payment of taxes." The Prime Minister added that in this regard he expects suggestions from Roumanian Jewish leaders. He has, he said, a sincere appreciation of the constructive and valuable participation of the Jews in the development of the country

Concerning the recent reports that the Roumanian authorities have ordered the dissolution of the local Kehillah boards in various cities, the Prime Minister denied these reports, declaring differences of opinion, leading to conbetween groups, prevail troversies within the Tewish communities and between various Jewish leaders concerning the Kehillah problems. He hopes that the matter will enter a new stage of development after the new communities law will have been promulgated.

The Prime Minister admitted the probability that there are about 200.-000 Jews in Bukowina who were not granted Roumanian citizenship and are therefore in the status of "men without a country" suffering much hardship from this. He explained, how-ever, that this was not due to anti-Semitism. The general regulations obtaining in those districts complicate naturalization proceedings, but they are applicable to Jews and non-Jews alike. He expressed the hope that the new citizenship law will offer greater facilities for naturalization and will solve many of these problems.

The Prime Minister pointed out, not without satisfaction, that since his government is in power no anti-Semitic student disturbances occurred in Roumania. This is further proof of the maxim that freedom and order go well together. He made this statement in reply to the question whether there was any truth in the report that his government permitted the reopening of the Roumanian student organizations which were closed by the previ-ous Liberal government. The Prime Minister admitted that this was the fact, but explained that the dissolution
