ROUMANIAN PARLIAMENT TO VOTE ON RELIGIOUS LAW AS JEWISH LEADERS PROTEST Bill Given Priority on Calendar as an Urgent Motion

Bucharest, July 16—By a vote of the
majority, the Roumanian Parliament
declared the government bill for
amending the religious law, already
fassed by the Senate, "to be an urgent
motion," giving it priority on the calmark. An early vote on the bill is therefore expected.

This was done at the urging of the Minister of Religion. Jewish leaders in Roumania continue to protest against the bill. The National Club as well as the Union of Roumanian Jews in Bucharest, issued a call for protest meetings to be held.

BIALIK IN BERLIN; TO UNDERGO OPERATION (Tewish Telegraphic Agency)

Berlin, July 16-Chaim Nachman Berlin, July 10—Chaili Nachhall Blallk, the Hebrew poet, has arrived here and is at a Berlin hospital. Be-cause of his ill health, he has de-clined the invitation of Dr. Chaim Weizmann to address the Zionist Congrees and to attend the meeting of the Council of the Jewish Agency to which he was elected as one of the representatives of Palestine Jewry.

He will spend some time in the re-sort place, Wildungen. It was stated that the famous poet may have to undergo an operation.

TAKES LIFE IN MOSCOW (Jewish Telegraphic Agency)

Moscow, July 16—A young Jewish engineer named Kaplan, employed in the Soviet glass factory in Moscow, has committed suicide as the result of anti-Semitic persecutions. Novikov, the chief engineer of the factory, has been arrested and will be held for trial, on the charge that he was re-sponsible for the libels leading to the young man's act.

Kaplan, it is declared, was the victim of anti-Semitic acts on the part of the older engineers, who destroyed his laboratory preparations. It is al-leged that Novikov incited the workers against Kaplan.

Mr. Warburg, who served as chairman of the Committee of Seven. appointed by Louis Marshall, at the Non-Zionist Conference held in New York City on October 21, 1928, made public the list of those selected on the occasion of the sailing for Europe of Morris Rothenberg, acting President of the Zionist Organization of America, to attend the sixteenth Zionist Congress, which will have to finally approve the agreement between the Zionists and the non-Zionists for the formation of the Jewish Agency for Palestine, as provided in the Palestine Mandate. Three more delegates are to be named as, under the agreement, between Mr. Marshall and Dr. Chaim Weizmann, President of the World Zionist Organization, the American non-Zionists are entitled to 44 repre-sentatives. The non-Zionists of various European countries have named their representatives during the last several weeks, at special conferences convoked for that purpose.

Dr. Abram Simon

Dr. Abram Simon, who is a for-mer President of the Central Conmer President of the Central Conference of American Rabbis, is Rabbi of the Washington Hebrew Congregation since 1904, and a native of Nashville, Tennessee. He was born July 14, 1872. A graduate of Cincinnati University, he received the degree of Doctor of Hebrew Literature from Hebrew Union College, and the degree of Doctor of Philosophy from Nebraska and George Philosophy from Nebraska and George Washington University. From 1920 to 1923 he was the President of the Washington Board of Education. 1924 and 1925 he held the post of president of the Central Conference of American Rabbis. HUGO VON HOFFMANTHAL DIES; WAS BORN A JEW

(Tewish Telegraphic Agency)

Vienna, July 16-The sudden death of Hugo Von Hoffmansthal, who passed away while preparing to attend the funeral of his son who committed suicide, called forth recollections here of the Jewish origin of the German poet who was at one time hailed as the greatest German poet since Goethe.

Hoffmansthal, who was 55 years of age, was a descendant of Isaac Lowe Hoffman, a past president of the Jewish community of Vienna, who was elevated to the nobility in 1835. Hugo von Hoffsmanthal himself was born a Tew, but was converted to Christianity, as was his brother-in-law, the Dominican Father Schlesinger who still regards himself as of "Jewish nationality" and expresses pride in his Jewish origin. Jews in Middle East Countries Barred from Zionist Congress

Jerusalem, June 27—Jews of three countries in the Middle East are debarred from playing a part in Palestine reconstruction owing to restrictions imposed on Zionists, or non-recognition of the Zionist movement, it is learned here in connection with the election of delegates to the approaching Zurich Congress.

The governments declining so far to recognize Zionism are those of Turkey and Persia, while the recent quarrel among the Jews of Bagdad over the Chief Rabbi has had a somewhat paralyzing effect on the activities of Zionists in Iraq.

"Modesty Campaign" in Jerusalem

A "modesty campaign" reminiscent of the last century in Jerusalem is being waged by a delegation from Hungary which has come to Palestine to investigate the tangled affairs of the Hungarian Jewish Congregation in Jerusalem

Dr. David Lefkowitz

Dr. David Lefkowitz, of Dallas, Tex., was elected president of the Cen-tral Conference of American Rabbis at the annual convention of that body held several weeks ago in Detroit. He was born April 11, 1875 in Eperies, Hungary. He was educated in the City College of New York and the University of Cincinnati, and graduated from Hebrew Union College in 1900. He was the organizer and first president of the Southwestern Jewish Chautaugua.

Harold Hirsch

Harold Hirsch, of Atlanta, Ga., is an attorney and director of many business corporations. Sidney Hillman of New York is a Jewish labor leader. He was born in 1887 in Zagare, Lithuania, was educated in the Yeshiva of Slabodka and became president of the Amalgamated Clothing Workers of America in 1915.

Jacob Solis-Cohen

Jacob Solis Cohen, realtor of Philadelphia, is a member of the distinguished pioneer Jewish family among the first Jewish families to settle in the United States. He was born June 26, 1890 in Philadelphia. He takes an active interest in philanthropic work in Philadelphia. He is the author of a number of articles on real estate subjects in technical publications. He is affiliated with the Mikve Israel Sephardic congregation.

Meyer Elsasser

Meyer Elsasser of Los Angeles, Cal., is an engineer, and was born March 13, 1867 in Mobile, Alabama. He was educated at the University of California and has extensive experience in metallurgical, mining and land development projects in England, the United States and Mexico. He is the Presi-dent of the Merchants Finance Company of Los Angeles. He is a member of Temple Bnai Brith, Los Angeles. Solomon M. Stroock
