### DISMISS LITHUANIAN CHIEF OF POLICE FOR LAXITY IN PROTECTING JEWS Official Organ Now Retracts Denials of Outrages: Demands Guilty

Be Punished (Tewish Telegraphic Agency) Kovno, Aug. 21-From denial of the occurrence of anti-Jewish excesses to demanding severe punishment for those guilty of perpetrating the excesses at

Slobodka was the swift swing of the Lithuanian official government organ, "Lietuvas." In an editorial published yesterday the "Lietuvas" devotes much space to

the Slobodka occurrences and demands the severe punishment of those guilty. The newspaper states that the director of police, Staschkewitch, was dismissed from his post because he did not take sufficient measures to safe-

guard the population.

In Tewish circles this announcement has caused some surprise as Staschkewitch has been known as a friend of the Jews and it is believed that his dismissal has no connection with the Slobodka occurrences, since he returned on August 1 from his vacation, while the attacks were prepared dur-ing his absence. The representation of his dismissal as having connection with these occurrences is viewed here as a gesture of the government to whitewash its reputation.

#### PORT JOBS AGAIN OPEN TO JEWS IN CONSTANTINOPLE (Jewish Telegraphic Agency)

Constantinople, Aug. 21—The barring of non-Moslem Turks from employment on foreign ships in the Constantinople port has been stopped. They are again being allowed to work and it is understood that instructions are to be issued to the police against putting further obstacles in their way.

Jews, Turkish subjects, who were hitherto regularly employed in the port service, upon reporting for work on August 11th were prevented from entering by the police. Under the Turk-ish Constitution religious discrimination is not permissible.

#### HALL REFUSED FOR YIDDISH LECTURE

(Tewish Telegraphic Agency) Warsaw, Aug. 21-Learning that the lecture for which they rented their hall was to be delivered in Yiddish, the Hygienic Society of Warsaw withdrew the permit it had granted the Labor

Pro-Palestine League of Poland. The League hired the hall of the Hygienic Society for a lecture by A. Shiplacoff, American labor leader who arrived here after attending the sessions of the Jewish Agency Council in Zurich. The lecture had to be cancelled at the last minute because the Society refused to permit a Yiddish lecture on their premises.

## JERUSALEM POLICE CLASH WITH JEWISH FUNERAL PRO-CESSION: VICTIM OF ARAB ATTACK DIES

### 3 Seriously Injured, Several Arrested; British ond American Press Aroused Over Events: Wailing Wall Incidents International Scandal, Louis Lipsky Declares

Jerusalem, Aug. 21—Three persons Holy Place of the Jews, where they were seriously injured, 21 beaten, and have worshipped since time immemseveral were arrested, in a clash this jorial. morning between the British police of Jerusalem and a Jewish funeral proticinated

It was the funeral of Abraham Mizrachi, one of the victims of the anti-Jewish attacks by Arabs at various points in Jerusalem occurring since last Thursday. Mizrachi was stabbed Saturday afternoon near the Bukharin quarter. The news of his death spread rapidly among the Jewish population. The police, including many Arabs, were mobilized to guard order and, it was

stated, forced the procession to leave

the main road in order to prevent an

Arab-Jewish encounter.
Dr. Wolfgang von Weisl, correspondent of the Berlin "Vossische Zeitung," and a member of the Zionist Revisionist party, was arrested at the Jerusalem post office in an encounter with a sheik. He was released several hours later.

A speaker at the funeral exercises charged the Jerusalem police with failure to do its duty in protecting the Jewish population against assaults by Arabs.

Two new attacks on Jews occurred Tuesday afternoon in the Old City. One was seriously wounded and taken to a hospital. Two Arabs were arrested.

Sixteen Jews and 27 Arabs were Palestine." arrested by the police since the beginning of the agitation on Thursday, August 15, the day of Tisha B'Ab. Since then, 26 persons were wounded in the attacks. Among the wounded are 16 Arabs and 10 Jews. Of those arrested, seven Arabs and six Jews are still held by the authorities; the others were released on bail.

The police guard at the Wailing Wall has been extended since Sunday. A guard has always been on duty at the Wall during the day. Since Sunday a

night watch was added.

London, Aug. 21-The British press devotes much attention to the Jerusalem situation and the Arab assaults on Jews in connection with the Wailing Wall controversy. Notes of criticism of the British administration of Palestine are not missing in the editorial comments.

The "Evening Standard," in its Tuesday afternoon edition says editorially that apart from the question of dinance authorizing Zionist policy, the Wailing Wall is the law in Palestine.

"The trouble is that all the ground surrounding the Wall is occupied by Mohammedans. Nevertheless, under the Turkish rule, the Jews were un-molested. It should not be impossible for the British administration to secure

a similar freedom of worship,' The "Daily Telegraph," in its Wednesday morning edition, devotes a full column editorial to a discussion of the Wailing Wall position. The newsment for "following up a mistaken concession to the Jews, namely permission to demonstrate on Tisha B'Ab. with an equally mistaken concession to

the Arabs.

"A few more such examples of weakness, and the fires of religious hatred will be lighted, which will be difficult to extinguish," the paper says, ex-pressing its hope that action will be taken to avert the danger and to re-establish the old Jewish-Arab friend-"The Jews have enjoyed the right of worship at the Wall for thousands of years. It is the only Holy Place left to them. #### PEACE BODY PLANS SESSION IN JERUSALEM

(Tewish Telegraphic Agency)

Frankfort, Aug. 21—Jewish repre-sentatives from various countries are participating, together with Christians, Moslems and Buddists, in the sessions of the Universal Religious Peace Conference taking place here under the chairmanship of Shailer Matthews of Chicago.

Among the Jewish delegates are Dr. Stephen S. Wise of New York, Dr. J. H. Hertz, Chief Rabbi of Great Britain, Dr. David de Sola Pool, New York, and Senator Isaac Rubinstein, Chief Rabbi of Vilna.

The overwhelming sentiment among the delegates is that the next session of the conference be held in Jerusalem.

Nathan Straus, American Jewish philanthropist, in a message cabled to the Universal Religious Peace Conference in Frankfort, declared: world religious conference on international peace is an earnest of the dawn of the day when nation shall not lift up sword against nation, neither shall they learn war any more. For when men of all races and creeds come together and look each other in the eyes without fear or mistrust while proclaiming peace and brotherhood as the teaching of all their religions, there is achieved that recognition of world brotherhood out of which world peace can be born.

"I have been taught all my life that there is but one God and all men are equally His children and therefore brothers to one another. Now in the evening of my days I realize more fully than ever that all religions summon their followers to the same fel-lowship under the Fatherhood of God and the Brotherhood of Man. The day on which church, synagogue, mosque and temple shall unitedly refuse to sanction war for their followers will be the most glorious in the igious striving."

COLUMBIA UNIVERSITY SEEKS PROFESSOR TO OCCUPY JEWISH CHAIR

(Jewish Telegraphic Agency)

Berlin, Aug. 21—Negotiations in behalf of Columbia University with a view to securing a Jewish scholar to occupy the chair for the study of Jewish history, literature and institutions, established by Mrs. Nathan J. Miller of New York are being conducted here. An offer was made to Dr. Jacob Klatzkin, well known Hebrew scholar and philosopher, author of many books and essays and co-editor of the Eskol Encyclopedia (in Hebrew and German), but it was stated that he had declined to accept the post.

Negotiations have been started with Dr. Ismar Elbogen, one of the leading authorities in Germany on the "Wis-

authorities in Germany on the Wis-senschaft des Judentums."
Dr. Ismar Elbogen was born at Schildberg, Germany, September 1, 1874. He was educated by his uncle, Jacob Levy, author of the "Neuche-braisches Woerterbuch" and at the symnasium and the Jewish Theological Seminary in Breslau. He received his doctor's degree from the Breslau University. He obtained his rabbinical diploma in 1899 and was appointed lecturer on Biblical exegesis and Jewish history at the Collegio Rabbinico Italiano in Florence. In 1902 he became privat-docent at the Lehranstalt fur die Wissenschaft des Judentums, Ber-

Among his writings are: "Der Tractatus de Intellectus Emendatione und Lipsky Calls Incidents International tatus de Intellectus Emendatione und Seine Stellung Innerhalb der Phil-osophie Spinoza's," "In Commemorazi-one di S. D. Luzzatto," "Die Neueste Construction der Judischen Geschichte. and many other works.

Dr. Elbogen is a leading member of the Gesellschaft zur Foerderung der Wissenschaft des Judentums.

The chair for the study of Jewish history, literature and institutions was esthe proceeds of an endowment fund of the proceeds of an endowment and a \$250,000 provided by Mrs. Nathan J. Miller, New York. Dr. Nicholas Murray Butler, President of Columbia, in apparation the efft on October 15, announcing the gift on October 1928, declared that "no effort would be spared to secure for this chair the most distinguished scholar available, and that a special committee of members of the University had been entrusted with the duty of surveying the field at home and abroad and of making a suitable recommendation." He pointed out that with the instruction in religion already given at Columbia, with the array of courses in Christian history, literature and theology provided by the faculty of the Union Theological Seminary, and with the advanced program of research conducted in the various religions of the Orient, Mrs. Miller's gift would enable Columbia to make notable progress in the field of comparative religion.

### MANY JEWISH WOMEN AFFILIATED WITH EASTERN STAR IN WESTERN STATES

### Order's Funeral Ritual Outspokenly Christian, Chicago Rabbi Says; Urges Central Conference of American Rabbis to Take Action

Jewish women in New Jersey from the chapters of the Order of the Eastern Star in that state upon their dis-covery that the Order's ritual, made obligatory, places them in conflict with their profession of Judaism, is an issue of nation-wide signicance, is the burden of the argument made by Rabbi Gerson B. Levi, writing editorially in "The Reform Advocate" of Chicago.

Rabbi Levi bases his opinion on the character of the Eastern Star funeral ritual which he heard recited at the funerals of Jewish women who were

"When will it dawn on the minds of some of the Jewish women of the Middle West that their affiliation with the Eastern Star places them in an in-congruous and apologetic attitude. It has already dawned on the minds of some of their sisters in the East, who have, because of the ritual impossibilities of the Eastern Star, severed their connection with it. And no one who has heard the ritual of the Eastern Star at a funeral service can question the rightness of the action of the women of the Jewish faith who have rebelled against the outspoken Christian character of the ritual. We do not know the rituals of the closed meetings of the Eastern Star. If they are anything like the services that are read in public, or if in them the same characters appear and speak as do at the public funeral service of the Order, there is additional reason for the secession of the Jewish women from the Eastern Star.

"We do not know whether it was ignorance on the part of the Jewish women of their Judaism or of Christianity that left them so far unrebellious, or that the desire for companionality is the state of the st ionship with the larger circles of socalled non-sectarian groups that held them loyal to the Eastern Star. In the first case we think that the ignorance is blameworthy and in the second we think that companionship was being purchased at too high a price. If Jewish women had the least information about the characters that appear at the funeral services they would know that they are for the most part out of alignment with Jewish teaching on the subjects of life and death, and they would know that as-surances worded by one of the characters because of a supposed knowledge that she may have about something that might have happened some nineteen hundred years ago are not at all satisfactory or acceptable to Jewish thinking. It is true that quotations and references from the New Testament are not labelled as such, but honestly they ought to have quotation marks around them.

"We are not saying that the services are bad. They are good for Christion funerals, at which the listeners

The secession of a large number of may accept the truths that are being propounded. For them the truth is clinched by a quotation from the New Testament or by a saying Jesus.' But what can it possibly mean more than a mere mummery to have a family of mourners, Jews, comforted by quota-tions from a book that they do not believe in, and to tell the truth, if the quotation were made openly, would be scandalized. It is worse than mum-mery to have a good Jewish woman. who does not believe anything that she says of the ritual, impersonate a character upon whom she does not privately set the value that the book sets, and in the person of the character speaks words taken from a literature that she does not take to be final or binding at all. And surely when the service of the Eastern Star is given in conjunction with a Jewish service at which a Rabbi is bringing the message of his Judaism, and not of the blue points and other such, the Rabbi is tempted to say-Well, this is a funeral of a Jewish woman, the family is Jewish, the characters have been impersonated by Jews, is there not a situation here that must be cleared up at once? We cannot have both. This is neither fish, nor flesh, nor fowl, nor good salt herring.

"Of course, if the woman who is dead had been so good a Jewish woman, why did she join the Eastern Star? We beg to relate the question, why She having joined did she stay in? joined and her joining was easy to account for. She joined as many join secret organizations. She joined like many join the Ku Kluxers. If there is a secret to be known it is human nature to want to know it. A whole room filled with people may be chatting away very comfortably. Let there be a suggestion that in one corner of the room someone is telling a secret and the whole room will stop talking and listen for the secret. And so this woman joined the Eastern Star, and she will be the more likely to join it if her husband did not belong to a congregation. She has lost companionship with others who work in the fine lewish cause so she attaches herself to something anyway. She remains in because someone really has not pointed out to her the incongruity of the whole situation. We are pointing it out now, and we call for action on the part of the Jewish women of the Middle West that will parallel the action taken by the women of the Eastern States. The time has come when we must set the proper values to things and not deal too lightly with our Judaism. Surely the Christian members of the Eastern Star have taught us how to set value on the things that are to be believed and followed. They have resolutely refused to change their service from the Christian form to the non-sectarian.

Moscow, Aug. 5-"God went bankwas the pronouncement of the Jewish Communists of the town Vapniarke, Tultchin District, in resolving to convert the local synagogue into a factory. This is the first case in the Ukraine of a synagogue being turned into a factory.

A "Cherem," religious ban, was pronounced by the local rabbi against all those assisting in changing the syna-The Commugogue into a factory. nists, however, derided the ban.

The Zaratchi synagogue of Vitebsk was converted into a Jewish tailors' club. A red flag was substituted for the Parocheth, the curtain before the

Another synagogue, that in the small town Pyatigorsky, Belozerkov district, will be converted into a Kulturhaus by a decision of the local Com-

The danger that synagogues will be converted into offices exists in Zlatopole, Zaporozhje, the second self-governing Jewish district. It was de-clared that since the district requires buildings for government offices and the Communists are acquiring the synagogues, which are the best buildings, it was only right to utilize them for better purposes than the recital of the Psalm, Ashrei.

In the town Dunevetz, Kameniez district, a campaign was started against the local Melamdim, Hebrew teachers. In Dunevetz the Hebrew teachers are still active, some having more than thirty pupils. The local Yevsektzia therefore decided to conduct a drive against them.

The danger that the declassed Jews in some towns of the Ukraine will not be able to secure the food products they lack, even if they are willing to pay for them, was seen from reports received here.

The Soviet laws forbid declassed persons from becoming members of the cooperatives which now are the only source of supply, since private stores are disappearing. Until now the declassed bought their foodstuffs from private markets, paying a higher price. Now, in many towns, not a single private dealer remains and the declassed have no place to buy from.

The situation is so serious that local Jewish Communist leaders are appealing for a modification of the cooperative law to enable the cooperatives to sell to the declassed who, otherwise, are destined to starve or migrate. The Communists emphasize that even up to the present the declassed could not afford to pay the high prices to the private dealers. Now, however, the problem must be solved.
