Zionist General Council Sends Delegation to Paris to Pay Last Respects (Tewish Telegraphic Agency)

Zurich, Sept. 16-The body of Louis Marshall, accompanied by his son, lames, and other members of the family, was taken to France en route to the United States.

London, Sept. 16-The body of Louis Marshall will leave for the United States aboard the "Levinthan" sailing States aboard the "Leviathan," sailing tomorrow, it was understood here.

Motzkin, Victor Jacobson and M. M. Ussishkin, representing the Zionist General Council, have left for Paris to pay their last respects.

WEIZMANN POLICY FAILED. REVISIONISTS CHARGE;

Revisionist Executive Calls General Council Demands Inadequate (Jewish Telegraphic Agency)

Paris, Sept. 16—That the policy of Dr. Chaim Weizmann and his Executive in the Zionist movement has been "clearly demonstrated a complete fail-' is asserted in a statement issued by the Executive Committee of the World Union of Zionist Revisionists. The resignation of Dr. Weizmann and his committee is demanded in the statement, which declares the demands formulated by the Zionist General Council are "inadequate.

The Revisionist Union further states that it has abstained from demanding Weizmann's resignation because it was anxious to preserve Zionist unity but all proposals of the Revisionists for united action have been turned down on the ground that the Revisionists had declined to be represented on the Jew-

BELGRADE SEPHARDIC COMMUNITY HEAD DIES (Jewish Telegraphic Agency)

Belgrade, Jugoslavia, Sept. 16—Dr. Solomon Alkalay, president of the Sephardic Jewish community of Belgrade, died here today.

The late Dr. Alkalay was one of the leading gynecologists of Europe and rendered distinguished services as an army physician during the World War. He was president of the Jugoslavian section of the Sephardic World Organization and president of the Belgrade lodge of the Independent Order B'nai

With his brother, Rabbi Alkalay, Chief Rabbi of Jugoslavia, he was a delegate to the first Zionist Congress. He had always been an active Zionist worker.

The Jugoslavian press today contains many laudatory statements on the late Dr. Alkalay.

NEW UNEASINESS IN JERUSALEM AS CURFEW IS PARTIALLY LIFTED Jewish Agency Objects to Withdrawal of Troops Until Danger Entirely Passed

(Jewish Telegraphic Agency) Jerusalem, Sept. 16-Considerable uneasiness is felt in Jerusalem, especially in the Old City, tonight, the first night that the curiew has been partially lifted, being extended from 6 P. M. to 9 P. M. The uneasiness is felt owing to a report that Moslems warned Christians to chalk crosses on their houses to distinguish them from Jewish houses. The police authorities have minimized these rumors.

It is understood that the Tewish Agency is making strong representations against the reduction of troops in the country before the investigation is conducted by the Commission of Inquiry and the Jewish High Holidays have passed.

Jerusalem, Sept. 16-The reorganization of the military protection brought to Palestine by the British authorities, following the outbreak of the Arab riots, has created measiness in certain localities

The military authorities declared that the detachments will, from now on, be centralized at a few points, patrolling the country in mobile units instead of permanent patrols. Particular uneasiness was felt at Athlit where the Arab workers at the harbor excavation are in possession of explosive

London, Sept. 16-The misfortune which came to the home of Sir Herman Gollancz with the death by suicide of his son, Leonard, a week ago. remained to add to the grief of the aged rabbi and scholar. Lady Gollancz succumbed today to the stroke she suffered when she learned of her son's untimely death.

Sir Herman, who is seventy-seven years old, is lying seriously ill in a hospital. His wife's death is the third bereavement that has come to him in the last week. Several days ago his sister Emma died.

JEW NAMED PRESIDENT BUDAPEST SUPREME COURT (Iewish Telegraphic Agency)

Budanest, Sept. 16-Dr. Tibor Loew was appointed president of the Buda-pest Supreme Court. Dr. Loew is an observant Jew and is a prominent member of the Executive Committee of the Budapest Kehillah.

He is a descendant of the Maharal, the Rabbi of Prague, creator of the "Golem." according to legend.

MARMAGGI, PAPAL NUNCIO, RECOGNIZES JEWISH RIGHTS TO WAILING WALL

Views, Said to Be Shared by Pope, Expressed in Warsaw (Jewish Telegraphic Agency)

Warsaw, Sept. 16-The rights of the Jews to the Wailing Wall have been deciared as fully justified by historical and sentimental considerations in an interview granted to the press by here.

The Wailing Wall, he said, is the oldest historical relic of the Jewish race. The Nuncio spoke with sympathy of the Jewish work in Palestine and expressed the hope that peace will be established soon in the Holy Land which he said, contains many places which are deeply venerated by the entire Christian world.

This interview was welcomed by the lewish population here in view of the present situation in Palestine and particularly so since it is stated that these views are shared by the Vatican.

GRAND MUFTL SOUGHT ENTRANCE TO SYRIA DAY BEFORE PALESTINE RIOTS

Refused Visa: Purpose Either to Organize Demonstrations or Create Alibi

(Tewish Telegraphic Agency)

Jerusalem, Sept. 16-The correspond-ent of the Jewish Telegraphic Agency here learns that the Grand Mufti of Palestine applied for a visa to Syria the day before the riots occurred in lerusalem The application of the Mufti was refused by the French Consulate here owing, probably to the Mufti's participation in inciting Syrian Moslems against the French.

The object of the Mufti's frustrated mission to Syria, it is believed, was either to organize the demonstrations which occurred in Damascus and were suppressed by the French, or to establish an alibi during the disorders.

CONAN DOYLE SUES SLATER FOR £250 ADVANCED BY HIM (Jewish Telegraphic Agency)

London, Sept. 16-A piquant quarrel whose setting is in the British courts, is now in progress between Oscar Slater, who was released recently after eighteen years imprisonment on a murder charge, and Sir Arthur Conan Doyle, one of the principal protago-nists in the fight for his release during that entire period.

Conan Doyle has initiated court proceedings to recover 250 pounds from Slater. Conan Dovle guaranteed 1,000 pounds to defray the expenses of Slater's trial, 700 pounds of which were raised through subscriptions among the Jews. Despite the fact that Slater received 6,000 pounds, he has refused to pay the balance due Doyle.

AGUDATH-ISRAFI CONCRESS DECIDES NOT TO JOIN JEWISH AGENCY AS LONG AS IT INCLUDES CULTURAL WORK IN ITS PROGRAM

Appeals for Limiting Agency Work to Political and Economic Questions; "Unbelieving" Zionists and Non-Zionists Rebuked

(Jewish Telegraphic Agency)

Vienna. Sept. Jewish masses in Eastern and Central Europe insofar as they are represented by the Agudath Israel will not join the extended Jewish Agency for Palestine as long as this body will include in its program cultural and educational work in Palestine. A decision to this effect was reaffirmed by the Agudath Israel World Congress in session here at its world Congress in session here at its meeting Sunday afternoon, when the matter came up. The delegates, while standing, accepted with applause the report submitted by Jacob Rosenheim of Frankfort, one of the leaders of the Agudath Israel, containing the opinion of the Rabbinical Council, the supreme body of the organization, declaring that the Agudath Israel will not join in the extended Jewish Agency be-cause the Agency includes in its work cultural and educational activities to which the Orthodox leaders cannot agree and which they cannot support in accordance with their religious convic-The resolution further declared that

hitherto the Jewish Agency has taken no steps to secure the cooperation of the Agudath Israel. In view, however, of the shattering events in Palestine, the Agudath Israel Congress appeals for the last time to "our berthren of the Jewish Agency" to take into consideration the conscientious objections of the Orthodox Jewish masses and by limiting the jurisdiction of the Jewish Agency to economic and political questions, without extending support to cultural activities, enable Agudah members to participate in the economic and political tasks of the Agency. The Agudath Israel would be ready to join the Tewish Agency if it should be transformed into a neutral body on religious questions with guarantees that the re-ligious laws will be respected. As long as this has not occurred and the Agudath Israel is outside of the Jewish Agency, the Agency cannot be regard-as representing in Palestine the Orthodox Jewish masses. At the same time the Agudath Israel considers it as a sacred religious duty to appeal to its membership to pursue and continue with devotion the work for the up-building of Palestine in accordance with the Commandment of Yishub Eretz Israel.

Dr. Pinchas Kohn, president of the Organization, sharply criticized the Zionists and the present form of the extended Jewish Agency, which, he said, represents "a Torah-less people and a Torah-less country." In a similar vein were the addresses of Rabbi Sankiewicz, who stated he spoke in the name of twenty-three Palestine rabbis. and of other rabbis, delegates from various countries, who arraigned the "Apikorsim" (unbelieving) Zionists and non-Zionists.

16-The Orthodox with what seemed to be unanimity, there were many delegates who continued to urge another approach to the question. In particular, Rabbi the question. In particular, Kauber Neustadt appealed against "politics" in relation to Palestine and cooperation with the Agency. He was interrupted by other delegates who stated that the speaker is perhaps no Zionist, but he is also not an Agudist.

During the discussion on Palestine. Rabbis Horowitz and Blau of Jerusalem reported on the situation in Palestine. They described the Arab atrocities and read messages concerning the situation there, emphasizing that the lewish population, without regard to group, defended Jewish honor. They laid emphasis on the need for increasing the work of the Agudah in Palestine just because it is probable that the organization will not participate in the Jewish Agency. The delegates Ehr-mann, Wrescher and Hollaender also demanded an increase of Palestine work and urged the creation of an Agudah bank in Palestine.

The Congress also concerned itself with the question of the Agunoth, the Rabbinical Council submitting a resolution expressing its readiness to institute research into the religious law to solve the question of those women whose husbands have disappeared and who cannot remarry without a divorce or concrete evidence of the husband's Monday afternoon the Congress discussed organization and fin-ance questions. ASKS EXTENSION OF TIME LIMIT TO PRESENT CLAIMS

FOR LOSS IN ARAB ATTACKS Jewish Legal Commission States One Month Time Limit Too Short

Jerusalem, Sept. 16—The one month time limit for the presentation of claims for losses suffered during the Arab outbreak is considered too short by the Jewish legal commission here and it is understood that the commission has made representations to the Attorney General for an extension of

It is physically impossible to lodge all claims for compensation within this period in many cases, such as those of the seriously wounded of Hebron, it is pointed out. It is understood that the government is reluctant to extend the time in order that the proceedings shall not be drawn out, but it is intimated that claims in special cases will be accepted later.

RAID VILLAGES IN SEARCH FOR LOOT

(Jewish Telegraphic Agency)

Jerusalem, Sept. 16—A military de-tachment led by Harrington, superin-tendent of the Jerusalem police, this morning raided Teiba and other neighboring villages, searching for loot. Teiba is situated thirty kilometers north of Jerusalem and is believed to be the concentration point of Bedouins from across the Jordan, suspected as among the attackers of Ataroth and other Jewish settlements. A fight between Bedouins and mili-

tary patrols in northern Palestine, near Hattin, resulted in sixteen dead and many wounded among the Arabs. They were dispersed, and cattle stolen from Jewish settlements recovered.

MANDATORY POWER'S FULL COOPERATION FOR PALESTINE PEACE AND RECONSTRUCTION WORK DEMANDED BY JEWISH LEADERS

Impressive Meeting Held in New York Sunday; Memory of Louis Marshall Honored; Warburg, Lipsky, Wise and Others Speak; British Attitude Called Vacillating; Charge Balfour Declaration Turned into Scrap of Paper by Luke: Demand Dismissal of Luke and Keith-Roach

The full cooperation of Great Brit-I ain as the Mandatory Power for Palestine in the restoration of peace and the continuation of peaceful reconstruction work in Palestine was the keynote of addresses delivered by Zionists and non-Zionists at a meeting held Sunday at Town Hall, New York City, under the auspices of the Zionist Organization of America, on the occasion of the return of the Jewish Agency leaders to the United States. The memory of Louis Marshall was honored at the meeting, where much of the proceedings were devoted to tributes to the late leader.

Two thousand were present, and about three thousand were unable to

gain admittance.

Unusual interest was aroused in the meeting due to the fact that this is in Palestine took place that the leaders of Zionism in America have had an opportunity to give their views to the American Jewish public. All those who spoke at the meeting were in London durnig that time, participating in the political negotiations with the British Government. Mr. Lipsky, Dr. Wise and Mr. Warburg returned from Europe last week.

...Among others who spoke at the meeting were Herman Bernstein, who presided, Moris Rothenberg, vice-president of the Zionist Organization, Judge William M. Lewis of Philadel-phia, chairman of the United Palestine Appeal, and Judge Bernard A. Rosen-

blatt.

During the course of the meeting, a cablegram was read from Gershon Agronsky, representative of the Zionist Organization of American in Jerusalem, which gave high praise to Paul Knabenshue, United States Consul-General in Palestine, for his cooperation with American-Jewish citizens during the riots.

In his speech opening the meeting, Mr. Bernstein paid tribute to Louis Marshall, of whom he said that "all American Israel mourns this great leader, whose death is an irreparable loss to all world Jewry." The audience then rose in memory of the departed leader.

Tragedy in Palestine Challenge to Civilization

"The tragedy that befell the Jewish people in Palestine," Mr. Bernstein said, "is a challenge to civilization. It is particularly a challenge to Great Britain, who solemnly gave the Bal-four Declaration to the Jewish people and upon that basis solemnly took the Mandate over Palestine from the League of Nations, with the approval of America and the sympathetic endorsements of the American Presidents-from the great idealist, Woodrow Wilson, to the great humanitarian, Herbert Hoover."

Mr. Bernstein then introduced Mor- II would say that he was unfit to be ris Rothenberg, who returned on the S. S. Berengaria on Friday. In a speech which was greeted with frequent applause as he demanded the removal of a number of Palestine of-ficials. Mr. Rothenberg said in part as follows:

"It seems unbelievable that the Iews who came into Palestine with the word Shalom (peace) on their line, who carried out their work molesting no one. bringing health and healing into the land; who opened their hospitals, their clinics to Arab children, curing them of blinding diseases, whose doctors and nurses delivered Arab wives of their newly-born and taught Arab mothers hygienic standards in the caring of their youth; who rid the infected water supply of Palestine from fever, who caused new schools to be opened, and who enriched the Arabs through land purchases, that those Jews should have been foully murdered by those whom they aided.

"But can we spare him? No. Can we do without him? We must try! Not one man nor a few can take and fill his place, but in unity is strength, and if we want to be worthy of his leadership, his ideals, his confidence, his friendship, we can only do one thing: carry on the causes that were dear to him.

"It is too bad that coinciding with his sickness, so unexpected but unavoidable, that other blow should have struck us, the terrible, cruel blow of vicious violence in Palestine. Dear Marshall, death was unavoidable. What self-sacrificnig medical care could do. Dr. Libman and his colleagues and friends have done, and we thank them heartily.

for the Promotion of Aeronautics, to succeed Noble Brandon Judah of Chi-cago as Ambassador to Cuba. Mr. Guggenheim, who is a graduate of Pembroke College, Cambridge, Eng-

land, was a member of the Committee of Experts which met in Brussels in February 1927 to study the economic consequences of any limitation of air armament which would include civil aeronautics. In 1928 he served as the United States delegate on the Inter-American Commission of Commercial Aviation at the third Pan-American conference held in Washington.

The son of Daniel Guggenheim, he is President of the Daniel Guggenheim Fund for the Promotion of Aeronautics founded by his father in 1926 with a \$2,500,000 grant. The fund which has been active in almost every phase of aeronautics has given more than \$1,200,000 to various universities and engineering societies for academic instruction and for research in aeronautical problems.

Mr. Guggenheim was an official and director in several copper companies from 1913 to 1923 and from 1916 to 1923, a member of the firm of Guggenheim Brothers.

During the war he served as naval aviator in the foreign service of the United States Aviation Forces in France, England and Italy, with the rank of Lieutenant Commander. He is a member of the American Society of International Law and of the Ameri-can Institute for Mining Engineers. He is forty years old.

SOVIET PROCLAIMS COLLECT-IZATION DAY OCT. 4: CO-INCIDES WITH YOM KIPPUR

Jewish Section of Communist Party Urges Colonists to Be at the Tractor on Yom Kippur

(Tewish Telegraphic Agency) Moscow Sept 16-While Jewish workers were urged to observe a special industrialization day on the second day of the Jewish New Year, the Jewish colonists are to observe a "collectivization day" on Yom Kippur. A proclamation of the government declared October 14 as "collectivization for the entire country. All work-

ers are to be in the fields on that day. The Jewish Section of the Communist Party, which conducts propaganda against the Jewish religion, issued a proclamation to the Jewish colonists urging the colonists "not to make any ceremonies and to be at the tractor on Yom Kippur."

Under a seven column headline: "Against God, Yom Kippur for Collectivization," the "Emes," Communist Yiddish daily, devotes a full page to its anti-holiday campaign, calling for the conversation of more synagogues into workmen's clubs.

When an anti-religious demonstration with 5,000 participating took place in Kiev, a proclamation was issued declaring: "Brothers, Jews, a pogrom is being prepared in Kiev. Down with anti-Semitism. Hands off the Jews."

The proclamation was signed by the Ozet, Jewish society for land settle-ment. The Jewish Communists, however, maintain that the Zionists and not the Ozet issued the call, desiring to bring about clashes at the demonstration, which passed peacefully, the marchers proceeding to the Petroysk synagogue, which they occupied with their Red banners.

Moscow, Sept. 16-Jewish workers in the shoe factory in Briansk broke up a meeting and precipitated a fight when the question of working Rosh Hashonah and Yom Kippur, the earnings to go to the Bira Bidjan fund, arose. While the factory administration remained neutral, a group of religiously inclined workers attacked the atheists.

Reports indicate that the anti-religious campaign in Russia will fail, due to the inability of the provincial Com-munists to organize. This is indicated munists to organize. This is indicated even by the "Emes," Moscow Communist Yiddish daily.

ARREST ZIONISTS IN SOVIET RUSSIA (Jewish Telegraphic Agency)

Moscow, Sept. 16-The functioning of a Zionist organization in Yevpa-toria was discovered with the result that many members were arrested. The prisoners were accused of carrying on anti-Soviet activities.

Abraham Kinkin, 64 years old, was arrested and sentenced to three months in jail by the Klinzer Jewish Court for conducting a Cheder. Zusic Tusman was sentenced by the same court to a 300 rouble fine on a similar charge.

IT IS AFFECTED BY SINO-RUSSIAN WAR

BIDJAN COLONY DENIES

Jewish Bank and Kassas Bankrupt in Harbin, Soviet Reports: Tenseness Among Jews

(Tewish Telegraphic Agency) Moscow. Sept. 16-A quieting tele-

gram signed by ninety-three Jews, the entire colony of Amurzet in Bidian has been received here by the Ozet in which denial is made that the Sino-Russian conflict has affected the colony.

Amurzet is so near the Manchurian border that Jewish settlers can see the Chinese. The colonists left the settlement a few days ago, fearing the warfare. Every one has now returned and is continuing the field work. "We feel calm, please do not believe rumors," the telegram states.

Moscow, Sept. 16-The Jewish bank and all Jewish kassas in Harbin are bankrupt, a Soviet report here states. The difficulties, it is declared, are due to the liquidation of the Far Eastern Bank controlled by the Soviet which supplied the Jewish kassas with credit.

Shareholders and depositors are besieging the doors of the bank for money. Tens of thousands of dollars will be lost, it is anticipated.

Nervousness and tensity pervades the Jewish community in Harbin. The Jews are afraid that pogroms are inevitable if the White Army evacuates the city before the Red Army enters. Such an eventuality is anticipated in Harbin if the Sino-Russian dispute is not settled soon.

EMERGENCY FUND

TOTALS \$1,074,322

Contributions totalling \$1,074,322 have so far been received by the Palestine Emergency Fund, the headquar-ters of the Fund announced.

Jewish refugees numbering 8,360 are being cared for by the central relief committee in Jerusalem, until such time as the Palestine authorities can guarantee that the towns and colonies from which they fled during the Arab riots are adequately safeguarded against further outbreaks.

Col. Frederick H. Kisch informed David A. Brown, that a reconstruction committee has been set up which is functioning separately from the relief committee. One of the first projects taken up by the reconstruction committee is the provisional establishment in Jerusalem of the Hebron Yeshiva. He added that the Vaad Leumi-the Jewish National Council of Palestinehad agreed with the Emergency Fund Committee not to sanction any separate appeals for funds being made in America or elsewhere by any Palestine institution.

Mr. Brown explained that this action had been made necessary because of the large number of cables from Palestine institutions, other than those maintained by the Zionists, to the Emergency Fund Committee, for special appropriations.

LIFTA ARABS HOLD GRAND MUFTI RESPONSIBLE FOR THREATENED BANKRUPTCY

Quarrying at Standstill Due to Stop of Jewish Building; Demand Mufti Supply Money or Work (Jewish Telegraphic Agency)

Jerusalem, Sept. 16-The Arabs of Lifta, the first village to attack the Jews of Jerusalem, Motza and other towns, will look to the Grand Mufti to provide money or employment, according to trustworthy accounts of a meeting held on Friday. Quarrying, which was one of Lifta's

principal occupations, is at a standstill, owing to the temporary cessation of the Jewish building industry. The Lifta villagers now hold the Grand Mufti responsible for their threatened bankruptcy, he presumably having urged them to precipitate the attack.

Opposition among the Moslem Arabs to the Grand Mufti is spreading to other towns. The Moslems of Gaza are preparing a memorandum to be submitted to the government against the head of the Moslem Supreme Council.

The Arab delegation which was to have gone to London will not proceed there until the arrival of the Commission of Inquiry, according to the Arab

HONDURAS ARABS PROTEST 'MASSACRE" OF BRETHREN (Jewish Telegraphic Agency)

San Pedrosula, Honduras, Sept. 16-The Sociedad Union Palestina of this city has registered its protest against the "massacres" perpetrated against the Arabs of Palestine in the following proclamation issued under the signaprocumation issued under the signature of its President, Jacobo D. Kattan, and Secretary, Elias C. Juya:
"In the name of justice we protest

energetically against the massacre of all our Arab brethren in Palestine and we strengthen their attitude against the Jewish invasion and pretense and demand the annulment of the Balfour promise."

The protest has been forwarded to the League of Nations, Prime Minister MacDonald of England, the High Commissioner of Palestine and King Fuad of Egypt.

Mexican Jews Hold Protest Meeting Mexico City, Sept. 16-All Jewish organizations here participated in a mass meeting Thursday evening to protest the massacre of the Jews in Palestine.

Resolutions were adopted in which England was criticized and its laxness charged with responsibility for the occurrences.

MERCHANTS ATTEMPT TO END MUTUAL ARAB JEWISH BOYCOTT

Executive to Bring in All Chaluzim Holding Immigration Certificates (Jewish Telegraphic Agency) Jerusalem, Sept. 16-Attempts to

bring about an end to the mutual Arab-Jewish boycott are being undertaken by merchants here. A prominent Jewish merchant applied to the Zionist Executive to arrange an urgent conference on the present commercial situation in the country.

Jerusalem, Sept. 16-The Zionist Executive has decided to bring into the country within a few weeks all Chaluzim, pioneers, who are now in possession of immigration certificates. They number between seven and eight hundred. A special fund will be obtained for this purpose.

42 JEWS HELD IN ACRE

ON MURDER CHARGE (Jewish Telegraphic Agency) Jerusalem, Sept. 16-Charged with murder by premeditated shooting, forty-four Jews have been imprisoned in the citadel of Acre, where Vladimir Jabotinsky and nineteen of his co-de-fenders of Jerusalem were confined in 1920. Their release on bail is impossible before a magistrate decides under which charge they shall be held.

This forty-four men were captured in the flour mill of Haifa during the riote They are reported to be in excellent

spirits and do not complain against the ill treatment which they suffer at the hands of the wardens. They are being supplied with food by the workers of the Haifa kitchen.

PRESENTS PLANS FOR CONSOL!-DATING TEL AVIV FINANCES (Jewish Telegraphic Agency)

Tel Aviv, Sept. 16-The full plan for consolidating the finances of Tel Aviv was presented by Acting Mayor Rokah of Tel Aviv to the Town Council last night.

The Palestine government is writing off the municipality's indebtedness of £75,000, the Palestine Executive £60,000

and the Hadassah £1,000. The Anglo-Palestine Company is likewise cancelling £8,000 owing it in

interest for a loan. The Council will also receive a loan from the government of £40,000, to be repaid within seven years at 6½ per cent interest and a loan from the Anglo-Palestine Company of £50,000 at 6 per cent, repayable in ten years. Urgent debts of the Town Council are being discharged with these sums.

WARN SHEIKS WILL BE HELD RESPONSIBLE FOR VIOLENCE OR ROBBERY OF JEWS

"Doar Ha'Yom" to Resume Publica-tion; Two Arab Dailies Barred from Mails (Tewish Telegraphic Agency)

Jerusalem, Sept. 16—Sheiks of the quarters of the Old City neighboring the Jewish quarters will be held responsible for any violence or robbery against the Jews declared District Roach, to a delegation of the Vaad Leumi, National Council of Palestine The District Commissioner advised

the Jews of the Georgian quarter, where the assault began on August 23 to return to their homes in view of the protection afforded by the police post near the Damascus Gate. Mr. Keith-Roach said he was unable

to promise patrols in other parts of the city before the arrival of the new British constables, but he undertook to break up the boycott propaganda conducted by the Arab youth in front of Jewish shops. It is understood the "Doar Ha'vom" will probably be permitted to appear

on Tuesday, following representations made by the Zionist Executive that the poem by Reuveni appeared in the paper before the editors agreed to refrain from publication of articles and other material likely to prolong the conflict. The government barred from the

mails of Palestine two provocative Arab dailies, "El Shura" and "El Ah-rar." One of the papers is published in Egypt, the other in Syria.

Dismissal of Norman Bentwich, high-

est Jewish official in the Palestine government, is demanded by the Arabs of Nablus in a memorandum to the High Commissioner urging the appointment of a non-Jew in his stead. Mr. Bentwich is a member of the Government Executive Council.

TO EMPLOY JEWISH LABOR IN ROAD CONSTRUCTION (Jewish Telegraphic Agency)

Jerusalem, Sept. 16-Jewish labor will be employed in the construction of roads which are being undertaken by the Department of Public Works.

The Director of Public Works con-

firmed to the representatives of the Zionist Executive that the road north of Petach Tikvah, the Mescha-Afula Road and the Hadar Ha'Carmel Road will be constructed by Jewish labor.

CALL MEETING TO AID ARAB JEWISH CONCILIATION (Jewish Telegraphic Agency)

Paris, Sept. 16-"Peace in Palestine and a Jewish-Arab reconciliation" is the aim of a meeting called for Tuesday by the International Anti-anti-Semitic League, of which Prof. Albert Einstein is honorary president and Bernard Lecache, chairman.

Placards posted urge "all free men, everyone who loves Jews and Arabs" to come. Speakers will be Ferdinand Buisson, chairman of Parliament; Pro-fessor Langevin, Pierre Bonardi, journalist, and Daladier, radical leader.

PROMPT POLICE ACTION PREVENTED UPRISING OF TRANSJORDANIAN TRIBES Sheik, Seeking Mufti, Invited to Coffee

at Police Station and Kept 8 Days (Jewish Telegraphic Agency)

Jerusalem, Sept. 16-A possible uprising of the Transjordanian tribes was prevented in the early days of the Palestine disturbances by the prompt action of the Jerusalem police, according to a circustantial account obtained by the Jewish Telegraphic Agency today from authoritative sources.

Mithgal Pasha, leading sheik of the Ben Sakhr tribe in Transjordania, ac-companied by the President of the Moslem Supreme Council, Amin, and a number of other sheiks, was seen in the Old City the day the riots broke out. They were asked by a police officer whither they were bound and Mithgal Pasha said: "To see the Mufti."

Thereupon the police officer "in-vited" him to have coffee at the police station, where Mithgal and his party remained eight days, until the authorities considered it safe to return him to Transjordania. His son, becoming anxious, proceeded toward Amman, accompanied by 150 riders, fifty on horses and 100 on camels, demanding to know where his father was. He gave no trouble when he was told his father would be released in due course.

A report received here from Cairo states that a group of 200 prominent Egyptian Arabs are preparing to come to Palestine for the purpose of bringing about a reconciliation between the Jews and the Arabs. Among the Egyptian Arabs, there is reported to be a growing feeling of dissatisfac-tion with the Grand Mufti of Jerusalem who is held responsible, by the Egyptian leaders, for the Palestine troubles. Dissatisfaction is also expressed by the Egyptians with the alleged failure of the Grand Mufti to fully account for funds raised there for the purpose of repairing the Mosque of Omar.

A Hebrew supplement to the "Pal-estine Weekly," an English publication, was confiscated by the authorities vesterday. The supplement contained an open letter to the High Commissioner by Ittamar Ben Avi, Hebrew publicist and co-editor of the "Doar Ha'vom," the Jerusalem Hebrew daily which was suspended by the government, complaining against its suppression. It was reported that the Palestine authorities contemplate action against the writer.

The Jaffa police officer, Nassar, to whom Jewish lawyers objected as an investigator, was ordered to suspend his investigations.

Jerusalem, Sept. 16-The steamer "Asia" arrived at Jaffa this morning, bringing 205 Chaluzim immigrants, and returning residents. Among the 205 are 94 pioneers, 42 immigrants, 32 tourists and 37 returning residents.

American citizens who have sustained losses as a consequence of the disturbances may deem it desirable to obtain the services of local attorneys in connection with the preparation and pre-sentation of their claims to the commissioner.

The Department of State will supply such American citizens with a list of attorneys in Jerusalem, Jaffa, Tel Aviv or Haifa whom the department believes to be reputable attorneys.

standing that we expect to build Palestine to the glory of Jewish life and the benefit of the world.

"But that does not mean that a policy of peace should be built upon the giving away of rights, upon excessive acquiescence in unfair demands, or in not being prepared to take up arms vigorously in self-defense. "Great Britain has at no time vig-

orously defended the justice and right contained in the purposes of the Mandate. It never attempted to justify the Jewish National Home in a public manner. It expected to muddle through with compromise, concession and evasion with the hope that in the process of time the distorted picture of intention would assume equitable form.

"It is against this policy that we protest. The lesson of the disorders is plain. The Mandatory Government must begin over again frankly and honestly. It is called upon to make the Mandate a force for the reality of the Jewish National Home, Words will not comfort or encourage us. It is a change of heart and of courage that is demanded of that great Power which, under the leadership of that distinguished statesman, Lord Balfour, achieved a new lustre in history when it issued the declaration in favor of the Jewish National Home.

"The time has come for us to say to Great Britain, if the Mandate means a National Home, tell it to the Arabs not to the Jews.

"The Mandate given under the aegis of Balfour has become a Mandate to be given to Mr. Luke, to be crumpled up and thrown aside.
"The Jewish people register their

protest not only in Downing Street but in Washington and Geneva against turning the mandate into a scrap of paper. I am sure when we show the facts, the justice of our acts, of our intentions, the good we are building there is no civilized nation which will fail to say to Great Britain; 'Come to the bar and defend yourself against this just indictment of your actions.'

Cable Lauds Services af U. S. Consul

A cablegram was then read by the chairman which had just arrived from derusalem, which evoked tremendous applause when high praise was given to Paul Knabeashue, United States Consul-General in Palestine, for his cooperation with American Jewish citizens in the Holy Land.

The cablegram was sent by Gershon Agronsky, representative of the Zionist Organization of America, who denied that Mr. Knabenshue had not been entirely helpful during the crisis in Palestine and said that the Consul-General deserved a vote of gratitude

from the Jewish people.

The cable reads in part as follows: "The United States Consul General was extremely helpful during the crisis in Palestine and showed an acute awareness of the gravity of the situation which he repeatedly reported to Washington. He did everything in his

power to protect American nationals. to which end he initiated a joint action with the consular corps which resulted in the restoration of telephones to the consulates, which the authorities had first allowed to be cut off.

"Mr. Knabenshue's own position is best shown by the fact that the Consulate was unguarded until the third or fourth day of the riots. In one instance when the Consul brought back from Haifa thirty boys attending the Biram School, which included fourteen Americans on an excursion to Metullah. the Consul displayed energy, resourcefulness and knowledge of threatened danger. He did all in his power to protect and assist two thousand American citizens throughout the

Judge Bernard A. Rosenblatt was the next speaker who described the Balfour Declaration as "a holy contract" between the Jewish people and Great Britain, which the justice-loving British people would never dishonor. He declared that the Jewish Legion which had fought under General Allenby had helped give the Arabs seven-eighths of the land of Palestine and all that the Jewish people were asking for their share in the recapture of the land from the Turks was the opportunity to develop the land to the mutual advantage of Jews and Arabs.

Wise Calls for Investigation of Palestine Officials

The final speaker on the program was Dr. Stephen S. Wise, Rabbi of the Free Synagogue, who was given a huge ovation when he went to the rostrum. During the course of his speech, in which Dr. Wise said that there must not be an investigation of the recent Palestine riots by the Palestine Government but an investigation of the Palestine Government officials themselves, Dr. Wise declared:

"If they have not lost faith in Pal-

estine, shall we lose heart in the Diaspora? That is the question we are asked to ask ourselves at this mo-

"Certain things must be made clear, I am tempted to believe that they have been made clear this afternoon. There have been no 'disorders' in Palestine, unless disorders is used in a new sense. There has been no race war' in Palestine. There have been attacks and assaults; there have been mutilations; there has been violence and there has been destruction. It is possible for us to say that all this has been made possible by a negative, neutral, non-cooperative attitude of the British Government which has been twisted and tortured by the Palestine Government into sanction and acquiescence in anything that the wrongful leaders-and only some leaders-of the Arabs have chosen to do.

"There was no offending on the part of the Jews. The offense came from some Arabs. The offending came from a gentleman whom I refer to as his unholiness, the Mufti of Jerusalem, and finally from the Palestine Government which was charged with responsibility

by Arabs. The answer to Arab deci-mation is Jewish immigration. There must be no investigation by the Palestine Government. "The 'Daily Mail' tells Great Britain to give up the Mandate. The Mandate for Palestine has not cost Great Britain one shilling. On the contrary we Jews are paying year by year, instalments of the pre-war Turkish debt. We have an answer to make to the 'Daily Mail' and to the 'Daily Express. You say to England: Give up the Mandate. We answer: You, England, dare not give up the Mandate. England made a covenant with the Jewish people; England made a covenant with the League of Nations; England made a covenant with honor itself when she took upon herself the Mandatory for Great Britain. To abandon the Mandate now would be fatal to the prestige of Great Britain.' "An Arab Palestine is a threat to

Great Britain and the world. A Jew-ish Palestine is an asset to Great Britain and the world.

In concluding, Dr. Wise paid tribute

to the late Louis Marshall, of whom he said: "No more devoted, passionately loyal,

greater Jew has lived in generations you and say as I conclude: Let the valiant, the unwithstandable spirit of Marshall guide us that we may be just, that we may be wise, and deal self-respectingly with our problem and remember whatever else happens; Israel lives and Zion will become the Jewish National Home."

ish Agency. The Zionist General Council also adopted a program of political demands which has "eliminated the most essential requirements" re-jecting the demand for Jewish military and police units and for a free Jewish immigration to the country.
