## COMMISSION OF INQUIRY HOLDS MEETING PRIOR TO SAILING FOR PALESTINE

Meetings of Commission Will Not Be  
Public, But Communiques Will  
Be Issued

(Jewish Telegraphic Agency)

London, Sept. 24—The British Parliamentary Commission of Inquiry, appointed by the Colonial Office to investigate the causes of the recent outbreak in Palestine, held a meeting here on Monday prior to its departure for Palestine on October 3.

The diplomatic correspondent of the Jewish Telegraphic Agency understands that the meeting was confined to a consideration of the question of procedure and that questions of policy were not dealt with. It appears that the question of procedure is considered sufficiently intricate and it is stated that the Commission decided that the British officials in Palestine first collect the evidence which will be placed before the Commission on its arrival. When the Commission will start functioning in Palestine, evidence will again be taken from both Jewish and Arab sources. The preliminary collecting of evidence was found necessary in order to secure first hand information as near the date of occurrence as possible. The meetings of the Commission will not be public, but communiques will be issued from time to time, it being anticipated that the Commission will make declarations while still in Palestine.

While the terms of reference of the Commission are necessarily confined

## POLISH SYNDICATE BUYS PALESTINE TOBACCO

Warsaw, Sept. 24—The Polish tobacco monopoly purchased the entire tobacco crop of the Jewish colony Rosh Pinah, Galilee, according to an announcement made here by Mr. Barsilai, president of the Upper Galilee tobacco syndicate, who is now here.

The crop amounts to 5,000 kilo. Mr. Barsilai expressed the hope that the Polish syndicate will purchase 100,000 kilo next year, it being convinced of the high quality of the Palestine tobacco.

## ANNOUNCE COLLECTIVIZA- TION DAY ON YOM KIPPUR

## THOUSANDS IN SOLEMN TRIBUTE TO LOUIS MARSHALL AT SIMPLE FUNERAL SERVICES

Four Thousand Fill Temple Emanu-El While Same Number Unable to Gain  
Admittance; Funeral Rites Consist of Three Prayers by Rabbis of the  
Temple; Outstanding Jewish and Non-Jewish Leaders Attend

American Jewry, joined by city and state officials, and leaders of the American bar, paid its last tribute yesterday to Louis Marshall. Four thousand men and women, representing a cross section of Jewish life in New York and America, filled Temple Emanu-El, to pay their last respects, while a group equal in number, stood for two hours outside the Temple, unable to gain admittance.

A detail of one hundred police, under the personal direction of Police Commissioner Whalen, were required to handle the crowd.

The men and women who had known Louis Marshall personally and shared in his varied activities, were there; the high and mighty of New York City and State, the Lieutenant-Governor of New York, Herbert H. Lehman, former Governor Alfred E. Smith, the Chief Justice of New York Supreme Court, Benjamin N. Cardozo; the Negro leader, James Weldon Johnson; the heads of various organizations representing Jewish activities in this country, and the thousands who know Louis Marshall only by virtue of his deeds. Many cities were represented, and 54 Jewish organizations.

In the beautiful Temple sat men of every shade of opinion and religious belief, Orthodox Jews in high hats and flowing beards, side by side with bare-headed leaders of the Reform wing, united by the solemnity of the exercises.

A simple religious service, consisting of three prayers, formed the only rites for Louis Marshall. The absence of all eulogies, the utter simplicity, lent a deep impressiveness to the services, which lasted one-half hour.

Promptly at ten o'clock, when the services began, the honorary pallbearers marched up a side aisle to the Beth El Chapel, where the body of Louis Marshall had reposed since its return from Zurich, Monday, on the "Leviathan," filing past it in silent tribute.

## TYPHUS SPREADS IN THE UKRAINE

Moscow, Sept. 24—A large number of cases of typhus are reported from the Ukraine. In Charkov there are 278 cases, in Odessa 160 and in Mariupol 90. The epidemic is spreading because of the lack of medical aid.

President of the Jewish Theological Seminary, wearing a skull cap, and Rabbi M. S. Margulies, President of the Union of Orthodox Rabbis of the United States, with his high hat and flowing white beard, stood out.

The entire audience stood as the cortege proceeded, the police stationed in the Temple, in stiff salute. A solemn silence pervaded the assemblage, broken only by the shuffling tread of the pall bearers.

Before the altar which Louis Marshall had presented to the Temple in memory of his wife and parents, on the rostrum from which he was to have delivered the dedicatory address of the still uncompleted Temple, of which he was the President, the sealed casket

## ARAB MARAUDERS KILL JEWISH WATCHMAN AT CHILDREN'S VILLAGE

Authorities Seek Origin of Ammunition Used in Outbreak

(Jewish Telegraphic Agency)

Jerusalem, Sept. 24—Solomon Sandler, a Jewish watchman at the children's village, Kfar Yeladim, in the Valley of Jezreel, was killed Monday evening when Arab raiders descended on the village, drove off four miles and set down the telephone wires. The report of this raid on the children's village, located on a hill overlooking Merhavia, just outside of Old Balfouria, was contained in a bulletin of the Zionist Executive issued this morning from Afulah.

It was estimated that fifteen raiders had entered a stable. When they heard the watchman approaching, they opened volley, killing him instantly. It is believed that about forty shots were fired.

Troops from Merhavia reached the spot within an hour, followed by police from Nazareth, but the marauders are still untraced. A military guard has

## REVISIONISTS BROKE UNITED JEWISH FRONT ZIONIST EXECUTIVE HOLDS

Though Executive Not Intimidated by  
Threats, Deeply Concerned by  
Threatened Disruption

(Jewish Telegraphic Agency)

London, Sept. 24—The Zionist Revisionists, by their recent statement of continued opposition to the Zionist Executive, broke the united Jewish front, according to Dr. Leonard Stein, political secretary of the Zionist Executive, in a statement at a press conference here.

"It was rightly expected that under the present trying circumstances, all sections of the movement join the Executive in prosecution of their political aims and that the meeting of the Zionist General Council established a united front. Unfortunately, these expectations did not materialize, and one of the parties of the Zionist Organization—the Revisionists—have seen fit even to declare war on those charged with the heavy responsibility of representing and safeguarding the interests of the Jewish National Home," Dr. Stein declared.

"The Revisionist statement declared that they will continue in their 'struggle against the present leadership and its policy,' reserving for themselves the right to launch separate political action. Although the Executive is not intimidated by such threats, they are deeply concerned that on such a critical occasion, the Zionist movement should be threatened with disruption," the political secretary continued.

## JEWIS SENTENCED FOR POSSESSING ARMS WHEN COLONY WAS THREATENED

Arab Attacker of Rehoboth Gets Like Sentence

(Jewish Telegraphic Agency)

Jerusalem, Sept. 24—Prison terms of one year each were imposed upon two Jews of the colony Rehoboth, found guilty of possessing two rifles on August 25. The defense contended that even if the prosecution had substantiated the charge, which it failed to do, the accused were entitled on that day to protect the colony which was definitely threatened.

The judge, in pronouncing sentence, said that on that day the military was responsible for security and therefore self-defense was unnecessary.

An Arab accused of possessing a rifle was given a like sentence in the Jaffa District Court.

## WISE SEES HOOVER, STIMSON, HOWARD

(Jewish Daily Bulletin)

Washington, D. C., Sept. 24—Dr. Stephen S. Wise was received by President Hoover on Monday afternoon and discussed with him the Palestine situation. Dr. Wise thanked the President for his message to the Madison Square Garden mass meeting on the Palestine events. Dr. Wise also conferred with Secretary of State Stimson and Sir Esme Howard, British Ambassador at Washington.

Dr. Wise was in Washington yesterday to address a Palestine relief mass meeting.

opinion will not be misled by terminological inexactitudes. The struggle announced by the Revisionists is not directed against the Executive, but against the Zionist Organization itself. The policy of the Executive has been approved and adopted by an overwhelming majority of the Zionist body to which the direction of Zionist affairs is entrusted between Congresses. The General Council carefully scrutinized all proposals submitted by them, especially those of the Revisionists, and the political proposals of the Revisionists were rejected.

"The great majority in the Zionist movement consider the main political demands of the Revisionists impracticable and leading only to fruitless discussions and useless friction with the Mandatory. On the other hand, the Revisionists demand in relation to the Executive is nothing less than a constitutional coup d'état. Their proposals amounted to a resignation of the Executive, while the opposition, which formed only ten per cent at the Zionist Congress, demanded fifty per cent representation in conducting the political work. Apart from the question of the impossibility of agreeing with the Revisionists on a common policy, their demands are constitutionally absurd and intolerably ambitious. They were, accordingly, vetoed by the responsible representatives of the General Council," Dr. Stein declared.

## AGITATION AMONG PALESTINE ARABS CONTINUES UNABATED

Plan Memorial to Arabs Killed in Outbreak

(Jewish Telegraphic Agency)

Jerusalem, Sept. 24—The Arab slogan, "Sell Jews everything but land," is being improved upon by the sheiks of the village Chuarem, who published a statement in the "Flestin" lamenting the fact that they are obliged to leave a stretch of land purchased and paid for by Jews.

An appeal to the Grand Mufti to convene Islamic preachers throughout Palestine to decide upon the erection of a monument in the form of a mosque or a school house to the Arabs killed in the outbreak, was published in the Arab paper "El Carmel."

The Arab dead are represented as martyrs. A relief campaign in favor of Arab sufferers, including the families of those Arabs who were killed in action against the British troops, has been extended to Iraq, where more than 30,000 rupees have been collected. King Feisal is reported to have made a contribution of 1,000 rupees.

The conference of Moslem preachers is urged to consider plans whereby Arab owners of orange land or groves, who contemplated selling them to Jews, be enabled to retain their property. The establishment of an Arab match factory by an Arab cigarette firm is advocated to compete with a similar Jewish enterprise.

## Hymn of Hate Published

The Arab newspaper "Surat Mustakim" published a "hymn of hate" with the refrain: "Guard your country, which your fathers won. Strike down the Jews. Allah's will be done."

## Ex-King Hussein Sends Message to Palestine Arabs

Ex-King Hussein, receiving Sadki Dejani, a member of the Moslem Supreme Council of Jerusalem on a visit to Cyprus, expressed regret over the recent Palestine outbreak and especially at the dissension among the Arabs themselves. "By Allah, you know I should not have been a miserable exile but for my intervention in behalf of Palestine," he said, urging the Arabs to cease fighting among themselves.

Sadki Dejani reports on his return to Jerusalem that he was given documents by Hussein purporting to contain promises to the Arabs more important than the Balfour Declaration, but the Arabs did not know how to use them, Hussein declared.

## COMMUNIST ORGAN ATTACKS LUBAWITSCHER REBBE

Moscow, Sept. 24—Rabbi Jacob Joseph Schneerson, the Lubawitscher Rebbe who is now on a visit in New York, is the object of an attack published against him in the "Comsomolskaya Pravda." The Communist youth organ accuses the Rabbi of organizing "crazy anti-Soviet propaganda abroad" and keeping up illegal connections with agents in Russia.

## RELIEF TO PALESTINE VICTIMS TO BE GRANTED AS LOANS; NOT TO PREJUDICE CLAIMS

Mrs. Felix M. Warburg Sends \$50,000  
for Education Budget  
(Jewish Telegraphic Agency)

London, Sept. 24—Aid granted the victims of the Palestine outbreak from the Palestine Emergency Fund will be regarded as loans, the acceptance of which will not imply the abandonment of claims against the government. In announcing this arrangement, Dr. Leonard Stein, political representative of the Zionist Executive, declared that it has been made abundantly clear that the Palestine government cannot repudiate its liability on the pretext that relief funds are being collected by the Jewish public.

Over £300,000 (approximately \$1,500,000) has been raised for the relief fund to date. The success of the collection, which provided a magnificent demonstration of Jewish feeling, the Executive declared, was due considerably to its centralization. Most important, however, is the continuation of constructive work. The situation calls for justice intensified tenfold and the strengthening of immigration. The Emergency Fund will continue until October 15, when the Jewish National Fund and the Palestine Foundation Fund will resume their normal fund collections.

Declaring that all relief campaigns in the United States were discontinued for the present, in deference to the Palestine Emergency Fund, Rabbi Meyer Berlin, announced that the campaign will be concluded the day after Yom Kippur, October 14. Not a single point destroyed during the disturbances will be left waste, Rabbi Berlin declared. On the contrary, all, including Hebron, will be rebuilt. Where it is impossible to leave isolated points with a small population, the settlements will be enlarged and strengthened.

Jerusalem, Sept. 24—A gift of \$50,000 from Mrs. Felix M. Warburg of New York was received by the Keren Hayesod, Palestine Foundation Fund. The gift was earmarked for the education budget.

Jerusalem, Sept. 24—Seventeen hundred refugees are being fed in the Straus Health Center and soup kitchens, in addition to the 1,200 regular recipients, the Zionist Executive reported in a cablegram despatched to Nathan Straus, American philanthropist. Eight hundred are receiving meals at the Straus kitchen in the Old City.

Immediately after the riots the Health Center sheltered about 500 refugees, principally from Hebron. They have since been evacuated to other public buildings. Preparations are now being made for a day nursery in the Center for about 100 refugee children.

### Evidence Ready in \$80,000,000 Claim

Montreal, Sept. 24—Rev. Isaac de la Penha, the minister of the Spanish and Portuguese Jewish Congregation in Montreal, who for many years has followed, through much legal debate, the hope of obtaining possession of some \$80,000,000 worth of the peninsula of Labrador, has just received information from his legal advisers in London, that they have assembled sufficient documentary evidence to show the justification of his claim, and propose to lay it before the Privy Council in the near future.

Rev. de la Penha contends that he holds certain documents that show that William III, the king of England and Prince of Orange, gave to his great-grandfather, Joseph de la Penha, then a resident of Amsterdam, the perpetual rights to a section of Labrador. This was in 1697, and some time later, in 1732, and again in 1768, documents were issued by William IV and William V respectively, of the Netherlands, renewing this concession. Since that time, however, no other renewals were given out. The original concession states that the portion of Labrador was donated to the family for all times. Experts state, that at the present day, the property is valued at no less than \$80,000,000.

Leo M. Friedman, lawyer of Boston, and M. Wallach, international law expert of Amsterdam, have been working on the case in England, through the intermediary E. Eliasoph, Montreal lawyer, who is acting on behalf of Rev. de la Penha. They have found in the Egerton Manuscripts, published in 1839, by Sir Henry Cavendon, and containing his memoirs of the British Parliament at that time, a number of statements, tending to prove Rev. de la Penha's claim. Among them, is a document dated 1760, of Sir Francis Bernard, Governor of Massachusetts, asking the British Government to show clearly to whom Labrador belonged. In the treaty of Paris, an important section stipulates also that gifts and concessions to individuals were to be respected in the future.

With much documentary evidence unearthed from old records to back his claim, Mr. de la Penha feels hopeful that results may be achieved before long.

### PERMIT EX-KING HUSSEIN TO RETURN FROM EXILE

Jerusalem, Sept. 24—Former King Hussein, exiled ruler of Hedjaz, will be permitted to leave Cyprus, where he has been since his abdication, and settle in Bagdad, capital of Iraq, where his son Feisal is king, according to reports received here today.

The former monarch is said to be writing a history of the Arab revolt against Turkey.

## ARABS ASSERT JEWS ARRANGED MASSACRE IN HEBRON FOR SYMPATHY

Ascribe View to American Consul  
Who Promptly Denies It  
(Jewish Telegraphic Agency)

Jerusalem, Sept. 24—A monstrous suggestion, ascribed to Paul Knabenshue, United States Consul General, and promptly denied by him, was put forward in the Arab press.

The newspapers, quoting Consul Knabenshue, asserted that the Jewish population of Hebron arranged the murder of the Yeshiva students in order to evoke the sympathy of American Jewry.

Sixty-five Arabs are now imprisoned in Hebron, 32 were released for lack of evidence against them and 28 sentenced to from six months to a year each, according to the Arab press.

## BRITISH POLICE OFFICIALS DISPROVE ARAB RUMORS JEWS POISONED FOOD

Eat Sweets to Prove to Arabs They  
Are Not Poisoned

(Jewish Telegraphic Agency)

Jerusalem, Sept. 24—Rumors spread among the Arabs that Jews were poisoning candy and fruits, were disproved in dramatic scenes in the office of the Jerusalem police district, report the Jerusalem correspondents of the London "Daily Chronicle" and "Daily Mail."

An excited crowd of Arabs rushed into the office of Major Harrington, Deputy Superintendent of the Palestine police, Jerusalem district, bearing with them specimens of the alleged poisoned candy. Major Harrington ordered the Arabs to gather round while he ate the sweets one by one, saying, "They are excellent." Seeing that Major Harrington was unharmed, the Arabs left the office shouting, "Wonderful!" The crowd soon dispersed.

A similar scene occurred in the office of Major Harrington's assistant, Superintendent Ibrahim Bey Stambull, an Arab. When he was brought figs which were alleged to be poisoned he ate them saying, "This is the second dessert we had today."

## COLONIAL OFFICE STAYS DEPORTATION ORDER

Jerusalem, Sept. 24—Deportation orders against two Oriental Jewish families were stayed by the British Colonial Office on appeals lodged a year ago. In the meantime, one of the families was deported, the other having been permitted to remain in the country owing to the illness of a child. The High Commissioner stated that there is no objection to the deported family returning to Palestine.

The new Temple Emanu-El and Abraham Fabian Memorial Hebrew Free School of Paterson, N. J., was opened with impressive ceremonies.

Abraham Miller, president of the congregation, Simon H. Fabian, honorary chairman of the school, James Wilson, president of the Chamber of Commerce, Rabbi Reuben Kaufman, Rabbi William Wittenstein and others spoke.

to an inquiry into the immediate causes of the recent outbreak, it is stated that at a later stage of its work, the Commission will also inquire into the wider aspects of the problem, occupying itself with the broader reasons for the recent outbreak.

In London official circles, it is reiterated that in any case the British government will enforce and uphold the terms of the Balfour Declaration, there being no question of any retreat from that position.

The recent press rumors concerning England's intention to give up the Palestine Mandate or permit its reversion to Italy, the United States or Poland are regarded as gossip which is unfounded and absurd.

London, Sept. 24—At a press conference at Zionist headquarters here Dr. Selig Brodetsky, member of the Executive Committee of the Jewish Agency in charge of the political work, made the following statement:

"The result of the recent meeting of the Zionist General Council was the approval, by an overwhelming majority, of the policy formulated and pursued by the Executive. We hope all those in authority will learn the lesson taught by the premeditated criminal attacks to which the Yishub has been submitted.

"First, we are entitled to ask the Mandatory for speedy measures which will ensure the security of Jewish life and property. The reorganization of the Palestine police and the Transjordanian defense force, in order to introduce an adequate proportion of Jews into the defense forces, is of paramount importance. After three attacks within nine years that the Arabs made against the peaceful Jewish population, the government must realize that the Jews cannot rely on a predominantly Arab police and defense force for protection.

"Another essential condition for security and progress is the faithful, whole-hearted cooperation of the Palestine administration with the Jewish Agency in the execution of the Mandate in its letter and spirit. More active support of the Mandatory in the sphere of economic development and the opening of possibilities for enlarged Jewish immigration and colonization, must be an integral part of the measures necessary in order to put into effect the promises contained in the Mandate and the Balfour Declaration. The Executive is taking all possible steps to press energetically for these two main reforms. Negotiations in this direction have been initiated with Premier MacDonald and Lord Passfield. We have confidence that with the help of united world Jewry we shall succeed in our endeavor," the statement declared.

was placed. A blanket of roses and a wreath to one side were its only decorations. At the request of the family, no floral offerings were sent by organizations.

Rabbi H. G. Enelow and Rabbi Samuel Schulman conducted the services at the altar. Rabbi Enelow recited Psalms 90 and 91. Rabbi Schulman, beginning in Hebrew with a special prayer for the dead, ended with the recitation of the 23rd Psalm in English. These and a musical program constituted the only services at the Temple. The choir of Temple Emanuel, under the direction of Lazare Zaminsky, together with a symphony orchestra, accompanied by the organ, rendered the musical part. Following Rabbi Enelow's prayer, the choir sang "O Lord, What Is Man," set to traditional music. Miss Amy Ellerman was the soloist and Gottfried Federelein, the organist.

Mendelssohn's "Funeral March" concluded the exercises in the Temple. With the honorary pallbearers lined up as a guard of honor, the coffin was carried to the waiting hearse by the Shomrim.

Hundreds of automobiles were in the funeral procession to Salem Fields, Cypress Hills, Brooklyn, where interment took place beside the body of Mr. Marshall's wife. An automobile filled with flowers, tributes from members of the family, followed the hearse.

Rabbi Nathan Krass, who delivered the prayer at the cemetery, broke down during the recitation of the Kaddish. Many wept as the body was lowered into the grave. As a last farewell, the mourners circled the grave, throwing flowers on the casket.

Mr. Marshall is survived by three sons and one daughter.

London, Sept. 24—Among the appointments to the Royal Air Force announced by the Air Ministry are 34 officers for Transjordan, Palestine Iraq and other points in the Middle East.

## Seek Origin of Ammunition Used in Palestine Outbreak

Efforts are being made by the military in Palestine to trace the origin of ammunition used by the Arab attackers in the recent outbreak, the Jerusalem correspondent of the London "Daily Mail" reports. The ammunition was made to fit British rifles, but does not bear a British mark. It is believed this ammunition was supplied from an outside source, the correspondent writes, in order to discredit the British by the suggestion that anyone killed by this ammunition was shot by the British soldiers.
