466 ARABS, 54 JEWS, TRIED BY PALESTINE COURTS IN CON-NECTION WITH DISORDERS

Instigators, Perpetrators, Looters, Get Light Sentences; Punish Jews for Preparing Self-Defense (Jewish Telegraphic Agency)

Jerusalem, Sept. 26-Five hundred and twenty Arabs and Jews have already been tried by the courts of Palestine and given varied sentences in connection with the recent disturbances, according to an estimate of the Arab press.

According to these figures, up to September 19, 374 Arabs and 39 Jews were given prison sentences ranging from one to twelve months, 85 Arabs and 14 Jews were committed to the District Court, and 7 Arabs and 1 Jew are awaiting trial on criminal charges. Official figures are not available. Thirty-three Jews who were arrested in the flour mill at Haifa during the

disturbances in the port city, were re-leased for lack of evidence against them. They had been charged by the police with attempts at premeditated

The body of an Arab was found out-side of the flour mill after the advancing mob was repulsed. The police alleged that three firearms were in the building, but were unable to produce

#### 397 POLISH CHALUZIM LEFT FOR PALESTINE SINCE RIOTS

(Jewish Telegraphic Agency) Warsaw, Sept. 26-Three hundred and ninety seven chaluzim left Poland for Palestine since the outbreak of the disturbances, including a group of 80 which left vesterday.

A group of 480 will leave on a special train on October 9, to embark for Plestine, it being expected that by October 15, the number of Palestine immigration certificates will be exhausted.

POGROM PROPAGANDA GROWS AMONG COMMUN-

ISTS; GORKY AROUSED In Article in "Pravda," Cites Anti-Semitic Proclamation, Asks How Publication Possible (Tewish Telegraphic Agency)

Moscow, Sept. 26-Anti-Semitic pogrom propaganda is growing among the members of the Communist party, it is evident from an indignant article by Maxim Gorky, published in today's "Pravda."

In his article against anti-Semitism and the mehtods of combatting it, the famous Russian writer declares that this week he received a proclamation headed "An Order for Every Communist" consigned to "Communists commit-tees" urging them to organize a Jew-ish pogrom. "Arise you Russians and other nationalities and kill the Jews, the proclamation agitated.

Expressing certainty that the authors of the proclamation are not Communists, Gorky says: "This dirty sheet which was written grammatically and very shamefully, does not astonish me. I have seen dozens of them during my thirty years of fighting anti-Semitism. I am indignant—and very much soabout something else more serious. I ask myself how it is possible that in the thirteenth year since the revolution such sheets can be published? What, kind of cultural sphere is it that admits the development of such disgusting filth as anti-Semitism? Is it possible that we may believe the fierce assertions of the White Guard press abroad that even the Communists are infected with anti-Semitism?"

Saving that there is no question Russia whether anti-Semitism should be combatted, Gorky emphasizes that to them two other questions should, how-ever, be asked: first, is the fight con-ducted with sufficient devotion? Second, are the methods correct? Gorki expresses the opinion that those issuing the proclamation will be unsuccessful

#### ASK WITHDRAWAL OF HALS-MANN PATRICIDE CHARGE

(Jewish Telegraphic Agency) Vienna, Sept. 26-A formal request for the withdrawal of the charge of Philip Halsmann, whose second trial is now going on at Innsbruck, was presented to the Austrian Ministry of Justice by the counsel for the defense. The counsel submitted the latest evidence brought to the court which shook the basis of the accusation.

Terms Mufti's Methods Unscrupulous: Obstacle to Friendship Between Jews and Arabs (Tewish Telegraphic Agency)

London, Sept. 26-An attempt made by Amin el Husseini, Moslem Grand Mufti of Jerusalem, to support his charge that the Jews of Palestine have designs on the Mosque of Omar area, by quoting an alleged statement by Lord Melchett, was declared "unscrupulous propaganda" by Lord Melchett in a statement he issued to the Jewish Telegraphic Agency here.

The Grand Musti in a letter addressed to Pierre Van Paassen, special correspondent of the New York "Evening World" and the Jewish Telegraphic Agency, quoted Lord Melchett as having said, "I will consecrate the re-mainder of my life to the rebuilding of the Jewish Temple." It was this rumor which was spread among the Moslems of Palestine which was said to be responsible for gathering the Moslem villagers to Jerusalem on August 23, and causing the outbreaks.

"I should like to make it clear that I never made any statement of the kind referred to in connection with the remains of the Temple in Jerusalem," Lord Melchett declared. "Any attempt to connect any words which I said with (Continued on Page 4)

NEW LITHUANIAN GOV'T DISBANDS POGROM GROUP (Jewish Telegraphic Agency)

Riga, Sept. 26-The Iron Wolf, Lithuanian Fascist organization modelled after the Ku Klux Klan was dissolved by an order of the new Minister of the Interior, Musteiks, it is reported here from Kovno.

It was stated that the Iron Wolf which supported the Waldemaras government planned a march on Kovno, following the resignation of the Waldemaras cabinet for the purpose of declaring Lithuania a Fascist state in imitation of the Fascist march on Rome.

The Iron Wolf was said to have been responsible for the recent anti-Jewish excesses in Slobodka and the frequent attacks on the Jewish population in the provincial towns. Mass arrests among the members of. the Iron Wolf were ordered by the new government.

#### BEDOUIN ATTACKS ON PALESTINE RUMORED

## MIZRACHI LEADER URGES VIGOROUS BUT CAREFUL ACTION FOR PALESTINE

Says Stand of American Jews of Tremendous Political Importance

Gedalia Bublick, president of the American Mizrachi, who was an eyewitness of the events in Palestine and, on his way back to the United States attended the Zionist General Council session in London, in a statement to the Jewish Daily Bulletin, urged careful but vigorous action on the part of American Jews with regard to the present situation in Palestine. Mr. Bublick returned to New York this

"The stand taken by American Jew-

ry towards the great national calamity in Palestine was like balsam to the Jewish sufferings in this dark hour, he stated. "It is impossible to relate in words the tremendous and encouraging effect upon Palestine Jews of the news about the protest meetings and demonstrations of the American Jews against the horrible happenings in Palestine. At the meeting of the Actions Committee in London, much was said about the action of the American Jews at this moment. It was felt by all that the action taken by the Jews of America was of tremendous political importance. The English Government, it was felt, could not ignore the four million Jews in America and would not disregard the forcefully expressed sympathy of leading Americans over the tracic occurrences in Palestine. COMPLAINT RETIRING AUS .TRIAN GOV'T'S LAST ACT Declares Barring of Jewish Guests at Resorts Unconstitutional (Jewish Telegraphic Agency)

Vienna, Sept. 26-The last act of the resigning Austrian government was a reply given by it to a complaint of the Union of Austrian Jews in regard to the action of some resort communities barring Jewish guests.

In the government reply made pub-lic today, signed by the Vice-Chancellor, it is declared that the action of resort municipalities barring Jewish guests is unconstitutional and that the Union should lodge complaints against such communities with the proper administrative organs. In regard to anti-Semitic utterances by certain societies, the taking of necessary steps depends on the determination of the proper authorities as to whether transgressions against prevailing laws have been com-mitted. The government therefore recommends that complaints along these lines be submitted to the institutions dealing with these matters.

The communication further states

that the government is not in a position

to issue a general order concerning

anti-Semitic actions by the resort com-

munities, as only the courts are competent to determine whether the refusal of anti-Semitic owners to house Jewish guests is contrary to law. The formation of a cabinet under Shor is considered likely today. The guarantee of law and order in the country is expected to be the first act of the

IBN SAUD'S FORCES ROUT REBEL TRIBESMEN (Jewish Telegraphic Agency)

new cabinet.

Jerusalem, Sept. 26-Sixty tribesmen were killed and a large number wounded in fifteen-hour batrebel tle between a punitive expedition sent by Ibn Saud, ruler of Nejd and Hedjas, against the rebel tribes under Faisal Dawish, who, with his warriors, concentrated on the Neid-Kuweit boundary, has avowed his intention to occupy El Haasa as part of movements to weaken and eventually unseat the Wahabi monarch, according to Central Arabian reports reaching Jerusalem yesterday.

Emil Ibn Mesaad headed the expedition, routing the rebels who sustained the casualties. The rebels were unable to penetrate Watta El Harud, held by Emir Ibn Mesaad, a relative of Ibn Sand

The battle outside this town resulted in more rebels being killed, including Abu Elaziz, son of Faisal Dawish. The rebels fled to El Sabachia, sixty miles from Kuweit, but the Emir of Kuweit warned the insurgents not to

expect hospitality in his domain. Faisal Dawish, hearing of the death of his son, announced he will continue the war against Ibn Saud until the last moment, hoping to mobilize sufficient

regulars, the report states.

VAAD LEUMI MEETS:

Move to Strengthen Executive Welcomed by Palestine Press (Jewish Telegraphic Agency)

Tel Aviv, Sept. 26-At a meeting held here last night, the Vaad Leumi, the National Council of Palestine Jews, decided to strengthen its Executive Committee by drafting into the work, Pincus Ruttenberg, head of the Palestine Electric Works; Meyer Dizengoff, Mayor of Tel Aviv; and Mr. Dutkow-sky of the colony Hedera, as the farm-

ers' spokesman. The Palestine press welcomes the entrance of Mr. Ruttenberg into the National Council, pointing out that since he settled in Palestine, he has kept aloof from public matters. Much is expected of his leadership.

#### PLAN HALT TO ARAB BOYCOTT PROPAGANDA (Jewish Telegraphic Agency)

Jerusalem, Sept. 26-Drastic measures by the authorities with the cooperation of Jewish and Arab merchant groups are planned for the purpose of stopping the boycott propaganda.

It was learned that the Jewish merchants of Jerusalem have agreed to sign a proclamation calling upon all races, creeds and religions in the Holy City to "freely trade, buy and sell in peace one with another." When the Arab merchants will agree to this proclamation, the District Commissioner will issue it over his and the Terusalem Mayor's signature, as an official order.

Moslem and Christian Arab shopkeepers of Jaffa have decided to follow the example of Haifa Arab mer-chants in boycotting the Ruttenberg Electric Works. They decided to discontinue electricity supplied to them

from the Ruttenberg works.
Thirty Jewish families returned to Beisan, where two British platoons have been stationed. District Commissioner Lovett is actively engaged in trying to break up the Arab boycott propaganda in this town, which was looted during the disturbances and from which all Jewish residents fled.

While the government is contemplating measures to stamp out the anti-Jewish boycott agitation, a Jewish merchant of Jaffa was fined £1 and ordered to pay 2d. damages to an Arab official of the Jaffa municipality, whom the merchant ejected from his shop, from which the Arab official was at-tempting to draw out Arab customers.

The official admitted he was active in the boycott campaign and evidence against him showed that he is con-stantly interfering with Jewish trade. The Jewish merchant was found guilty for offensive conduct towards the Arab.

## TESTIMONY OF ORPHANED JEWISH CHILDREN MOVES NEW ATTACKS DISTURB HEBRON COURT

## H. C. Luke Admits Government Committed Error, But Insists It Must Be Neutral

ith Reizmann of how she saw her father, mother and uncle pursued by a mob of howling, blood-thirsty Arabs, brandishing knives and daggers, later finding the bodies in the gutters, produced a dramatic atmosphere in the Hebron court, where the examining magistrate began yesterday sifting the evidence for the Crown in the forthcoming Criminal Assizes. Col. Maxton of the Welsh Guards, and other British military officers, were on the bench with Governor Bailey of Hebron, who is personally conducting the investigation in the most objective manner.

When the Reizman girl had told her story in the breathless silence of the courtroom, the judge asked her if she could identify anyone from a number of barefooted, unkempt Arab prisoners who were brought into the court under heavy escort. She calmly walked up to Ibrahim Abd El Assiz, a young Hebron merchant, her father's next door neighbor, saying, "Yes, Ibrahim was nearest my father with a knife uplifted when the mob overtook my father." Then addressing the Arab, who hung his head in shame, the girl asked him in the kindest voice imaginable, "Ibrahim, how could you?"

The scene produced great emotion in the court. The steel-nerved He-bron governor, who has seen years of service in the Near East, burst into tears, many sobbed loudly, and Colonel Maxton found it necessary to get up and walk to a window and gaze out.

Judith told how, at her father's insistence, she had climbed a garden tree when the Arab marauders began pounding the front door and smashing it. From the tree she saw her father run into the garden, followed by her uncle, Jacob Reizman, pursued by Arabs yelling, "We'll cut your throat." Her father scaled the wall, but the mob was hard on his heels, Ibrahim Assiz in the lead, no more than three yards behind. She did not see what took place in the street where her father had fallen or been overtaken, but later, when rescued, she saw his body, stabbed in a score of places, his

head almost severed. Judith's twelve-year-old brother caused a new sensation when he told his version of his father's murder respectively in English, Arabic and He-After the boy's calm recital, the judge looked round the circle of lawyers, military men and officials, saying, "I don't think anyone else here has a similar linguistic ability. When Arab legal luminaries from Jerusalem had for half an hour vainly attempted to trip up the Talmud Torah-trained Jewish boy, unable to shake his story, the judge remarked: "Your efforts are useless. This child speaks the truth. This boy could not

The whole procedure was a contrasting scene, the uncouth, raggedly Arab illiterates blubbering and protesting innocence, listening horror-stricken to the eye-witness accounts, and on the other hand, the cleanly-dressed Reizman orphans, who are children of unusual physical beauty, almond-eyed, olive-skinned, Palestinian-born, true da Vinci angel models, who held the spectators breathless for over an hour, when the sessions adjourned.

Hebron is commercially a dead city, Merchants' stalls are heaped high with unsold fruit and vegetables, not only because the Jews evacuated the town, but Jerusalem Jews refuse merchan-dise from the city where the greatest massacre took place. The otherwise lively bazaar, one of the most ancient and picturesque in the entire Orient, crowded the year round with pilgrims and tourists, is wrapped in a tangible, dismal gloom, the merchants sitting on stools in front of the holes-in-the-wall in solemn, brooding silence. The Jewish ghetto, which is a veritable rabbit warren, undoubtedly the most intricate labyrinth of human habitation in the entire world, with hundreds of cubicled dwellings, with super-imposed staircases, is lifeless and vacant, mute witness to the past terror.

A 90-year-old Hebron Jewish refugee

PALESTINE PEACE; JEW STABBED TO DEATH Safed Refugee, Returning from Wed-

ding, Killed on Jerusalem Street (Jewish Telegraphic Agency)

Jerusalem, Sept. 26—Two attacks which occurred on Wednesday dis-turbed what was believed to have been the condition of safety to which the

country had returned.
Jacob Cohen, 65, a refugee from Safed, was stabbed to death shortly before nine o'clock, the curfew hour, when he was on his way from a wed-ding. The attack occurred at an empty lot near the Wittenberg Kolel house, a stone's throw from St. George's Cath-edral. The aged Jew was found by a lewish youth, Moses Hirsch, who rushed him to the Hadassah Hospital. He died on the way. The assailants disappeared.

An attempt to attack the Jewish colony Nachlath Jacob was made Wednesday evening by a band of marauders who tried to set fire to the colony's threshing floor. They were repulsed when the watchman sounded an alarm.

Two minor attacks on individual Jews were reported today. A Jewish butcher was injured in a slaughter house by Arab butchers, while an aged Iew in the Old City was hit by stones thrown by Arabs.

#### DENOUNCE YIDDISH WRITERS FOR CONDEMNING COMMUN-ISTS ON PALESTINE RIOTS Meeting of Writers in Moscow Scores Action of U. S. Jewish Writers

Moscow, Sept. 26-American Jewish writers who condemned the attitude of the Jewish Communists and their New York Yiddish daily, the "Freiheit, regard to the events in Palestine, were denounced at a meeting of Yiddish writers held in Moscow yesterday. The meeting was called to consider in particular the action of Abraham Reisin, Yiddish novelist, and three others who were members of the editorial staff of the "Freiheit" but resigned when the paper took a pro-Arab stand.

Addressing the meeting, M. Litvakov, editor of the Moscow "Emes" sharply attacked Mr. Reisin, calling him "the greatest traitor." A resolution adopted at the meeting drew attention "of the working masses to the shameful behavior of Abraham Reisin, who, because of his old revolutionary traditions, was given a great welcome in Russia, which he is now betraying.

In regard to the Palestine events, the meeting declared that "the entire re-sponsibility falls upon the Zionists." The J. L. Peretz Writers' Club of New York was denounced for its resolution to exclude those members of the staff of the "Freiheit" who remained with the paper. It was stated that meetings to protest against Mr. Reisin will now be held in every Jewish Communist club in Russia.

He further said that he knew the authorities were looking for the animal, but he hid it, fearing it might "kick the children" if allowed to be loose.

The Mukhtar's aids were sentenced to three months imprisonment each. An Arab from the village Walaiah

who was found in possession of phylacteries, will be sentenced Thursday. Instigators Get Light Sentences Eleven Arabs of Acre, who were found guilty of instigation to riot, were

given light sentences ranging from a £5 fine and two months imprisonment. An Arab who was found with a revolver in a Jewish house outside of Ness Ziona was sentenced to eighteen months imprisonment. Another found carrying a hand grenade outside the Kalendia aerodrome was sentenced to l twelve months imprisonment. young Arabs of Tul Kerem, charged with arranging a demonstration with-out permission, were fined £2 each.
