MAXIMUM PENALTIES TO 32 ARAB ASSAILANTS GIVEN BY HAIFA DISTRICT COURT 12 Arabs, Motza Murderers, Face Death Penalty

(Tewish Telegraphic Agency)

Jerusalem, Sept. 30-Twelve Arabs charged with the murder of the Makleff family at Motza will face trial under the article of the Palestine law imposing the death penalty. The in-dictment was upheld by the magistrate before whom the prisoners were first brought.

Following a three-day trial in the District Court of Haifa, 32 Arabs of the willage Tireh were sentenced to five years imprisonment each and 5 Arabs to two years each, for having assembled for the purpose of attacking Beth Galim, a Jewish suburb of Haifa, on August 26. The mob was dispersed by an aeroplane, the military taking fifty prisoners, all of whom were armed with clubs. The air force as well as the military had orders to shoot at the crowd marching on Haifa on that day.

The prison superintendent, Matson, was the first to sight the crowd on August 26. He went by motorcycle to warn the police, whereupon a special and an aeroplane carrying Judge Litt as an observer. He ordered the action.

Police Superintendent Foley testified that the condition in Haifa that day was very grave and had the mob penetrated into the town the situation (Continued on Page 4)

J. Kook announced today. This permission is granted provided they fast and pray on the Day of Atonement.

FORCE DOWN MOSLEM DIVINE DEPLORING SAFED BLOODSHED (Jewish Telegraphic Agency)

Jerusalem, Sept. 30 - Anti-Jewish feeling prevailed in the Safed Mosque on Friday when an 83-year-old Moslem divine reproached the congregation for causing the bloodshed of their innocent neighbors and enjoining the worshippers to repent. A young Arab, a government official, it is reported, interrupted him, shouting: "You are integering with the holy war." The aged Arab was finally obliged to leave the platform.

The Ministry of the Interior announced that it will take strict measures to curb anti-Semitic excesses and that it will punish officials responsible for maintaining order for laxity in this matter. Six gendarmes, it was stated. were punished and others will be courtmartialled for their failure to obey orders in preventing attacks on Jews by the members of the student con-

Union of Roumanian Jews urged those Jews who suffered in the recent excesses to immediately file claims for damages.

Czernowitz, Sept. 30-The papers here reproduce a despatch from the "Lupta," reporting that the Rou-manian Ministry of War issued a circular ordering the dismissal of Jews from military offices.

ISRAEL BELKIND. ZIONIST PIONEER, DIES IN BERLIN

(Jewish Telegraphic Agency)

Berlin, Sept. 30-Israel Belkind, Russian Zionist leader and one of the early pioneers in Palestine, died here today in the hospital of the Jewish community. He was 69 years old.

The late Mr. Belkind was one of the founders of the Bilu group, the group of Russian Zionist student pioneers who settled in Palestine following the Russian pogroms of 1881. He was active in many Zionist enterprises, including the establishment of a colony for the orphans of the pogrom victims, wrote and spoke in many countries, propagating Zionism and the upbuilding of Palestine. His body will be taken to Palestine for burial.

HIGH COMMISSIONER ORDERS REFUGEES FROM JERUSALEM SUBURBS TO RETURN HOME New Excesses by Students Instigated Hesitate for Lack of Safety: Rations Withdrawn

(Jewish Telegraphic Agency) Jerusalem, Sept. 30-Jewish refugees

from the Jerusalem suburbs and the Old City were ordered forthwith to return to their homes by Deputy Commissioner of Jerusalem Keith-Roach acting on instructions from the High Commissioner, Sir John Chancellor. The refugees affected are from the suburbs Shiloach, Musrara, Damascus Gate, Givat Shaul, Nachlath Zion, Nachlath Achim, and the Old City. The time has now come when refu-

gees having homes to which to return should do so, the order stated. From October 1, refugees from these sections now sheltered in public buildings will not receive rations. However, many of the refugees are reluctant to act upon this order, claiming that it is impossible for them to return to the neighborhoods which are still unsafe.

Safed Sephardic Quarter Desolate

The Sephardic quarter of Safed is utterly desolate. The houses, unfit for re-occupation, have become hiding places of Arab ruffians who descend at nightfall to the deserted buildings, whence they snipe at the infrequent Jewish passersby.

Distribution of arms in the villages

surrounding Safed still continues, according to a youth found with a revolver, who confessed that an effendi (Continued on Page 4)

THIRTY WOUNDED AT WARSAW MASS MEETING ON PALESTINE EVENTS Question of Attitude Increases Agitation and Friction

(Jewish Telegraphic Agency)

Warsaw, Sept. 30-About 30 persons were wounded in a free-for-all fight which developed among Jewish workingmen following a mass meeting held here Saturday night at the Skala Theatre under the auspices of the Right Poale Zion party.

The meeting was devoted to a discussion of Palestine events, but Bundists and Communists present caused a disturbance, necessitating the intervention of the police who removed those interfering with the proceedings. the close of the meeting the fight was renewed. The victims were principally members of the Poale Zion Party in-Gluding Abraham Prazan, Leib and Janina Malkin, Moses Altuski, Simcha Rosen and David Wenger.

The meeting adopted resolutions condemning the attitude of the Commu-nists and the Bundists toward the Palestine events.

MICHAELSON RALLIES AFTER RELAPSE: NOT OUT OF DANGER

(Jewish Daily Bulletin) Chicago, Sept. 30-Prof. A. A. Michaelson, famous scientist, gave hope to attending physicians today that he was winning a fight for life against bronchial pneumonia, the high fever which caused a hurried consultation of physicians yesterday, having abated during the night. Attendants at the Presbyterian Hospital early today announced Prof. Michaelson's condition

greatly improved and that he had spent a restful night. Yesterday a consultation was called by Dr. Herman L. Krestchmer, attend-ing physician, of Dr. James B. Her-rick and Dr. Erneste Irons.

Prof. Michaelson entered the hospital four weeks ago for a minor opera-

tion. Bronchial pneumonia developed after another operation had been planned.

"Despite his grave condition, Prof. Michaelson is leaving it to his physicians to do the worrying," Dr. Krestchmer said. "His fighting spirit and will to surmount difficulties, so notably manifested in his scientific experiments, anay win this critical battle for him."

NEW YORK LEADS IN EMERGENCY FUND

New York State leads in contributions to the Palestine Emergency Fund, with a total of \$711,317, according to the announcement by David A. Brown, chairman. Of this New York City has given \$600,432. The rest is from 123 communities outside

the city. Philadelphia ranks second with a contribution of \$89,494, and Chicago is third with \$73,705. Other communities that have given large sums are Boston, \$51,224; Baltimore, \$40,725; Detroit, \$40,665; Newark, \$27,850; Cincinnati, \$17,067; Los Angeles, \$15,896 and Paterson, \$12,211. The total fund is now \$1,757,451.

FIND BIDJAN SUITABLE TERRITORY FOR JEWISH LAND SETTLEMENT Head of American Commission Says It Is Better Suited than Palestine (lewish Telegraphic Agency)

Moscow, Sept. 30-Prospective Jewish settlers may expect that Bira-Bidjan, the Far Eastern region where Jewish land settlement is being sponsored by the Ozet, society for Jewish land settleemnt, will be turned into a well-developed country, Prof. Harris, head of the American investigation commission which went to Bira-Bidjan, declared to the representative of the Jewish Telegraphic Agency on their return to Moscow today.

"The Commission is confident of the possibilities of Bidjan, which is a vast empire in the making, having great agricultural and industrial potential wealth," Prof. Harris stated. Admitting that there are great difficulties in the problems of drainage of the summer rains and road building. Prof. Harris declared that they can be overcome by diligent work plus modern technical methods.

Prof. Harris, who has visited Palestine, said that in his opinion Bidjan is better suited for colonization than Palestine. The commission found the local population cooperating with the Jewish settlers. They will sail for the United States next week.

CANADIAN ZIONISTS ADD \$100,000 GIFT TO J. N. F. (Jewish Telegraphic Agency) Jerusalem, Sept. 30-The Jewish National Fund headquarters here is in tional Fund headquarters nete is in receipt of an additional \$100,000 from the Canadian Zionist Federation. This sum was the fourth remittance of \$100,000 each received from the Canadian Zionists on their \$1,000,000 pledge. Although the remittance was not due until six months from now it was expedited because of the recent events in the country.

GIVES \$250,000 TO

Mr. and Mrs. Morris Goldberg of Seagate, Coney Island, have made an additional contribution of \$250,000 to United Israel-Zion Hospital Brooklyn.

The gift is a memorial to their daughter. Henrietta, who died in 1921 at the age of 9. A previous gift of \$50,000 in memory of their daughter made possible the erection of a fourth wing to the hospital. The new contribution is to perpetuate the wing known as the Henrietta S. Goldberg Pavilion.

The contribution was announced at a dinner Saturday night at the Half Moon Hotel in honor of Mr. and Mrs. Goldberg, attended by 500, including Borough President Byrne of Brooklyn.

LONDON PAPER SAYS U. S.

London, Sept. 30-American Zion-ists have decided to demand from ists have decided to demand from Ramsay MacDonald, upon his arrival in New York, a statement regarding Great Britain's policy towards Palestine, the "Evening Standard" says that it understands. Commenting editorially, the paper

staes that "American Zionists are confident of persuading MacDonald to declare that the Mandate will be re-tained and that Jewish settlers in Pal-estine will continue to receive favor-able consideration. Behind the hope of these expectations lies a menace.

If MacDonald does not make up his mind in the desired sense, he is threatened with the same kind of reception in America as a British Premier would have received from the Irish population of New York in the days before the Irish settlement."

MINISTER SAYS MANDATE POLICY REAFFIRMED (Tewish Telegraphic Agency)

Brighton, Eng., Sept. 30-Herbert Morrison, Minister of Transport, in an address delivered this morning at the annual conference of the Labor Party here declared:

"There has been bloodshed in Palestine. We express our profound sympathy with those who suffered and with the relatives of those who lost their lives.

"We re-affirm our policy with regard to the Palestine mandate and the obligation it carries towards the Jewish people, towards the Palestine inhabitants, whether Jew or Arab, and the League of Nations.

"We do not agree that there exists a diversion of interests between the Jewish and Arab working population in Palestine. There is room for both and understanding cooperation between both races is essential for the peaceful development of the country. The just claims and grievances of both communities must be met," he declared.

Labor organizations in America and the Zionist Federation of Jewish Labor cabled messages to the confer ence concerning the Palestine events.

KING FUAD DISCUSSES PALESTINE WITH RABBI (Jewish Telegraphic Agency)

Cairo, Sept. 30-King Fuad received Rabbi Haim Nachum Effendi, Chief Rabbi Haim Nachum Effendi, Chica Rabbi of Egypt, on Tuesday evening, and discussed the Palestine situation with him for fifty minutes. The king showed much interest and sympathy in the question.

The Chief Rabbi received this week many letters from Egyption sheiks and high government officials expressing their sympathy with the Jews in Palestine.

LOUIS LIPSKY REPLIES TO DAVID A. BROWN ON CHARGES AGAINST RABBI WISE

Declares It May Harm Cause of Unity: Brown Issues Reply

Taking issue with David A. Brown. Chairman of the Palestine Emergency Fund, for remarks of aspersion cast upon Dr. Stephen S. Wise by Mr. Brown in a statement to the news-papers of Sunday, Louis Lipsky, President of the Zionist Organization of America in a statement before a special meeting of the Administrative Committee of the Zionist Organization held all day Sunday at the Hotel As-tor, characterized as "baseless and uncalled for and hurtful to the cause of unity" the charge made by Mr. Brown that Dr. Wise had broken the united Tewish front. Mr. Lipsky's statement was as fol-

"It is to be regretted that David A. Brown should have made the statement attributed to him in the press on Sunday morning. Had he known the facts he would not have spoken as he did and raised the question of a united front at this time. He could easily have ascertained the facts from Felix M. Warburg, who knows the source of the proposal for the calling of an all-Jewish American conference for Palestine. It was at the invitation of Palestine. It was at the invitation of Dr. Chaim Weizmann, President of the Jewish Agency, that Dr. Wise, forgetful of past differences, placed himself in the service of the Zionist Administration, promising to further the call-ing of such a conference. This conference was not to be an independent effort, but was to emanate from the Jewish Agency, of whose Administrative Committee Mr. Warburg is Chairman. Approval of the calling of this conference, leaving the date open, was given by the National Executive Committee of the Zionist Organization and by the Executive Committee of the American Jewish Congress.

"When the American Jewish Congress received a reply from Mr. Warburg suggesting that a conference at this time would be premature, the American Jewish Congress agreed to abide by his decision. The insinua-tions of Mr. Brown regarding Dr. Wise are therefore baseless and uncalled for, and, I am afraid, may be hurtful to the cause of unity which Mr. Brown thinks he is serving."

Cleveland Jewish Center Case to Be Appealed to Supreme Court By Our Cleveland Correspondent

Cleveland, Sept. 30-Abraham Katz, who headed the committee of the Orthodox members of the Jewish Center here, which waged the legal fight for the restoration of the Orthodox ritual in the Center, is expected to appeal to the Supreme Court against the ruling of the Court of Appeals, dismissing the suit as a strictly ecclesi-astical question. The attorneys for the Orthodox committee hold that the present court decision is a reversal of another Court of Appeals decision that the case was not subject to dismissal on a demurrer that had brought a previous dismissal of the suit in the county court. Rabbi Solomon Goldman, who was

instrumental in changing the ritual from Orthodox to Conservative at the Center, recently resigned to head a synagogue in Chicago. He was suc-ceded by Dr. Harry S. Davidowitz, formerly of New York City. Dr. Davidowitz is a graduate of the Jewish Theological Seminary.

The opinion written by Appellate Judge John J. Sullivan, unanimously affirmed by his two associates, read:

"The prayer for this court to adopt a rule by which the congregation in question shall abandon its present ad-ministration and conform to the doctrine of traditional orthodoxy and Judaism, even if this legal tribunal had the right to interfere in religious matters for which provision has been made as to the control within the church itself, is incapable of being granted for the reason that every member of the congregation of the church might have a different view as to what this doctrine is in all its various phases and it would be impossible to lay down a rule, with these conflictcould follow, because in order to do so, the religion would have to be as definite as a science and even with respect to science it would be impossible to do so because of the divurging opinions that exist among scientific men upon scientific principles." The suit, which had been previously

dismissed by the Cuyahoga County Common Pleas Court, was aimed principally at Rabbi Solomon Goldman, head of the Anshe Emeth Beth Tephilo Congregation, which has been a consolidation of two congregations since January 1, 1917. Among other of the 24 defendants were the trustees of the Center.

Following the consolidation, according to the minority group's claim, the congregation was operated as strictly Orthodox for about six years. with the installation of Rabbi Goldman and the building of the present Jewish Center, it was claimed, hostility has been shown to Orthodox Judaism and all the ritual and ceremonial observ-ance pertaining to it. BRITISH COMMISSION OF INQUIRY AGAIN POSTPONES DEPARTURE FOR PALESTINE Decides to Admit Counsel for Both

Sides and Permit Cross-Examination (Jewish Telegraphic Agency)

London, Sept. 30-The British Parliamentary Commission of Inquiry, which was scheduled to sail for Palestine on October 3, has again postponed the date of its departure probably until about the middle of October.

An announcement issued by the Colonial Office stated that the postponement was decided upon in order that all parties who are principally concerned in the inquiry into the causes of the recent Palestine outbreaks may have ample time to adequately arrange the presentation of their interests to the Commission. At a meeting held at the Colonial

Office Sunday the Commission decided, the Jewish Telegraphic Agency correspondent learns, to permit the parties concerned to be represented by counsel at the sessions of the Commission. The counsel will also be permitted to cross-examine witnesses in the usual way. No further meetings of the Commission will be held before its departure.

SETTLE DISPUTE WITH ROUMANIAN ACADEMY

(Jewish Telegraphic Agency)

Vienna, Sept. 30-The dispute between the Sephardic community of Vienna and the Roumanian Academy of Science over the legacy of the late Jewish millionaire philanthropist, Elias, was settled out of court.

The Academy agreed to pay to the Vienna community the amount of 60,000 schilling outside of the costs of the trial

Elias had left a large sum with the Academy as trustee for a foundation, the proceeds of which were to go to the Sephardic community. The will was filed before the war, but due to the deflation of the currency, the sums which the Academy was willing to pay, on the currency specified in the will, was negligible.

men, were given the maximum punishment as an example to others who might be similarly tempted.

Fifty troops surrounded the court house while the verdict was being pronounced. An armored car was stationed at the exit of the courthousy where an enormous Arab crowd broke into a terrible wail when the prisoners were marched out in chains.

Three Arabs were sentenced to prison terms on charge of blackmail. Gante, the leader, was sentenced to six months and his accessories to the crime to four months each. They were found guilty of having extorted money from a number of Arab families in Mejdel, by threatening letters signed, "Black Hand."

One of the letters was sent to a police officer, who placed marked money where the writers of the letter had directed and captured them when they came to collect.
