MOVE STRONG MILITARY FORCES TO JERUSALEM ON EVE OF ROSH HASHANAH Military Regulations Describe Objects

Permissible at Wall; Moslem Gate Closed; Machine Guns Ready

Jerusalem, Oct. 4-Eight hours be-fore the Jews of Jerusalem were to hold their religious services at the Western Wall of the Temple, commonly known as the Wailing Wall, ushering in the Jewish New Year, 5690, the British authorities took extraordinary measures of precaution to prevent the recurrence of any disturbances at the sacred area. It was the disorders which occurred on August 15 in the precincts of the Wailing Wall which gave rise to the Arab attacks and bloodshed.

At ten o'clock Friday morning a most formidable military force moved into the bazaar to reinforce the police squads on guard there. Infantry, machine gun units, bombing squads and aeroplanes were sent to the scene, where the Moslems were about to Mosque of Omar and the Jews, later in the afternoon, for their Rosh Hashanah prayers-in-front of the Wailing Wall.

Moving from three sides, the military forces took up their position at the Citadel of David. Steel-helmeted Tommies lined the streets and the semidark alleyways leading to the Wailing Wall. New armored cars recently brought from Egypt occupied strategic (Continued on Page 4)

LACK OF CONFIDENCE IN LUKE IMPLIED IN ARAB REQUEST TO CHANCELLOR Ask Luke Be Relieved of Handling Arab Executive Complaints

Jerusalem, Oct. 4-Lack of confidence in H. C. Luke, Civil Secretary of the Palestine government, was implied by the Arab delegation in its interview with the High Commissioner on Ved-nesday. The delegation proposed that Major Mills, Assistant Chief Secretary, and Antonios, a Syrian, member of the Secretariat, should handle all com-plaints and petitions submitted by the Arab Executive for the 11igh Commissioner, evidently not desiring Mr. Luke's intervention.

The Arab paper "Felestin," which is responsible for this report, asserts that the High Commission promised to consider permitting Mr. Drayton, Assistant Attorney General, to cooperate with Attorney General Norman Bentwich on all Arab cases.

The Arabs also protested against alleged corporal punishment of prisoners. The High Commissioner requested the delegation to issue a notice allaying excitement among the Arabs.

The regular religious services at the Wailing Wall were renewed on Rosh Hashanah eve, Friday, at 4 P. M. in the presence of police and military. A superabundance of military precautions marked the occasion, as the District Commissioner, his Jewish and Arab assistants, as well as the Police Commandant, were on duty, while an additional number of Palestine police patrolled the passages leading to the Western Wall.

Rabbi Chaim Sonnenfeld, the aged Orthodox leader of Jerusalem, conducted the services, completely oblivious to the bustling officials, leading his congregation which did not exceed twenty worshippers as if thousands were jostling around him.

The pavement before the Wall was stripped of all furniture and appurtenances, in accordance with military regulations issued the day before, except a diminutive washstand, a small table for the reading of the Torah, a book-rack and an Ark. All articles were previously measured and stamped by the government. No benches, stools or mattings were allowed. The passage was entirely dark except for an acetyline lamp erected just before the service began near the newly built entrance to the Mosque overlooking the passage from a height of about fifty Col. Frederick H. Kisch, member of

the Jerusalem Zionist Executive: Jacob Fishman, managing editor of the New York "Jewish Morning Journal," and Gershon Agronsky, correspondent of the Jewish Telegraphic Agency, formed a part of the small congregation which came to worship at the Wall. the congregation increased to several hundred, being comprised of members of all communities with a fair sprinkling of American tourists. A number of women came, clinging to the northern part of the passage to the right of the spot where last Yom Kippur a filmsy screen divided the men and women worshippers. The screen was prohibited this year, pending the definition of what constitutes the status quo at the Wall.

Refugees quartered in the public buildings celebrated the New Year as usual, many crowding the synagogues, others making a pilgrimage to the Western Wall, all doing their best not to remember that they were fugitives from quarters still considered not entirely safe for them to return

MacDONALD ON ARRIVAL SAYS HE WILL MAKE STATEMENT TO JEWISH DEPUTATION Declares His Views, Expressed in 1924 Article, Are Unchanged

Ramsay MacDonald, Premier of Great Britain, arriving in New York on the steamer Berengaria, declared to the representative of the Jewish Daily Bulletin that the Labor cabinet has made it clear that there will be no deviation on the part of the present government from the Balfour Declaration. Except for this statement, the Premier declined to discuss the Palestine situation in detail.

"I am occupied with Anglo-American The Palestine question is relations. being handled by Arthur Henderson, Foreign Secretary, and Lord Passfield. Besides, I will receive a deputation of the Jewish Agency in New York on October 11, when I will have an opportunity of saying more," Premier MacDonald stated.

EXEMPT JEWISH COLONIES FROM COLLECTIVIZATION DAY ON YOM KIPPUR Instructions to This Effect Issued by

Smidovitch, Vice-President of U. S. S. R.

Moscow, Oct. 4—Jewish colonists in the Ukraine and White Russia were exempt from observing Collectivization Day, proclaimed by the Soviet authorities, for October 14, coinciding this year with the Day of Atonement.

Over the signature of Peter Smido-vitch, vice-president of the Union of Socialist Soviet Republics, telegraphic instructions were issued today by the Wzik, All-Russian Executive Committee, to the Ukrainian Comzet and the Crimean Zik, to exempt the Jewish colonists. "If the carrying out of the Collectivization Day on October 14 meets with hindrances in the Jewish colonies, the Wzik has no objections to postpone the Collectivization Day for the Jewish colonists for a following day. Inform the respective authorities and take the necessary measures," the instructions stated.

The instructions were issued following a session of the Wzik, when attention of the members was drawn to the coincidence of the holiday and the collectivization day. The correspond-ent of the Jewish Telegraphic Agency learns that Mr. Smidovitch was interested in having the Jewish colonists participate in the collectivization day voluntarily, without compulsion. order to secure Jewish voluntary participation, the exemption order was issued, showing that the authorities had no anti-religious purpose in the setting of the day for October 14.

DR. LEE K. FRANKEL RETURNS URGES UNDERSTANDING WITH ARABS IN PALESTINE Conferred with MacDonald Aboard S. S. Berengaria

Dr. Lee K. Frankel, vice-president of the Metropolitan Life Insurance Company, and a member of the administrative committee of the Jewish Agency Council, returned on the "Berengaria" Friday. HIGH HOLIDAYS CREATE UNEASINESS IN JERUSALEM RIGHT OF SELF-DEFENSE

The same applies to Jaffa, where the unfounded flying report of a pitched battle approaching, on Wednesday caused a near panic, the shops closing rapidly, merchants and the bazaar crowds, including women, scuttling for cover, bringing business to a complete standstill within a few minutes. To ance of an open signal for alarm in low-flying observation planes roaring above the thoroughfares of the port

district, firing spasmodic, chain-rattle machine-gun salvos into the air, either

large congregations in the streets to

disperse.

When such news reaches Jerusalem, the coffeehouse gossips get busy, exerting their amazing inventive genius, distorting the events out of all pro-portion to their real importance. Special efforts like these were apparent on Thursday to prepare the population for grave happenings on Friday, which is the Jewish New Year, usually drawing large crowds of worshippers to the Wailing Wall. The fact that this year the holiday falls on Friday, which is the Mohammedan Sabbath and therefore occasions an influx of thousands of outside Moslems for prayer at the Mosque of Omar, is foreshadowed as extremely grave. The strengthening of the police patrols was pointed to as indicating that the government is aware of the serious portents and the significance of this was magnified beyond recognition.

The rumor mongers are playing the game of the fanatical religious leaders who are anxious to impress the government and public opinion that the Arabs are at the end of their patience. They realize that world opinion unanimously condemns the recent savagery accusing them of instigation of the troubles for their own ends to maintain their hold on the Arab peasantry. They are now aware that retribution is coming, as their attempts to intimidate the Jews have completely failed. They are feverishly stirring up trouble in order to convey the impression that the anti-Jewish movement is of national scope. If they fail this time, they will be completely discredited.

The opinion is growing in all sections of the population, Jewish, Arab and English, that the only means of extricating the country from the eco-

All classes are anxious to resume their peaceful pursuits, not the least being the Arab merchants, who are seriously concerned over the falling off of their profits and prospects of a further decline in commerce.

The postponement of the arrival of the Commission of Inquiry acted detrimentally, as obviously lengthening the present time-marking period, which is due to the general belief that normalcy will not return until the inquiry is behind.

TESTED IN TRIAL OF JEW WHO FIRED AT 300 ARABS Claims for Damages in Jerusalem and Vicinity Total £303,000

(Jewish Telegraphic Agency)

Haifa, Oct. 4-The right of self-defense is being tested before Judge Litt in the case of Joseph Kranitz on the charge of attempted murder by shoot-ing at a mob of 300 armed Arabs advancing on the lewish colony Hadar Ha'Carmel on August 24.

Two Arab policemen are the principal witnesses against Kranitz. They assert that they saw Kranitz fire at the advancing horde after they had failed to disperse the mob. The policemen declared they did not know the exact object of the mob in advancing on Hadar Ha'Carmel.

Jerusalem, Oct. 4-The former Ouartermaster Sergeant Marshyim and another Jerusalem Jew, Zweig, were jailed following their arrest yesterday. No reason was given for the arrests.

Jaffa. Oct. 4-Two Arab youths who were imprisoned here for incitement have declared a hunger strike.

Arab orange growers and commis-sion merchants here are endeavoring to organize for the sale of oranges through a committee of their own. It is estimated that a million boxes of oranges would be shipped by the Arab growers. Their object is presumably in order to avoid dealing with Jewish growers and commission merchants.

Jerusalem, Oct. 4-Claims for damages in Jerusalem and vicinity during the disturbances, total £303,000, according to a report published here.

Jerusalem, Oct. 4-After being acquitted on the charge of carrying hand grenades, two Jewish youths of Jeru-salem were fined £25 or two months imprisonment each for the possession of revolvers during the riots. The leased.

Four Communists Sentenced

Jerusalem, Oct. 4—The trial of ten Communists arrested on August 3 for resisting the police during an illegal demonstration was concluded today. Six were acquitted and four sentenced to three months imprisonment each. They are to serve one month each, having spent two months in prison before trial which was postponed owing to the disturbances in the country.

A tumultous scene took place in the courtroom when the prisoners refused to be handcuffed, saying they are willing to go to prison peacefully. They are political prisoners and handcuffs were, therefore, unwarranted, they declared. The judge replied that it was a police matter, whereupon policemen handcuffed the prisoners but not before they were overpowered and thrown to the floor. The noise attracted policemen outside the court, some of whom broke in through a window and drew their revolvers. Forty Brit-ish and Palestine police were in the courtroom before the scene ended.

"I repeat against the villagers of Beitdaras the words of Disraeli: 'They who are our bread have risen against I ask the court to find these fifteen villages guilty and subject them to the heaviest punishment," the public prosecutor declared.

The headsmen did not reply, asking postponement of the investigation until Monday, which was granted.

Regarding another village, Zeunis, the judge found the charge against it unproven and released the headsmen.

Two Jewish policemen in Jerusalem are under arrest following refusal to patrol sections exclusively inhabited by Arabs because they were not al-lowed firearms. The refusal followed the policemen's written request a few days before for rifles which was refused. They were ordered on duty armed only with batons.

It was stated that Arab policemen are not being sent on duty in the Jewish quarters, where they are not ex-

posed to danger.

Regulations for the holding of Jew-ish services at the Wailing Wall were issued by the military authorities Friday morning. The regulations stipu-lated that all appurtenances brought by the worshippers to the Wall must be in accordance with dimensions fixed by the government and that no outside objects are to be introduced.

The recently opened door to the right of the Wall, leading to the Mosque of Omar area, is to remain closed during the Jewish holidays so that no Arab muledrivers will be able to drive their animals across the pavement before the Wall as was often the practice in the past. All traffic past the Wall is to be suspended.

The marching in of the troops, bringing with them field kitchens and munition caissons, brought out the crowds which lined the sidewalks along Jaffa Road leading to the Old City. Overhead roared the planes as apparently the authorities intended to make an impressive demonstration of power.

Jewish Defender Sentenced to 4 Years Hard Labor

A youthful Jew named Elazar, an employee of a British concern in Jaffa was sentenced by the Jaffa District Court today to four years at hard labor for wounding an Arab during the turbulent days. Sentence was pro-

nounced by Judge Kermack.

Elazar's counsel, Mr. Horowitz of the Zionist Executive, pointed out that the mood of the Arab mob in Jaffa on that day justified the gravest apprehension on the part of every Jew.
