TWO JEWISH POLICE-MEN DISMISSED FROM JERUSALEM FORCE Safed Murderers Go on Trial in Haifa; 65 Arabs Summoned

(Jewish Telegraphic Agency)
Jerusalem, Oct. 8—The two Jewish
policemen of the Jerusalem force who
refused to go on duty in unsafe Arab
quarters without being permitted to
carry frearms were dismissed from
the force.

The Hebron police informed the Chief Rabbinate that thirty-two Scrolls of the Law had been saved during the massacre. The Scrolls are now at the Hebron police headquarters.

The trial of Arabs charged with murder in the massacre perpetrated at Safed opens today in Haifa. Sixtyfive Arabs have been summoned to

appear.
The Moslem Christian Association of Jaffa despatched a cable to the British Colonial Office and a telegram to the Palestine government demanding the abolition of the collective punishment ordinance, providing the imposition of payment for damages on villages guilty of participating in the riots,

The Arab Executive is sending delegations to the Moslems of Iraq, India and Hedjaz to conduct propaganda and raise funds for purchasing land in Palestine to be added to the Waqf property (religious foundation).

The Arab paper, "Felestin," reproducing a summary of the appeal issued by the Brith Shalom, Palestine Jewish organization seeking amity with the Arabs, mocks at the organization and alleges that the latter was established for the purpose of "misleading the Arabs and concealing the true Jewish aims."

JEWS EXEMPT FROM TURK-ISH RESTRICTIVE ORDER (Jewish Telegraphic Agency)

Constantinople, Oct. 8—Turkish subjects belonging to the national minorities are forbidden to leave the city of Constantinople for other towns, even in the adjoining provinces, according to

an ordinance issued.

Only Jews are exempt from this restriction, being permitted to travel anywhere.

JEWISH MERCHANTS SEEK TO BREAK ARAB BOYCOTT

RULES BIALIK JUSTIFIED IN ATTACKING BRAININ, BUT EXPRESSIONS TOO SHARP Dramatic Trial in Berlin Between Famous Hebrew Poet and

Reuben Brainin (Jewish Telegraphic Agency)

Berlin, Oct. 8—Chaim Nachman Bialik, famous Hebrew poet, was justified in his attack against Reuben Brainin in connection with the latter's attitude toward the Russian Jewish question, but he used too sharp expressions in the statement he signed on May 21 in behalf of a group of Hebrew writers in Tel Aviv.

This was the verdict handed down by the Zionist Congress Court acting as a court of honor, under the chairmanship of Dr. S. Gronemann. The trial, in which Brainin was the plantiff and Bialik the defendant, lasted all night Monday. Mr. Brainin is to pay ninetenths and Mr. Brainin is to pay ninetenths and Mr. Bialik one-tenth of the court expenses.

The trial grew out of the issuance of a statement by Mr. Bidlik in which Mr. Brathin was charged with being "a raitor" to the Zionist cause and "a falsifer" because he allegedly kept quiet, following his visit to Soviet Russia two years ago, about the persections of the Hebrew language and zionism in Soviet Russia. AUSTRIAN PRESS LAUDS
VIENNA ROTHSCHILD FOR
SAVING CREDIT INSTITUTION
"Schober and Rothschild Saved Austria," Recurrent Note in Press

Vienna, Oct. 8—The action of the
Vienna branch of the Rothschild house
in saving from bankruptcy one of the
leading Austrian credit institutions
which was formerly the Imperial Court
Bank, is praised highly in the Austrian
press as an act of high patriotism coupled with business caution.

The bank which specialized in land credit was boset by difficulties and the new Prime Minister, Schober, appealed urgently to Louis Rothschild who was away on a hunting trip to return and see what he could do to save Austria's credit abroad. Mr. Rothschild complied with the Prime Minister's request and confidence was restored when the government issued a community of the composition of the complex of the com

It is stated that the Rothschilds are carrying through this transaction with the cooperation of their American business friends.

The laborite press took the occasion to attack the anti-Semitic government parties and in particular the Christlich-Soziale party which "had to call on a Jewish banker to save Austria."

Jewish banker to save Austria."
"Rothschild saved Austria" or "Schober and Rothschild saved Austria" is the note running through the Austrian press, including even the "Arbeiterzeitung." It is pointed out that Rothschild's action prevented the collapse of the second largest bank in Austria which would have inevitably ruined many important industries causing the unemployment of tens of thousands of workers. This is openly admitted by the Hakenkreuz press which, however carried simultaneously appeals for anti-Semitic meetings against "the Jewish capitalists and swindlers."

GIFTS TO EMERGENCY FUND CONTINUE

The attitude of the Jews of America regarding the disorders in Palestine. as evidenced by their immediate and generous response to the Palestine Emergency Fund, and the vigorous protests by Christians as well as Jews against the riots there, prevented fur-ther atrocities, according to a cable to David A. Brown, chairman of the Palestine Emergency Fund, from Jonah J. Goldstein, New York lawyer, who is now in Jerusalem. Mr. Gold-stein left for Palestine recently at the request of Felix M. Warburg, chairman of the Administrative Committee of the Tewish Agency, in order to render advice and assistance to Col. Frederick H. Kisch, the head of the central relief committee in Palestine, through which relief is being extended to the Jewish refugees in Jerusalem and Tel Aviv. He is accompanied by Mrs. Goldstein.

Mr. Goldstein's cable to Mr. Brown is as follows:

"Terusalem, Oct. 6. "The attitude and spirit of Ameriand immediate response to the Palestine Emergency Fund, and also the Icws in America against the barbarous massacres here saved the day, and doubtless prevented further atrocities. More important is the fact that these things gave courage to the Jews of Palestine who are most grateful and send New Year greetings to their brethren in America.

JEWS IN LITHUANIA HELPLESS, AMERICAN DELEGATION FINDS

75% of Jewish Population Dependent on Funds from U. S.

The Fact-Finding Commission which the Federation of American Jews of Lithuanian Descent sent to Lithuania, has just returned. The Commission consisted of Herman L. Winer of New York, Judge William M. Lewis of Philadelphia, Elihu D. Stone of Boston, and Maurice Rosenblum of Flint,

The Commission, which was sent to Lithuania by the Federation to make a thorough investigation of the Jewish situation, reported as follows: The situation of the Jews in Lithu-

ania is almost helpless. The country has practically no trade relations with the important centers of Europe. As a result, exports have shown a great decrease, and the Jews have almost no means of making a livelihood. It is hardly an exaggeration to say that about 75 per cent. of the Jews await impatiently the funds which are sent

from America. The political situation is more cheer-

ful. There is no parliament in Lithtania at present, but from the conversations the Commission had with Premier Waldemaras and other officials of the Government, there seemed to be the impression that an understanding could be reached between the Government and the Jews. Such regrettable occurrences as the recent disturbances in Slobodka can be avoided in the future. As a result of the Commission's interview with Premier Waldemaras, the police official in the Slobodka district was punished. Prof. Waldemaras promised to acquaint himself with other Jewish demands, as he had not been in direct contact with the Jewish leaders for some time. The Jewish leaders in Lithuania feel that the interviews of the Commission with the Government authorities were important steps toward the betterment of the political situation of the lews. The Commission also conferred with

the lewish leaders and representatives of all lewish organizations regarding the economic situation. As a result of the failure of the crops last year the conditions had grown far worse, and had it not been for the relief funds sent over by the Federation of American Jews of Lithuanian Descent, many people would probably have starved.

The only economic institution of the Jews is the Folks Banks. There are 86 branches throughout Lithuania. These banks lend money to the Jews who can afford to pay interest and have some sort of collateral to offer. But there are many Jews who are unable to borrow from these banks and the only hope for them is the establishment of free loan institutions. The Commission proposes that the Federation begin a campaign to raise funds Folks Banks and to establish free loan banks.

84 POULTRY DEALERS FACE 3 YEARS PRISON, \$15,000 FINE FOR VIOLATING TRUST ACT Trial Ends in Mistrial on Second Day: Resumed After 40 Minutes

A mistrial, because Juror No. 7 recognized Benjamin Simon, one of the principal defendants, as a friend, brought to a temporary end, yesterday, on its second day, the trial of 84 poultry dealers charged with violation of the Sherman Anti-Trust Act and with maintaining a reign of terror over the \$50,000,000 live poultry business in the metropolitan area.

The trial was resumed 40 minutes later before Judge John C. Knox in the U. S. District Court, when a twelfth juror was chosen, and attornevs for both sides had consented to accept the remaining eleven jurors.

The defendants face a possible sentence of 3 years in prison and a fine of \$15,000 each. The trial is expected to last six weeks.

Of the eighty-four defendants, seventy-seven are officers and members of the Greater New York Live Poultry Chamber of Commerce, three officers of the Official Orthodox Poultry Slaughterers of America, Inc., and four officers of Local 167 of the International Brotherhood of Chauffeurs, Teamsters, Stablemen and Helpers of America.

A grandstand was erected in the court, on which the defendants were seated in six rows, each banked higher than the other.

The first day's proceedings were enlivened by the protests of the counsel for the defense, Arthur N. Sager, who contended that the structure was not only uncomfortable but unconstitutional. Declaring that the men in the upper rows were deprived of their constitutional right to consult with counsel because of the seating arrangement, he moved that the trial be adjourned until the stand erected as a cost of \$417 be taken down and replaced by chairs with backs. Without disposing of this motion, Judge Knox proceeded

to impanel the jury. Benjamin and William Simon of the Live Poultry Chamber of Commerce pleaded guilty after the jury was chosen. A third defendant, David Wernick, pleaded guilty last week, and a fourth, Louis Cohen, absent because of illness, will be tried separately later.

HEBRON, FIVE WEEKS AFTER THE MASSACRE

By Gershon Agronsky

(Staff Correspondent, Jewish Telegraphic Agency) regarding Hebron, it is not purposed to add descriptions of the gruesomeness accompanying what is going down in Jewish history as the "Hurban Hevron." The destruction was in the minds of all Jews reciting the Nessan-eteker on Saturday and Sunday, a stricken people adding the massacres of Hebron and Safed to the insufferably long martyrdoms of a hunted

On the eve of the New Year an expedition went on Thursday to Hebron to prepare a report on behalf of the reconstruction committee, to inspect the ground whereon, should the Hebron survivors or others desire it, a new lewish quarter would be reared as soon as expedient, replacing the ancient murder traps of the old ghetto. H. Wolofsky, publisher of the "Canadian Jewish Eagle," Montreal; M. M. Ussishkin, two Jerusalem businessmen, Mohl and Perlman, a representative of the Sephardic community and one of the Ashkenazic community, as well as one Hebronite, were members of the expedition, which did not intend to examine the horror striking evidence of the inexplicable visitation of seven Fridays ago. It practically avoided the deserted ghetto, which has been boarded up on all sides by the authorities, pending the Commission of Inquiry's probable visit. We did not expect to visit Slonim's and the other houses of slaughter, to which entrance is allowed by special permission of the Chief Secretary.

We closely inspected the empty lots belonging to Jewish societies in the Jewish quarter overlooking the smiling olive groves and vineyards just under the windows of antiquated tenements, where modern cottages and gardens are planned if, when the wounds are healed, when the memory of the sixtysix victims ceases to haunt them, when the Jews will become reconciled, as they undoubtedly will, once more to reside amidst the neighbors, friends and lifelong associates who suddenly became slaughterers of men and rapers of women.

But the practical commission could not help seeing things such as the wrecked and charred Hadassah clinic, which for more than a decade cured the Arabs who turned around and destroyed the premises, pillaged the medicants which had saved them from decimation by loathsome diseases; it could not help hearing reports of the mob's demand that A. D. Slonim should surrender the "foreigners," meaning the Yeshiva students sheltered in his house if his and his family's lives were to be spared and the martyr's historic answer, "We Jews are one."

We fingered in the former home of the Slobodka Yeshiva, a large, wellventilated, bright, white, square hall, with windows overlooking the fertile valley. The hall, which accommodated \$5,000 scholarship, the interest of this year.

presented Mr. Bialik, turning his defense plea into an accusation stated that Russian Zionists handed over to Mr. Brainin material concerning the martyrdom of Russian Zionists for transmission to the proper Zionist bodies but Mr. Brainin failed to deliver the material. On the other hand, Mr. Brainin praised in the most laudatory terms the Russian Jewish colonization although the Jew-ish colonies there are nothing but Marrano colonies, Mr. Bialik stated. Mr. Bialik further charged that Mr. Brainin accepted praise from the Soviet press and failed to deny reports published in the Yiddish Communist daily, "Frei-heit," of New York wherein he was quoted as having made anti-Zionist references at a public mass meeting. He therefore felt that the reproach against Mr. Brainin was justified. He wished to add, however, that there occurred an error in the published text of the declaration. Instead of "Boged" (traitor)
"Moel" (one who abuses confidence placed in him), the correct version was that Mr. Brainin was guilty of a "Beged Maal" (faithless treason), Mr. Bialik stated.

Dr. Seadiah Mase and Mr. Jehudi were heard as witnesses supporting Mr. Bialik's description of the persecutions of the Zionists and the Hebrew lan-

guage in Russia.

Mr. Brainin, in a moving address, re-ferred to his forty-five years of work in Hebrew literature and in the Zionist movement to which he has always maintained a hundred per cent loyalty and devotion. He found it necessary, however, to say that the body of Russian Jewry must be saved from starvation so that the Jewish spirit may sur-vive. He therefore thought that the colonization work, being an action to save large masses of Russian Jews, was in accordance with the meaning of Zionism. On the other hand, he realized that protests would be of no avail. He has submitted the material given him by Russian Zionists to competent Jewish bodies. The reports in the "Iz-vestia" and the "Freiheit" concerning his alleged addresses at public meetings were false, but he found it unimportant to issue denials. "I am weak and at the decline of my life. How could Bialik dare hurl at me the term of traitor? I demand justice!" Mr. Brainin exclaimed.

The verdict, issued at five o'clock in the morning and read by Dr. Gronemann, stated that Bialik's attack was to the point and justified, since a great Hebraist and old Zionist as Mr. Brainin has kept quiet on the persecutions of Zionism and the Hebrew language in Russia and, on the other hand, has ascribed an exaggerated importance to the advantages of the Jewish policy of the Soviet government. In so acting Mr. Brainin has created dangers for Russian Jews. Nonetheless, the court disapproves of Bialik's sharp words.

mouth at the orifice through which for centuries, the Jews inserted written petitions destined for Abraham's Tomb, whispered a prayer. In and out through the bazaars we went, the Moslem shopkeepers endeavoring to exchange compliments with our two Hebronite guides, who remained re-markably cool and almost haughtily aloof. Bejaia, our Sephardic mentor, a Mizrachi school teacher, walked unafraid, feeling that Hebron belongs to him more than to any murderous inciter, for his family has resided in David's City for three hundred and fifty years. Schneerson, our Ashkenazic friend, the son of a hotel keeper whose premises opposite the Sloning house was one of the moral fortresses of Hebron, protested against the onslaught because of his excellent relations with his neighbors, listened skeptically as one after another Moslem assured him they were not anywhere near Hebron on the fateful days. We heard again the now old story that the Moslems are burning many extra lamps to appease the spirits of the murdered lews.

An Arab police corporal asked me when I thought complete calm would be restored, to which I answered, "When some, at least, of the two hundred prisoners will expiate their crimes, serving as an example and warning to others. But even this is not altogether certain, since it is rumored the Mufti gave an undertaking to the family of Sheik Taleb Markah, chief instigator of the Hebron massacre, that the sheik will not pay the capital penalty."

Leaving Hebron hours later, we took
