ARABS AND JEWS PRO-TEST NEW REGULATIONS AT WAILING WALL

(Jewish Telegraphic Agency)

Jerusalem, Oct. 10—The new regula-tions at the Wailing Wall will cause new disturbances. This warning was made by Amin el Husseini, Grand Mufti, in a protest he submitted to the government against the regulations.

Objections to the regulations were also voiced by the Chief Rabbinate, the Zionist Executive and the Vaad Leumi, National Council of Palestine Jews, who protested particularly against the prohibition of benches for the worshippers in the area before the Wall. This is especially important for the Yom Kippur services, they pointed out.

A number of Hebron Arab notables informed the government that they will not be responsible for the security of Jews returning to the city where sixty-five were massacred unless the collective punishment ordinance imposing the payment of damages is withdrawn. A rumor current has it that the government is intending to pay only a small part of the damages suffered.

It is believed that the British troops brought here during the outbreak will remain in Palestine for at least half

a year.

Col. Frederick H. Kisch, member of the Palestine Zionist Executive, visited Safed yesterday. He thanked the chief of police there for the restora-tion of security. Col. Kisch also visited Acre where he thanked the authorities for the measures taken during the riots, so that the local Jews were little affected by the outbreak.

Two houses in the Georgian Jewish quarter of Jerusalem, evacuated by the inhabitants who still fear to return, were looted last night. The looters

P. E. C. VOTES \$250,000 NEW APPROPRIATIONS FOR PALESTINE WORK

Mufti Warns They Will Lead to To Build Small Houses in Town and New Disturbances Country: Declare This Most Country; Declare This Most Pressing Emergency Need

The Executive Committee of the Palestine Economic Corporation held a special meeting on Thursday at which reports from Palestine were received and considered.

The Committee fully considered the immediate problems in Palestine in the face of the present situation and particularly re-examined the problem of building small houses suited for the working classes of the Jewish population in town, village and country, in which field of work the Corporation has in the past allocated considerable funds. It was felt that the continu-ance and further extension of this housing work was one of the most urgent needs to further the agricultural and general economic life and that it would also be a most constructive contribution to cope with the present emergency. The Committee, therefore, voted an additional sum of \$250,000 for these purposes.

It was further agreed that \$1,000,000 was urgently needed for this work and plans were considered towards securing the balance of \$750,000 in the hope other bodies would be able to con-

NEW ANTI-SEMITIC STUDENT EXCESSES OCCUR AT BUDAPEST UNIVERSITY Invade Lecture Halls, Beat Jews; De-

mand Increase of Numerus Clausus (Jewish Telegraphic Agency) Berlin, Oct. 10-New anti-Semitic ex-

cesses broke out in the Budapest University, as the result of an agitation for an increased numerous clausus, limiting the number of Jewish students admitted to the universities, it is reported here from the Hungarian capital.

In the medical school the Jewish students were compelled to leave the lecture hall when a band of Hungarian students marching in two columns in-vaded the lecture hall, beating the lews, throwing them down the stairs and shouting anti-Semitic slogans.

Anti-Semitic agitation has been go-

ing on during the last several days in the technical school of the University where anti-Semitic leaflets were distributed. Clashes in the schools of philosophy, law and medicine were prevented two days ago when the Jewish students left the lecture hall upon the demand of the Hungarian students.

PEACE CONGRESS ADOPTS PALESTINE RESOLUTION (Jewish Telegraphic Agency)

Athens, Oct. 10-A resolution on Palestine was adopted by the Twentyseventh Annual International Peace Congress in session here. The resolution, adopted by a vote of

50 to 22, expressed regret at the recent events and formulated the hope that England will take measures to prevent the outbreak of new troubles.

FXECUTIVE PLANS TO SETTLE LEGIONNAIRES (Jewish Telegraphic Agency)

Jerusalem, Oct. 10-A plan to settle fifty former Jewish legionnaires in the colony, Kastinia, which was attacked during the recent outbreak, is being considered by the Zionist Executive. The legionnaires will be settled together with the returning colonists. Each legionnaire would receive 100 dunams. Fifteen former legionnaires are being settled in the colony, Rabia, by Jews of Riga.

500 CHALUZIM LEAVE FOR PALESTINE (Jewish Telegraphic Agency)

Constanza, Oct. 10-Five hundred Polish and Roumanian Chaluzim, pioneers, embarked today on their way to-Palestine.

Warsaw, Oct. 10—A group of 459 Chaluzim, Palestine pioneers, left to-day for Palestine. Among them were 300 from Galicia. A throng of many thousands were at the railroad station to bid them farewell.

RIGA JEWISH HOSPITAL

EJECTED FROM QUARTERS ON CLAIM OF CHURCH Purchased House But Held Site on Lease; Action Based on Senate

Ruling (Jewish Telegraphic Agency)

Riga, Oct. 10-Acting on a court order issued by the Latvian Senate, the police yesterday put out on the street the belongings of the Riga Linas Hacedek, Jewish hospital society, at 118 Dzirnavn Iela Riga. The belongings remained on the pavement throughout the night, while the patients in the hospital as well as the staff gathered in the hospital ward and declared they would not leave the hospital building unless ejected by force.

The case which culminated in the

action of the police yesterday, dates back many years. In 1920, T. Chedack, president of the Linas Hacedek, purchased from the Church of Jesus an old house, ruined during the warfare, at 118 Dzirnavu Iela, at the price of 120,000 Russian roubles. No feudal deed was obtained in view of the unsettled conditions. Only the house was purchased, while it was agreed the church be paid 20 Latvian roubles annually as rental for the site, part of

the church's property.

With the aid of an appropriation from the American Jewish Joint Distribution Committee, the house was repaired and equipped for a Jewish maternity hospital at a cost of 3,000,000 Latvian roubles.

The church, however, demanded that nal purchase price, which, at the present rate of exchange, would amount to \$385. The claim was brought before the Senate, which granted a judgment to the church on the basis of an ancient Russian law that the seller has the right to repurchase at the sale price.

No appeal from the Senate decision was possible. A number of Jewish deputies attempted to secure relief from the order and representations were made to President Semgal. In the meantime the Linas Hacedek arranged to pay a monthly rental of

POLICE FRUSTRATE ATTEMPT AT ANTI-JEWISH DEMONSTRATION IN JASSY Students Endeavor to Fasten Guit for Attempt on Vaida's Life on Jewish Population

(Jewish Telegraphic Agency) Bucharest, Oct. 10-An attempt by Roumanian students to hold a protest demonstration against the Jews of Roumania in connection with the unsuccessful attempt on the life of government member Vaida by a group of Communists including Abram Golden-berg was prevented by the police. The anti-Semitic students attempted to fasten the guilt of the occurrence on the Jewish population. No disturbances occurred in other parts of Roumania as a result of the unfortunate incident.

The police arrested a number of students. New arrests were also made by the police in connection with the Com-munist plot. Two Jewish and two Romanian young Communists were found at the secret headquarters of the Communists.

The parents of young Goldenberg, aged folk, were deeply grieved over the misdeed of their son and pleaded to the officials that their son's action cannot and should not be ascribed to the Jewish population. This opinion was concurred in by leading members of the Ministry of the Interior who stated that the Jewish population cannot be held responsible for the misdeed of one individual.

COMMUNIST YOUTH BAR REIZEN FOR PALESTINE VIEWS (Jewish Telegraphic Agency)

Moscow, Oct. 10—Because of his resignation from the editorial staff of the "Freiheit," New York Communist daily, to whose attitude with regard to the recent Palestine events he object-ed, Abraham Reizen, Jewish writer, was excluded from honorary memberwhich was granted him during his re-cent visit here. It was also decided to take from him his red pioneer neckband given him. The organization, in making these decisions, branded Reizen as a "traitor."

THE SAFED TRIAL PROCEEDS

Haifa, Oct. 10-The grim tragedy of the Safed attack on the sixth day after the Jerusalem outbreak, when Safed Jews believed they had escaped and while nearly the whole country was embroiled they were safe, was today painfully recalled piecemeal as the Jewish witnesses courageously testified against the three young Arabs accused of the murder of Isaac Mamaan.

The court was opened this morning with Assistant District Officer Bergman as the Hebrew interpreter. Everybody, the witnesses, the inscrutable British Judges and the public jammed into the courtroom no bigger than a small liv-ing room, breathed a sigh of relief. The proceedings were only marred by the grueling cross-examination.

The cross-examination, however "fish ing" did not shake Joseph Benderly's evidence that he saw the three accused and a fourth man, who absconded, at-

tack Mamaan.

Mordecai Klinger, young, tall, with a blond mop of hair, squarely facing the lawyer who was seeking to discredit him, proved an excellent, impressive witness earning the Chief Justice's re-peated approbation. He corroborated under unceasing fire that Benderly told him, as they both sped to their houses. which they heard were burning, to run for his life from Mamaan's assailants who had just appeared. While Benderly escaped, Klinger was trapped and a knife was about to descend on him when one of the accused for some re-

son said "Pass." This dramatic scene was told simply Klinger only pointing to the accused man who saved him from certain death. Simplicity and directness also marked Klinger's recital of how they heard their houses were burning while the mob fired on the defenseless occupants. Without pathos, answering a direct question about his house which also served as a bank-Klinger is the son of Safed's richest Jew-he said: "When I heard my family was attacked, I thought of my people not the property."
Without moving an eyelash he identified the prisoners as Maughanan rained blow upon blow on his credibility.

Klinger unflinchingly spoke only through the Hebrew interpreter, dis-

He described himself as "a son of Arabia" and was distinguished from the Ashkenazic witnesses with whom he admitted he had little to do, although he knew all of them as well as the Arabs, including the prisoners whom he saw attack Mamaan with "daggers gleaming in the sun." Eyes sparkling, arms eloquently gesticulating, Nissim, who is a tinsmith, held the court enthralled with his simple narrative, fencing with the Arab counsel's purposeless questions which again exasperated the harassed Judge to warn the second lawyer "Please don't burst out into unnecessary outbreaks." When the lawyer attempted to bully the unshakeable eyewitness, Nis-sim said: "We were that day like floating wreckage. Our brains were not in our heads. We did not know whence death would come.

The small courtroom was crowded to suffocation at the first night session of the murder trial last night, the glaring unshielded electric lights making brighter the Chief Justice's scarlet robes. Two witnesses for the prosecution were heard, one, Nissan Finkelstein, 70 year old native of Safed, who spoke in Yiddish, to which the Arab defense objected as an unofficial language but the court ruled as permissible, as the venerable Yeshiva man, versed in Hebrew lore and acquainted with the Arabic vernacular, expressed himself best in Yiddish. The Judge expressed admira-tion for the old man's ability to locate places on the map. Finkelstein, however, saw eight men attacking Mamaan, one holding the dagger and all the oth-ers having clubs. He was able to iden-

LEAGUE ASSEMBLY ACTS ON CALENDAR REFORM

Washington, Oct. 10-Action taken by the Assembly of the League of Nations at its recent session holds much promise that an international conference to simplify the calendar will be held next year, said George Eastman, Chairman of the National Committee on Calendar Simplification, in a statement today commenting upon advices he has just received from Geneva.

State Department Declines to Handle Claims for Americans in Palestine By Our Washington Correspondent

Washington, O. C., Oct. 10-Secretary of State Stimson, in reply to Congressman Celler, declined to adopt Congressman Celler's suggestion, recently made, that the State Depart-ment handle the Palestine damage claims for American claimants before the Commissioner of Lands of the Palestine Government without the necessity of employing their own attorneys. according to a letter from Secretary Stimson to Mr. Celler, made public by the latter today.

Secretary Stimson, however, informed Congressman Celler in this reply of two important steps taken by the Department, which were included among the suggestions originally made by Mr. Celler in his proposals to Secretary Stimson. These two steps are: first, that the State Department has instructed the American Consul General at Jerusalem to obtain an extension of the time limit for filing claims with the Commissioner, which has since been extended from one to three months, and second, the Consul was also instructed to "make suitable reservation" as to the provision that payment of compensation is to be dependent upon the imposition or collection of collective fines. This reservation made by the American Government presages a possible future conflict with the British Government over claims of American citizens who suffered per-sonal or property damage in Palestine during the recent disorders, if these claims are rejected on the ground that no collective fine can be imposed to their satisfaction and if, in that event, the Palestine administration refuses to pay claims out of its own treasury.

Secretary Stimson, in replying to Mr. Celler's proposal that the State Department handle the claims, declares that before the Department may decide on the propriety and advisability of presenting diplomatic claims of this character, it is a fundamental prerequisite to show that the remedies afforded the claimants by the Palestine Government have been exhausted. The Palestine Government has taken steps, however, to hear and pass upon claims, and therefore the Department at this stage can only suggest that American claimants should take advantage of this opportunity afforded them by the au-thorities. "Obviously the Department is not in a position to undertake to handle the cases for the American claimants before the Commissioner, Secretary Stimson observes. He also calls attention that the original suggestion of the Consul General that the claimants employ attorneys to present their claims was intended in an effort to be helpful, but that claimants are at liberty to decide this for themselves, although pointing out the possibility that competent attorneys could render national and international bodies, all valuable assistance to the claimants in

Probably the best witness for the dealer named Namous who, lying in the next bed when Mamaan was brought to the Hadassah hospital, heard the wounded man tell his wife that the four accused, including the one who abscond-

ed, attacked and robbed him of £34. It was reported here last night that many Safed Arabs are assembling in Haifa to await the result of the trial. The authorities are taking all precau-tions against possible demonstrations.

A sensational development came on the second day of the trial of three Safed Arabs for the murder of Isaac Mamaan when Maughanan, chief counsel for the defense, who is secretary of the Arab Executive, after a scathing re-buke from the Chief Justice, Sir Michael MacDonnel, threw up his brief, leaving the defense in the hands of the junior counsel, Asfour, also a Christian Arab. The scene occurred at the close of the morning session when the exasperated Judge took the excellent Jewish witness, Mordecai Klinger, under protection after Maughanan, during three hours of cross-examination, was twice reminded that his questions were irrelevant, the Judge once saying: You are wasting our time. There is a limit to my patience." Nothing daunt-ed, the counsel continued to worry Klinger, whom the Judge described as a "very fair witness" until the witness appealed to the court to protect him from personal questions unrelated to the evidence.

It was then that Chief Justice Mac-Donnel, addressing Maughanan in a firm tone said: "You are conducting a fishing examination. My brother, Judge Litt, thinks it is a gross waste of time. If the witness is exasperated he has my full sympathy. We will now adjourn and I advise you to reflect what I said

before the next sitting."

Maughanan did not appear at the afternoon session nor did he send direct word that he had withdrawn. Accordingly, he was reprimanded at the end of the afternoon session for discourtesy and inconvenience caused to the court, whereupon the counsel apologized. The Judge simply said: "I understand you wish to withdraw."

During the recess Maughanan went to call on Judge MacDonnel, after which he informed the Jewish Telegraphic Agency representative that he had withdrawn in spite of the wishes of his Moslem colleagues who threw the whole burden of the defense upon him. He had been endeavoring, said Maughanan, to prevent an Arab lawyers' strike. but he now thinks a strike is highly probable, both on account of Judge Litt's previous sentences and "the af front" to himself. He also said he never hoped to obtain the acquittal of the accused but to save them from the death sentence, getting them off with fifteen years imprisonment.

A British Laborite's View

Montreal, Oct. 10-In an address before the Canadian Women's Club, George Young, M.V.O., former member of the diplomatic corps and one of the Labor Party in England, declared that the cause of the recent trouble in Palestine was not a religious one, but rather the clash of western industrial civilization and eastern Islamic civilization. It is the collision between two continents-Europe and Asia. It was hoped, he stated, that when the Ottoman Empire, after its adoption of the old Byzantine Greek institutions, had fallen into a decadent condition, it might adopt western civilization. Palestine was largely set up in the hope that the returning Jews would further in Asia the adoption of western industrialism in the form of nationalism. This was introduced by the Zionists. "We British," he added, "have every sympathy for the Zionists, the idea of their having a national home appeals to us." The difficulty of the position, Mr. Young claims, lies in the population of Zionists in Palestine. The Zionist Jews who are of the most militant section come in from Russia and are Communists. They have not the same ideals as those from England and the United States. Thus these Zionists, that compose exactly one-sixth of the popula-tion in Palestine, are given at least one-half of the political power, with the British casting votes in their favor. However, Mr. Young strongly af-firmed that "we of the Labor Party

are going to maintain the Mandate, even if we have to charge the British taxpayer for it, but we shall not be able to do it if this serious trouble in Palestine continues. Boycott Propaganda Continues

The Moslem Association of Haifa is considering a plan to establish an Arab flour mill to compete with the Rothschild Grands Moulins, against which a strong boycott agitation is going on.

Two Jaffa Arab officials left suddenly for abroad. It is believed that their hasty departure was decided upon when they learned they would be summoned for investigation during the Inquiry Commission's hearing.

JEWISH CENTERS MARK HIGH HOLIDAYS

The Jewish Welfare Board has made available a comprehensive bulletin, which includes detailed suggestions for the conduct of Holy Day services for young people. It also contains material for club programs preceding the High Holy Days, comprising appropriate selections from quotations in prose and verse, a list of topics for essays and addresses, and data on the history and significance of the Holy Days.

Arrangements have been made by the Jewish Welfare Board for the attendance of soldiers, sailors, marines and disabled veterans of the Tewish faith at services in this country and in outlying possessions of the United States. Holy Day prayer books, Jew-ish calendars, and New Year greeting cards have been distributed to the men in service. Patients in government hospitals will be remembered with appropriate delicacies and will be visited by representatives of the Board.

for there would be no authority of armed force behind it. That would put upon the inhabitants of Palestine the obligation of maintaining the peace among themselves. The artificial establishment of Jewish authority in a place where the Jewish race has no real root, is rather a reversal of the usual order of things. The Jewish race will only be able to succeed in Palestine if they are able to build within the mind the empire that abides.'
