ARAB STRIKE ENDS UN-EVENTFULLY; GOVERNMENT TOOK SAFETY MEASURES Military and Police Were Ordered to

Fire at Least Sign of Disturbance (Jewish Telegraphic Agency) Jerusalem, Oct. 17-The Arab gen-

eral strike in which Arab and Christian Moslems participated, ended uneventfully last night. That the strike has ended was announced by Propresev, secretary of the Arab Executive. in a statement to the correspondent of the Jewish Telegraphic Agency. Propresey declared that the end of the strike included Transjordania where considerable agitation occurred the results of which are not yet known.

While the one day general strike was uneventful, the correspondent of the Jewish Telegraphic Agency learns that the Palestine government had warned the Arabs that the least disturbance would be dealt with summarily. The military and the police had been ordered to fire at the first indication of trouble.

The Arab strike in which the Arab boatmen participated affected the landing of passengers. While the steamer Alesia, bringing 550 passengers, including 400 Chaluzim, pioneers, successfully landed its passengers Tuesday, the steamer Anchor was obliged to proceed to Beirut to dis-charge 40 Chaluzim, while the Adria, which arrived yesterday with 170 passengers, was forced to wait until today in order to land them.

Disregarding the advice of the Jaffa District Commissioner the Tews of Jaffa opened their shops yesterday. Except for the closed Arab shops,

INTERPELLATION ON JEWISH SITUATION IN HUNGARY IS SUBMITTED TO GOVERNMENT Asks Whether Hungary Will Grant Own Population Protection It De-

Government willing to accord the lewish population in the country the same protection which its delegate M. Apponyi, demanded for Palestine Jewry at the League of Nations session in Geneva?" This was the sense of an interpellation introduced in Paliament yesterday by the Social Democrat, Peyer. A reply is expected from the Government next Thursday.

Commenting on the interpellation the Liberal press states that it will precipi-tate a discussion of the Jewish situa-tion in Hungary and will bring out that the Jewish population is unprotected against persecution.

TRIAL OF PHILIP HALSMANN, CHARGED WITH PATRICIDE, RESUMED IN INNSBRUCK

Ministry of Justice Refuses to Dismiss Case (Jewish Telegraphic Agency)

Vienna, Oct. 17-The trial of Philip Halsmann, charged with the murder of his father, was resumed in the Innsbruck Court, the Ministry of Justice having refused to dismiss the case. The youth was previously sentenced to ten years imprisonment by an Innsbruck jury. An appeal was granted on the contention that there were on the jury men belonging to the anti-Semitic party.

It now rests with the State attorney to decide whether, in the light of new evidence, the case should be carried on. The principal testimony against Philip

PALESTINE GOVERNMENT COMMUNIQUE ON SAFED OUTBREAK ERRED

Failed to Report It as Anti-Jewish. Attack, Haifa Trial Reveals (Jewish Telegraphic Agency)

Haifa, Oct. 17-An important revelution that the government communique on the Safed outbreak was inaccurate was made during the trial of three Arabs accused of the murder of the Jewish mechanic, Isaac Mamaan by Police Commandant Farraday. The original report said that disturbances had broken out, but did not mention that it was an anti-Jewish attack. This was evidently due to the mistaken belief that Mamaan, the first lew killed, was a Moslem because he spoke Arabic when he lay wounded and groaning in the street. Farraday said that he did not know that the High Commissioner had placed blame on the Jews also for the riots, although he heard that Si John had asked a Jewish deputation whether it was true that the Jews were responsible which they denied.

Searches in Arab houses in Saied yielded scores of knives and daggers. Farraday said. Only one revolver, which had not been used, was found in a Tewish house.

OUIET IN HUNGARIAN UNIVERSITIES: JEWS ABSENT

Budapest, Oct. 17-Comparative quiet following the anti-Jewish student at-tacks of the last few days, prevailed at the Hungarian universities since Jewish students remained away from their classes in fear of renewed attacks al-though they had been promised protection by the authorities.

In the Technical Institute of the Budapest University, 25 Jewish students attempted to enter their classes. They were beaten and thrown out by anti-Semitic students despite warnings. against attacks made by the Rector.

The executive of the new committee is composed of Rabbi Ostrowsky, Isaac Eliashar, leading merchant, Mrs. Norman Bentwich, wife of the Attorney General, Rabbi Blau, Mr. Zaavi repre-senting the Agudath Israel, Dr. Yaski of the Hadassah and Haim Solomon. acting head of the Vaad Leumi during the outbreak.

Arrangements have been made to prevent the interruption of the food supply to the refugees during the transfer.

OVER 200,000 TREES PLANTED IN BALFOUR FOREST LORD MELCHETT REPORTS Tells of Progress at London Cere-

monies in Honor of Sir Charles Batho (Jewish Telegraphic Agency)

London, Oct. 17-Two hundred and eight thousand trees have already been lanted on 600 dunams in the Balfour tion project undertaken by the Jewish National Fund. Lord Melchett reported on the progress thus far at the ceremony held yesterday at the Mansion House, the residence of the Lord Mayor of the City of London, to present a certificate of the Golden Book to Sir Charles Batho, former Lord Mayor of London. The names of the Guildhall, the Lord Mayor and the Sheriffs of the City of London were inscribed in the Golden Book of the Jewish National Fund in Palestine. to commemorate the banquet held in the Guildhall in July 1928 in aid of the Balfour Forest. LACK OF CONFIDENCE IN PALESTINE ADMINISTRATION HAS GRAVE REPERCUSSIONS

Oct. 17-Though Palestine | such drastic action will be unneces-Jews have never lost for a single moment their determination to carry on the redemption of the national homeland nor faith that Great Britain will stand by her solemnly guaranteed pledge to facilitate the upbuilding task, the present situation of uncertainty and insecurity of life is threatening the gravest consequences as the country on the whole has not confidence in the local administration and is convinced that the case is being prepared for the forthcoming Commission of Inquiry to show the Jews and Arabs are equally responsible.

The personnel of the commission

and the terms of reference make it undesirable that Jews appear at all, in the growing estimation of many leading financiers, businessmen and industrialists, as the upshot is bound to be a whitewashing of the local administra-

tion, in their opinion.

Though mass attacks have not been repeated in the country in general, isolated cases of stabbing and shooting continue, creating a feeling of insecurity. This is having a repercussion on the resumption of business and the return of normalcy. The theatres of Tel Aviv, Haifa and Jerusalem were allowed to reopen, but they re-main empty. The old lively spirit of Tel Aviv, where thousands of the youths spend their evenings at the seashore singing and dancing, has not re-turned, in spite of the lifting of the curfew restrictions. Businessmen generally are talking of pinched conditions. especially among the middle class. The hotels were hardest hit as the tourist influx is beginning to lag.

The failure of the local government to immediately legitimize the Jews arming themselves in their own communities, on the ground that no community was attacked where the Arabs knew that arms existed, has created the greatest disappointment in all circles. It has had this result that arms smuggling on a large scale has been initiated. The colonists and the townspeople by the score affirm that they are determined to arm themselves as they have been attacked three times in seven years and no guarantee exists at present that this will not be repeated in the future.

If the Government persists in disarming them, many prefer resistance and a fair fight with the British patrols and police to having their throats slit by Arabs while they are asleep. There is a hopeful subcurrent that

Defense Seeks Postponement; Court Rules Other Cases Await Verdict Whether Markah Incited Mob to Massacre

Jerusalem, Oct. 17—The trial of Sheik Taleb Markah, charged with being the chief instigator of the Hebron massacre, was adjourned this morning owing to the non-appearance, supposedly on account of illness, of the government prosecutor. El Alami, a Moslem, from whose hands the judges on Wednesday practically took the conduct of the case, owing to his evident indifference to the prosecution. Some observers expressed the opinion that the illness may be "diplomatic." In the meantime, the court is endeavoring to arrange for another government prosecutor.

The defense attempted to secure postponement of the case, but Judge Corrie intimated that this is not practicable, since other Hebron cases await the disposition of this one.

Visa Rules Cause Overlapping of Two Immigration Laws

By Our Washington Correspondent Washington, Oct. 17-The fact that

visas issued to aliens seeking to enter the United States are valid for four months has caused an overlapping of the old immigration act, based on the census of 1890, and the national origins act, which became effective July 1, 1929, it was stated orally by J. J. Kunna, of the Bureau of Immigration, Department of Commerce.

Some aliens arriving in this country in July, August, September, and October, have been coming in under the old quota, although the new one is now in effect, for they were issued visas before July 1, Mr. Kunna pointed out. The situation may continue for some time, since an alien merely must leave his own country within four months of the time he acquired his visa, to be permitted to enter this country, Mr. Kunna said. Thus, if an alien leaves just short of the time of expiration of his visa, and his journey takes a number of months or is interrupted, he may enter the United States six or eight months, or even longer, after obtaining his visa, it was stated.

Another unusual situation is caused by the length of time a visa is good, according to Mr. Kunna. It is possible, he said, for a nation with a small number of applicants for visas to surpass another nation with a large quota and a much larger number of applicants, in the number of persons admitted to this country during a single month.

Mr. Kunna cited the case of Great Britain and Germany. Under the old law it was the usual thing for Germany to supply more immigratus than Great Britain, for the respective quotas were about 51,000 and 34,000, he says. This was true despite the fact that Germany's waiting list was slightly less than her quota, while that of Great Brit-(Continued on Pase 4)

Under the national origins clause, Germany's quota, in round numbers, is 26,000 and Great Britain's is 66,000, according to Mr. Kunna. The latest available figures show that Germany has about 44,000 on the waiting list and Great Britain about 141,000. Yet it is still possible for Germany in some months to supply more immigrants to the United States than Great Britain.

Visas can be issued to 10 per cent of a nation's quota in one mouth, Mr. Kunna said, which would be 2,600 for Germany and 6,600 for Great Britain. If Germany used up the full 10 per cent of her quota for each of four consecutive months, July, August, September and October, for instance, she would have obtained 10,400 visas in that period, Mr. Kunna pointed out. If all the Germans who received visas in that period decided to come to this country in October, as they could do because the visas are good for the four months, the total for that one month would be 10,400, said Mr. Kunna.

If Great Britain, during the same four months, used up her full 10 per full electron for the United Statestain, electron for the United Statestain grants for October would be 6,600, or 3,800 less than Germany's total for the month. Mr. Kunna stated. Germany would, therefore, lead the immigration list, although Great Britain has a quota list, although Great Britain has a quota waiting list more than double the mota.

J. N. F. GIVES £15,500 FOR HAIFA BAY REGION (J. T. A. Mail Service)

London, Oct. 4-The Jewish National Fund for Great Britain and Ireland sent to Palestine a sum of £15,500 for the amelioration of the Haifa Bay area. The amount was received by the Jewish National Fund as the first iustalment of the loan of £25,000 which it has obtained from the Norwich Union Life Insurance Company, pledging its income for the next six years. The loan was raised, as Leopold Schen, the president, explained at the Jewish National Fund Conference held last week at the specific request of the Iewish National Fund headquarters in Jerusalem. "The interest we are paying," he said, "is less than the bank rate today. We are to repay this loan in twelve six-monthly instalments, beginning eighteen months after the date of signature.
