# ARAB EXECUTIVE TO CALL SECOND STRIKE NEXT WEDNESDAY

Chancellor Demands Arab Executive Refute False Reports in Syria and Transjordania

(Jewish Telegraphic Agency)

Jerusalem, Oct. 18-The Arab Ex-ecutive intends to call another general strike throughout Palestine for next Wednesday, the correspondent of the Jewish Telegraphic Agency learns, despite the general feeling that the strike held this Wednesday was a failure inasmuch as it included only shopkeepers, neither laborers nor farmers joining.

Although the strike was uneventful in Palestine where it occurred, false reports circulated in Syria and Transjordania have caused a considerable stir, with the result that Sir John Chancellor, High Commissioner of Palestine issued a demand to the Arab Executive to refute the false state-Executive to retute the false state-ments. It is believed this request has been complied with. In Syria, mis-leading messages were circulated by the Moslem Wailing Wall Committee of Jerusalem, to the effect that the Palestine Government has turned the pavement adjoining the Wall area into an open synagogue. Similar false re-ports circulated in Transjordania necessitated a hurried consultation here with Resident Cox and High Commissioner Chancellor, as a result of which the Arab Executive was obliged to wire a correction. Information, received through French sources, declares that a demonstration was held in Beirut. As an aftermath of the strike, much

#### JEWS HELD FOR UNPREMEDI-TATED MURDER OUT ON BAIL (Jewish Telegraphic Agency)

Jerusalem, Oct. 18-The four Jews of Sanhedria who were committed for trial for the unpremeditated murder of an Arab during the outbreaks, were released on bail.

An Arab witness in the investigation into the Miller case in Haifa, was arrested on the charge of perjury. The magistrate declared that the prosecution was prejudicing the case by producing such a discreditable witness.

## 500 CLAIMS BY VICTIMS IN SOUTHERN PALESTINE

(Jewish Telegraphic Agency)

Jerusalem, Oct. 18-More than five hundred claims for compensation for loss of life and property by Jewish victims of the recent outbreak in the southern district alone have been presented. Including Jaffa and Jerusalem the claims total £186,248 (approximately \$931,240). Of this sum £65,000 is claimed for loss of life and for bodily injuries and loss of limbs.

### DEATH SENTENCE PRONOUNCED FOR 3 ARABS FOUND GUILTY OF MURDER IN SAFED ATTACK

Murderers of Isaac Mamaan, Jewish Mechanic, Sentenced by Chief Justice MacDonnel, No Demonstration Within or Without Courtroom; Ringleader of Safed Attack Escapes Prison

(Jewish Telegraphic Agency)

District Court by Chief Justice Sir Michael MacDonnel. They were found guilty of conspiring with one another and participating in action endangering Jewish life and property and causing the death of Isaac Mamaan, lewish mechanic of Safed, after leading a hostile demonstration. The condemned are Ahmed Jabour and the brothers Raneim of Safed.

When sentence was pronounced the prisoners declared, "Allah knows the truth." No demonstration was staged by Arabs who filled the courtroom and were ranged outside awaiting the verdict.

#### PALESTINE ARABS CONSIDER BOYCOTT OF PARLIAMENTARY COMMISSION OF INQUIRY Recall Egyptian and Indian Boycott of Commissions Sent There

(lewish Telegraphic Agency) Jerusalem, Oct. 18-Boycott of the parliamentary Commission of Inquiry by the Arabs is being discussed in some Moslem circles in Palestine, recalling the Egyptian boycott of the commission to Egypt headed by Lord Milner and the boycott of the Indian commission under Sir John Simon.

"Who is this Commission which is entirely British in spite of the Arab demand that a neutral, international commission be appointed? commission be appointed? We de-mand the withdrawal of the Balfour Declaration or the cancellation of the British Mandate. In accepting the Inquiry Commission, we accept British tutelage, which brought the Mandate and the Balfour Declaration."

These arguments are being put forward by the advocates of the boycott.

#### DENVER SOCIETY GETS PERMIT FOR NEW YORK SANITARIUM

Permission to establish a sanitarium near-Highland Mills, Orange County, N. Y., was granted the Jewish Consumptives Relief Society of Denver by the State Board of Charities. Last year the Board declined permission for establishment of the sanitarium near Goshen, N. Y., following a three year fight by the town against the sanitarium.

The new sanitarium will care for 140 adults and 40 children. It will be erected at a cost of \$1,000,000 and will be patterned after the parent institution in Denyer.

# BEAT JEWISH STUDENTS AT HARVARD DURING INITIATION CEREMONY Campus Publication Reveals Outrages By Hasty Pudding Club

Cambridge, Mass., Oct. 18—Revelations that a number of Jewish students were beaten at Harvard University, one of the leading American institutions of higher learning, were made in the university newspaper, "The Crimson." The outrage was perpetrated at the order of members of the Hasty Pudding Club, a campus organization, during an initiation.

In an editorial against drunkenness during initiations, leading to unseemly conduct on the part of the initiates, the paper reveals that one of the initiates, George R. Clark, a sophomore, entrenched himself at the door of the Fogg Art Museum. Clark threw a Chinese student bodily down the steps, when he attempted to enter. Previously, the paper writes, "Clark, at the order of those in charge of the initiation, had been beating a group of jewish students, whom he also ordered to keep out of the museum."

#### JERUSALEM MUFTI HAS RELIGIOUS POWER ONLY: POLITICAL VIEWS BINDING ON NO ONE, SAYS GRAND MUFTI OF CAIRO

Same Influences Which Engineered Druse Revolt in Syria Behind Anti-Jewish Agitation in Egypt; Little Inroad Made; Myth of Moslem World Solidarity Exploded

Cairo, Oct. 17-"The Jerusalem Mufti | opinion on the Palestine situation, say-Muftis, either on account of the sanctity of the city of his residence or personal claims of being a lineal descendant of Kalif Ali, grandson of Moham-med," declared Abdul Meguid Selim, Grand Mufti of Cairo, who is the final arbiter of religious disputes of the entire Moslem world, and is considered one of the most eminent Koranic teachers of the present epoch, enjoying a high standing in the theological faculty of the world-famous Alazar University at Cairo. His Eminence received me in a council meeting of a group of distinguished Ulamas who were summoned as witnesses and councillors when informed I had come especially from Palestine to ask for his Eminence's statement regarding the status of Amin El Husseini, the Jerusalem Mufti, who was made out to appear as speaking for the entire Mohammedan world in his opposition to the establishment of a Jewish National

Home in Palestine.

Abdul Meguid began explaining the meaning of the Mufti's office which, he said, is the religious function of teacher and interpreter of the Koranic law and doctrines of Islam. "When interpreting the sacred scriptures, a Mufti has the authority vested in his office. In such his authority is the same as the Mufti of Jaffa, Bombay or Teheran. In regard to the superiority of the Jerusalem Mufti above his colleagues in other dioceses, this is out of the question." "If any superiority exists on account of world-wide presexists on account of word-wine pres-tige, this devolves on the Grand Mufti of Egypt," interjected Sheik Ali, fam-ous Ulamo of Cairo. To this His Emi-nence countered, "There is no ques-tion of superiority in this matter. Before Allah we are equal as teachers and interpreters of the divine will and commandments. When the Jerusalem Mufti speaks on religious matters and is within the precepts of Orthodox doctrines, the entire Moslem world is in accord with him but when he makes declaration of a political nature or engages in any other activity, this is a purely private affair and cannot be accepted as binding up any Moslem anywhere, not even upon those resid-ing within the confines of his own religious jurisdiction. In short, the Jerusalem Mufti is a Moslem religious teacher of Jerusalem and as such has religious authority, but nothing more." The words were spoken in Arabic and translated into French by Abdul Suleiman El Said, Cairo Arabic newspaperman, who took notes of the conversation. In order to avoid any misunder-standing, I repeated the Mufti's words back.

Leading in the anti-lewish behind the scenes movement is Dr. Shanbander, who in conjunction with Prince Lotfallah and Dervish Sultan Latrash. were implicated in the Druse revolt in Syria, and who fled from French jus-tice and settled in Egypt.

The Chief of the Egyptian State Police, following the complaints of Egyptian citizens that the agitation of the Syro-Palestine Committee and the newspapers under its control, may have serious consequences for Egypt, warned the newspapers today that they are under strictest surveillance by the political branch of the Intelligence Service of the Egyptian Government.

The myth of a Moslem world solidarity which is upheld as a bugaboo by the Jerusalem Moslem council, was completely exploded as the surrounding Moslem countries remain calm, showing a minimum of interest in Palestinian affairs, especially Egypt, where the Syro-Palestine Committee's doings have failed to cause any ripple despite the grotesque assertions about Jewish atrocities on the Mosque of Omar, the slaughtering of Moslems while at prayer, the printing of a photograph alleged to show a prominent Palestine Arab's home destroyed and books scattered, this being in reality a photo-graph of the Hebron Jewish Yeshiva, rumors that the Egyptian Consul was murdered in Jerusalem and further that fifty Arabs are being starved to death while prisoners of the Haifa Jewish Army. All this fails to affect the Egyptian population. The Moslem world is fast becoming

like the Christian world, each nation placing national interests before international relations. They are one solely in religious doctrine and local interests are too varied and contrasting to make a common cause on behalf of any

SHEIK TAKES STAND IN OWN DEFENSE IN TRIAL FOR INSTI-GATING HEBRON MASSACRE

Declares He Is Friend of Jews; He Pacified Mob, Was Unaware of Mas-sacre Until After Its Occurrence (Jewish Telegraphic Agency)

Jerusalem, Oct. 18—Sheik Taleb Markah took the stand in his own dedefense yesterday as the alleged instigator of the Arab massacre at Hebron. Carefully coached, looking down at his counsel for approval, after every question, until he was requested by the judges to look up at them when mak-ing his answers, Taleb endeavored to have his alleged pacification of the crowd on Friday, serve as an alibi for his innocence in the bloody massacre Saturday.

In the story which he told on the witness stand, he declared: "Friday, while in the shop of Sholom Ben Hyim, I heard a boy outside shouting 'Riot!" I went out and beat the boy, and then reported the matter to the police, returning to dissuade the crowd excited over the reported riots in Jerusalem, which I did not believe. I did not incite the crowds. I never made a speech in my life. After I dispersed the crowd, in the presence of Cafferatta, everything was quiet. I knew about the murder in the Yeshivah, but I did not think conditions in Hebron abnormal. That night I did not leave the house. But Saturday morning I was with Slonim and walked with him from Schneerson's Hotel, Then I went to my shop. I sat there from eight-thirty to eleven, and was not among the attackers of Slonim. I knew nothing until nine o'clock.'

Several weak questions were put to the defendant by the prosecutor, Zaki Temini, the Moslem who succeeded El Alami. He showed the same indifference as his predecessor, to such a point that the judges took over the cross-examination themselves. Zaki Temini is further handicapped by his ignorance of the English language.

The peculiar situation of a trial being sabotaged by the prosecuting attornevs. developed in the trial. first State Attorney, El Alami, resigned from the prosecution after it had become evident that he had been entirely inactive, asking the witnesses no questions. The new State Attorney, Zaki Temini, acted in a similar way. He spoke only in Arab, his questions being translated for the court by the

# STOKER SAILS TO PRESENT ARAB CASE TO COMMISSION (Jewish Telegraphic Agency) London, Oct. 18-William

tendency in the first moment of anger. "If we are to be led by our intelligence and not by our emotions, we must remember that the two races are in the same land and they must live together. It is the duty of thoughtful men of both races to adopt such meas-

ures as will promote reconciliation and good fellowship," he declared. Lord Melchett declared: "There has not been a single action taken by individual Jew or organization since the Mandate which has not been of benefit to the entire country and people. We developed industry, have given the land electricity and Jewry the world over has given financial assistance amounting to millions of dollars. As a matter of fact, if the lews left Palestine, the country's revenue would become bankrupt, educational facilities of the higher type would cease to exist, agricultural development with modern methods would no longer make progress, commerce would dwindle, industry would die out and the country would sink back to its state under the Turkish regime from which the British administration rescued it.

"What is the complaint made against us?" Lord Melchett asked. "That we acquired with good money land which for some time was worthless, that we introduced peaceful, in-dustrious citizens to work there?" Speaking of the Hebrew University,

Lord Melchett continued: "In these days of trouble, grief, discouragement the open, bleeding wounds of Israel in dr beloved country to the spiritual and educational side of our work on Mount Scopus. Many thought our effort was premature, preferring that the money be devoted to more immediate economic needs. I always thought that we stamped and symbolized ourselves by having the courage to establish our own University. During my recent visit, I was really astonished to find important and interesting research in biology, postology and malaria going on, also the chemical department is doing useful work as well as the agricultural.

"There is not an educational institution, nor a research station organized by Palestine Jews which does not admit freely Arabs equally with Jews. "The Jewish people in Palestine, al-though battered and buffeted, will

stand together, regardless of division of opinion, class or origin as one solid phalanx. Their sufferings have united them," he declared.

A resolution, proposed by Sir Mathew Nathan, declared: "The recent lamentable Palestine events encourage, rather than discourage our efforts to increase the activities and influence of the University and the hope is confidentiy expressed that enlightenment emanating from Mount Scopus will materially help improve the relations between Arabs and Jews. head of the criminal investigation depatrment of the Palestine government, Mr. Cosgrave.

When Sheik Taleb was on the witness stand, the State Attorney asked him questions running along the same lines as the defense lawyers, with the obvious intent of facilitating matters for the accused. A curious fact in connection with this situation is that the Arab prosecuting attorneys were appointed by Attorney General Norman Bentwich, a Jew. Originally a British attorney, Mr. Drayton, had been appointed. He was well versed in all the details of the case and had prepared himself for the trial. At the last moment he was recalled by Mr. Bentwich, who replaced him by the Arab attorney, El Alami.

Mr. Bentwich, against whom a fierce Arab campaign is being waged, most probably wishes to impress the public with his impartiality and fairness toward the Arab case by appointing an Arab prosecuting attorney. The Arab prosecutor, openly sympathizing with the defendant, created the rare situation of compelling the judges to assume the role of prosecuting attorneys.

Under cross examination, Taleb declared that he is a friend of the Jews, whereupon Presiding Judge Corrie asked him, "Why do people who are friends of yours charge you with the instigation of the massacre?" In reply, the defendant declared the charges are the invention of others, not the lews of Hebron. No Moslem leaders supported the idea of the riots, he asserted. Pointing out that Taleb's testiomny contradicts the testimony of Cafferatta, Assistant Police Superin-tendent of Hebron, the Judge asked Taleb: "Is he a liar?"

Taleb, responding, said that on Friday he saw an automobile with twenty Moslems, armed with swords, ready to proceed to Jerusalem. He stopped them, and dissuaded them from their purpose when Cafferatta approached and told them to go. This incident was at no time mentioned in Cafferatta's testimony.

When Taleb asserted that the Jews of Hebron should be grateful to him, Judge Defreites asked him: "What for?
