"The tragic events which recently occurred in Palestine have shocked the conscience of the whole world and has threatened to arrest the peaceful dev-elopment of this country," Sir Walter elopment of this country," Sir Walter declared in opening the sessions over which he will preside. "The events are deplored by every section of the peo-ple who are united in the demand that the causes be impartially investigated and a recrudescence of the disturb-

"With this object in view, the Sec-retary of State for the Colonies appointed this Commission for the purpose of inquirying into the immediate causes which led to the outbreak and make recommendations of steps necessary to avoid a recurrence.

"Our duty is to hold a full, complete and impartial inquiry. We are precluded from considering questions of major policy. Such questions do not fall within the scope of our reference. It is a matter of satisfaction to this Commission that the inquiry into the immediate causes of the recent trou-bles is welcomed by all parties, and the Commissioners therefore feel justified in expecting to receive in the investigation the fullest assistance of all those desiring that these causes be ascertained and wish to contribute to the future peace and prosperity of the

"The Commission observes that charges of a serious character have been made by the Arabs against the lews and the Jews against the Arabs, each attributing to the other responsibility for the events which both deplore. Charges have also been made against the administration. All these allegations, from whatever quarter, will receive the most careful examination in our endeavor to fulfill the purpose of our appointment, which is to ascertain the truth and restore confidence, upon which contentment and progress depend," he declared.

Oct. 24-A sentence of two years imprisonment and the payment of a fine of £50 plus the costs of the trial, was pronounced on Sheik Taleb Markah, on trial in the Jerusalem District Court as one of the chief instigators of the Hebron massacre in which sixty-six Jews were killed and scores injured. The trial, which began on October

was the center of interest of all Palestine, as it was considered a key case in the trials growing out of the recent outbreak. Judge Defreites pronounced the sentence. Government ter, conducted the case after two Arab prosecutors were withdrawn.

Jerusalem, Oct. 24-Two Arabs, spectators at the trial of Sheik Taleb Markah, were arrested outside the courtroom on Wednesday. The arrests were made on the evidence of a British official who recognized the prisoners as a part of a mob which fired on the Jews in Hebron on the day of the massacre.

EDITOR AND CARTOONIST GET MONTH TERM FOR LIBEL

(Jewish Telegraphic Agency) Berlin, Oct. 24-Imprisonment of one month or the payment of a fine of 300 Marks, was the sentence imposed on the Socialist Deputy Schemm, editor of the weekly, "Weekruf," and a car-toonist, Braeutigan, for libel.

2 ARABS SENTENCED TO DEATH FOR MURDER OF JEWISH WOMAN

12 Arabs Get Life Terms for Arson. Causing Woman's Death (Jewish Telegraphic Agency)

Haifa, Oct. 24-The second pro-nouncement of death sentence on Arabs found guilty of murder during the Palestine outbreak, was made today in the Haifa District Court, sitting as the Criminal Assizes, by Chief Instice Sir Michael MacDonnell, sitting with Judge Litt. The same court last week sentenced three Arabs to death for the murder of Isaac Ma-mann, Jewish mechanic of Safed.

Two Safed Arabs, Ahmed Schariffa and Ahmed Selim Zanib, were sentenced to death at noon today for the murder of Hannah Kohen, wife of Raphael Kohen, during the outbreak at Safed on August 28. Two other Arabs, found guilty of complicity in the murder, were sentenced to ten

years each.

The trial was the shortest held so far, on the charge of murder. Three witnesses for the prosecution were heard, the son and husband of the murdered woman, and a doctor. The son and husband testified that they witnessed the shooting.

Haifa, Oct. 24-Twelve Arabs of Safed were sentenced to life imprisonment at hard labor and two to five ment at nare labor and two to hve years imprisonment for setting fire to the house of Solomon Goldzweig on the day of the riots, when Goldzweig's wife was found asphyxiated in the burned house. The two sentenced to five years were given lighter sentences because of their youth.

PRIME MINISTER BETHLEN ANSWERS INTERPELLATION OF SOCIALIST DEPUTY

Denies Anti-Jewish Discrimination; Promises Measures Against Student Attacks

(Jewish Telegraphic Agency)

Budapest, Oct. 24-Denial that antilewish prejudice exists in Hungary was the keynote of the address before Parliament today by Premier Bethlen. The Premier's address was in reply to the question of Socialist Deputy Pey-ser as to what Hungary was prepared to do to protect its Jewish population. No Jewish deputies participated in the discussion.

Count Bethlen and Deputy Peyser were the only speakers. Deploying that the Socialist Party should have chosen a Parliamentary interpellation as a means of solving the Jewish question, a method which he said is frowned upon by the Jewish deputies, Count Bethlen said Hungary is prepared to to its duty by the Jewish community. The comparison with Palestine, which is a nation, is unfair.

The government is prepared to take severe police measures to quell disturbances in the universities. Police will be authorized to enter school buildings and the University of Budapest closed, if it becomes necessary.

Parliament voted its approval of the Premier's reply, while Deputy Peyser insisted his interpellation still stands.

JEWISH FARM SETTLEMENTS COMPANY GRANTS SOVIET \$9.000.000 17-YEAR LOAN

Expansion of Activities Under Way, James N. Rosenberg Announces

The American Society for Jewish Farm Settleemnts in Russia has granted the Soviet Government a \$9,000,000 loan for seventeen years at 5 per cent, states an Associated Press despatch from Moscow. The loan, which will be handled by the Chase National Bank, will be issued in forty quarterly instalments of \$250,000 each for ten years, beginning in 1929.

"This is no new matter," declared James N. Rosenberg, president of the American Society for Jewish Farm Settlements in Russia, when intersecuements in Kussia, when interviewed by the representative of the Jewish Telegraphic Agency on the Moscow despatch.

"The arrangement for a \$10,000,000 investment at the rate of \$1,000,000 a year for Jewish Farm Settlements in Russia was made over a year ago and a public stateemnt was then issued regarding the matter.

"Dr. Joseph A. Rosen, the head of the work, is at present in this country, and his reports show that there are today upwards of 200,000 Jews settled on over a million and one-half acres of land in Russia and that all the settlers who have been on the land two years or more are self-supporting. progress of the work has been far greater than we hoped. Plans for the enlargement of our activities are now under consideration," Mr. Rosenberg stated.

POALE ZION OPENS CONVENTION IN BUFFALO (Jewish Daily Bulletin)

Buffalo, N. Y., Oct. 24—The seven-teenth annual convention of the Poale Zion. Zionist labor wing, was opened at the Hotel Lafayette here last night. One hundred delegates from the United States and Canada are attending.

Berl Locker, secretary of the World Confederation of the Poale Zion, Joel Entin and Dr. Judah Kauffman, addressed the opening session. Isaac Hamlin presided. The convention will last four days, concluding with a ban-quet on Saturday evening.

ARABS TO PLAN ACTION AGAINST WALL RULINGS: COLLECTIVE PUNISHMENT Call Conference October 27, Neighboring Countries to Send Delegates

(Jewish Telegraphic Agency) Cairo. Oct. 24-A conference to which neighboring countries are expected to send delegates, has been called for October 27th by the Palestine Arab Executive, declares Ahram" of Cairo.

The Arab paper declares that it is the intention of the conference to consider action against the regulations at the Wailing Wall, which the Arabs claim infringe on the status quo, and the collective punishment ordinance, and the proposed refusal to pay taxes. The conference will also voice its opposition to Jewish immigration, "especially against the youth brought by the Zionist Executive for defense purposes," the paper declares. It will also consider a boycott of British goods.

Jerusalem, Oct. 24-The meeting of Arab women scheduled for Saturday. will be limited to a consideration of the boycott of Jewish merchandise. Relief measures for Arabs who suifered when the troops exerted measures to quell the riots, will also be adopted.

It is my understanding that the reports of the incident appearing in the metropolitad daily papers, were in certain respects exaggerated," the Dean continued.

Leonard L. Cohen Succeeds Late Franz Philippson as Ica President By Our Paris Correspondent

Paris, Oct. 20—Leonard L. Cohen, vice-president of the Jewish Colonization Association, as was foreshadowed by the Jewish Telegraphic Agency, has been unanimously elected president of the Ica, by the Administrative Council of the Ica, which has been meeting here, succeeding the late M. Franz Philippson, who died early in July. Professor Salomon Reinach was also

Professor Salomon Reinach was also unanimously elected by the Council as vice-president of the Ica in succession to Mr. Cohen. M. Max Gottschalk has been appointed by the Brussels from Communication of the Brussels from Communication of the International Cohen, and the International Cohen, paid a tribute to the memory of the late Louis Marshall.

At the general meeting of the Ica, over which he presided, Mr. Cohen paid a tribute to the memory of the late M. Franz Philippson.

Mr. Cohen spoke of the prosperity of their colonies in the Argentine, the vitality of their capricultural groups in Brazil, Canada, Palestine, and Poland, and of the hopes which have been relaized in respect of the new Jewish colonization in Russia. He also referred to the success achieved by their credit work, thanks to the Joint-lea-Foundation, and also to the great progress made in their emigration work, with the assistance of the Hicem.

Leonard Lionel Cohen, the new president of the Ica, is widely known and popular in London Jewry through his long association with the Jewish Board of Guardians, to which he has given over forty years of continuous service, acting as its president for twenty years, from 1900 to 1920.

He was born in London on April 17, 1858, son of the late Lionel Louis Cohen, M.P., also a former president of the Jewish Board of Guardians, whose "Scheme for the Better Management of All the Jewish Poor" practically formed the Constitution of the Constitution of the United Synagogue, presiding over the first meeting of its Council.

Mr. Cohen joined his father's firm. Louis Cohen & Sons, foreign bankers, which was founded by his grandfather, the late Louis Cohen. He was a member of the Committee of the Stock Exchange, and a director of a number of railway companies. On retiring from business in 1895, he devoted most of his leisure to charitable work, principally in the Jevish Community. He is a member of the tounder which he mittee. He was one of the founders of the League of British Jews. He is not a Zionist, but he is a member of the Economic Board for Palestine.

Official Circles Dismiss Rumors: Un-

aware of Arab Demands for Immigration Bars (Jewish Telegraphic Agency)

London, Oct. 24—Official circles here dismiss as speculation the rumors current in certain sections of the London press that Lord Passfield, Secretary of the Dominions, is contemplating the setting up of a Parliamentary Commission to deal with the larger questions of policy in Palestine, such as the future method of applying the Palestine Sundate, declares the diplomatic correspondent of the Jewish Telegraphic Agency.

Official circles, the correspondent says, are not cognizant of any such Commission coming into being.

Competent quarters declare that they are unaware of any demand forwarded to the Colonial Office by the Palestine High Commissioner, setting forth the Arab desires to restrict Jewish immigration to the country. It is taken for granted that the Arabs desire restriction of Jewish immigration, but no official demand has as yet been transmitted.

A number of protests have been received here against the death sentences imposed on the three Arab murderers of the Jewish mechanic of Safed, Isaac Mamaan. They will not, however, make any difference to the carrying out of justice, it is stated. The government is determined to execute its responsibilities in the spirit of equity.

The fact that the new regulations at the Wailing Wall displease both the Jews and the Arabs is interpreted as proving the objectivity of the Government, the discontent of both disputants being inevitable.

SYMPATHY DEMON-STRATION IN DAMASCUS (Jewish Telegraphic Agency)

Cairo, Oct. 24—Several were wounded in clashes between the police and a crowd of Christian Moslems participating in a sympathy demonstration with Palestine Arabs, in Damascus on October 21, according to a report in the El Ahram," Arab paper of Cairo.

The demonstration which started from the Mosque and the Greek Church, passed the government offices and the offices of the consulates. Damascus papers ceased publication on the day of the demonstration.

DR. JUDAH L. MAGNES RETURNS TO JERUSALEM (Tewish Telegraphic Agency)

Climaxing Climaxing the day's testimony, Sheich stated that he saw an armed crowd of two hundred pass his shop and the cafe next door, whereas Taleb and his friends said they saw no erowd pass the cafe where they sat. Sheich declared that upon seeing the crowd he ran to the home of Rabbi Kastel, to see if he was safe, but was beaten back. He then ran back to his shop where he fainted.

A witness attempted to prove the alibi of Sheik Taleb Markah that he was in the cafe and later in the office of Abdul ab Sheich, when the riots occurred. The witness declared that he did not hear of the riots until Sunday, although he spent several hours in the cafe Saturday with Taleb.

"Do you want me to believe that you were in the cafe two hours with Taleb, without mentioning the riots?" Judge Defreitas demanded. "You are wasting our time. I will never be-lieve you. I think you are deliberate-

ly lying.

Sheik Taleb Markah was recalled to the witness stand to testify again con-cerning his "rovings," between prayertime and three o'clock Friday afternoon, the day preceding the day of the massacre, the court evidently suspecting his alibi concerning his whereabouts during the demonstrations, which Assistant Police Superintendent of Hebron, Cafferratta testified he incited

The brother of the Grand Mufti of Jerusalem, one of the counsel for the defense, spoke for the first time since the trial opening, questioning the authority of the Sheik in testifying that the small mosques were used for prayer on Friday.

nell in passing sentence, said he is not satisfied that the accused directly caused the woman's death, but the court does not doubt that all the accused conspired to destroy Jewish life and property.

The sentenced men include the two Raneim brothers who were condemned to death for the murder of Isaac Mamaan, Jewish mechanic of Safed, the first to fall a victim during the massacre

During the proceedings, the son of one of the accused begged the court to permit him to plead his father's case since all the Arab lawyers in Jerusalem and Haifa had refused to defend the prisoners. The court denied this plea but announced that it would permit the accused to plead their own cases. The only person to do this was

the father of the petitioner. Chief Justice MacDonnell, sitting with Judge Litt, has sentenced nineteen for participation in the Safed mas-

sacre.
