ISOLATED INCIDENTS OF VIOLENCE REVEAL ALL NOT YET QUIET IN PALESTINE

**Sacher Sees Chancellor; Demands
Adequate Protective Measures**
(Jewish Telegraphic Agency)

Jerusalem, Nov. 14.—That all is not yet quiet in Palestine and that the situation is not as well in hand as it might be is evident from the frequency with which isolated but nevertheless significant occurrences of violence are reported. A British soldier in Safed was fired on and wounded today during a rain of shots that lasted for thirty minutes. The injured man was taken to the Hadassah hospital.

According to further particulars which have become available with regard to the outbreak at Safed, it has been established that the clash between Arabs and British soldiers occurred west of Safed about 7 o'clock last night. The clash was between English soldiers, who were escorting armored tanks, and a band of Arabs. The shooting in Safed lasted more than half an hour. A panic broke out in Safed, but no disorders occurred in the town itself.

Yesterday, Mekor Hayim, a suburb of Jerusalem, was fired on. A Jewish official, Mamman, who had recently been transferred to the law courts at Nazareth, was stoned there yesterday. He has resigned his position and left the town.

TWO AMERICAN WITNESSES OFFER CONTRADICTORY TESTIMONY TO INQUIRY COMMISSION

**Assertions of New York "World" Correspondent He Was Warned by American
Jews, from Authoritative Sources, That "Bust Up" Inevitable, Denied by
Miss Anne Goldsmith, Daughter of New England Zionist; Haifa Police
Commander Admits He Failed to Arrange Promised Joint Con-
ference Between Jewish and Arab Leaders**

Jerusalem, Nov. 14.—To the conflicting testimony from which the Parliamentary Commission of Inquiry is expected to unravel the causes of the outbreak in Palestine, were yesterday added the contradictory statements of two American witnesses, Vincent Shean, correspondent of the North American Newspaper Alliance, and Miss Anne Goldsmith, an English teacher, and the daughter of a prominent New England Zionist.

On the witness stand yesterday and Wednesday, Mr. Shean asserted that it was Miss Goldsmith who informed him that armed chaluizin were coming to the Walling Wall on Tisha B'Ab, that a Jewish demonstration would be held, that trouble was expected, and that a "bust-up" was inevitable. On the basis of this information, Mr. Shean sent despatches to the United States of a distinctly anti-Zionist character, which were the cause of considerable resentment in Jewish circles in America. Taking the stand for the first time today, Miss Goldsmith flatly denied having given Mr. Shean the information described.

The American witnesses were preceded on the stand by Major McClaren, Acting Commandant of Haifa, in the absence of Colville, and by Major Crosbie, Police Commandant of Jaffa, in the absence of Major Campbell. They were heard by the Commission first in a public session, and later, privately without the presence of representatives for any of the three sides.

Silley, assistant Arab counsel, introduced a telegram sent by Mr. Shean to the North American Newspaper Alliance, notifying the syndicate of his intention to discontinue writing, declaring that he had turned anti-Zionist because he considered Zionism aggressive, dangerous, unjust, stating that he had witnessed a deliberate Jewish organized insult to the holiest Islamic place in Palestine. Silley also read into the record a letter addressed by Mr. Shean to Meyer Weisgal, editor of the "New Palestine," then in Zurich, cancelling his arrangement to write articles and to deliver lectures under Zionist auspices.

Shean explained that his change of heart was caused by the Zionist temper. He declared he found the young Jews of Palestine flippant and cynical concerning the Arabs. He was convinced that the Jewish National Home

interferes with the representative institutions of Palestine. The Zionists told him, he stated, that they can buy any Arab. His Zionist sympathies vanished when he learned that there were such things as separate school systems where the children were brought up to hate each other.

At this point, Harry Snell, Labor Commissioner, interrupted to ask: "Which Zionists are flippant?" "I mean mostly the young people, not the responsible official Zionists, who are very moderate." "Do you find any temper among the Arabs?" asked Snell. "Yes, but I didn't know any Arabs then," Shean answered.

Sir Walter Shean believed Miss Goldsmith expressed her own or authoritative opinion, when she warned him an outburst was imminent. Shean suggested she spoke from official knowledge.

At this point, Miss Goldsmith was called to the witness stand. From her testimony developed the revelation that the Palestine Government had ap-

PALESTINE GOVERNMENT MAKES DETERMINED EF- FORT TO SUPPRESS P.T.A.

**Cancels Concession to Palestine Tele-
graphic Agency; Seeks to Control
News to and From Country**
(Jewish Telegraphic Agency)

London, Nov. 14.—What appears to be a determined effort to suppress the activities of the Palestine Telegraphic Agency, the Palestinian link in the world-wide news gathering service of the Jewish Telegraphic Agency, and to obtain control of the news service to and from Palestine, on the part of the Palestinian government, is indicated in the cancellation of a concession granted to the Palestine Telegraphic Agency. It appears that the Palestinian government, in expectation of terminating the work of the Palestine Telegraphic Agency, is preparing to replace it with a news service controlled and manipulated by the government.

Last Spring an arrangement was concluded by which the Palestine Telegraphic Agency became the Palestine representative of Reuters, the latter placing at the disposal of the P. T. A. a daily cable service consisting of the

ENTER CLAIMS FOR**7 AMERICAN VICTIMS**

Civil claims for damages on behalf of the next of kin living in the United States, based on the death of each of seven American citizens in the late Palestine outrages, have been filed with Commissioner of Lands in Palestine according to information obtained by Congressman Emanuel Celler at another conference with Secretary of State Stimson. The seven for whom claims have been filed are Aaron David Epstein, Jacob Wexler, William Berman, David Shainberg, Benjamin Hurwitz, William Greenberg and Hyman Krassner.

In connection with the filing of claims for civil damages, Congressman Celler pointed out the last date to do so is November 23 and that consideration of these claims will not start until after that date. Claimants for damages will need an attorney in Palestine to represent them in the hearings to be held before the British Commissioner of Lands.

**BOOM NATHAN STRAUS, JR.
FOR SANITATION COMMISSION**

Nathan Straus, Jr., son of the philanthropist of the same name, is being seriously considered as one of the three members of the newly created Sanitation Commission. The law under which the Commission becomes operative on December 1, provides that one member be a physician, one an engineer and the other a layman. Mr. Straus is being boomed as being particularly well equipped for the duties of the lay member. Mr. Straus is now president of the Parks Association of New York and is a former state senator.

**DENIES ANTI-SEMITISM
IN L. I. COLLEGE HOSPITAL**

There is no discrimination against Jewish students in the Long Island College Hospital, declared Dean Adam M. Miller, in a statement to a representative of the Jewish Daily Bulletin.

Of the four hundred and thirty-seven students enrolled in the Medical School, between forty and fifty percent are Jewish, declared the Dean.

Asked whether anti-Jewish discrimination against Jewish students existed in other institutions throughout the country, as had been charged before the Association of American Colleges by Dr. A. M. Schwitella, of St. Louis, Dr. Miller declared he did not know, and that his knowledge was confined to the practice in his own institution.

He denied that he had endorsed the statement of Dr. Schwitella, Dean of the St. Louis University School of Medicine, to the effect that scholastic averages and personality ratings are so combined as to disguise the fact that racial discrimination is practiced.

He declared that he had made no comment upon Dr. Schwitella's paper. His own statement, in the course of a paper read, to the effect that four and one-half times as many applications for admission to medical schools were received as applicants admitted, had absolutely no relation to racial discrimination. The figures were compiled purely on the basis of scholastic averages, and had not the slightest bearing on the religious faith of the applicants, he asserted.

He affirmed that while each school determines its own policy, every school requires in addition to scholastic rating, a personal interview with the applicants for admission.

**JEWESS NAMED SPANISH
TRADE ADVISOR**

Lucy Goldsmith Shore, New York foreign trade analyst and consultant, has been named special trade adviser to Spain by Primo de Rivera, Spanish premier, according to advices received yesterday at the New York office of her firm, Goldsmith-Shore Company. It will be Miss Shore's job to make recommendations to the Premier on ways and means of improving the export and import trade between Spain and the United States. She has long been prominent in her chosen career of finding suitable markets for American concerns seeking foreign outlets.

**MRS. FELIX FULD GIVES
\$5,000 TO JEWISH COUNCIL**

The largest gift by a Jewish woman in the history of the National Council of Jewish Women, \$5,000, has been made by Mrs. Felix Fuld of South Orange, N. J., to the National Council of Jewish Women, in response to a plea of its executive secretary, Mrs. Estelle M. Sternberger. In making her gift Mrs. Fuld voiced her deep interest in the program of the National Council of Jewish Women, particularly in its efforts to solve the vocational and employment problems confronting Jewish women and girls throughout the country.

**NEW FORM OF GIFTS
TO NATIONAL FUND**

Jerusalem, Nov. 14—A new means of supporting the Jewish National Fund, the company which assumes title to all lands bought by the Jewish Agency, has been introduced. Mrs. A. V. Rosenbaum, of Brighton, England, whose late husband bequeathed an estate worth some \$125,000 to the Jewish National Fund, has bought an annuity from this Fund. She has paid the sum of \$6,000 to the Fund, for which it has agreed to pay her an annual amount during her life-time, the principal remaining at the full and restricted use of the Fund.

It is expected that many Jews, anxious to assure themselves of a regular annuity, but still desirous of being helpful to the Jewish National Fund, will adopt this new procedure.

**ARAB PAPER IN COURT
FOR JEWISH INSULT**

Jerusalem, Nov. 14—The Jew named Makovi who had been summoned to court for insulting the Moslem nation, has been acquitted. The Haifa newspaper "Annafir" has been summoned to court by the Government for publishing an article insulting to the Jewish religion.

proached the London "Times" to dismiss Gershon Agronsky, staff correspondent of the Jewish Telegraphic Agency as correspondent of the "Times" on the ground that he was a Jew.

Flatly denying Shean's allegations, Miss Goldsmith told the following story. A friend and neighbor of the Agronsky family, staying in Mrs. Agronsky's home, in Tel Aviv, she came to Jerusalem on August 14 to pay some bills. Mrs. Agronsky had requested her to visit an upholsterer and to inquire at the post office whether the London "Times" had arranged for collect messages to be filed by Mr. Agronsky and to deputize some reporter in the event something happened. At the upholsterer's, she related, she heard that the Hadassah had ordered extra stretchers in the event Jews were injured on Tisha B'Ab, owing to the unrest in connection with the Arab building operations at the Wall, and that an Arab attack was feared.

After endeavoring to communicate with another correspondent, she decided to see Shean, who was a good friend of the Agronsky family. She decided to take him to the Wailing Wall, in the belief that Tisha B'Ab scene might interest him. She denied telling him a "bust-up" was inevitable. She declared she told him about the stretchers, but gave him no information about the Wailing Wall or the Jewish procession. Not having read the newspapers, she was unaware that trouble was expected. She saw no crowd and she never told Shean that armed chaluzim were coming to the Wailing Wall, as he testified Wednesday. She did not see a revolver, which Shean declared he saw, stating that if Shean saw one, he did not call it to her attention.

The crowd at the Wall consisted of young and old. There were tourists and visitors, and nothing irregular. She declared she remembered seeing an Arab, dressed in a white robe, edging his way through the worshippers a dozen times. Neither the Zurich Congress nor politics were mentioned by her, she asserted.

The attacks in Haifa and Jaffa, and the events leading up to them were reviewed. Under cross-examination by Viscount Erleigh the admission was made by McClaren that he failed to bring together Jewish and Arab spokesmen, after he had been informed by Shabbatti Levi of Haifa that he had approached a Moslem named Ibrahim Bey Khalil, regarding a joint meeting on the 24th of August to check the agitation. At the same time, Levi requested McClaren to preside. McClaren declared that he had had a casual conversation with Khalil, but that nothing came of the proposed meeting. At any rate, he said, it would have come too late, since feeling was so tense, and since Khalil had gone to

his house in Mount Carmel and did not return until after the disturbances.

He said that he had first heard of the troubles in Jerusalem on Friday evening, August 23rd, when the outbreak started, aifa with its Moslem population of 13,000 and Jewish population of 14,000, the remainder being Christian Arabs and Europeans, showed slight interest in the agitation until August 24th. On that day he informed a Jewish deputation that precautions had been taken to safeguard them. Although they were excited, the Jews assisted him in maintaining order, while the Moslem notables also promised to keep order.

Under Erleigh's cross-examination McClaren admitted knowledge that agitators, and in particular the Young Men's Moslem Association, were busy spreading propaganda, and that pamphlets had been distributed which excited the Samaritan Arabs. He conceded that only the prompt action at Nablus prevented the trouble there from spreading.

He agreed with Silley, assistant Arab counsel, that the trouble, while neither spontaneous nor simultaneous, radiated gradually as the news spread of the anti-Jewish movement.

Major Crosbie described his efforts to prevent the Arab demonstration on August 25th in Jaffa, which he considered to have a most dangerous portent. He declared that he met the Arab leaders twice. At their first conference,

PALESTINE GOVERNMENT SOUGHT AGRONSKY'S DISMISSAL FROM LONDON "TIMES"

Efforts to Cause Dismissal on Ground He Was a Jew, Revealed at Commission Hearing (Jewish Telegraphic Agency)

Jerusalem, Nov. 14—That the Palestine Government approached the Colonial Office to intervene with the "London Times" to secure the dismissal of Gershon Agronsky, an American, as its correspondent, on the ground that he is a Jew, was revealed to the Parliamentary Commission of Inquiry, by Sir Boyd Merriam, counsel for the Jewish Agency.

The request to the Colonial Office was forwarded by the Palestine Government at a time when Mr. Agronsky had not yet assumed his work for the "Times," he being on his way from the Zionist Congress to Palestine.

Mr. Agronsky, who is the correspondent of the Jewish Telegraphic Agency, despite the request of the Palestine officials, was appointed by the "London Times" to act as its correspondent, pending the return of its regular correspondent, Cannon Danby.

These facts developed following the testimony of two Americans, Vincent Shean, correspondent of the New York "World," and the North American Newspaper Alliance, and Miss Anne Goldsmith, an English teacher.

ARAB QUESTION MOST IMPORTANT PROBLEM OF JEWS, SAYS EINSTEIN

Must Find Ways of Co-existence with Arabs; Should Create Non-political Mixed Institutions (Jewish Telegraphic Agency)

Paris, Nov. 14—Albert Einstein, in an interview with the Parisian Jewish paper "Hajnt," said that "the most important problem facing us (the Jews) is the Arab question. Until now we acted as if we lived in a vacuum without paying any earnest attention to what was going on among the Arabs. Our present duty is to find ways of co-existence with the Palestine Arabs."

"It is necessary to create a series of non-political mixed institutions such as economic unions and insurance companies and through these daily Jewish-Arab contacts and collaboration an amicable understanding will be reached. There is also a wide field open before us for the enlightening of the Arabs."

"It is also necessary to make clear to our Jewish masses that we cannot conduct our policy along lines of ultra-nationalism similar to the nationalistic chauvinism current in other countries. Our extreme nationalism in Palestine will only be counteracted by an extreme nationalism from the other party, something which we have unfortunately already achieved."

"We must regard the occurrences in Palestine as symptoms requiring serious treatment. In this respect we should not rely upon England's protection, but we must demand that England do nothing to sharpen the animosity between Jew and Arab, but as for friendship, that remains our duty."

EDUCATION ASS'N WELCOMES J. GOLDSTEIN AT DINNER

Jonah Goldstein was welcomed home from Palestine, where he had gone as the personal representative of Felix Warburg to make arrangements for the distribution of the Palestine Emergency Relief Fund, Wednesday night at a dinner in the Hotel Biltmore given by the Jewish Educational Association in whose activities Mr. Goldstein has long been prominent.

A donation of \$10,000 for a scholarship fund was announced at the dinner as coming from the Jewish, the women's section of the Jewish Educational Association. The announcement was made by Mrs. Gabriel Hamburger, chairman of Jewish. Other speakers were David Mossosohn, editor of the "Jewish Tribune"; David Sarnoff, vice-president of the Radio Corporation of America, and Bernard Semel, honorary secretary of the Jewish Educational Society, all of whom praised Mr. Goldstein's services.

Felix Warburg in connection with Mr. Goldstein's work in Palestine said he had obtained much valuable information of conditions in that country as the result of Mr. Goldstein's trip. In passing Mr. Warburg remarked that what was needed in Palestine was peace above everything else.

they were unanimously decided against the demonstration. At their second meeting, held after eleven o'clock in the evening, unanimity was lacking, it being obvious that outside forces had been at work to influence the Moslems not to check the demonstration which was bound to result in trouble.

Major Crosbie agreed to Mr. Silley's statement that while a small, discontented majority was responsible for the actual attack, the whole population of Jaffa was opposed to the Balfour Declaration.

A general massacre in Tel Aviv was prevented, Major Crosbie declared, by the prompt action in firing of the Police Officer Riggs. Riggs and a group of four men with rifles protected the Jewish quarter of Tel Aviv. A crowd which surged around them shouted, "Kill Riggs," and subsequently attacked a Jewish house, where the Jewish owner was killed and his two sons wounded. Crosbie agreed that Riggs's own description that "by firing we prevented further concentrated attacks" was accurate. Crosbie denied Silley's innuendo that the firing excited the Arabs, declaring that at the time all the Arabs were belligerent.

Sheik Muza Far of Jaffa, Arab lawyer, who is on the government's blacklist and who occupied a seat with the Arab counsel, was identified yesterday by Crosbie as the sheik who delivered a speech before the Young Moslem Association. At the same time, R. Hopkin Morris, member of the Commission, recognized him as having addressed a petition to the Commission when it visited Jaffa.

Crosbie, in reply to Erleigh's questioning, declared that he did not recollect an interview with a Jewish farmers' deputation informing him of the danger of an attack on the Jewish colonies. While Erleigh read him the list of the members of the deputation from the "Davar," Labor daily, Crosbie stated that he remembered only making an appointment, but not that the interview had taken place. He said further that once the disturbance had started, so many meetings were held that he could not remember them all. When Erleigh pointed out that this was a very important meeting, dealing with the exodus of the Arab laborers and their women from Petach Tikvah, Crosbie hedged, saying: Such departures are usual whenever a conflict arises between Arab and Jewish labor, over orange picking for instance. Preedy, government counsel, supported the suggestion that the exodus was due to labor friction. Sir Boyd Merriman, flushing, corrected that impression.

The question of the Jewish self-defense action figured in the proceedings when Silley attempted to draw out Major Crosbie on the subject, and the spurious booklet which Stoker tried to introduce yesterday was again offered by Silley. The queries of the Arab counsel received little satisfaction from Major Crosbie. He declared that he

causing great excitement. The attacks on Dr. Ticho and the murder of Fanny Badash and the injury of her escort, Isaiah Levitte, are worrying the Jewish populace. Harry Sacher, member of the Zionist Executive, had an interview today with the High Commissioner in which he demanded that strong measures be taken to protect the Jewish population.

The Chief Rabbinate has ordered the prayers be said for the recovery of Dr. Ticho. Late medical bulletins indicate that the condition of the distinguished oculist, who has consistently befriended the Arabs, is better. Several Arabs suspected of the attack on Dr. Ticho have been arrested.

Commenting on the new incidents, the "Ha'Aretz" writes that in no country in the world is Jewish life and property so unprotected as now in Palestine.

The "Doar Hayom" declares that the attack was due to the weak attitude of the Government towards the Arabs.

RABBI AARON TEITELBAUM RETURNS FROM PALESTINE

Rabbi Aaron Teitelbaum, member of the praesidium of Mizrahi World Organization, arrived here Tuesday from Palestine, on the "Majestic."

"The great interest American Jews take in Palestine affairs is an encouragement to the wounded hearts of the Palestine Jews," Rabbi Teitelbaum stated. "The interest of American Jews strengthens not only economically but also politically the development and upbuilding of the Jewish Homeland," he added.

Rabbi Teitelbaum further stated that Jewish traders in Palestine suffer from Arabian boycott and many of them are forced to change their profession.

PALESTINE GOVERNMENT MAKES DETERMINED EFFORT TO SUPPRESS P.T.A.

most important news items to the extent of 7,500 words a month. At the same time Reuters agreed to take the P. T. A. news from Palestine. At this point it is well to note that in Palestine the P. T. A. is a general news agency and not only a Jewish news agency.

As the basis of the five year agreement with Reuters the latter placed at the disposal of the P. T. A. an arrangement it had made with the Palestine authorities according to which the Palestine administration agreed to waive the local terminal charges (landing tolls) of 6.25 gold centime per word on condition that Government headquarters receive gratis one copy of all Reuters news telegrams.

Before entering into the agreement with the P. T. A. an inquiry from Reuters to the Palestine government as to whether P. T. A. would be considered a suitable agent was answered in the affirmative. On May 8, the Palestine government agreed to waive the local terminal charges as regards all Reuters telegrams. The concession went into operation on June first and was terminated October first. In answer to a request made by Jacob Landau, managing director, to the Palestine Government to reconsider this question, an answer was received from Chief Secretary H. C. Luke, refusing this request but indicating that the government was prepared to take into its own hands the manipulating of Reuters service in Palestine.

That the cancellation of the concession is part of a general policy to obtain control of the news service to and from Palestine, upon which the Palestine government has embarked is evidenced by the fact that through the Colonial Office, it tried to bring pressure to bear upon the "London Times" who had appointed as its representative in Palestine Gershon Agronsky, the correspondent for the P. T. A. and the J. T. A.

Difficulties encountered by Pierre Van Paassen, a special representative of the J. T. A. in Palestine and also acting for the "Evening World," in obtaining usual post office facilities for collecting messages, the suspension of the Hebrew daily, "Davar," for publishing a document which had received publicity in hundreds of newspapers throughout the world, are further indications of the government's efforts to make the press of Palestine dependent on news sources which would be in the hands of the government.
