Parliament Learns Professors Stood By as Students Beat Jews at University of Jassy

Jewish Deputy Fischer Submits Photographs of Injured; Charges Police Knew Guilty but Did Nothing (Jewish Telegraphic Agency)

Bucharest, Dec. 24-Charging that professors stood by while Gentile students beat their Jewish fellow-students, saring the doors so they could not scape, Deputy Theodor Fischer yesterday in Parliament questioned the Minister of Interior regarding the disurbances which occurred at Jassy University on December 16. Stating that the Christian students had seriously injured a large number of the lewish students and submitting photo-graphs of some of the injured to substantiate his complaint, Fischer stated that complaints were made to the police and although the names of the attackers were known to them, they did not act to indict anyone. The prolessor, after whose lecture the riots occurred, Fischer stated, remained passive, while a laboratory assistant aided the Christian students in their attacks, Fischer charged. For the sake of Roumania's good

name, and to restore normal work at the University, Fischer suggested that all state officials who preach enmity between sections of the population should be subjected to disciplinary action, and be made to answer before court for the

incitement against peace.

Moscow, Dec. 24-Nearly four hundred Zionists, of all parties were ar-rested this week and imprisoned in Odessa. A number of seventeen-yearold youths were among those arrested. They were members of Hashomer Hazayr (Zionist Youth Organization). Hachalutz (Palestine pioneers) were also included in the arrests which were made in the evening. It is understood that no one connected directly or indirectly with the Zionist movement now remains in Odessa.

All sides called final witnesses yesterday in order to clear up the outstanding points. The witnesses for the lews included Barshed, a hotel keeper and act-ing mayor of Safed. By August 22ud he stated, Amman buzzed with rumors that Jews had killed Arabs in Jerusalem and testified that as a waiter at the officers mess in the Transjordanian capital, he heard these rumors discussed freely.

That the Jews forty years ago had been allowed to repair the much-discussed pavement near the Wailing Wall. was brought out in yesterday's hearing of the Palestine Inquiry Commission, when 70-year old Yosel Kives testified that he himself had helped lay the stones following the Turkish L'asha's consent to the repairs.

The chief witness before the Commission, Abdul Kardus, district officer of Hebron, a Christian Arab, preceded two Jews both of whom had signed petitions to Sir John Chancellor High Commissioner, demanding Kardus's dismissal. Denying, under examination by Preedy, government counsel, that he had neglected his duties, as charged, he told how he had faced a mob of 400 Arabs who were trying to break into the house of Rabbi Epstein, dean of Slabodka Yeshiva. MacDonald Considering Balfour Plan for Palestine Commission

London, Dec. 24-That the joint letter of Lord Balfour, Lloyd George and General Smuts calling for a new commission to investigate the workings of the Palestine Mandate is receiving the attention of Prime Minister Ramsay MacDonald was revealed yesterday in

the House of Commons.

In response to a question from Sir Archibald Sinclair whether a commission to inquire into questions of major policy affecting the future administration of the Palestine Mandate will be set inasmuch as such questions lie out-side of the terms of reference of the present Shaw Commission, Premier MacDonald replied that he had seen the proposal in a letter under influential signatures which command his most careful attention, but that there are, however, important considerations which must be carefully weighed before deciding. The Prime Minister declared that the subject of a new commission is clearly outside of the terms of reference of the Shaw Commission and cannot be made part of its report.

Warsaw City Council to Reject Anti-Shechita Proposals for Fear of Higher Meat Prices

(Jewish Telegraphic Agency)

Warsaw, Dec. 24-It appears likely that the Warsaw City Council will reject the proposal, made at its session a few days ago, to concentrate the entire kosher killing of cattle in Warsaw as well as the sale of meats in the city abbatoir under the supervision of the municipality. If this proposal were to be carried out, it would mean ruin for the Jewish meat dealers.

Aldermanic President Slominsky today informed the Jewish Aldermen that this proposal is not practical, since it would lead to higher meat prices for the Christian population. He therefore expressed his belief that the proposal

will not be adopted.

According to the law, every enactment by the City Council would have to be approved by the Minister of the Interior before it becomes binding.

Dr. Mombelli tells of an appeal for an understanding between Jews and Arabs which has recently been issued by a "prominent Zionist" in Palestine and which reads in part as follows:

"Two years ago when the Arab leaders sought our help in connection with the strife for the establishment of a Legislative Council, they gave us to understand, in various ways, that they were prepared to negotiate with us. We did not take advantage of that opportunity. On July 28, 1922, the Zionist Executive stated that the Zionist policy would be conducted in accordance with the policy laid down in the White Book. The Zionist Executive further stated that this policy loyally accepted by all parties, would mark the beginning of a new era of peaceful progress. In making this statement the Zionist Executive accepted the only official interpretation extant of the Balfour Declaration, This official interpretation could have been an instrument of peace in Palestine, but we have to admit that certain Zionist sections only accepted the White Book under protest and continued to plead for a Maximalist policy. This attitude has contributed towards the creation of an atmosphere of distrust. The Zionist leaders must speak such words and do such deeds as will convince ourselves and the Arabs that the Zionist program is to be carried through in full cooperation with the Arabs in Palestine."

Resolutions condemning the statement of Kenelm Preedy, counsel for the Palestine Administration at the Inquiry Commission, that Zionist aspirations were responsible for the Palestine massacres, were adopted at a mass meeting called by the Zionist Revisionists last Saturday at the Hias Building.

The meeting also protested against Dr. Chaim Weizmann's statement that the British Government's policy in Palestine was in general in accord with the Mandate and satisfactory to the Zionist aims.

It was decided to demand that Vladimir Jabotinsky, leader of the Revisionists, be invited to give evidence before the Commission of Inquiry and to demand the resignation of Joshua Braude, a member of the temporary Palestine Zionist Executive during the disturbances, for his statement that a Jewish state in Palestine is a dream.

Alliance Israelite Universelle Refutes Claim It Is Indifferent to Palestine by Pointing to Its Trade and Primary Schools

Committee of the Alliance Israelite Universelle has just published its annual report, some of the salient fea-tures of which are given below. Answering the claim that the Al-

liance has been indifferent to Eretz Yisrael, the report says:

"We need only point to our chain of primary schools, of trade schools, and to our agricultural school, from whom have gone forth several genera-

tions of pupils who have been trained and re-educated and who are the living testimony of the value of our work of emancipation and fraternity there. Reporting on Jewish conditions in Poland, Hungary and Roumania, the report finds that they have during the past year been bad in an extreme degree. The report notes that special taxes are levied upon certain groups in such manner as to particularly af-fect the Jew, that Jewish students are shut out from the technical schools and colleges and that government positions are systematically closed to Jews. The Alliance has interceded

The Alliance has aided Jewish immigrants from Eastern Europe, who have come to France. Numerous organizations have been formed to help the newcomers. An employment com-mittee is being subsidized by the Alliance in Paris, as well as courses in French for adult immigrants.

Social and Labor Laws Unenforced in Palestine

(J. T. A. Mail Service)

Amsterdam, Dec. 6-It is a wellknown fact that social legislation in Palestine is only in its infancy, declares the Internation Federation of Trade Unions, "Among the few regulations existing in this sphere are those dealing with the employment of women and children, 'Davar,' the organ of the Palestine trade union centre, points out in its last number. however, that even the few regula-tions which exist are by no means applied. The passage in question runs as follows:

"'It decrees an eight hour day for boys and girls under 16, no night labour for women and children, and a weekly day of rest. But it fixes the age limit for children at 12, while usually it is 14. Moreover, it covers only industrial undertakings, affording no protection whatsoever to children employed in agriculture, in house and shop service, in road making, etc. And these are legion. There is no reason why they should not be brought in, at least gradually. (The fact that children are employed on road construction by government contractors is a crying shame.) Still less is there reason why such abuses as have beer pronounced illegal should not be ac-tually prevented. Yet from the outse the Government seems to have missed the lesson taught by the history of factory legislation, that it is more than uscless to legislate unless there is efficient inspection to enforce the measures prescribed. The Jerusalem Workers' Council had again and again to draw official attention to the wholesale violation of the law. Even after certain officials were saddled with the office of factory inspector in addition to their regular duties, no appreciable change was noticeable."

New Orleans, Dec. 23-The Jewish Community of New Orleans is preparing for two important January events. "Man Hunt" On for Jews Who Deserted Wives in Poland

Chicago, Dec. 24-One of the most strange "man hunts" in history is under way today in Chicago and throughout the United States.

It is a search for husbands-1,000 of them, who deserted their wives and families in Poland many years ago. Of this number, 125 are believed to be in the United States, and orthodox rabbis of Chicago and leaders of the local lewish community are engaged

The search is being directed by Rabbi Eliohu Lifshitz, delegate of the Polish Rabbinate, alderman, president of the community of Gritz, Poland, and prominent social worker, who has come here for that purpose.

The rabbi hopes to force either the husbands to re-unite with their families or divorce their wives, since a Jewish wife, according to the orthodox law, may not divorce her husband on grounds of desertion unless she knows what became of him.

Kalman Greenfield and Baruch Cohen, Safed chauffeurs, gave detailed stories of their trips a fortnight before the outbreak in Safed when Subhi Khadra and other Arab agitators journeyed to many northern villages. Meetings were held and the chauffeurs, the witnesses stated. were forced to remain a few hundred yards away from the villages while these occurred, even though formerly they were guests in the house.

To fix the time when the first Jewish dead were brought to hospitals in Terusalem, the lewish counsel called the head nurse of the Hadassah hospital, Miss Sherrowitzky, and Dr. Agyiss, in-terne at the Rotschild hospital. "Until now we have been calling upon the policeman and the prosecufor to stop the shameful deeds of the 'true-German' rascals and cowards. Why? Did it ever bring us any re-lief? Why doesn't Jewry as a whole adopt the means of enlightenment among the German populace? Tell our fellow-citizens what we are, how we live and what we want! We wish to work and to be left in peace by those who calumniate our people.

"lewry must see to it that Christian ministers and teachers be made to regard it as their duty to teach the truth, and only the truth. Adult Christians must also be shown, by means of educational pamphlets that are to be distributed on masse, the real character of Jewry.

(Continued from Page 1) versity, if Fischer's report were accurate, and feels that the students should exclude politics and attend to their work at the University. However, he said, anti-Semitic activity, in so far as it is confined to a conflict of ideas, enjoys liberty of assembly and of the press similar to other movements. This does not mean, he stated, that anti-Semitism is allowed in the universities, nor that the government permits violence to occur in or out of the universities. He is convinced, he stated, that measures have already been taken against the aggressors. If the accusations against the faculty mem-bers were true, the University will

undoubtedly take steps. Fischer then demanded a reply from the Minister of Education, saying it seemed that the government justified anti-Semitism to a certain extent. This provoked considerable tumult, Madgearn angrily saying that Fischer mis-represented his words and that the government cannot prevent citizens from holding any views no matter how deplorable. The government, he said, condemns violence and if the lassy incidents were as described they would be condemned with all possible energy. It was necessary to wait, however, for the report of the inquiry which the Minister of Education is conducting before the Government could act.

"From information so far gathered in connection with incidents which occurred at the University of lasi (Jassy) in the class of Prof. Smuleanu. it seems that there were injured. among the Jewish as well as among the Christian students.

"The intervention of the authorities and the arrest of the heads (leaders) of the movement have brought the incidents to a stop. The University has been closed and a drastic investigation begun by the prosecuting attorney and the University authorities. In reply to a question put in the House by Congressman Fischer, Ministers Madgearu and Costachescu answered that the government is doing its utmost to suppress the movement and is taking strong measures for ascertaining who is responsible for it and to punish the

Sons of Confederate Veterans Plan Memorial to Benjamin (Jewish Daily Bulletin)

Richmond, Va., Dec. 24-A monu-ment to Judah P. Benjamin, secretary of state and war in the Confederate cabinet, and known as the brains of the Confederacy, will be erected in this city, the former Confederate capital, if Stonewall Jackson Camp.
