### Problem of Jewish Artisans in Small Towns Near Collectives Becoming Serious in Ukrainia (Jewish Telegraphic Agency)

Moscow, Feb. 13-Worried over what s to become of the thousands of Jewsh artisans in the small towns near the collectivized regions, the All-Ukrainian Central Executive Committee today urged the Soviet cabinet to out-

line concrete plans for solving this new and serious problem which endangers the existence of every resident of

the small towns.

It is foreseen that the small towns as such will be entirely uprooted by the present collectivization of villages and no one will have any work there. This no one will have any work there. This is due to the fact that the collectivized villages accepted as a full-fledged member of the collective one or two artisans from the town leaving the rest entirely without prospects because the artisans who are members of the collectives serve the collective in their profession, thus a few do the work of dozens of Jewish artisans who served the same peasants individually before they were collectivized.

Because of this concentration of labor and also because the collectives are unable to absorb the complete small town, those Jewish artisans who have not been accepted into the collectives are facing starvation, having nothing to do. The same is true of the Jewish youth in the small towns who are losing interest in being trained as artisans because they cannot in the future ap-

ply their training.

A similar problem has also faced the

### Report Anti-Jewish Excesses Again from Kishinev

(Jewish Telegraphic Agency) Vienna, Feb. 13-Widespread anti-Tewish excesses have occurred in Kishinev, according to reports in yes-terday's afternoon Vienna papers. Theological students are reported to have demolished a number of Jewish shops, destroyed property and thrashed a number of Jewish visitors in the Cafe Venezia. The anti-Semites then proceeded to stage a demonstration in the streets. While the police are said to have done their best to prevent the trouble from spreading and arrested a number of the students the Jewish population is panic-stricken.

# Seek to Protect Jewesses from Polish White Slave Traffic

Warsaw, Feb. 13-The committee to combat the white slave traffic has asked the Rabbinate to exercise the greatest care in the marriage of girls going abroad, particularly where the husbands are foreigners. Simultaneously the committee has asked the au-thorities to increase their control over women going abroad because there has recently been an increase in the white slave traffic which has been responsible Jewish girls.

# Kosher Meat Controversy Stirs Jews of Cleveland and Neighboring Towns

(Jewish Telegraphic Agency) Cleveland, Feb. 13-Hope for peaceful settlement of the controversy be-tween Benjamin Cohen for Swift & Company, on one hand, and the kosh-Company, on one nand, and the kosn-er board and rabbis' union on the other, vanished when a conference called by Judge David Thomas of Common Pleas Court ended without the desired results. The trouble arose from a demand by Cohen for a permanent injunction against the rabbis, who a few weeks ago banned two Jewish slaughterers. A temporary injunction enjoined the rabbis and the kosher board from interfering with the business of Swift & Company and Cohen. and forbade the kosher board from advising the Jewish community that meat coming from Swift was not under its supervision, that it was not kosher and that Swift's slaughterers were under the ban.

When Cohen, testifying on his own behalf, pretended to be an authority on Jewish ecclesiastical law and attempted to tell the court what can and cannot be done under the kashruth laws, Jews in the court burst into tears at the spectacle of a Jew dragging Jewish law in the mud. ### South African Quota Bill Passes Second Reading (Tewish Telegraphic Agency)

Capetown, Feb. 13-The new South African immigration quota bill limiting the number of immigrants to be admitted annually from all countries except 12 Nordic ones in Europe, the British Commonwealth and the United States to 50 was overwhelmingly passed at its second reading, with the major-ity voting for it being composed of

all parties.

An amendment suggested by a Labor member to refer the bill to a select committee was defeated with only eleven votes in favor of it. Minister Malan and other speakers vigorously denied that the bill discriminates against the Iews, while admitting that the Jews form the bulk of immigrants from certain of the countries restricted under the bill.

A significant feature of the debate was the almost complete absence of speeches on the government side. Even the premier was silent. No direct attack on the Jews was made; on the contrary, all speakers gave vent to expressions of friendship. The one exception was Mr. MacCullum of the South African Party, from Capetown, who directed his attack on the busi-

ent of the "Kolo," or Jewish Parliament Club. Gruenbaum resigned because a meeting of the "Kolo" had refused his proposal to vote as a body in parliament against the government budget. Only three other deputies, Hartglass, Davidsohn and Koerner, supported Gruenbaum, who claimed that the changes which the government had made in the budget in favor of Jewish needs were too insignificant for the Iewish deputies to support the budget as a whole. Deputy Szabad did not vote on the Gruenbaum proposal.

The majority of the "Kolo" members took the attitude that though they couldn't vote for the budget, because of the government's attitude towards minorities, the government of Premier Bartel had, however, shown good will, and that they must therefore refrain from voting in order to give the government time to realize its good intentions.

#### 60 Hebronites Return to Tombstones of Riot Victims

(Jewish Telegraphic Agency) Jerusalem, Feb. 13-About sixty Hebronites, mostly yeshiva students, visited Hebron yesterday for the dedication of the tombstones of the victims of the massacre and also for the burial of the clothing and other blood-soaked effects left in houses since the massacre. The strike of the New York dres makers which had been going on for more than a week was officially ended on Wednesday when representatives of the International Ladies' Garment Workers' Union, the manufacturers. contractors and jobbers met at City Hall and signed an agreement to maintain peace in the industry for the next two years. The settlement of the strike was accomplished through the mediation of Lieutenant-Governor Lehman. Both the Lieutenant-Governor and Acting Mayor McKee acted as witnesses when the agreement was signed at city Hall.

As a result of the settlement about 22,000 workers were expected to return to work within the next few days. The agreement which is considered a victory for the workers will virtually do away with the sweatshop and will result in the formation of an impartial commission which will henceforth set-tle disputes which may arise in the dress industry. This commission will be appointed by Governor Roosevelt and will be composed of representatives of the unions, of the three employers associations and of three other disinterested persons. The commission will be appointed for a period of three months, but if it is successful, it will be made into a permanent body.

Besides the abolition of sweat shops

and the formation of the impartial committee, the settlement also gives committee, the settlement also gives the workers a 40-hour 5-day week. No increase in wages was asked, that mat-ter having by agreement been postponed for a year.

Two thousand cutters and sample men went back to work Wednesday after their agreement had been rati fied. It is expected that the full 22,000 will be back at work by Monday. An additional 10,000 will still be out, pending the settlement of their differences with independent shops not members of either of the three employers' associa-

### Notable Collection of Jewish Books Acquired by Harvard (Jewish Telegraphic Agency)

New Orleans, Feb. 13-Harvard University has acquired the library of Ephraim Deinard, father-in-law of Rabbi Mendel Silber, both of New Orleans. One of the largest, most complete and most valuable collec-tions of Hebrew books and manuscripts to be found in private posses-sion anywhere in the world, Mr. Deinard's library was much sought after. On many occasions a duplicate volume supplied an urgent request from the British Museum in London.

Ill health and loss of eyesight caused Mr. Deinard, now in his eighties, to give up the 12,000 volumes he had collected through years of travel in Europe and the Orient. At Harvard the books will constitute the "Deinard Collection," just as does the section on Semitic literature in the Library of Congress in Washington.

Included in the collection are 65 volumes by Mr. Deinard, himself, in-cunabula of which the first Hebrew book printed—Tur Hoshen Mishpat is one, and 21 volumes published in Piove di Sacco in 1475 are others; 25 volumes of half-incunabula; 500 volumes of First Editions and exceedingly rare prints, Talmud, Lexica and thousands of others as valuable.

Previous to the foundation of the "Deinard Collection" in the Library of Congress, Mr. Deinard made one of the many trips he has taken throughout the civilized world in search of Semitic books. This journey was sponsored by the United States government.

# 15.300 Names Now

(Jewish Telegraphic Agency) Ierusalem, Feb. 13-More than 15,300 names have been inscribed in the Golden Book, according to a statement made by the headquarters of the Jewish National Fund in Jerusalem, which has charge of the Golden Book, a record of service to the upbuilding of Palestine as the Jewish National Home. The third volume is now being concluded. The first two volumes have been completed and each contains 5,000 inscriptions. A special volume was compiled on the occasion of the 25th Jubilee of the Jewish National Fund and contains 2,000 names especially inscribed on that occasion. Some \$462,750 have been contributed to the Iewish National Fund for the purpose of inscriptions in the Golden Book, of which \$200,700 were contributed in the last two years. Of the latter sum, \$72,000 were contributed by the United States.

### Ran on Schechita Discussed **By American Jewish Committee**

The passage by the Bavarian Diet of a law prohibiting Schechita, the politi-cal situation of the Jews of Roumania, and the oppression of religion in Russia, were among the questions considered by the Executive Committee of the American Jewish Committee at its re-cent monthly meeting. Among the domestic matters taken up were proposed immigration legislation and various anti-Iewish manifestations which had been called to the Committee's attention.

In connection with the Schechita question, Dr. Cyrus Adler, president of the Committee, had furnished a state-ment of the American attitude toward Schechita.

The immigration situation was reported on by Max J. Kohler, chairman of the Standing Committee on Immigration, who, with the secretary, Morris D. Waldman, represented the Committee at a hearing on various bills introduced by Congressman Samuel Dickstein, before the Committee on Immigration of the House of Representatives, on January 27. The Committee decided to take steps to combat the legislation proposed in two bills recently introduced in Congress, in conjunction with other organizations which are opposed to the registration of aliens.

### Palestine Government to Repress Moslems' Tactics

(Jewish Telegraphic Agency) Ierusalem, Feb. 13-The Palestine government is determined to suppress before it is too late the repressive tactics that the Moslems have recently revived to annoy the Jews at the Wailing Wall, the Jewish Telegraphic Agency's correspondent learns on good authority. Such annoyances as ordering the worshippers to lower their voices, the extinguishing of candles and the renewal of the Zikhr, a ritual fre-quently referred to as a "jazz band" during the Inquiry Commission's hear-ings will get the government's atten-

The authorities whom your correspondent has consulted do not disguise their concern over the latest developments wherein they see the hand of the Grand Mufti, who owing to the growing Arab opposition on account of the distribution of the relief fund and the unrepresentative character of the London delegation, is trying as usual to divert attention to the fabricated religious issue and check dissension.

### Privy Council Not Yet Ready to Hear Arab Death Appeals (Jewish Telegraphic Agency)

Jerusalem, Feb. 13—Reports from Arab sources that the Privy Council will hear appeals against Arab death sentences are declared to be premature. While no application for a hearing has yet been made in London, Abcarius, the Jewish proselyte attorney, is expected to leave for London shortly to brief the case and make the application.

(Continued from Page 1) White Russian Central Executive Committee where the non-Jewish collectives refuse altogether to accept Jewish members. The White Russian government is trying to have the Jews from the small towns enter the neighboring collectives as plain laborers. The collectives, however, do not need laborers and also cannot feed them.

Golendo, a member of the land commissariat, who returned to Moscow today from White Russia after studying the situation of the Jews in the collec tivized regions there told the Jewish Telegraphic Agency that his reccommendations to the government would be that the collectives should be compelled to accept the Jews from the neighboring small towns as farm mem-The only question is about aged people and orphans who cannot be utilized for farm work.

It is understood, however, that the White Russian government does not share Golendo's opinion and although it is making an effort to solve the problem of the small town it nevertheless feels that the small towns in the collectivized regions are doomed to ab-

solute annihilation.
