#### Smuts' Amendment to South African Quota Bill Rejected (Jewish Telegraphic Agency)

Capetown, Feb. 19-An amendment by General Smuts to the new immigration bill, which would have given each East European country a quota of five percent of the number of its immigrants who lived in South Africa in 1926, instead of limiting the quota to fifty immigrants a year, was defeated yesterday in the South African parliament, as a result of the opposition of Premier Herzog's party.

Both the Premier and Minister Malan stated that while they are opposed to more immigrants entering South Africa from Eastern Europe, they do not at the same time wish to limit immigration from the "Nordic" countries. Their attitude was strongly criticized by the Jewish deputies who supported General Smuts' amendment.

## Soviet Exiles Aged Rabbi from Leningrad

(Jewish Telegraphic Agency) London, Feb. 19-It has been reliably learned here that the Soviet government has ordered the 84-year-old Rabbi Katzenellenbogen of Leningrad, formerly of Suvalk, to leave Leningrad immediately.

#### Russia Wars on Anti-Semitism Prevalent in Red Army (Jewish Telegraphic Agency)

Moscow, Feb. 19-David Schoichet, a soldier in the Red Army, committed suicide today because of anti-Semitic persecution. A special Red Army seminary has been established in Moscow of fight the increasing anti-Semitic tendencies among the soldiers. Each soldier is required to attend five seminary lectures to acquaint himself with the Soviet national minority policy as well as the background of anti-Semitism and the useful role of the Jews as workers and colonists.

### Minsk Kehillah Leaders To Be Tried Soon on Serious Charges

(Jewish Telegraphic Agency) Moscow, Feb. 19-Moscow officialdom in commenting on the arrest last Saturday of practically all of the leaders of the Minsk Jewish community says that the rabbis were arrested not because they were religious leaders but because they had been maintaining secret connections with counter-revolutionary organizations abroad. arrests should hence not be interpreted as anti-religious persecution. It is understood that those arrested will be tried shortly on an official charge of abroad which is a serious accusation.

#### Two Jews Lose Mandates as Polish High Court Cancels Elections from Volhynia

Warsaw, Feb. 19-The Polish Su-

preme Court ,after hearing complaints of irregularities in elections, has cancelled the parliamentary elections held in March, 1928 in the province of Volhynia, thereby annulling the mandates of Deputy Wislicki and Senator Lazar Dal, two of the three Jewish candidates who were returned in the general election on the government ticket. Deputy Kirschbraun is now the only Jewish member of the government

It is expected that Wislicki and Dal will present their candidacies again in the new elections which will take place within three months. Twenty-two complaints of election irregularities were made altogether, and in three cases, including those of the two Jewish deputies, the election results were cancelled. The third parliament member, a leader of the government party, whose election was invalidated, was Prince Radziwill, the leader of the Polish aristocracy, president of the Sejm Committee on Foreign Affairs.

#### Hear Arab Delegation Not Going to London Until March (Jewish Telegraphic Agency)

Jerusalem, Feb. 19-A report is current here that the Arab delegation going to London is postponing its de-parture until early in March so that its arrival will coincide with the ex-Commission's report. The delegation had been expected to leave next week.

#### Ukrainia to Effect Measures for Aid of Declassed Jews (Jewish Telegraphic Agency)

Moscow, Feb. 19-The president of the Ukrainian Central Executive Committee, M. Petrovsky, urged today that certain categories of Jewish ex-traders be reinstated in their election rights similar to the reinstatement decided on by the Central Executive Committee in Moscow for the Jewish ex-traders of Central Russia. He made his recom-mendation at a meeting of the Central. Executive Committee's secretariat where a number of speakers established that the situation of the declassed Jews in Ukrainia is more than catas-

Petrovsky also emphasized the situation of the declassed Jewish youth, recommending that even those without election rights should be admitted to the factories. A member of the Cen-tral Executive Committee, M. Gorlinsky, suggested that the laws regarding voting rights be revised in favor of the Jewish declassed.

The recommendations of Petrovsky and Gorlinsky were approved and the technical committee of the Central Executive Committee will work out the details for the reinstatement of the declassed Jews.

#### Jewish Group in Germany Rejects Jewish Nationality

Berlin, Feb. 19-That Germany is the center of their political and cultural lives and that they therefore decline to participate in National Jewish propaganda and also refuse to join the Jewish Agency for Palestine, was the declaration of the members of the Central Verein of German Citizens of the Jewish Faith at their annual meeting A unanimous resolution was adopted rejecting any Jewish national aspira-tions including Palestine work.

#### Form Jewish Service Association in Memphis (Jewish Daily Bulletin)

Memphis, Feb. 19-Seeking no funds, Mempnis, Peb. 19—Seeking no tunds, but asking only "time, thought and self" for its membership, the Jewish Service Association was formed here last Saturday, with Bernard L. Cohn, financier, as president. The membership will be limited to Jews but the organization's work is to be non-sectarian. Its principal object is to co-ordinate activities of Memphis Jews in Jewish and communal fields.

### Deaths of Safed Jews

(Jewish Telegraphic Agency) Jerusalem, Feb. 19-The police have failed to clear up the mysterious killing and wounding of several Jews from Safed who were sheltered in the police barracks after the massacre it was disnarracks after the massacre it was uns-closed today by the Hebrew newspaper "Doar Hayom." On the Saturday fol-lowing the massacre, says the "Doar Hayom," a trooper of the Transjor-danian defense force boasted in the presence of Habib Hadad, a Sephardic Jew from Tiberias whom he mistook for an Arab, that at dawn he had fired on the Jews in the police barracks.

The trooper repeated the same story to another Jewish youth, continues use "Doar Hayom," who after drawing him out informed the police in Tiberias. The latter questioned the trooper but then released him. This week, six months after the event, the police held without finding the trooper.

illustrated but the language will be simpler and the contents adapted to the age of the readers. This Library is to be known as "Latalmid" and it is anticipated that it will meet with the same success that is attending the youth (Lanoar) Library.

#### 50 American Chalutzim Leave for Palestine

The first American group of "chal-utzim," which sailed yesterday on the "Mauretania" for Palestine, was hon-ored by the Zionists of New York City Tuesday night at a farewell reception in the Jewish Club. The group consists of fifty men and women. Several hundred people were present at the reception.

The principal speakers were Dr. Shmarya Levin, Rabbi Stephen S. Wise and Rabbi Gold. Dr. Levin, in the course of his talk, expressed the opinion that six million Jews of Eastern Europe are doomed to perish. He advised the American "chalutzim" to "write good letters home, though with-out exaggerations," assuring them that no matter what hardships they may have to endure in Palestine as pio-neers, they will nevertheless feel happy.
Dr. Wise expressed confidence that

England has already recognized its mistakes in Palestine and will soon rectify them, and said that the Jews will not surrender under threats of force. "Palestine is not only a refuge for the Jewish homeless, but also, and more so, for Jewish homelessness," he said. Judge Bernard Rosenblatt presided at the reception.

#### Herman Bernstein Leaving Soon for Albanian Post (Jewish Telegraphic Agency)

#### New Terminology May Void Bavarian Anti-Schechita Law (Tewish Telegraphic Agency)

Berlin, Feb. 19-The commission on legal terminology of the German Reichstag has adopted the motion of the Centrists to add to the paragraph on animal slaughter in the new book of legal terms a clause to the effect that schechita, the Jewish mode of animal slaughter, does not constitute cruelty to animals, and therefore is not puishable by law.

It is believed that in this way the recently passed Bavarian law which forbade schechita on the ground that it constituted cruelty to animals will be-come inoperative. The Phoenix Insurance Company also invests in Palestine, in consequence of this arrangement, and the new Zionist headquarters in Jerusalem are being built as a result of financial assistance

on favorable terms from the Phoenix.

By decision of the Zionist Congress, the Jewish National Fund is among Zionist institutions, given a monopoly of insurance propaganda. Judea Life Arranges to Raise Capital and Surplus

A special meeting of the directors of the five inter-connected Judea companies, held at the Governor Clinton Hotel, approved the contract entered into between the Judea Industrial Corporation and the investment house of Moses & Company, Inc., whereby 130,000 shares of the new stock of the Judea Life Insurance Company will be sold to the public, according to a statement issued by the company. The old stockholders of the Judea

Industrial Corporation will first be given the opportunity to subscribe for over 100,000 shares of the new stock at the rate of three shares of the new issue for each share held in the Indus-

trial Corporation.

The investment house will purchase and sell only part of the new stock; the remainder of the two hundred thousand shares authorized by the Insurance Department will be purchased by the Judea Industrial Corporation in connection with this financing. It is stated that this arrangement will assure the continued control of the Judea Life Insurance Company by the Judea Industrial Corporation and its wholly owned subsidiary, the Judea Insurance Company, Ltd., of Pales-The new capital and surplus will go

to expand the insurance business in the many States where the company is favorably known but not now operating. The directors of the Judea companies at the meeting, some 36 in number, were enthusiastic over the new prospects for the company and its Palestine aims.
