New Measures for Relief of Jewish Ex-Traders Adopted by Ukrainia

(Jewish Telegraphic Agency)

Moscow, Feb. 25-Further measures for the relief of Jewish ex-traders, even those who employed five persons. were decided upon today by the Ukraivian cabinet. The decision has not yet been published, but the correspond-ent of the Jewish Telegraphic Agency possesses the text.

It declares that the industrial cooperatives, the artisans' cooperatives and the land collectives should accept the following declassed Jews who have no election rights: first, the impoverished ex-traders who employed one or two assistants; such ex-traders would be accepted on equal rights in the usual procedure.

Ex-traders who hired from two to five employes would be accepted not earlier than two years after they had given up trading providing they do not maintain relations with commercial and capitalistic elements, in others if they do no illegal trading. Ex-traders or manufacturers who exploited more than five laborers would not be ac-cepted. The grown-up children of cepted. The grown-up children of those in the latter category would be accepted if they have severed relations with their parents and are earning an independent livelihood upon the expiration of a year after the severance.

The Ukrainian cabinet's decision emphasizes that the absolute expulsion of ex-traders as carried on hitherto was illegal. The decision further urges the institutions concerned "not to make any more mistakes and to understand the difference between real kulaks and nepmen and such ex-traders who are now actually poor.

3 RUSSIAN ANTI-SEMITES SENTENCED TO DEATH (Iewish Telegraphic Agency)

Moscow, Feb. 25-Alexander Gaupt, Nikolai Zlatomerzhev and Ivan Potchupov, three prominent agronomists in the Odessa region, have been sen-tenced to death for driving Elena Goldman, a young Jewish agronomist, to death by suicide by their persistent anti-Semitic acts. Twenty others involved received lesser sentences. The trial lasted four days.

Dr. Senator in Warsaw on Way, to Palestine (Jewish Telegraphic Agency)

Warsaw, Feb. 25-Dr. Werner Senator, Berlin director of the Joint Dis-tribution Committee, arrived here to-day on his way to Palestine to take up his new duties in the executive offices of the Jewish Agency. Before going to Palestine he will stop off in London.

Communist Press of Minsk Publishes Charges Against Arrested Kehillah Leaders (Jewish Telegraphic Agency)

Moscow, Feb. 25-While the Russian foreign office confirms the report that eleven of the fourteen leaders of the Minsk Jewish community have been released, the names of the three still under arrest have been refused. The Communist press in Minsk today prints the names of those arrested and the charges against each one, but the name of Chief Rabbi Menachem Gluskin is not included.

While the general charges are in accord with those published yesterday in the London "Times," the individual charges are as follows: Benjamin Sakowizki, "a preacher with a crooked Talmudical mind who was sentenced to be shot in 1919 because of stock spec-ulations, but he escaped. When business was bad he began trading with God, holding sermons and preaching 'save our children from the fire that is destroying the Jewish people'."

Jacob Mizes, the head of a rabbinical seminary, is accused of having headed a number of illegal seminaries. Simon Kabakov is charged with being a bourgeois ring leader. Krengel, an ex-jeweler and silversmith, is said to have utilized confiscated metal for making spoons and forks.

Settlement in Cleveland's Kashruth Case Favorable to Jews Laid to J. T. A.

(Jewish Telegraphic Agency) Cleveland, Feb. 25-The publicity given the Cleveland kashruth trial by the Jewish Telegraphic Agency is credited by both sides to the controversy with being responsible for the settlement outside of court which yesterday culminated the affair that has been agitating the Jews of this and surrounding cities for several weeks. In an advertisement in the local Yiddish and English press the kashruth board expresses its thanks to the J.T.A., while the Swift & Co. officials present at the trial admitted that the J.T.A.'s handling of the news forced the Chicago office of Swift & Co. to stop the proceedings.

The tentative agreement that has been reached brings to an end the suit against the kosher board and the rabbis' union by Benjamin Cohen, agent for Swift & Co., who demanded a permanent restraining order against interference with his and Swift's business by telling the Jews that meat from his stores was not under the supervision of accredited slaughterers. This matter has been entirely eliminated by the agreement. The introduction into the proceed-

ings of E. W. Phelps, manager of the Swift plant in Cleveland, made possible the settlement when he agreed to the kosher board's conditions and gave it and the rabbis full recognition. Swift (Continued on Page 4)

Borah Communicated With Moscow Through Soviet's Information Bureau in U.S. (Jewish Telegraphic Agency)

Moscow, Feb. 25-Senator Borah, chairman of the Senate foreign relations committee, did not attempt any direct intervention in his inquiry to charge of counter-revolutionary activity, the correspondent of the Jewish Telegraphic Agency learned to-

night. No direct communication from Senator Borah was received by the Soviet's foreign office nor did the Soviet's information that eleven of the fourteen who had been arrested were released, come directly to Senator Borah. Senator Borah's inquiry was directed Borah. to M. Skirvsky, director of the Soviet Bureau of Information in Washington, who forwarded it to Moscow. Simi-larly Moscow's reply from Maxim Litvinoff, acting-commissar of foreign affairs, was sent to M. Skirvsky who then communicated the information to Senator Borah

Soviet to Move Library and Museum of "Ope" to Kiev (Jewish Telegraphic Agency)

Moscow, Feb. 25-The Soviet commissariat of education has decided to transfer the library and museum of the Ope, the Society for Spreading Culture Among the Jews, to the Kiev Institute for Jewish Culture and has assigned 3,000 roubles for shipping it from Leningrad to Kiev.

On December 30 the Ope, which had been in existence for more than 70 years, was liquidated by the Soviet government. The library contains over 10,000 valuable books and its archives are rich in old manuscripts,

Possession of Land Bought and Paid for by J. N. F. (Jewish Telegraphic Agency)

Jerusalem, Feb. 25-Somebody is apparently interested in preventing the Jews from possessing land that they have already bought. An instance of this is the Wadi Hawareth land, bought with funds subscribed by the Canadian Zionists, which Arab tenants have ploughed and planted despite the court's decision confirming the Jewish National Fund's title to the land

After fully compensating the ten-ants, the Jewish National Fund made them an offer which the central government considered extremely generous. Despite this, the Jews have been unable to take possession. The Arab papers in the meantime report that 'somebody" promised the tenants about \$200,000 to enable them to purchase the land already sold to the Jewish Na-tional Fund . While this is probably inaccurate, it is possible that the Arab Executive or the Moslem Supreme Council have been encouraging the resistance of the squatters and promising them money which will almost certainly not be forthcoming. (Jewish Telegraphic Agency) Warsaw, Feb. 25-On the occasion of the seventieth anniversary of the death of Isaac Baer Lewinsohn, famous Hebrew scholar and writer of Russia, one of the founders of the movement for "Haskalah," or enlightenment among Russian Jewry a century ago, a committee was organized vesterday in Lewinsohn's birthplace, Kremenetz, now in Poland, for the purpose of converting the house in which he lived into a Jewish National Museum.

Copeland Atacks Religious Ban and Alien Registration at Brith Sholom's Silver Jubilee Dinner

(Jewish Telegraphic Agency) Philadelphia, Feb. 25-Characterizing religious persecution in Russia as "absurd, unthinkable and unpardonable," and comparing the immigration legislation now pending in Congress with the old Czaristic days, United States Senator Royal S. Copeland of New York, speaking at the silver jubilee dinner of the Independent Order of Brith Sholom, made it clear that the governments of the world must give serious consideration to the former and the American people must not permit

the latter to be enacted into law. Though offering no definite solution, must be found to put an end to antireligious practices now in vogue in Russia, "Sometimes when one thinks of the intolerance abroad in the land and the efforts of those who would enact such laws as registration bills, we get a little blue about America. The entire American people should oppose such measures."

16 Arabs Committed for Murder, Theft and Looting (Jewish Telegraphic Agency)

Jerusalem, Feb. 25-Of the twenty Arabs charged with looting and at-tacking Selim Cohen's house in Safed during the riots, sixteen have been committed for premeditated murder, arson, theft and loot. Four were discharged.

Judge Plunkett in Haifa discharged three Arabs accused of burning the Klinger house in Safed. They were discharged without hearing the defense because expert testimony showed that the witnesses could not have seen the accused setting the fire.

Complains Anti-Rutenberg Boycott in Jaffa Fails (Jewish Telegraphic Agency)

Jerusalem, Feb. 25-"El Jamal Arabia," the organ of the Moslem Supreme Council, complains that the streets of Jaffa are electrically lighted despite the municipality's resolution to substitute lux lamps in pursuance with the boycott against the Rutenberg electric plant. It is understood, however, that Jaffa does not intend to carry out the resolution, owing to the excessive cost of lux lamps and especially since the municipal revenue has been greatly reduced on account of the removal of many Jews from Jaffa.

Quebec Government Planning to Offer Bill for Separate Montreal Jewish Schools

(Jewish Daily Bulletin) Quebec City, Feb. 25—Hon. Louis Alexandre Taschereau, Premier of the Province of Quebec, has announced that the government will make certain changes in the bill for a separate Jewchanges in the bill for a separate Jewish school panel recently introduced in the provincial legislature by Peter Bercovitch, M.L., and will then itself introduce it in the legislature, for the purpose of solving the Jewish school problem of Montreal.

This government bill would give the Jews of Montreal an opportunity to come to an understanding with the Protestants about the education of their children. Should it be impossible

The Bercovitch bill, which will soon come up for a second reading before the legislature, calls for the creation of a Jewish section of the "Council of Public Instruction" and Jewish school boards in the municipalities of the province. These bodies would have the right to create separate Jewish schools, in case of failure to agree with the Protestants.

The Premier stated that the government bill will lay the foundation of the apparatus for creating the new school system. The further work necessary will be done by the government itself, through "Orders in Counwhen such a separate Jewish school panel will be created will also be de-termined by an "Order in Council."

Montreal, Feb. 25—Commenting on Premier Taschereau's announcement that the government of Quebec will itself introduce a bill for solving the Montreal Jewish school question, the "Jewish Eagle" in an editorial points out that the Premier's bill, like the one of Mr. Bercovitch, still leaves a way open for negotiations between Jews and Protestants, which would preclude the organization of separate Jewish schools. The editorial is of the opinion that the Jews of Montreal can obtain nothing of permanent value through such negotiations. "The main question," it says, "is who will be the Jewish committee which will be appointed by the government after the bill will have been adopted, and what path this committee will choose."

Jewish Youth in Germany Ask Community Centers (Jewish Telegraphic Agency)

Berlin, Feb. 25—Two thousand representatives of Jewish youth unions meeting in the city hall here today adopted a resolution demanding community centers and other youth centers similar to those in vogue in the United States. The president of the Jewish community Kareski promised that the community would start a campaign for such a center.

Questions Proposed Colony for Armenians in Palestine

(Jewish Telegraphic Agency) London, Feb. 25-Ormsby Gore, M.P. in the House of Commons asked the Colonial Office for information regarding a proposal for the sale of 9,000 dunams of land in Palestine for the purpose of establishing a Palestine colony for distressed Armenians now in Syria. Gore also asked whether such a sale was under the control of the Palestine government and whether the scheme had the support of the League of Nations commission dealing with refugees and minorities and whether the establishment of such a colony in Palestine was considered consistent with the articles of the Mandate for Palestine.

Dr. Gaster Tells English B'nai B'rith He Doesn't Believe Tenth of Stories from Russia (Jewish Telegraphic Agency)

London, Feb. 25-Declaring that he does not believe one-tenth of all the stories current about the persecution of Judaism in Russia, Dr. Moses Gas-ter, noted rabbi and scholar, speaking at the first conference of the B'nai B'rith of England, said that "we Jews have learned not to believe all stories have learned not to believe all stories circulated. The infamous blood libel made us victims of foul concocted stories. Those responsible for public opinion should take great heed of what they say. I warn our people to be careful and to remember that there are five million Iews in Russia.

Prof. Selig M. Brodetsky speaking of unified Jewry "lying at the bottom of the B'nai B'rith" said that he "re-fuses to give up the Bolshevik Jews of Russia as a lost branch or the intolerant section of the Agudath Israel or the Reform section of English Jewry."
He declared that the "red proletarian Jews, the black orthodox Jews and the colorless liberal Jews all form part of the Jewish people."

while David Salomon "is president of a society of rabbinical students which is an outspoken counter-revolutionary organization whose object is to fight the Soviet and at whose meetings anti-Soviet speeches were made and sometimes a sermon ending with 'uva lezion goel,' a dangerous Zionist slogan.'

Asher Kirshtein, a rabbi, is said to be "a speculator who established loan societies that supported nepmen from ruin, is a reactionary clerical and a counter-revolutionary enemy, an enemy to the workers and an active supporter of the illegal rabbinical clique" Moses Gabrielov, "Rabbi Glsukin's right-hand man, became chairman of the Jewish community when the White Poles arrived and hung a revolutionary. Jewish War Veterans to Meet in Providence

Providence, Feb. 25-Thousands of Jewish veterans of various wars from all sections of the country are expected to be here from July 3 to July 6, when the national encampment of the Jewish War Veterans of the United States will be held. Jewish Teachers' License Exams April 15, 16, 17

The Board of License for teachers of Jewish schools of Greater New York, which was organized on the initiative of the Jewish Education Association, under the auspices of a large and representative committee on license, announces that the first examination of candidates will take place on April 15, 16 and 17, between 10 a.m. and 1 p. m., at a place to be deter-mined.
