## WARBURG, ON BEHALF OF AMERICAN MEMBERS OF JEWISH AGENCY URGES BRITAIN TO REVOKE ORDER SUSPENDING IMMIGRATION TO PALESTINE

upon the British government in a statement addressed by Felix M. Warburg, chairman of the Administrative Committee of the Jewish Agency. The statement was handed to the British Ambassador, Sir Ronald Lindsay, today in Washington with a request to transmit it to his government

The statement made public through the Jewish Telegraphic Agency was authorized at a special meeting of the American members of the Administrative Committee of the Jewish Agency held at the offices of Mr. Warburg. Among those present there were Bernard Flexner, Judge Julian Mack, Louis Lipsky, Baruch Zuckerman, Morris Rothenberg, Judge William Lewis, David M. The Jewish Agency, according to the Mandate of Palestine, has to advise and cooperate with the Administration of Palestine in such economic, social and other matters as may effect the establishment of the Jewish National Home and the interests of the Jewish population in Palestine, according to article 4 of the Mandate.

Last August in Zurich, the Jewish Agency was enlarged. The non-Zion-ists, under the leadership of the late Louis Marshall and Felix M. Warburg, joined the Agency, the membership being equally divided between Zionists and non-Zionists. It is on behalf of the Administrative Committee of this enlarged Jewish Agency that Mr. Warburg handed the statement to the British Ambassador, the text of which reads as follows:

#### Brandeis-Mack Group Defines Terms on Which It Will Resume Active Z. O. Work (Jewish Telegraphic Agency)

Washington, May 22-Complete re-organization of the Zionist Organization of America is proposed in a statement signed here today by Justice Louis D. Brandeis in which he outlines the terms on which he and his followers would be prepared to resume an active interest in the Zionist movement. The other signatories to this statement are Judge Julian W. Mack, Jacob de Haas and Robert Szold.

The statement was issued following a conference between the signatories and a committee of the Zionist Organization of America consisting of Rabbi James Heller, chairman of the administration committee of the Zionist Organization of America, Dr. Israel Goldberg, David Freiberger and Dr. Nathan Ratnoff. The meeting took place this morning in the office of Justice Brandeis and the statement issued was in reply to overtures made at the meeting in Washington on March 26 by the Zionist committee.

An interim regime to be in charge of the Zionist Organization until December 31, 1930 to consist of neutrals (excluding any member of the present executive or of the Brandeis group) to be elected at the Zionist convention in June is one of the proposals.

> Zionist Organization Shows That 3,143 Suspended Immigration Certificates Were Justified by Palestine's Economic Needs (Jewish Telegraphic Agency)

> Jerusalem. May 22-Indications that the British government's order suspending immigration to Palestine had a political and not an economic motive are seen in the publication of the figures and facts on which the executive of the Zionist Organization based its demand for 3,143 immigration certificates and which were granted by the Palestine government only to be suspended a day later by the British Colonial Office.
>
> A statement of the executive of the Zionist Organization just published

> reveals that the executive had made application to the Palestine govern-ment to place at its disposal for the six months beginning April 1, 1930, 3,143 certificates for new immigrants, 2,509 for men and 634 for women. This application was based on an exact estimate of additional Jewish labor required in all branches of Palestine industry.

> Explaining the need for 3,143 certificates the figures presented to the government by the executive showed that 2,645 workers were needed in industrial and constructional work. Of this number 30 were to be women. For agricultural labor 825 workers were needed, 121 of which were to

#### Artisans' Property Not to Be Confiscated Even If They Do Not Pay Government Tax (Jewish Telegraphic Agency)

Moscow, May 22-The property of artisans is not to be confiscated even if they are unable to meet the government taxes, it was decreed in an order issued today by tax collectors through-out the Soviet Union by the Council of Labor and Defence, the highest eco-nomic body in Russia. The order also instructs the tax collectors not to overtax the artisans, especially in White

Russia and Ukrainia. The order further says that the children of artisans should be registered for jobs at the Soviet labor exchange bureaus with the same privileges as chil-dren of labor union members. This order, by means of which thousands of Jewish artisans will benefit, aims to improve the artisans' industry which the Soviet is now beginning to consider an important part of the Soviet industrial

In the Samarkand district alone there are 32 synagogues while there are only 8,000 Jews. Six of the nine pre-Soviet synagogues in Old Bukhara still exist while the other three have been tions by the Communists. All religious customs are strictly kept by the Jews as in the past but their children are attending Soviet schools, where they are being educated in Soviet's anti-religious

The 24 Jewish Soviet schools are attended by 2,760 Jewish children. The language of instruction is Russian or the local native tongue but in none of the schools is Yiddish or Hebrew used. the latter being entirely prohibited. As schools are non-existent.

Hebrew, once the pride of the Bukharian Jews, is rapidly disappearing. Only small groups of the younger people still understand the ancient tongue. No kosher meat is available here, the Jewish population confining it-self for the most part to yegetarian

#### La Guardia Charges Bias to Jews in Consular Service

(Jewish Daily Bulletin) Washington, May 22-Representative LaGuardia of New York City yesterday

In the House charged that Jews are dis-criminated against by the State Department in making appointments to the foreign consular service. Specifically the Congressman charged that Jewish the Congressman charged that Jewish graduates of Columbia University in New York City who pass the written examinations or the foreign service are rejected on oral examinations before the personnel board

"Young men whom I know," said Mr. LaGuardia, "have been rejected by the board, are brilliant and anxious to serve their Government in the Foreign Service, but no matter how high their standing in the written examinations, they have been unable to get by the board."

The charge was made by Rep. La-Guardia while the House was considering a bill introduced by Representative Linthicum of Maryland, providing for the grading and classification of clerks in the foreign service and readjusting rates of compensation. Several members took issue with Rep. LaGuardia, but the latter declared that he knew the facts and that there could be no question whatever as to discrimination.

#### Arab Delegation to Make Wide Tour of United States (Jewish Telegraphic Agency)

Chicago, May 22-A tour of the Middle West and a trip to Washington is planned by the Arab delegation from Palestine which arrived here this week from New York. The delegation, which consists of Emir Ardel Arslan and Issak Bandak, will cover an itine-rary including Milwaukee, Michigan City, Grand Rapids, Detroit, Flint, Mich., Saginaw, Toledo, Cleveland, Akron, Cincinnati, Pittsburgh and a number of cities in West Virginia, Kentucky and Tennessee. The Arabs will return to New York after visiting Washington and later Boston.

# Ban Only Temporary But Britain Must Allay Feeling

Confidence that the stoppage of Jewish immigration into Palestine was only temporary, and that the British Government had not changed its policy with regard to facilitating the establishment there of a Jewish homeland, was ex-pressed by Felix M. Warburg, chairman of the Administrative Committee of the Jewish Agency for Palestine, at a luncheon by Zionist leaders of this city to James N. Rosenberg, chairman of the New York Allied Jewish Campaign at the Hotel Biltmore vesterday.

"However, the Jews have a right to ask prompt action of the British Government to relieve the situation, and to allay the tense feeling of the Jewish people everywhere," Mr. Warburg de-

"On the other hand, the Jews must show that they have a real interest in Palestine, and that they are backing up that interest not merely by speeches and by resolutions, but by giving money for its upbuilding. The larger their finan-cial sacrifices for the sake of Palestine, the larger will be their influence with the British Government."

Support for the work of the Jewish Agency, through contributions to the Al-lied Jewish Campaign, Mr. Warburg said, would have a wholesome effect on the morale of the Jews in Palestine. "It will show them that the Jews of America are with them, and will give them strength to go on with their work," he said.

About forty Zionist leaders, all of whom are taking active part in the New York Allied Jewish Campaign, including Mrs .Robert Szold, national president of the Hadassah, and Mrs. Rose Jacobs, chairman of Hadassah's Palestine Committee, participated in yesterday's lunch-con to Chairman Rosenberg. The host was Morris Rothenberg, vice-president of the Zionist organization of America and one of the national chairmen of the Allied Jewish Campaign. Optimism as to the outcome of the New York "drive" which will officially begin next Tuesday was expressed by all of the speakers.

#### German-Jewish War Veterans to Be Settled on Land (Jewish Telegraphic Agency)

Berlin, May 22-At a meeting of the Federation for Jewish Land Settlement in Germany, Franz Oppenheimer reported that the Federation has bought a stretch of land in Grossgablow near Cottbus, and that the Berlin Kehillah has contributed one-hundred thousand marks to begin the settlement on the land of former German-Jewish soldiers who fought in the war.

This, declared Oppenheimer, is the beginning of a far-reaching plan for Jewish land settlement which aims to establish a large number of Jews upon German soil. He declared that the Fe-deration expects the German government to support the plan.

#### No General Stoppage of Immigration to Palestine Shiels Tells Commons

(Jewish Telegraphic Agency) London May 22-There has been no general stoppage or prohibition of im-

migration to Palestine but owing to a misunderstanding, the schedule of 3.300 persons had been approved by the High Commissioner for the six months period ending September 30 which included the 950 persons whose admission has been sanctioned with the advice of the Colonial Office.

This was the reply of Dr. Drummond Shiels, under-secretary for the Colonies today in the House of Commons to Sir Archibald Sinclair's question of "isn't it contrary to the terms of the Mandate that the government should stop immigration? On the other hand if the economic capacity of Palestine is in-sufficient to absurb 3,300 immigrants why did the High Commissioner grant them?"

Dr. Shiels also pointed out that the British government had taken the position that in view of the criticism in the Shaw Commission's report and the subsequent mission of Sir John Simpson it was desirable that pending the son it was desirable that pending the receipt of Sir John's report further arrivals be in the meantime restricted. Accordingly, he said, it had been decided to confine the issuance of certificates for the present to 950 but no certificates had been cancelled nor has any final decision been reached regarding the labor schedule covering whole period up to next September.

The situations on which the demands for certificates were based, Dr. Shiels explained, were works of a temporary nature. "We have been attempting to carry out the policy of the 1922 White Paper of allowing immigrants to Palestine only in accord with the economic capacity of the country." Dr. Shiels said that the present restriction should be interpreted as "ordinary discretion" so that "we should not be accused of having made mistakes that the Commission says we made in the past" He pointed out that about 2,000 people would be affected by the restriction but he said there was no reason why they should be ultimately affected.

#### Indian Moslems Restive If Arab Demands Not Met (Jewish Telegraphic Agency)

London, May 22-Unless the demands and claims of the Palestine Arabs are met it will be difficult to keep in check the Moslems of India, declared a resolution adopted today by the council of India's Moslem Federation, as reported by Reuters. The "Davar," commenting on the last announcement of the government says: "Great Britain made a treaty with Arab despots for the preservation of Britain and their rule at the expense of the Jewish masses of the world and the Arab masses of Palestine. This cannot stand. We do not know how to break this pact

#### See Great Loss to England If Chaim Weizmann Resigns (Jewish Telegraphic Agency)

London, May 22-The loss to Great Britain of the friendship of the Jews is likely by the probable resignation of Dr. Chaim Weizmann, president of the Iewish Agency, as a result of the situation created in the Zionist movement by the suspension of immigration to Palestine declares the "Manchester Guardian" today.

Pointing out that Dr. Weizmann "throughout has staked everything on his loyalty to the British government and has defended it stoutly on hundreds of platforms at great risk to himself against the Revisionists (op-position to the Weizmann regime) and other critics," the "Guardian" says "his position is rapidly becoming impossible and hints have even been heard of his resignation as head of the Zionist Organization.

"It is hard to imagine the Zionist Organization without Weizmann, for the whole movement is his creation. Under any new hands this international organization will certainly be far less friendly to this country. Zionist Confidence in Britain Breaking, Lipsky Declares: Mandate Vindicated

The order of the British Colonial Office suspending Jewish immigration into Palestine, which has aroused the con-demnation of Jews throughout the world and which is the cause of the general Jewish strike in Palestine today, is called a "dastardly violation" of the Mandate granted to Great Britain by the League of Nations in an official statement issued by Louis Lipsky, president of the Zionist Organization of America, in which he expresses the views of American Zionists with regard to the action of the British Government.

The confidence which Zionists have reposed in the British Government is on the verge of breaking, Mr. Lipsky declares, saying that the only way for Britain to regain the confidence of millions of Jews is to order, without delay, the opening of the doors of Palestine. Pointing out that the suspension of the 3,300 immigration certificates is a purely political move and has nothing to do with the economic situation in Palestine, Mr. Lipsky emphasizes the fact that High Commissioner Chancellor had already approved the issuance of these certificates as economically justifiable.

It was said at Zionist headquarters yesterday that unless Great Britain changes its course with respect to Palestine, that drastic action will be taken by the Zionists of America, in consonance with Jews throughout the world

#### Chile Can Absorb 1,500 Jews Annually If They Know Trade. Survey by Hias Indicates

Chile can absorb between 1,000 and 1,500 Jewish immigrants annually, provided they know a trade, according to a report rendered to Hias by J. Lutzki, of Buenos Aires, who was sent to Chile by the Hias and other Jewish immigrant aid societies to study the possibilities of Jewish immigration there and report thereon.

Chile, reports Mr. Lutzki, has a total population of nearly four and a half million and is the only South American country that practically does not restrict immigration. The country is steadily growing and conditions are becoming Brown Again Heads
Jewish Workers' Alliane

Jewish Workers' Alliane 20 and 30 Chilean pesos daily (which is conidered a good wage) and for hatmakers, electricians, plumbers, ladies' tailors, upholsterers, bricklayers and others engaged in the building trades, all of whom can earn good wages as well. The climate of Chile is one of the best in the world, the atmosphere being practically dry.

Mr. Lutzki found that there are already in Chile between 1,000 and 1,200 Jewish families, of whom 200 are of Sephardic descent. Eight hundred families live in Santiago, the capital, which has a general population of 600,000, and the remainder are distributed in other cities. 99 per cent of the Jews are in business, the oldest settlers holding prominent places in the commercial world. The new arrivals, who are the friends and relatives of the older settlers, are engaged in peddling, mostly selling goods on the weekly instalment plan. There are practically no Jewish workingmen to speak of. The remaining 1 per cent is composed of professional men, such as lawyers, doctors, engineers; these are the children of the early settlers.

Notwithstanding the small size of the Jewish community, it is well organized for religious, cuitural, social and philanthropic purposes. In Santiago a Jewish Center which will cost around 1,000,000 pesos is being completed. In Valparaiso, which is the principal port of the country, and the second largest city, with a general population of 250,-000 and which has 80 Jewish families, plans for erecting a central building are also being made. Mr. Lutzki had several conferences with the leaders of the Santiago and Valparaiso communities and succeeded in organizing an immigrant aid society in each.

Dear Sirs:

We have made a careful study of the papers setting forth the present condition of the Z. O. A. transmitted by Mr. Freiberger for the Committee under date of April 22nd; have considered the present condition in the light of our knowledge of the past and the needs of the movement; and have reached definite conclusions. To preclude the possibility of any misunderstanding, we deem it appropriate, to state these conclusions in writing at our conference.

First-Your Committee has courteously suggested that our group resume in some way, and to some extent at least, the active participation in the work of the Z. O. A. which terminated in 1921, through the action of the Cleveland Convention.

## Economic Development Paramount

The experience of the last ten years has confirmed the views, expressed on July 14, 1920 in the Zeeland Memorandum, that the efforts of the Zionists should be directed primarily to the economic development of Palestine. In our judgment the best guarantee which we can create for the realization of our national aspirations in Palestine is widespread cooperation in a carefully devised plan of economic development, which will make practical immediate increased settlement by Jews in Palestine.

We believe that the Z. O. A. can, through such activities, be an important instrument in strengthening the spiritual and intellectual ideals of the movement in America, as well as in the practical aspects of national economic effort. We believe the Jewish Agency will welcome the cooperation of a Z. O. A. not only alive to the many problems that press upon it, but earnestly devoted to their solution. To this end we deem it essential that there be complete reorganization of the Z. O. A. in methods of control, in methods of management, in personnel and in finances.

(2) A board of management consistto the ends to be pursued and generally in accord as to the means to be adopted. (3) The assurance of effective cooperation by the body of Zion-ists. (4) Freedom from financial pressure during the period reasonably required for the reorganization and re-habilitation of the Z. O. A. and (5) Before assuming control, that full knowledge of the then existing conditions which can have been obtained only through free access to the books and files of the organization and familiarity with the problems arising from day to day.

Unless these conditions are complied with, we think we can best serve the cause by continuing the efforts which we are now making in various ways for Palestine development. If all of the conditions are satisfied, we shall be willing to make the attempt to find the men needed for worthy and adequate management and to secure their consent to serve.
