Congress of European Jewish Youth Organizations Opens

(Jewish Telegraphic Agency) Geneva, Aug. 4-The congress of Jewish youth organizations of Europe Jewish youth organizations of Europe was opened last night in the auditorium of the University of Geneva. Rabbi Aime Palliere, noted French convert to Judaism, presided at the opening session.

Among those who greeted the con-Among those who greeted the con-gress at the opening session were Grand Rabbi Salizer; Mr. Popovitch, on behalf of the League of Nations; Victor Jacobson, on behalf of the World Zionist Organization, and several others. All of the speakers praised the work done by the Jewish youth organizations in various countries in strengthening and uplifting Jewish life and in creating good will and better understanding between young Jewish and Gentile groups everywhere.

\$500,000 Export House to Be Established in Palestine (Tewish Telegraphic Agency)

Jerusalem, Aug. 4-An export house with a capital of \$500,000 will be established in Palestine by the noted exporters, Landau Brothers of London and South Africa, if Palestine industrialists comply with conditions which would make the proposed export house a profitable undertaking.

The proposal was reported during a meeting of industrialists at which M. Sheinkar described the interest which South African Jews have in products emanating from Palestine. At the same meeting it was resolved to send a message of thanks to Vladimir Jabo-tinsky, Revisionist leader, who on his recent tour through South Africa, urged the use of Palestine products.

Ludwig Haas, German Political Leader, Dead at 55 (Jewish Telegraphic Agency)

Berlin, August 4-Ludwig Haas, 55 leader of the National Democrats, died here yesterday. Haas was the leading executive member of the Central Association of German Citizens of the Jewish Faith. Since 1912 he had been a member of the Reichstag and in 1918 was minister of the interior of Baden. During the war Haas was director of the Jewish department of the German civil administration of the occupied Polish territories.

Jew Appointed New City Prosecutor of St. Paul

(Jewish Telegraphic Agency) Paul, Aug. 4-Irving Gottlieb. local Tewish attorney, has been sworn in as the new city prosecutor to handle cases for the city in police court. He succeeds Edwin J. Murphy who takes a new position as assistant corporation counsel.

Alliance Universelle Israelite Protests Attacks on Jews in Letters to Premier Maniu

(Jewish Telegraphic Agency)

Paris, Aug. 4-A letter protesting the attacks on the Jews in Roumania and the failure of the authorities to take adequate measures to suppress the disturbances was sent today to the Roumanian premier, Julius Maniu, by Sylvain Levy on behalf of the Alliance Universelle Israelite.

M. Levy's letter states, "The serious events which have taken place in the last weeks in different sections of Roumania, especially in Bukowina and Transylvania, have grievously harmed the life and fortunes of the Jewish population and are provoking deep concern in the Jewish world, especially in France.

"The surprise is still greater because when the King ascended the throne he solemnly declared that he would watch over the rights of all subjects equally, without regard to creed. The Borscha fire, the wild aggressions in Kimpolung, Suceava and elsewhere have caused a state of panic among Roumanian Jew-

ry. On the other hand it is serious to notice that the authorities did not take preventive measures and are not repressing the disorders.

Bucharest, Aug. 4-Dr. Alexander Vayda Voevod, Roumanian minister of the interior, will resign within a few days if reports in today's Bucharest papers are true. It has several times before been rumored that he would resign because he was hurt that he alone was being held responsible for the anti-Semitic outbreaks.

One paper says, "Surprises may be expected in the next few days in the cabinet in connection with Vayda Voevod's recent mistakes. In quarters close to King Carol it is said that Vayda Voevod's recent tactless intervayda voevous recent actiess inter-view that he granted to the corre-spondent of the Jewish Telegraphic Agency has made a very bad impres-sion. St Louis Jew Wills \$68,000 to Various Jewish Charities (Jewish Telegraphic Agency)

St. Louis, Aug. 4-Some \$68,000 in charitable bequests and gifts to rela-Iulius Weil, insurance broker, who died last Thursday. The largest sum, \$20,000, was given outright to the Jewish Hospital.

Other charitable gifts include \$5,000 to the Shriners' Hospital, \$5,000 to the Young Men's Hebrew Association, \$5,000 to the Federation of Jewish Charities, \$2,000 each to the Jewish Sanitorium located in St. Louis County, the Jewish Orthodox Old Folks' Home and the Jewish Orphan Home of Cleve-land. The Federation of Jewish Charities of Cincinnati will receive \$500 and the St. Louis branch of the Salvation Army \$200.

A \$10,000 trust fund was established for his cousin, Miss Fanny Weil. The principal of that sum will go to the St. Louis Jewish Orphan Home. The sum of \$16,500 was distributed to 15 other relatives and the residue of the estate to a sister and two brothers.

Services at Wailing Wall

Despite Darkness, Restrictions (Tewish Telegraphic Agency)

Jerusalem, Aug. 4-Ten thousand Jews wended their way to the Wailing Wall after sundown Saturday evening despite the oppressive heat and the stringent prohibitions which the government had set down for the services. Owing to the ban on candles and the removal of the customary lamps which the Jews were wont to use during their services at the Wall the reader intoning the Lamentations of Jeremiah resorted to the use of a tiny flickering oil lamp set on a reading table while the crowds either squatted on the bare stones or stood around the reader straining to hear his chant which was more difficult to follow because of the darkness.

Orthodox worshippers, stockinged but without shoes, and hundreds of youthful visitors, some of whom cus-tomarily hatless had converted their handkerchiefs into the headgear which is arbitrary, stood patiently throughout the Tish B'Ab ceremony. British constables, who regulated the move-ment to and from the Wall of the worshippers, stated that ten thousand had visited the Wall during the services, and added that the crowd despite its oppressive density, was the quietest that ever visited the shrine.

In the Old City the Jewish quarter was enveloped in darkness, the shops remained closed and all cafes and cinemas shut down to mark the first anniversary of the riots which occurred last Summer.

Members of the large crowd which thronged to the Wailing Wall did not tarry long because of the pressure of those behind who also wished to participate in the services. The procession to the Wall continued until after midnight. Arabs were not permitted to use the main lane leading to the Wall in order to leave it free for the worshippers.

(Jewish Telegraphic Agency) Tel Aviv, Aug. 4-As an expression of the national mourning on the day which marked both the opening of the riots last Summer and Tisha B'ab, this all-Jewish city, which had recently been supplied with electric street lamps by the Rutenberg Power Company, remained shrouded in darkness Saturday evening while all amusement places and other shops were closed.

Jew Running for U. S. Senate Nomination in West Virginia

(Jewish Daily Bulletin) Wheeling, W. Va., Aug. 4-Former Congressman Benjamin L. Rosenbloom of this city is one of the five candidates for the Republican nomination to the United States Senate. Mr. Rosenbloom, who was also a candidate in 1926, served in the House of Representatives for two terms and in the upper house of the West Virginia legis-lature from 1915 to 1918. The primaries will be held tomorrow.

2 Jews Figure in St. Louis Republican Party Primaries (Jewish Daily Bulletin)

St. Louis, Aug. 4-Judge Harry P. Rosecan, who now presides over the local Police Court, and Judge Moses local Police Court, and Judge Mosea Hartman, figure prominently in the local primaries that take place today, Judge Rosecan is a candidate on the Republican ticket for prosecuting at-torney. If nominated and elected he will be the first Jew to occupy the position of prosecuting attorney in position of prosecuting attorney in St. Louis.

He was appointed to the Police Court bench in 1925 and was reappointed in 1929. During his administration, he tried 217,000 cases.

Judge Hartman is president of a local Temple and received the highest vote from the members of the St. Louis Bar Association who endorsed him for a six year term for the Circuit Court. He is one of the prominent civic and Jewish leaders in the city. He is a member of the leading Jewish organizations of the city and has taken organizations of the city and has taken an interest in the work of the Zionist Organization. He presided over all the divisions of the Circuit Court and is recognized as an authority on Child Welfare, having had considerable experience with Iuvenile Court work. He leads the ticket for the Circuit Court.

Ukrainian Nationalists Revive Anti-Jewish Terrorism (Jewish Telegraphic Agency)

Lemberg, Aug. 4-Ukrainian nationalists have intensified their terrorist activities for the purpose of fighting Jewish villagers who are competing with the Ukrainian Consumers' Union. with the Ukraiman Consumers Union. In the village of Ruszkowice, in the neighborhood of Prezemysl, the house of Sonia Metzger, Jewess, was fired. Inquiry has established that the instigator of the fire was Vladimir Dudka. member of the Ukrainian Sports Union, Sokol, and who has been arrested many times previously on similar charges.

17 Patients from St. Marks Shifted to Beth Israel

Seventeen patients from St. Marks Hospital, which closed last week be-cause of lack of funds, have already been transferred to Beth Israel Hospital. The patients accepted by the Beth Israel Hospital will pay the same rates they had been accustomed to pay at St. Marks, and in some instances at St. Marks, and in some instances patients will receive free treatment and quarters. Altogether about 30 St. Marks patients are expected to go to Beth Israel during this week.

Epidemic of Disease Threatens 2,500 Borscha Jews as Fire Damage Is Still Unpaid (Jewish Telegraphic Agency)

Bucharest, Aug. 4-A serious epi-demic of disease threatens 2,500 Jews of Borscha who are at present homeless following the fires which swept that city. Because of the government's delay in paying for the damage caused by the anti-Semites, the Jews are being forced to live in the ruins of their homes and are suffering from lack of food and clothing. They are without protection from cold or rain, they told the correspondent of the Jewish Tele-graphic Agency, who made a special trip to Borscha to ascertain the condi-

Despite Minister Vayda Voevod's statement to the correspondent that the government would speedily reimburse the Jews, there has been no word yet as to when such damages would be assessed. Well informed officials, on the other hand claim that Vayda Voevod is trying to back out of his promise on the ground that the fire may have been a pure accident for which the government would in no way be responsible as it would be if anti-Semites had been responsible.

The question of the government's attitude toward the payment of damages is agitating all Roumanian Jewry which demands that payment should be made early, if possible before autumn which brings with it severe rains and will cause the Iews who are

Richard Sutro, Jewish Financier, Dies at 66 (Jewish Daily Bulletin)

Port Chester, N. Y., Aug. 4—Richard Sutro, prominent New York financier, for thirty-three years senior partner of Sutro Bros. & Co., died here yesterday at the age of sixty-six after an illness tion lasting five months. He is survived by a wife and two daughters.

Mr. Sutro was interested in railroad financing and fifteen years ago he aided in the reorganization of the Pittsburgh & West Virginia Railroad, of which he was a director and member of the executive committee at the time of his death. He was also interested in the production of copper and petroleum and was a director of many public service corporations.

Trial of Codreany Opens in Bucharest This Week (Jewish Telegraphic Agency)

Bucharest, Aug. 4-The trial of Zelea Codreanu, anti-Semitic leader charged with instigating riots, will take place this week in this city it was announced. The speediness with which the anti-Jewish leader is being brought to trial indicates the seriousness with which the ministry of justice is now regarding anti-Semitism, in contrast with its previous attitude which many regarded as conscious lenience toward anti-Semitic leaders. The usual policy was to arrest anti-Semitic leaders and release them a few days later, postponing their trials until everything was forgotten and then releasing them without punishment.

Even Vayda Voevod emphasized this policy when, talking to Victor Aberson, member of the Jewish investigation committee, he stated that the ministry of the interior was arresting the anti-Semites but the ministry of justice lacked firmness in handling the

Another step indicating the new frame of mind of ministry of justice is shown in the appointment of attornev general Alexandru to conduct an investigation in Kimpolung, Bukowina. Iews of that section had complained that the regional officials are prejudiced.

Meanwhile the "Curierul Israelite," organ of the Union of Roumanian Jews, severely attacks the government for not punishing its state officials who have been proven guilty of conducting anti-Semitic agitation.

King to Hold Premier Maniu Responsible for Anti-Semitism: Danila Escapes Police Net (Jewish Telegraphic Agency)

Bucharest, Aug. 4-Premier Maniu has been declared by King Carol to be personally responsible for any further anti-Jewish outbreaks. This statement is considered to be very important, carrying with it the King's personal statement of his sincere desire that Jewish safety be guaranteed.

The president of the Jassy Chamber of Commerce, seat of the anti-Semitic student organizations, today issued an appeal against anti-Semitism, stating that every "Roumanian patriot should combat anti-Semitism because it ruins the economic life of the country.'

In the meantime a bomb was thrown into the house of Menachem Rubinger, a Jew of Dorna, near Chernovitz. bomb failed to explode. Authorities, who conducted a search for the assailants, discovered a number of members of the anti-Semitic Cuzist group, in-cluding the notorious Nicolai Totu and M. Danila, agitators against the Jews, for whom the police throughout the country have been searching. Leaving one policeman to guard the hotel where Danila and his confederates were located, the police declared them under arrest and proceeded to Rubinger's house to investigate the bomb-throw-

Returning later to the hotel they found that Danila and his associates had disappeared, having forced their way past the single policeman. Their luggage was left behind and a search of it disclosed a French handbomb in Danila's luggage. The secret police, aroused by this discovery and the bomb throwing, are making every effort to locate Danila and Totu. The chief of the secret police left for Dorna with the assurance that Danila and his associates would be found within the next day or two.

In the memorandum submitted today by the Union of Roumanian Jews to Victor Cadere, chief of the secret police, the charge was made that the police in Cuvurlui, Old Roumania, are passive in combating the severe anti-Semitic agitation which is increasing there daily. M. Cadere immediately following the receipt of the memorandum, despatched his general inspector, Stenfanescu, to Cuvurlui to prevent any untoward events and to punish those local officials who have remained pas-sive in the face of anti-Semitic agita-

Baltimore, Aug. 4—An appeal to Jewish philanthropists to help him publish a treatise on Jewish law which was left by his great-grandfather, the "Yanover Gaon", has been issued by Rabbi M. N. Weisblatt of this city in the form of an advertisement in the Baltimore "Morning Sun." The appeal is endorsed by Congregations Anshe Sephard, Shomre Hadath, Anshe Kolk and Anshe Vohlin of Baltimore, and Wohliner Anshe Sephard of Wash-ington. In the appeal Rabbi Weisblatt

says:
"My great-grandfather, the sainted Rabbi Judah Leib Weisblatt, who was famed throughout the world as the 'Yanover Gaon', bequeathed to posterity a scholarly work of great merit. It is a treatise of Jewish law that, if published, would be of incalculable help to rabbis, schochtim and even to laymen, It was his devout wish to have the work printed in his lifetime, for the enrichment of Jewish learning. But unhappily it was not given to him to accomplish it. The manuscripts have been in my possession for many years.

Charges Market Officials Mulct Kosher Butchers

For years supervisors of the New York City Department of Markets have been collecting thousands of dollars a month in petty graft from Jewish butchers and delicatessen deal-ers in Brooklyn and Queens, accord-ing to charges laid yesterday before Mayor Walker by Oscar Glassberg, who has been a butcher in Brooklyn for the past twenty-five years. Mr. Glassberg stated that on four

different occasions in the last few years supervisors of the Department of Markets have brought him to court on charges of violating the law applying to the sale of kosher and nonkosher meat, after he decided to discontinue periodical payments of \$5 or \$10. Glassberg alleges that his repeated arrests were the result of an announced determination on the part of the supervisors whom he names to "get him", and that Commissioner Thomas V. Dwyer himself appeared in court on the last occasion and told the justices that his department was very much interested in pressing the case against Glassberg.
