5 Anti-Shiels Demonstrators, Released Yesterday Through Misunderstanding, Rearrested

(Jewish Telegraphic Agency)

Tel Aviv, Oct. 17—Owing to an incomprehensible misunderstanding, the five Jews who were yesterday acquitted and released after a hearing charging them with participation in the demonstration here last week against Dr. Drummond Shiels, British under-secretary for the Colonies, were rearrested on instructions from the attorney-general's office in Jerusalem.

The office of the attorney-general has explained that Wednesday's order telephoned from Jerusalem was to delay and not stay the proceedings. The order for the rearrest is causing great excitement, puzzlement and legal speculation in this all-Jewish city since the examining magistrate in discontinuing the hearing had said "I discharge and acquit you." A retrial would mean placing the accused persons in jeopardy twice for the same offense.

In the meantime all but Akhi Mayer, a contributor to the Doar Hayom, have been taken into custody. The whereabouts of Mayer are unknown. Lawyers for the defence have been summoned from Jerusalem to Tel Aviv.

After a five hour hearing yesterday the magistrate announced that the five Jews were acquitted because High Commissioner Chancellor had ordered their release. As they left the court room they were given a great ovation by a large crowd that was awaiting the court's decision.

328 Jews Entered Palestine During August

Jerusalem, Oct. 17—A total of 407 immigrants were admitted to Palestine during the month of August and 331 persons left the country during the same period making a total addition to the population of 76. Of the number of persons arriving 328 were Jews, 62 Christians and 17 Arabs. Of those who emigrated 158 were Jews, 128 Christians and 45 Moslems.

Melchett III, Cancels All Engagements for 3 Weeks

London, Oct. 17—Lord Melchett (Alfred Mond), prominent British industrialist and Jewish leader, has cancelled all his engagements for the next three weeks, being confined to his room with an attack of phlebitis, according to an official statement from his office to the Jewish Telegraphic Agency. Lord Melchett has been ill since his return from his recent visit to the United States and Canada.

Ratification of New Jewish Communities Law in Italy Unifies All Old Regulations

Rome, Oct. 17—The new communities law regulating and defining the rights and functions of the Jewish communities throughout Italy was ratified today by the Italian cabinet. The most significant feature of the law is its provision for the unification of the old community regulations still operative in various parts of the Kingdom.

Many of these antiquated regulations, which antedate the foundation of the Italian state, are now brought together under unified administration and placed under government control. Together with this codification of the regulations the communities law makes it compulsory for all Jewish communities to appoint recognized representatives of the interests of Italian Jewry into a federation which will be advised by the rabbinical council. The council itself, however, lacks even disciplinary powers over the rabbis because this has been rejected by the united organization of Jewish religious groups.

This latter provision of the Jewish communities law is being received by

Nazis Demand Confiscation of Property of Jews Who Came to Germany Since 1914

Berlin, Oct. 17—The confiscation of all the property of East European Jews who have migrated to Germany since 1914 was demanded today in the Reichstag in a motion introduced by the National Socialists. This is the first anti-Jewish motion offered by the Fascists as well as the initial step in carrying out their pre-election program.

The Fascists also demanded the confiscation of the property of all bankers and stock exchange brokers, the confiscated property to put under government control. The large banks would also be taken over by the government, according to the Fascists' plan. They would also make it a misdemeanor punishable by three months' imprisonment for anyone to charge an interest rate of more than five percent.

These motions have resulted in considerably strained relations between the National Socialists and the other Right Wing parties friendly to them. The Nazis' motions came as a surprise to the Economic Party and the Nationalists who now realize that the Nazis, instead of assisting in counteracting Socialism, are aiding the Communists in their plan to destroy German economic life.

Meanwhile two more Nazis who had been arrested in connection with Monday's anti-Semitic riots were sentenced to five months' imprisonment each.

Reichstag in Uproar as Nazis' Leader Launches Anti-Semitic Tirade; Center Deputy Objects

Berlin, Oct. 17—A storm of protest was raised in the Reichstag today when Deputy Gregory Strasser, a National Socialist, launched into a vicious anti-Semitic tirade in the course of an address supporting his party's motion to transfer to the state all capitalist properties.

"We do not desire persecution of the Jews, but we demand the elimination from German life of everything Jewish as well as the abolition of the influence of the Jewish press," Deputy Strasser declared. "The alarmist reports in the Jewish press shatter confidence in German economic life," he added. By the "Jewish press" the Nazis do not mean papers or periodicals dealing only with Jewish affairs or those publications that are the organs of specifically Jewish groups. They mean the German newspapers that are either edited or owned by Jews.

Deputy Strasser's outburst brought a storm of protest from Center and Left deputies. Deputy Joos, of the German Center Party, sharply attacked the Nazis for their anti-Semitic agitation. His attack was greeted with great applause by a majority of the Reichstag's membership. Strasser, replying to the criticism, declared, "The Reichstag today is like a synagogue. Even Moses condemned the usury of the Jewish people which proves that even in ancient times the Jews were usurers."

This caused another uproar with the National Socialists' 107 deputies vociferously applauding and the others voicing audible protests.

Jewish Ownership to 6,000 Dunams Hinges on Time Purchaser Returned to Country

Jerusalem, Oct. 17—On whether or not he can prove that less than ten years have elapsed between his return to Palestine after the War and the filing of the land claim in November, 1928, hinges Joshua Hankin's claim to 6,000 dunams of land he purchased on behalf of the Palestine Land Development Company before the War. The question is now before the local courts.

The Arab who sold the land to Hankin, who is an official of the Palestine Land Development Company, is pleading that the purchaser cannot claim title to the land, which is in the vicinity of Nablus, because the period for prescription or taking up the land has lapsed. Hankin counters by saying that the World War made it impossible for him to register his claim.

The court which is composed of one Briton and two Arabs, has decided

N. Y. State "Ys" Plan to Bolster Lay Leadership of Groups

(Jewish Daily Bulletin)

Rochester, Oct. 17.—Plans for strengthening the lay leadership of the Y.M. and Y.W.H.A.'s of New York State by the addition of representative members at large to the executive council were formulated at the fifteenth annual convention of the New York State Federation of Y.M.-Y.W.H.A.'s and kindred organizations held here this week.

Among the resolutions adopted by the convention was one calling upon all constituent organizations to lend their full support to the Allied Jewish Campaign, and one thanking the Jewish Welfare Board for its assistance and cooperation which had resulted in particular in new building projects in Rochester, Utica and Gloversville.

Harry L. Glucksman, executive director of the Jewish Welfare Board, pointed out the characteristic factors that have brought forth a Jewish center movement in this country, and outlined current developments, particularly in the field of program and administration. He laid special stress upon the present economic situation as it affects the Jewish center movement. "In effecting necessary savings there should be no essential diminution of the benefits of the Jewish center program which has taken years of devoted and intelligent effort to develop," he declared.

In addition to the annual report by Bernard Given, acting-mayor Isaac Adler of Rochester and Judge Isadore Bookstein of Albany, Republican nominee for attorney-general spoke. Haskell Marks of Rochester was elected president; Judge Bookstein, Albert Rosenthal of Gloversville, Arthur D. Mann of Schenectady, Jerome Dobin of Binghamton, vice-presidents; Herman Bronstein of Syracuse, treasurer; Mary Scherline of Utica, secretary; Helen Spellman of Binghamton won the oratorical contest.

New Book Proves Services of Haym Salomon to Revolution; Monument Plans Progressing

Simultaneously with the publication of a new book presenting additional and hitherto unpublished evidence proving the services of Haym Salomon, American-Jewish financier of Polish extraction, to the American Revolution, it is learned that a public drive for \$150,000 will shortly be launched to finance the Haym Salomon monument which is to be erected at Lincoln Square in New York. The Municipal Art Commission has approved the design of Anton Schaari and the chairman of the committee will be announced in a fortnight.

The new book, the work of Charles Edward Russell, and published by the Cosmopolitan Book Corporation, is called "Haym Salomon and the Revolution." Salomon's services to the Revolution, Mr. Russell says in the preface of his book, are adequately proven by the diary kept by Robert Morris during the latter's period of service as Superintendent of Finance for the young United States.

"References to Salomon at the beginning of the diary are few and formal," Mr. Russell points out, "but they curiously increase in frequency and the respectful terms in which they are couched until at least Salomon appears daily and has manifestly become the confidant and close advisor of the Superintendent who was in reality the nation's first secretary of the treasury. When Morris had a confidential message to send to New York it is by Salomon that he sends it; whenever he is in difficulties he turns to Salomon."

After summarizing the efforts of this Jew, whose services have so long been overlooked, to make the Revolution a success, Mr. Russell says, "if he had done no more than to keep James Madison and James Wilson in public life he would have marked American history indelibly, if unostentatiously, for these men were among its makers and directors. If he had done no more than to keep Robert Morris solvent and the credit of the United States from ruin that would have been enough, for if the Revolution had collapsed when it was most beset in 1781 there would have been no United States. But he did even more. He testified to the world that Americanism is not a matter of so-called race, of birthplace or descent but of faith and of faith alone. Its truest exponents might be borne anywhere and still be its indubitable sons.

"No reward of glory or eminence or praise or position waited upon his part, and, so far as we can discover now, he considered them not at all. He wore no uniform, clanked no sword, bore no title and had no acclaim as he went through the streets. He was never a member of Congress; from the rights and privileges of other citizens he was, even in liberal Pennsylvania, largely debarred. But beyond any doubt, he toiled like a man on a treadmill and gave all his possessions for the thing he believed in."

Mizrachi Convention to Take Up Wailing Wall Question

Baltimore, Oct. 17.—Among the many important questions to be brought before the Fifteenth Annual Mizrachi Convention, which opens here the 26th of October, will be that of the Wailing Wall to be discussed in the light of the latest developments in connection with it. The memorandum submitted by Dr. Cyrus Adler to the Wailing Wall Commission in behalf of the Jewish Agency will be put before the convention.

Rabbi Meyer Berlin, leader of the World Mizrachi and member of the Executive of the Jewish Agency, who will be the guest of honor at the convention, will discuss the Wailing Wall question. Rabbi Berlin, who witnessed the sessions of the Wailing Wall Commission in Jerusalem, is expected to throw much light on this complicated and vexed question.

4 Jewish Fraternities at U. of P. to Install Kosher Kitchens

Philadelphia, Oct. 17.—Four Jewish Greek letter fraternities on the campus of the University of Pennsylvania have made arrangements to install equipment for kosher kitchens in their fraternity houses. The action of the fraternities came as a result of the influence exercised among the Jewish students by the Jewish Students' House of the University of Pennsylvania maintained by the Pennsylvania branch of the United Synagogue of America.

The four fraternities that are preparing to equip their quarters with kosher kitchens are Phi Alpha, Phi Omega, Delta Sigma Theta and Sigma Epsilon Delta.

It is pointed out, however, that this Jewish Students' House is in no sense a missionary organization and is not seeking to exert influence on Jewish students in favor of any particular branch of Judaism. The action of the Jewish fraternities came rather as the result of a general Jewish awakening among the students which is fostered by the Jewish Students' House.

In a report submitted by Rabbi Simon Greenberg, president of the Philadelphia branch of the United Synagogue, he points out that the kosher dining room of the Students' House is being used this year almost to capacity. A movement is now on foot to establish a similar house on the campus of Temple University.

Symposium Marking 20th Year of Yiddishist Schools to Be Held

A symposium in connection with the twentieth anniversary of the establishment of Yiddishist schools in this country will take place tonight, Sunday, in the Stuyvesant Neighborhood House. Among those who will participate in the symposium will be P. Geliebter, Leibush Lehrer, Yakov Levin, S. Shapiro and S. Niger, who will be the chairman. Graduates of Yiddish schools will read their own poetry.

Delegates Gathering for 15th Session of American Jewish Congress Opening Today

Washington, Oct. 17—Hundreds of delegates are now arriving in Washington for the sessions of the American Jewish Congress which open here on Sunday. Preparations to receive the Rt. Hon. Harry Snell, British Labor member of parliament who dissented from the majority report of the Shaw Commission on Palestine, have already been completed. Mr. Snell has just arrived in this country at the invitation of the American Jewish Congress, whose session he will address on Sunday night.

Mr. Snell took exception to the findings of his colleagues on the Shaw Commission and laid the blame for the Arab riots of last summer at the doors of the Palestine Administration and the Arab agitators who are seeking the withdrawal of the Balfour Declaration. In his address at the session in Washington Mr. Snell will present the views of enlightened public opinion in England on the subject of Palestine.

The sessions of the American Jewish Congress, which will take place at the New Willard Hotel, will last two days, October 19-20. A series of addresses will be delivered on problems relating to the situation of the Jews in various

Brith Sholom Continues With Own Rutgers Bias Investigation

Newark, N. J., Oct. 17—The decision of seven Jewish organizations of national and state-wide scope to ascertain, through concerted action, facts relative to alleged racial discrimination at Rutgers University will in no way affect the investigation already under way by the Independent Order of Brith Sholom, A. Sigmund Kanegieser, past grand master, declared last night.

"We are glad, of course, to cooperate with the other groups," Mr. Kanegieser said, "but our own investigation will keep on. I expect to have our committee's report ready by the end of the week."

Meanwhile plans are progressing for the joint investigation committee voted at a meeting of the executive committee of the New Jersey branch of the American Jewish Congress. The exact date for the joint conference of organizations to decide upon the mode of procedure for the investigation, has not yet been announced, but it is known that it will be held early next week. Judge Joseph Siegler is temporary chairman of the conference committee.

Rabbi Julius Silberfeld of Temple B'nai Abraham, last night made public a letter he received from Morris Gusberg, who stated that his son had been denied entrance to Rutgers, although he ranked sixth in a class of 66 when graduated from West Side High School last January. Mr. Gusberg stated that his son subsequently was admitted to Michigan University without entrance examinations because of his high scholastic rating.

A. F. of L. Endorses Legislation for New Immigration Curbs

Boston, Oct. 17—Legislation designed to cut immigration to the United States almost to the zero point during times of economic stress was recommended in a group of resolutions adopted by the American Federation of Labor convention here. The resolutions were part of the report of the resolutions committee.

Reports to the Jewish Telegraphic Agency from Washington that the scheme of selective immigration would become a leading question at the next session of Congress were confirmed at the A. F. of L.'s convention. The immigration resolutions pointed out that since unemployment in many ways is intimately connected with immigration there is a need for "the utmost restriction of immigration possible under the existing law" as well as the "enactment of additional legislation designed to reduce immigration to the United States."

Alien registration also came in for considerable discussion when it was brought up by Frank X. Martel, president of the Detroit Central Labor Union. Andrew Furseth, president of the International Seamen's Union opposed alien registration as being ineffective.

Rabbis to Require Federal Prescription Permits in Issuing Sacramental Wine

Rabbis will be required to obtain federal prescription permits in dispensing sacramental wine, according to new regulations which will become effective within the next few weeks. Instead of personally dispensing wines to members of their congregations, as is the case at present, the rabbis will in the future be supplied with books of prescription blanks, similar to those issued to physicians, in quantities required for their congregations, and the prescriptions will be rigidly checked up by officials of the permit bureau of the prohibition department.

Prohibition Administrator McCampbell said last week that under the new system the rabbis will first have to submit a list of the members of their congregations and the number of permits which they will receive will depend upon the size of the lists. The permits will then be distributed by the rabbis as they see fit. The list of the members of congregations will be typewritten in alphabetical order, will be taken to the bonded wine dispensing places and the quantities of wine to be dispensed will be checked off against the names. In this way the government hopes to stop the present bootlegging of sacramental wines by unlicensed dealers.

Mr. McCampbell expressed the opinion that the new method will not be protested by the rabbis, since it will relieve them of responsibility and from the task of personally supervising sales of wines. Under the present arrangement rabbis are allowed to withdraw from bonded warehouses the quantities required for the use of their congregations for the religious holidays.

Anti-Zionist Parliamentary Bloc Plans New Offensive at Forthcoming Session

London, Oct. 17—The pro-Arab forces in parliament are determined to undertake a campaign of action at the next session which will surpass all their previous efforts, the parliamentary correspondent of the Jewish Chronicle writes. Encouraged by the government's decision suspending immigration the anti-Zionist parliamentarians are apparently confident that they can get better results by an efficient organization.

The chief leaders of the anti-Zionist bloc are Howard Bury, F. Seymour Cocks and J. J. McShane. These, together with about a dozen others, will launch a new anti-Zionist offensive.

The pro-Palestine parliamentary group, under the leadership of Col. Josiah Wedgwood, with the influential support of representative members, sees no danger from this new move on the part of the anti-Zionist bloc. The Jewish Chronicle's correspondent states on the highest authority that no decision has yet been reached with regard to the suspended immigration certificates. Representations on this score have been made by the Palestine parliamentary group and by Zionist leaders to the government.

The hostile reception accorded to Dr. Drummond Shiels, British under-secretary for the Colonies, in certain quarters on his visit to Palestine, was not unexpected by the British government. Under normal circumstances Lord Passfield himself would have gone to Palestine but owing to the tension in Palestine it was decided that Dr. Shiels should go. It is semi-officially stated in ministerial circles that after the Palestine program of the government is launched very frequent visits to Palestine will be made by members of the government.

Cincinnati Jewry to Honor Shohl on 80th Birthday

Cincinnati, Oct. 17—Jesse M. Joseph, Herbert C. Oettinger and Jacob W. Mack are general chairmen for the communal dinner to be tendered Charles Shohl on Oct. 26 in Cincinnati in honor of his 80th birthday. The three men are members of boards of the Union of American Hebrew Congregations of which Mr. Shohl is honorary president. He is also honorary president of the Plum Street Temple and Wise-Rockdale Center, as well as an honorary member of the Board of Governors of the Hebrew Union College.

Mr. Shohl, who is a retired wholesale clothing merchant, was born in Cincinnati and educated in the local schools. Since his retirement from business in 1911 he has devoted his entire time to religious, charitable and educational institutions. He is an honorary member of the Council of Jewish Women and of the Phi Beta Delta Fraternity and a member of the National Boy Scouts Committee.

countries of Europe. The question of discrimination in this country practiced against Jews in colleges and in the field of employment is also on the agenda. A meeting of the National Executive Committee of the Congress will be held tomorrow, Saturday, evening at the New Willard Hotel.

An important feature on the program of the session will be a report on the condition of the Jews in Roumania by Professor Salo Baron, who has just completed a special tour of investigation in Roumania at the behest of the American Jewish Congress. The session will listen to addresses by Dr. Stephen S. Wise, honorary president of the American Jewish Congress; Bernard S. Deutsch, president; Hon. Nathan D. Perlman, chairman of the executive committee; Hon. Carl Sherman, vice-president; and Bernard G. Richards, executive director, who will present a review of the activities of the American Jewish Congress since its last session in May, 1929.

Findings on Discrimination

The findings of the Committee on Discrimination Against Jews in the Field of Employment will be presented by David L. Podell and Rabbi Jacob X. Cohen, secretary of this committee. A report will also be presented by Dr. Mordecai M. Soltes, secretary of the Committee to Study Discrimination Against Jews in Colleges.

Elaborate arrangements for a banquet in honor of Mr. Snell, to be held on Sunday evening at the New Willard Hotel, have been made by the Washington Committee in charge of arrangements for the session. The officers of the Committee are: E. I. Kaufmann, honorary chairman; Leopold V. Freudberg, chairman; Mrs. John Safer, chairman of the Women's Committee; Morris Garfinkle, Louis E. Spigler, Joseph A. Wilner, Mrs. David A. Alper, vice-chairmen; Maurice Bisgver, executive secretary.

The delegates will be received by President Hoover at the White House on Monday. About 500 delegates are expected at the session of the American Jewish Congress.

Oldest Jewish Cemetery in Latvia Saved From Destruction

Riga, Oct. 17.—The oldest Jewish cemetery in Latvia was saved from destruction today by the decision of the local court at Boysk. M. Yvanovski, a Pole, claimed that the plot on which the cemetery stood was his by inheritance. He had already taken steps to tear down the synagogue on the cemetery grounds and had permitted cattle to graze on the graves.

The arguments presented by counsel for the Jewish community of Boysk convinced the court and Yvanovski's claim was not allowed. Considerable relief is being expressed in Jewish circles in Latvia that the cemetery was saved from desecration.

Jewess, Founder of "Poppy Day," Honored by Native Town

Athens, Ga., Oct. 17.—Miss Monia Michael, who has just returned from the Boston convention of the American Legion, where she was signally honored by the legion auxiliary for her part in originating "Poppy Day," was officially welcomed by the city today amid elaborate demonstrations.

The Georgia University R. O. T. C. unit and the university band formed an escort for Miss Michael in the parade to the city hall, where Mayor A. C. Dudley extended the official welcome. Delegations from Athens' civic and patriotic organizations were represented among the large crowds that participated in the tribute to Miss Michael.

At Boston Miss Michael was awarded the Distinguished Service Medal of the legion auxiliary at the same time that a similar honor was bestowed upon Mrs. Calvin Coolidge. Miss Michael, who is a member of a prominent Jewish family here and has taken an active part in civic affairs, is popularly known throughout the country as the "Poppy Lady."

that Hankin must present proof that less than a decade has passed between his return to Palestine and the filing of his claim in November 1928. It is interesting to note that while the British judge holds that ten years from the time of Hankin's return to the time the claim was filed is sufficient time for prescription, the Arab judges feel that fifteen years would be better.

Los Angeles Jewry Ready to Tackle Unemployment Problem

Los Angeles, Oct. 17.—The first step in the organization of a Jewish employment bureau in Los Angeles was begun at a meeting of prominent Jewish men and women of this city, held at the office of the Federation of Jewish Welfare Organizations this week. Edward Bastheim, well-known jeweler and communal worker, presided.

Considerable discussion as to the methods to be used by such an employment agency was aroused, I. Irving Lipshitch, executive director of the Federation, leading the discussion. It was finally decided to establish such an agency within a very short time on a purely business basis, with a nominal charge to the employee obtaining work through the agency's efforts.

Stress was laid on the necessity of avoiding any association between the welfare organizations and the agency. Mr. Lipshitch pointed out that workers who are sent from a welfare or charitable association to an employer are usually not given the same treatment and courtesy that is given an employee sent through a regular employment agency. On a motion of J. J. Cummins, editor of the B'nai B'rith Messenger of this city, the resolution to proceed with the employment agency was accepted.

Italian Jewry with mixed feelings because hitherto the Jews have been free, although never compelled, to associate themselves as they desired in friendly or educational societies. While the federation plan is in keeping with the Fascists' passion for grouping and labeling citizens it will also tend to create, it is feared, racial distinctions of which few Italians have hitherto been conscious.

Government Commission Had 3 Jews

The government commission that prepared the law consisted of three Jews and three non-Jews. The chairman was Senator Berio and the Jewish members are Chief Rabbi Sacerdoti, M. Sereni, president of the Jewish communities federation, and Professor Mario Falco of Milan University.

While the full text of the Jewish communities law has not yet been published the draft of it, which was submitted some time ago, gives a fairly accurate idea of its leading provisions. The law proposes that Jewish communities be recognized as authoritative bodies with the right to own and dispose of property under the supervision and protection of the government authorities.

The communities would be governed by committees consisting of from three to fifteen members according to the size of the Jewish population. The committees would be elected by the community taxpayers. Every Jew would be required to pay a community tax unless he does not consider himself a Jew. The community would provide for the proper observance of the Jewish faith, regulate charity, administer marriage ceremonies, according to the recent laws regulating non-Catholic ceremonies, and would supervise Jewish public institutions.

In order to carry out the proposed activities the Jewish communities would be entitled to dispose of funds raised among members of the community. The communities would be linked in a national federation whose headquarters would be Rome and would be governed by a congress of presidents of the communities. Individual communities would be required to submit reports of balance sheets for the approval of the government.

Reichstag Member Reports Hearst-Hitler Contact

Berlin, Oct. 17.—Deputy Gregory Strasser, a National Socialist member of the Reichstag opposed to the Hitler wing of the party, today revealed the existence of a contact between Hitler and Karl von Weizand, representative of William Randolph Hearst, by the terms of which Hearst agrees to pay Hitler one dollar a word for each word used in Hearst interviews provided the interviewer is not a Jew.

Inquiries at the New York office of the Hearst organization elicited the reply that nothing was known of a contract such as the one mentioned by Deputy Strasser.
