# Mandates Body Discusses Palestine Question Briefly, Will Study White Paper

(Jewish Telegraphic Agency) Geneva, Nov. 4-Although not on the agenda the Palestine question came in for a brief discussion at the opening session of the Mandates Commission today when its chairman, Marquis Theodoli, in concluding his opening remarks announced that the members of the Commission had received copies of the British government's White Paper and of the Simpson report.

He added that it was impossible for the members of the Commission to thoroughly study the documents be-fore arriving at Geneva but he was mentioning them despite the fact that the Palestine question was not on the agenda because he did not desire to allow such an important act of the Mandatory Power since the Commission last met to pass without men-

Marquis Theodoli officially informed the Mandates Commission that the meeting of the Council of the League of Nations in September had considered the Commission's report on Palsession last June, and the British government's observations on this report The chairman also told the Com-

mission that after its rapporteur, Hjalmar Procope made a statement on the Commission's report and the British observations an important declaration was made by Arthur Henderson, Brit-ish foreign secretary. Marquis Theo-(Continued on Page 4)

#### Landsteiner, Nobel Prize Winner, Left Vienna Because of Anti-Semitism, Austrian Papers Say (Tewish Telegraphic Agency)

Vienna, Nov. 4-The Austrian press in commenting on the ward of the Nobel Prize for medicine to Dr. Karl Landsteiner of the Rockefeller Insti-tute in New York, today reveals that while the University of Vienna is now joining in honoring Dr. Landsteiner, who was pathologist for the university in commenting on the ward of from 1909 to 1919, the same institution for many years prevented him from becoming a professor because he was the son of a poor Jewish journalist.

This resulted in his leaving his native

Austria for the United States. papers simultaneously report that the University of Vienna's anti-Semitic policy also prevented Dr. Bela Schick, of New York, from becoming a full-fledged professor. Other famous Jewish scientists such as Kraus, Freud, and Ziele remained at the University as a protest despite the fact they too were not admitted to full professorships.

Weizmann Tells Actions Group Jewish Agency Should Petition Mandates Body on Palestine (Jewish Telegraphic Agency)

London, Nov. 4—A suggestion that the Jewish Agency for Palestine sub-mit a petition to the Mandates Commission, now in session at Geneva, asking it to discuss immediately the Palestine question in view of the new dereport and the British government's new policy was made today by Dr. Chaim Weizmann, resigned president of the Jewish Agency and of the World Zionist Organization, at the opening meeting of the emergency session of the Zionist Actions Committee.

The Actions Committee was called into urgent session here to deal with the crisis in the Zionist movement as a result of the British White Paper and the Simpson report. Whether the Jewish Agency will adopt Dr. Weizmann's suggestion is not yet known but it is known that the Palestine question is not on the agenda of the present session of the Mandates Commission.

# Wailing Wall Commission Attempts Arab-Jewish Accord (Jewish Telegraphic Agency)

Stockholm, Nov. 3-While the international Wailing Wall Commission is ready to submit its report to the British government on its investigation of the claims of Jews and Moslems to the Wailing Wall, the Commission is still endeavoring to bring about a mutually agreeable understanding between the Jews and Moslems in order to avoid, if possible, the publication of the Commission's report, the Jewish Telegraday.

Every effort is being used in this direction. It is understood that the Commission's conclusions to be handed shortly to the British government contain a reservation covering the contingency of a possible last minute, agreement.

#### 60 Percent Increase in Acreage Sown by Crimea Jewish Colonies (Jewish Telegraphic Agency)

Moscow, Nov. 4-An increase of 60 per cent in the acreage sown this year, in the Iewish agricultural settlements of Crimea as compared with last year, is reported today by the Comzet, the Jews on the land. While last year 60,000 puds were sown over an area of 592 hectares this year 111,000 puds were sown over an area of 867 hectares.

The improvement is particularly noticeable in the settlements sponsored by the Agro-Joint, the American Jew-ish Joint Agricultural Corporation. which has now also come to the aid of machinery.

# Unequivocal Cancellation of Passfield White Paper Demanded

(Jewish Telegraphic Agency) Jerusalem, Nov. 4-An unequivocal demand for the cancellation of the British government's White Paper on Palestine and the "dangerous and erroneous basis underlying it" is made today by the Hebrew daily, Haaretz, in discussing the rumors that the Brit-

ish government is considering a new

statement that will explain and amplify the first one.

Reviewing Premier MacDonald's, Lord Passfield's and other official explanations since the state of policy was published, the Haaretz opines that despite assertions to the contrary the world-wide protests have been effective. All attempts to pacify, explain and even to hint at retreats will not avail "except to weaken our opposition against the Labor government's anti-Zionist policy," the Haaretz declares.

"Henceforth new declarations and commentaries will not suffice. We demand the cancelling of the White Paper and the dangerous and erroneous basis underlying it," the paper says.

Referring to Lord Passfield's interview with Reynold's Newspaper in London in which he denied that the White Paper contained any word about the stoppage of immigration, the Doar Hayom terms Passfield's state-ment "typical eyewash." When Lord Passfield divides Jewish immigration into nine categories he "conceals the fact that labor immigration forms from 80 to 90 percent of the entire Jewish immigration," the Doar Hayom says.

The paper also asks how Lord Passfield can speak of colonization being unrestricted when the "prohibition of land transfers is pending. Passfield's statement shows that he considers the which he does not intend to recede."

American, Revisionist Members (Jewish Telegraphic Agency)

Warsaw, Nov. 4-The creation of a provisional Zionist Executive to be composed of persons not now members of the Executive and to include American Zionist leaders and Revisionists the Zionist opposition, is demanded in a memorandum submitted today to the Zionist Executive in London on behalf of the Polish Zionist Central Committee by Leon Lewite acting for Deputy Isaac Gruenbaum, president of the Polish Zionist Federation, who is ill. The memorandum suggests that the

provisional Executive in cooperation with the Zionist Organization of America should take steps to continue the Zionist work but if such a provisional Executive is not possible then the resigned Executive without Dr. Chaim Weizmann, resigned president of the Jewish Agency and the World Zionist Organization, should continue the work.

Other recommendations contained in the memorandum are that the Executive decline any British declarations. reject compromises, demand that the House of Commons consider the Palestine policy, approach the Mandates Commission immediately, take the necessary steps to obtain the sympathy of the great powers, until the situation has cleared up, settle all Jewish Na-tional Fund lands over a period of not more than five years, prepare a plan for land reform in which Jewish capital will participate on condition that part of the lands be transferred for Jewish colonization, thus gaining the friendship of the fellaheen, and conduct the forthcoming Zionist Congress along the lines of the first Congress by considering the Iewish situation all over the world in order to make the Palestine question part of the solution of the entire Jewish question in which almost all nations are interested.

## British Cabinet to Consider Amplifying White Paper (Jewish Telegraphic Agency)

London, Nov. 4-The next meeting of the British cabinet will take up the matter of the government issuing a new statement that will amplify and explain its recent White Paper on Palestine which has aroused a storm of protest and indignation not only in Jewish circles throughout the world but among non-Jews as well.

Reports to the effect that the government has been considering such an explanatory declaration have been current for several days and are now confirmed by practically the entire London press, including the Times. While government circles are of the opinion that the White Paper has been misunderstood and misinterpreted by its critics there is no disguising the statement shows that he considers the fact that the government is seriously White Paper a fait accompli from disturbed by the resentment its new Palestine policy has created.

German Jewish Banker Denies Financing Hitler, Anti-Semite; Charge Repeated by Berlin Press

(Jewish Telegraphic Agency) Berlin, Nov. 4-While Jacob Goldschmidt, Jewish banker, economist and head of the Darmstadter National Bank, the largest in Germany, today denied published reports that he had paid Adolf Hitler 1,000,000 marks, the Communist press, particularly the Welt Am Abend which first gave currency to the report, repeats the charge.

Quoting the Welt Am Abend, the Liberal Montag Morgen editorially charged that Herr Goldschmidt had utilized the Lahusen firm as an intermediary in his negotiations with the Hitlerites whose activities he is accused of having financed. A number of papers, among them the Montag Morgen, took the reports in the Communist press seriously.

The Montag Morgen called on Herr Goldschmidt to state publicly whether or not he had directly or indirectly financed the National Socialists. If his answer was in the affirmative the Montag Morgen indicated that it would further like to know whether Herr Goldschmidt furnished the Hitlerites with funds because of his sympathy with their political aims or for business reasons.

#### Charges Bank Losses

In repeating its charge, the Welt Am Abend also publishes a report of allegedly serious financial losses suffered by the Darmstadter National Bank, adding that this information has tremendously impressed the Stock Ex-change. The Communist organ also intimates that it was Herr Goldschmidt and Dr. Emil van Strauss of Deutsche Bank who helped Adolf Hitler frame his plank to nationalize the banks deliberately giving it a ridiculous form in order to make impossible its acceptance.

In view of the fact that the charge is being repeated Herr Goldschmidt today authorized the Jewish Telegraphic Agency to state that neither directly nor indirectly does he support the National Socialists as a party, nor does he back any individual National Socialists

"I neither know Hitler nor have I ever spoken to members of the Na-tional Socialists," Herr Goldschmidt de-clared. "I never issue denials because I consider if ridiculous to denounce publicly rumors which are essentially untrue and it is obvious that I could not support the National Socialist movement," he said.

While the general press is describing the Communist allegations against Herr Goldschmidt as senseless it is being recalled that during the anti-Semitic Hitlerite riots in Berlin on the occa-sion of the opening of the Reichstag, the Darmstadter National Bank was one of the places of business attacked by the rowdies.

## Suggest British White Paper Be Submitted to Hague Court For Opinion on Moot Points

John Simon and Viscount Hailsham, a
former Lord Chancellor, follows:

"The correspondence which recently appeared in your columns regarding the Palestine statement led us to compare the recent White Paper with the terms of the Mandate. We are not at present concerned with the expediency of the Government's policy but the Mandate constitutes for the people of this country a legal as well as a moral duty and a breach of its terms by any British Government would lay this country open to a grave charge of breach of faith and disregard of its international

"The Mandate by its preamble defines its purpose to be the putting into effect of the Balfour Declaration 'in favor of the establishment in Palestine of a National Home for the Jewish People, it being clearly understood that nothing be done which might prejudice the civil and religious rights of the existing non-Jewish communities in Pal-

"This purpose is further elaborated in article 2 which makes the Mandatory Power responsible for securing the es-tablishment of the Jewish National Home as laid down in the preamble and for safeguarding the civil and religious rights of all inhabitants of Palestine. Article 6 runs as follows: 'The administration of Palestine, while ensuring that the rights and position of other sections of the population are not prejudiced shall facilitate Jewish immigration under suitable conditions and shall encourage, in cooperation with the Iewish Agency referred to in Article 4 close settlement by Jews on the land including state lands and waste lands not required for public purposes."

"In apparent conflict with these provisions the White Paper lays down firstly in Paragraph 15 that even in where state lands are unoccupied it is not possible to make these areas available for Jewish settlement in view of the importance of making available additional lands on which to place Arab cultivators who are now landless; secondly, paragraphs 19 to 23 lay down that the existing practice of the Jewish Agency of employing Jewish labor on its undertakings and of stipulating in its leases that only Tewish labor shall be employed, must be brought to an end apparently on the ground that it contravenes the provisions of Article 6 of the Mandate.

"Thirdly, Paragraph 28 lays down that no further immigration of Jews is to be permitted so long as it might prevent any Arab from obtaining emreferred to is not the eviction of Arabs from positions they now hold or the depriving of any section of the population of its employment, but the possi bility that the presence of the Jewish immigrant might prevent some unemployed Arab from obtaining employment, which in the Jew's absence he might be able to obtain.

# Rochester, Worcester, Baltimore, Hold Protests on British Plan

Rochester, Worcester and Baltimore have been added to the list of cities that held meetings of protest against the new British policy in Palestine while Newark is planning a demonstration of protest for Thursday night

In Rochester Iacob de Haas chairman of the Zionist Organization's organization committee, denied the right of England to convert Palestine into a Crown Colony. England does not own Palestine. Mr. de Haas told the large gathering in the Lyceum Theatre.

It is in acts like the Passfield White Paper and in administrative acts that violated the Mandate that the "fell design not of the British people who know nothing about these things, but of a life-long office-holding bureaucracy makes its power and its intentions manifest," Mr. de Haas declared.

In Worcester resolutions condemning the Labor government of England and calling upon the United States and the League of Nations to see to it that Great Britain is held to the terms of the Mandate were unanimously adopted by 2,300 Jews who stormed the Bancroft Hotel in the largest protest meeting that has ever been held in the city. The speakers included Judge Bernard Rosenblatt of New York, Louis Goldberg, Levi A. Olanoff and Rev. Father Edward A. Fitzgerald Thousands were turned away from

an overflow meeting that packed the Auditorium Theatre in Baltimore. Abraham Tulin and Judge William Lewis criticized the British plan. Baltimore. British plan. Judge Eli Frank presided. A committee headed by Harry Friedenwald was formed to raise Zionist emergency funds in Baltimore.

One hundred and twenty-five local Jewish organizations and synagogues will jointly sponsor a huge protest meeting in Newark Thursday night in Temple B'nai Abraham. Governor Larson and U. S. Senator Kean will Colonial Office Failure to Amplify White Paper Causes Much Confusion in Palestine

(Jewish Telegraphic Agency) Jerusalem, Nov. 4-The failure of the

Colonial Office to follow up immediately its new statement of policy on Palestine with new legislation giving effect to this policy, particularly as regards immigration and land purchase has left the local government authorities as much at sea as the Jewish officials regarding immediate action.

This is indicated first by the fact that a number of government departments have been instructed not to increase their scope of work in planning their new budgets and secondly by the unprecedented action of the High Commissioner in submitting to the Colonial Office for its approval the Jewish Agency Executive's immigration proposals for the next six month period. In the past these proposals have either been approved or rejected by the High Commissioner without consulting the Colonial Office. As regards land transfers confusion

is apparent among both sellers and prospective purchasers as well as the Purchasers are hesitating to deposit their fees at the land registry office, anticipating difficulty in obtaining refunds in the event that new legislation voids the sale.

Recommendation by Chancellor

It was learned today that the recommendation contained in the Simpson report that in estimating the economic capacity of Palestine to absorb new immigrants account should be taken of Arab as well as Jewish unemployment, a recommendation echoed in the government's statement of policy, was made by High Commissioner Chancellor. Although not receding from this stand as incorporated in the White Paper he is known to be anxious to permit the maximum number of persons of means and artisans not offering possible competition with Arab labor to enter the country.

Meanwhile more people are commenting on and discussing the Simpson report, having had an opportunity to study it since the full text has become available. A number of British officials and civilians have expressed themselves as struck by what they term the misplaced humor, petty and irrelevant facts, hasty judgment, general superficiality as well as the apparent misstatements that characterize the report on which the government's new policy is based.

The director of one government department has said that all of Sir John Simpson's conclusions relative to his department's activities are fallacious adding that this is perhaps also true of other departments. In this connection it is understood that the government is likely to ask all department heads to comment on the facts, figures speak. ### National Jewish Hospital. Denver, Issues Volume 9 in Tuberculosis Research Series

(Jewish Telegraphic Agency)

Denver, Nov. 4-With the issuance, during the past week, of the ninth volume of "Contributions to the Knowledge of Tuberculosis", the National Jewish Hospital at Denver makes another imposing addition to the literature of tuberculosis.

The Research Department is administered by a national and local Research Board. Dr. Alfred Meyer of Mt. Sinai Hospital, New York City, is president of the National Board, and Dr. John F. Anderson of the United States Public Health Service of Washington, as vice-president. Other members of the National Research Board are Dr. John A. Kolmer, University of Pennsylvania School of Medicine; Dr. S. S. Goldwater, Mt. Sinai Hospital, New York City; Dr. Morris Fishbein, Chicago, Illinois and Dr. Henry Sewall, Denver, Colorado.

Volume Nine of the "Contributions" embodies studies and scientific investigations made during the past year by members of the research and clinical staffs of the Hospital as well as others affiliated with the work of the Institution. It contains twenty-three articles of scientific significance and historic value in the field of tuberculosis.

When, in 1919, the National Jewish Hospital established its Research Department, under whose auspices these volumes have been issued, it set as the Department's goal the ultimate discovery of a specific cure for Tuberculosis. This Research Department, being operated and maintained by a national Jewish philanthropic organization, became, and world.

Members of the local Research Board, all of whom are residents of Denver, include Dr. Robert Levy,

chairman, Dr. Saling Simon, secretary and Dr. Henry Sewall.

"Contributions to the Knowledge of Tuberculosis" is published under the direction of Dr. H. J. Corper, Director of Research of the National Jewish Hospital, and the majority of the scientific papers contained therein describe the investigative work which has been done in the Research Department of the Hospital. Scientific studies by Dr. I. D. Bronfin, Medical Director of the Hospital and Dr. Saling Simon, member of the Medical Advisory Board, based on work done in the Medical Department of the Hospital, form an important part of the latest volume.

# Rabbi Silber Purchaser of Original Samaritan Bible

(Jewish Telegraphic Agency) New Orleans, Nov. 4-The arrival here of one of the few extant copies of the Samaritan Bible in the original a hand-written manuscript of the Hebrew Pentateuch dating from the 15th

century, has been announced by Rabbi Mendel Silber.

The Bible came into Rabbi Silber's hands following negotiations extending over a period of years between the late Ephraim Deinard, famous bibliophile and author, father-in-law to Rabbi Silber, and the family of the high priest at the Samaritan settlement in Nablus. Acceptance of an offer for the script made some years before was announced by the Samaritans the day of Mr. Dei-

nard's death which occurred during the Twenty-five years ago a similar Samaritan Bible was offered for sale in this country and among those inter-ested was Mr. Deinard. But because the price asked, \$35,000, was not met, it disappeared and was thereafter im-

possible to locate.

Four years ago Rabbi Silber, visiting Palestine, resumed the negotiations with the Samaritans who this time were in a more responsive mood, but the price they asked was prohibitive. Economic stress, however, rendered the owners of the Bible more reasonable and the last offer of Rabbi Silber was accepted. The Bible has been placed on exhibition at a public library in New Orleans.

son statement in the name of the Com-

Closing the discussion on Palestine, M. Procope noted that unanimous agreement had been reached. He paid tribute to the Commission for its impartial attitude and officially informed it that the League's Council had instructed the secretary-general of the League to forward the Commission's report to the British government requesting the latter to give effect to the recommendations and conclusions contained in the report and take the action suggested.

# Van Rees Starts Discussion

The conflict between the British government and the Mandates Commission was raised by M. Van Rees who pointed out that he reserved the right at the previous session to refer again to the British reply to the Com-mission's report. Nevertheless the Commission is not likely to discuss the Palestine question unless, as Dr. Chaim Weizmann, resigned president of the Jewish Agency and the Zionist Organization, declared at the opening of the emergency session of the Zionist Actions Committee in London today, the Jewish Agency will submit a petition to the Mandates Commission asking it to discuss the Palestine situation immediately.

So far, however, the only Palestine petition that figures at this session is one dated May 1930 from the Syrio-Palestine Committee referring to the arrest of the former Mufti, Abdel Ka-

der Mouzza Far.
