Jewish Governors in Oregon and New Mexico and Nine Jewish Congressmen Head Long List of Successful Jewish Candidates in Fifteen States: Lehman, Bettman, Levitan All Reelected

With the complete election returns the father of the newly-elected chief from all parts of the country now at hand the results show that for the first time in the history of American Jewry two Jews were elected governors of two Jews were elected governors of their respective states and nine Jews were elected to Congress, eight of them incumbents. In New York, Lt. Gov. Herbert Lehman was re-elected by an overwhelming plurality while in Ohio general on the Republican ticket despite the fact that the rest of the ticket went down to defeat.

Weizmann Tells Actions Group of Interviews with Passfield Before White Paper Issued (Jewish Telegraphic Agency)

London, Nov. 5-The Mandates Commission, now in session in Geneva, has been approached by Jewish spokesmen with a request to discuss the new Pales-18th, if it decides to discuss it at all, in order to enable the Jewish Agency to submit through the usual channels a reply to the report of Sir John Simpson, it was announced by Dr. Chaim Weizmann today at the emergency meeting

Comzet Approves Merger of Soviet Ort and Ozet (Jewish Telegraphic Agency)

Moscow, Nov. 5—The decision to merge the Soviet Ort, which has no connection with the All-World Ort, the society for promotion of technical trades and agriculture among the Jews of Eastern Europe and Russia, with the Ozet, society for settling the Jews on the land, was approved today by the Comzet, government department for settling the Jews on the land. Final 1929 Riot Case Closed

When Jaffa Jew Acquitted (Jewish Telegraphic Agency)

Jaffa, Nov. 5-The last of the cases resulting from the riots of August, 1929 was disposed of today in the district court when Raphael Turgeman, employed as an interpreter by counsel for Joseph Mizrachi Urphali, the Jew charged with the murder of two Arabs, was acquitted of a charge of suborning witnesses in the Urphali case.

Urphali, now under a ten year sentence, was accused of killing two Arabs on the day of the riots. Arab witnesses at the first of his three trials testified that British soldiers had killed the Arabs and not Urphali. They later retracted and charged that Turgeman had paid them for their previous testimony.

Friends of Urphali hoped that Turgeman's trial might shed new light on the murder of the two Arabs but the hearing witnesses for the defense, sim-ply noting that the evidence of the prosecution was contradictory.

National Socialists in Brunswick Raid Meat Factory

(Jewish Telegraphic Agency) Berlin, Nov. 5-The meat factory in the city of Brunswick that supplies the warehouses of the Jewish-owned firms of Tietz, Karstadt and Schocken were raided today and 20,000 tons of meat confiscated as part of the National Socialist state government's program of benefitting the small traders at the ex-

pense of the larger concerns.

The manager of the factory was arrested and the supervisor of another meat factory, M. Husemann, died suddenly of shock at the report of the

raid. In Ortelsburg, East Prussia, Selig were attacked and badly injured by a gang of Hitlerites today.

World Praises Suggestion World Court Pass on British Plan

Praise for Sir John Simon's suggestion that the World Court be asked to render an opinion on the British White Paper on Palestine and that the British government should not enforce the recommendations of the White Paper unless and until the court has decided in its favor, is contained in an editorial in Wednesday's New York World

"From every point of view this seems to be a statesmanlike proposal," says the editorial. "Sir John Simon speaks with great authority as an international lawyer. If he believes that the question properly be brought before the World Court there is good reason to believe it can. Since the dispute turns upon the interpretation of a Mandate of the League of Nations, a decision by the World Court would plainly be the most desirable and most reassuring method of settling the point of issue Reports of additional Jewish protest

meetings against the British declaration of policy on Palestine in various parts of the United States have been received by the Jewish Daily Bulletin. More than 3.000 persons attended a protest meeting in New Haven, Conn., on Sunday night, in New Haven, Conn., on Sunday ingina, ta which the speakers included Congressman John Q. Tilson, Mayor Thomas A. Tully, Louis Lipsky, Philip Troup, Louis Sachs and Isaac Hamlin. In Nashville, Tenn., Rev. Prentice A. Pugh, an Episcopal minister, was among the speakers at a big protest meeting held on Sunday night. Through a regrettable oversight, Sen-

ator William E. Borah's message to Sunday night's protest meeting in New York was omitted from the Jewish Daily Bulletin's report of that meeting. The following is the text of the message sent by Senator Borah, who is chairman of the Senate Committee on Foreign Affairs, to Emanuel Neumann, chair-man of the Committee on Public Information of the Zionist Organization of America:

"Deeply regret I am unable to be present in person, but I am in full sympathy with the object and purposes of your meeting. Not only all Jewry but all who are blessed with a sense of justice and who can understand and measure the hopes and aspirations of a great people, will share with you profound regret that an intimation of repudiation should Preuss, a Jewish merchant, and his son, attach itself to the Balfour Declaration. I have confidence that a wiser and more just policy will prevail."

Painleve Tells Paris Meeting British Pledge Must Be Fulfilled (Tewish Telegraphic Agency)

Paris. Nov. 5-Paul Painleve, former premier of France when that country signified its adhesion to the Balfour Declaration, told a mass meeting of 4,000 people here protesting against the new British policy in Palestine that the "promise must be fulfilled. The Jews held to their pledge and enriched the country but the Arabs who sold barren land and now see it prosperous want it back by violence. Civilization will not stand for that."

Other prominent speakers at the huge protest meeting were Anatole de Monzie and Justin Godart, former cabinet offi-cers, Jean Longuet, Socialist leader, and Paul Milioukov former Russian statesmen. The anniversary of the Balfour Declaration is not a time for mourning, M. Godart declared.

M. Milioukov said that as one of those who fought with the Jews for their national rights in Russia he was behind the present protests. M. Longuet asserted that the White Paper was based on a misunderstanding as the Labor government "knows the admirable Jewish deeds in Palestine.

Senator de Monzie, who presided, repeated what he had said in a previous interview that the British violation of the Mandate was a matter for the League of Nations. Hillel Zlatopolsky. M. Corcos and James Waterman Wise also spoke.

White Paper Hits Jews Not Zionism Primarily, Says Holmes (Jewish Telegraphic Agency)

Chicago, Nov. 5-The British White Paper on Palestine has not struck primarily at Zionism but fundamentally at the Jews, the Rev. Dr. John Haynes Holmes, pastor of the Community Church in New York, told 450 members of the Hadassah, the American Women's Zionist Organization. nouncing the new British policy, Dr. Holmes said it has caused the "gravest tragedy that ever happened in the his-tory of Zionism."

He said, "Had we been told three weeks ago that this thing that the Labor cabinet has done would be done we would have thought it incredible, Nothing can help the British Labor cabinet which will be damned forever in the light of history. The British White Paper has not struck primarily at Zionism but fundamentally at the Jews. It has done two other serious things. The new policy is dividing the British Empire and even the Labor

mitted to the Union in 1912 Mr. Seligman was a prominent political leader He has been chairman of the Sante Fe county commissioners, mayor of Santa Fe, the state capital, chairman of the Democratic county committee, head of the territorial Democratic committee member of the Democratic National Committee and a delegate to the Democratic national conventions of 1916,

1920, 1924 and 1928.

Lehman Heads N. Y. Winners

Heading the list of successful Jewish candidates in New York is Lt. Gov. Herbert Lehman who was reelected for a second term. Long active in multi-tudinous lewish affairs. Lt. Gov. Lehman will start his second two year term in Albany as the right hand man of Governor Roosevelt.

All of the New York Jewish congressmen were reelected despite hard fights. William Sirovich, Sol Bloom, Emanuel Celler and Samuel Dickstein will return to their customary places in the 72nd Congress. Magistrate Louis Brodsky lost a close decision to the incumbent, Mrs. Ruth Pratt. Jacob Panken, So-cialist opponent of Mr. Sirovich, came in a good third, as did B. C. Vladeck in Brooklyn. The numerous Jewish candidates for Congress on the Republican ticket were all defeated

Judge Bernard L. Sheintag, of the Supreme Court, was reelected while Borough President Julius Miller scored a sweeping victory in his campaign for the same court. David Cohn, the Republican nominee, was defeated. Louis Kahn defeated his Jewish opponent on the Republican ticket for the city court while Harry Fromberg was beaten in his race for the Brooklyn county bench as were the three Jewish candidates in Manhattan for the municipal court.

crisis in the Zionist movement and to take action on Dr. Weizmann's resignation. Today's session was conspicuous by the large attendance from practically every country in the world except the United States. The delegates from America were unable to attend because of the short notice given for the meeting, but Judge Julian W. Mack is participating in a consultative capacity. Although the Mandates Commission

has been approached it is not yet known whether it will devote any attention to the Palestine question on the suggested dates, Dr. Weizmann said. He also re-ferred to the possibility of an appeal to the Hague Court, particularly in view of the letter to this effect in the London Times from Sir John Simon and Vis-count Hailsham. In this connection Dr. were open, first either the government inquiring from the Hague Court directly concerning its new Palestine policy or else a request for an advisory opinion from the Court by the Council of the League of Nations.

Dr. Weizmann's political address was a chronological and detailed exposition of the immediate events leading up to the publication of the White Paper and of his own resignation. He said that on September 5, he, M. Namier, political secretary of the Zionist Executive, and Prof. Selig M. Brodetsky of the Zionist Executive saw Lord Passfield and gathered the impression that the scheme which the government was preparing and which subsequently ripened into the White Paper was of a most serious nature, and that the government did not intend to take the Jewish Agency into its confidence.

Wondering why the reception had been so unfriendly, Dr. Weizmann stated that he wrote to Lord Passfield from Italy on September 19th asking, among other things for an interview which was granted for October 1st. This was the first occasion on which the Simpson report was discussed, Dr. Weizmann said, but the document itself was not produced and hence he had to refrain from saying anything about a document of which he had no knowledge.

Mentioned Land Scarcity

It was during this interview that Lord Passfield mentioned the question of the land scarcity for the first time and the policy of the General Federation of Jewish Labor, adding, however that per-haps he had described the Simpson report in a darker light than it actually was, Dr. Weizmann reported to the Actions Committee.

Recalling that it was his impression that Lord Passfield considered Zionism a small affair, Dr. Weizmann asserted that the Colonial Secretary had pointed out in reference to the Simpson report's suggestion that there was a possibility of the settlement of 20,000 additional families that this was merely a personal In addition to Congressman Sabath, opinion of Sir John because until the

Documents Received Oct. 17

The documents were received by him on the evening of October 17th while he was in consultation with Lord Reading and James de Rothschild, Dr. Weizmann said, but with the week-end imminent he pointed out that he had little time to consult people and hence sought to secure the postponement of the official publication, being also pressed to this effect from New York by Felix M. Warburg and Prof. Felix Frankfurther. But when he telephoned Lord Passfield on Sunday night regarding a postponement, Dr. Weizmann said that the Colonial Secretary told him he could do nothing as the decision had been taken to publish the document in the form submitted.

Referring to the possible discussion of the Palestine situation in the House of Commons, Dr. Weizmann analyzed the mood of the House and asked the Actions Committee to consider two possibilities, first that of the government retreating from its policy and issuing a supplementary document and secondly the government's sticking to the White

He then announced that the Mandates Commission had been approached concerning the possibility of a Palestine dis-

Immediately after he had concluded his explanation of the political situation and the events leading up to it, Dr. Weizmann declared that in view of the fact that he had submitted his resignation he would not participate in the further deliberations of the Committee. His declaration followed a motion by the Revisionist members, the Zionist opposition, that the two items on the agenda concerning the Zionist situation and Dr. Weizmann's resignation be com-

After Dr. Weizmann had left the meeting room a motion of Lazarus Barth, German Zionist leader, was adopted asking that Dr. Weizmann remain for the discussion in view of the necessity for supplementary information and explanations from him. Nevertheless at both sessions that followed Dr.
