#### Asks Palestine Declare Moratorium on Private Debts

(Tewish Telegraphic Agency) Ierusalem, No. 6-An appeal to the

Palestine government to declare a moratorium on the payment of private debts as was done recently in Syria is urged on the High Commissioner by Sidki Uejni, Arab leader, in an open letter in the Arab paper, Al Hayat. He points to the great number of bankruptcies among Arab merchants and adds that only a moratorium will save the Arab business men, many of whom are unable to meet their obligations.

Dwelling on the economic effects of the British White Paper, the Hebrew paper, Davar, says that the financial crisis from which Arab merchants are suffering is doing much to temper their rejoicing over the White Paper. Arabs distrust the British promise to improve economic conditions and the effendis occupying seats in the legislative council will not invest money, hence the only effect of the White Paper is to shut off the supply of Jewish money," the Davar points out.

#### Stimson to Make No Statement on Palestine Yet (Jewish Telegraphic Agency)

Washington, Nov. 6-Secretary of State Stimson again declined to make a statement of the attitude of the United States toward the Passfield White Paper on Palestine, when he was once more persistently questioned by newspaper correspondents at a press conference following a report that he had commenced to study the White Paper after having received the full text from London.

Yielding, however to persistent questioning by the correspondent as to what the American government has been called upon and intends to do in the present situation, Mr. Stimson said that only a few letters had been received calling for action but that pending further study of the situation there was nothing as yet before the American government justifying action.

His assertion that only a few letters had been received calling for action was an evident rejoinder to a press association dispatch alluding to "an outpouring of appeals for action from Jewish leaders in the United States".

#### World Agudath, Palestine Branch Differ on Proposed Council (Iewish Telegraphic Agency)

Jerusalem, Nov. 6-Endeavoring to reconcile the attitude of the Palestine Agudath Israel Orthodox organization unaffiliated with the Jewish Agency. with that of the World Agudath, which has deprecated the attitude of its Palestine branch in announcing that it backed the Jewish community in declining to have anything to do with the proposed legislative council. # American Jewry Continues to · Protest British White Paper

Further reports of protest meetings seid last Sunday by American Jewish communities against the new British solicy in Palestine have been received by the Jewish Daily Bulletin from Minneapolis, Albany and Haverhill,

Twelve hundred Minneapolis Jews crowded the Beth-El Synagogue for the protest meeting, at which Governor Christianson of Minnesota spoke. Other speakers were Rabbi David Aronson and Mistavus Loewinger of St. Paul. Amos Deinard, Minneapolis Zionist leader, presided. The resolution of protest was frawn up by a committee consisting of Dr. M. L. Lefkovits, chairman; Dr. Moses Rahn, Rabbi S. Levin, Rabbi Albert Gordon and Rabbi Albert G. Minda. The meeting, sponsored by the Minneapolis Zionist District, was attended by representatives of the Jewish organizations in Minneapolis and St. Paul.

Jerusalem, Nov. 6-Fearing that the expected explanation by the British government of its White Paper on Palestine will depart from the standpoint of the White Paper which is considered favorable by the Arabs, the Arab Executive today forwarded a resolution to High Commissioner Chancellor protesting against the continued existence of the Balfour Declaration as a "conflict with the rights of the Arab nation and an "obstruction to their freedom."

It is understood that a similar resolution demanding the complete abrogation of the Balfour Declaration is to be sent to the Colonial Office. As a rethe government will shortly issue an explanatory declaration of its Palestine policy, a majority of the Arabs, hitherto prepared to participate in the proposed legislative council, are now reported to be assuming an uncompromising attitude.

#### Hadassah Pays Tribute to Mrs. Straus and Honors Miss Szold and Mrs. Warburg

"The Jews in Palestine are carrying on despite Mandates from Britain, despite anything. There were Jews in Palestine long before the Balfour Declaration. The Iew is so firmly rooted in Palestine that no external force can

This was the statement made by Miss Henrietta Szold, founder of Hadassah and member of the Jerusalem Zionist Executive who is now in this country, at a tea given in her honor Wednesday at the Hotel Commodore by the New York Chapter of Hadassah. Mrs. Edward Jacobs, newly elected national president of Hadasasah, referred to Miss Szold as "the great teacher" and asked her to remain in this country to breathe a new spirit into Hadassah.

The memory of Mrs. Nathan Straus, who was honorary vice-president of Hadassah, was eulogized by Dr. David de Sola Pool of the Spanish-Portuguese Synagogue, the oldest synagogue in the United States. In his eulogy of Mrs. Straus, Dr. Pool said that Mrs. Straus' devotion "came to its fullest expression and most concordant fulfillment in her labors for her Jewish people and its

Mrs. Felix Warburg was also lauded

at the meeting for her services on behalf of Hadassah. In a letter to the organization, Mr. Nathan Straus regretted his inability to attend the meeting and expressed his appreciation for the services rendered to Hadassah by Miss Szold and Mrs. Warburg. In his letter Mr. Straus also declared that he will continue to devote his life to the work that Mrs. Straus and he had started.

Two thousand Hadassah members were present at the tea which was presided over by Mrs. David de Sola Pool. Mrs. Warburg received a certificate of the inscription of her name in the Golden Book of the Jewish National Fund. Among the speakers were Felix Warburg; Robert Szold, chairman of administration of the Zionist Organization of America; Mrs. Rebekah Kohut and the Rev. Dr. Louis I. Newman.

Referring to the British White Paper on Palestine, Mr. Szold declared that it "struck at the very heart of the Balfour Declaration." Mr. Szold attacked particularly the restriction placed on immigration to Palestine because of unem-

ployment there.

sion of the emergency meeting of the Zionist Actions Committee appealed to Dr. Chaim Weizmann, resigned president of the World Zionist Organization and of the Jewish Agency, to remain in office because his resignation was intended chiefly as a gesture for the outside world

While the opposition was demanding the immediate resignation of the Zionist Executive as well as the resignation of the Zionist members of the Jewish Agency's Executive and the appointment of a provisional committee for political work, Harry Sacher, a member of the Palestine Zionist Executive, and one of the supporters of the present adminis-tration, declared that the tremendous political effect of Dr. Weizmann's resignation would be nullified if he was forced to resign from within the Zionist movement. Such action, Mr. Sacher said, would be construed as the failure of the Weizmann regime. The opposition that urged the removal

of the present Zionist administration was composed of the delegates from Poland, the Radicals, the Revisionists, Mayor Dizengoff of Tel Aviv and Isaac Naiditch. The spokesmen for the General Federation of Jewish Labor em-phasized the importance of concentra-ting on ways and means of building up

Sacher Makes Appeal

Discussion about the demand for the resignation of the Zionist Executive and on the resignation of Dr. Weizmann culminated in Harry Sacher's appeal to Dr. Weizmann to remain in office. Defending the administration, Mr. Sacher pointed out that the opposition had not offered a plan for future work nor had it proposed the membership of any provisional committee. Hence, Mr. Sacher said, the Executive, "conscious of its responsibilities was determined to carry on the fight in view of the fatefulness of the forthcoming few months for the entire Zionist cause.

Prof. Selig Brodetsky and S. Kaplansky, both supporters of the Zionist Executive, denied the allegation of the opposition spokesmen that the Executive was willing to accept the proposed legis-lative council in Palestine on condition that the Arabs recognize the Balfour Declaration and that the Jews be given fifty per cent of the seats in the council

Meer Grossman, vice-president of the Zionist Revisionists, submitted a resolution in which he held the Zionist Executive responsible for the breakdown of its policy. The Zionist reply to the British White Paper must be to decline to recognize the government's policy as declared

The reply must further be a refusal to participate in the legislative council and a protest to the League of Nations, he added. The Revisionist leader warned visionists would have to consider their rendered his political report.

Leaders Appeal for Keren Hayesod in Its 10th Year (Jewish Telegraphic Agency)

London, Nov. 6-"If every acre of land now in Jewish hands were brought under cultivation and if all economic and cultural efforts were rendered more fruitful then no power on earth could stay the further progress of the Jewish National Home," reads a manifesto of the Keren Hayesod, the chief financial instrument of the Jewish Agency, issued today in connection with the tenth anniversary of the Keren Havesod.

Issued under the signatures of Oscar Wasserman, president of the Deutsche Bank and chairman of the board of directors of the Keren Hayesod, and Arthur Hantké and Leib Jaffe, the manifesto calls on the Jews of the world to renewed efforts on behalf of the Keren Hayesod as a reply to the British policy. The manifesto reads as follows: "A grievous blow has been dealt by

the British government's latest statement at Palestine Jews and at all Jews asso-ciated with the establishment of the lewish National Home. But just as it has not caused a single Palestine Jew conviction because the reconstruction work is rooted in the profound yearning of our people for Zion, so it cannot weaken the bond that united the whole of Iewry in the sacrifice of achievement

"It is just ten years since the Keren Hayesod was established. It afforded the Jewish people an opportunity to manifest their spirit of sacrifice and their appeal in this solemn hour to all friends and fellow-workers to remain strong and loyal. The guarantee of our success lies in our own hands. Our determina-tion is proof before Jewry and the whole world that our hopes and actions are based on an unshakable foundation:

"The positions already won must be strengthened and fortified in Jewish towns, villages, schools and industries. If every acre of land now in Jewish hands were brought under cultivation and if all economic and cultural energies were rendered fruitful then no power on earth could stay the further progress and development of the Jewish National Home.

London, Nov. 6-Replying point by point to the attack on the British government's White Paper on Palestine by Sir John Simon and Viscount Hailsham in a letter to the London Times, Lord Passfield, Colonial Secretary, in a statement to the same paper today defends his Palestine policy.

Saying that it is "reassuring to find that such high authorities as Viscount Hailsham and Sir John Simon do not indicate that there is anything in the White Paper inconsistent with the Balfour Declaration and the Mandate save that they seek to draw from the language used in paragraphs 15, 19 to 23, and 28 three inferences which are unjustified and made plausible only by inaccurate representation of the contents. not one of which is quoted verbatim. defense of the bitterly criticized White Paper. Lord Passfield takes issue with the

"first inference from paragraph 15 which is represented as meaning the impossibility of making unoccupied state lands is no statement whatever in the document, he says, that "it is not possible to make these lands available for Jewish settlement nor do the words employed justify such an inference."

Says No Ban on Jewish Labor

He then seeks to break down the feeling that the White Paper demands that the Jewish Agency discontinue its practice of employing only Jewish labor. He says that the "second inference from paragraphs 19 to 23 is interpreted as meaning that the existing practice of the Jewish Agency of employing Jewish labor and stipulating in its leases that only Jewish labor must be employed 'must be brought to an end.' The paragraph does not contain such words, and only draws attention to the practice, to contrast it with the attitude of good-will toward the Arab people expressed in the declaration of the Zionist Congress of 1921, to give the Jewish leaders their own justification of the policy involved, and to indicate that the policy and arguments used in support of it take no account of the obligation under Article 6 of the Mandate to ensure that the rights and position of other sections of the

Lord Passfield also declares that "there is not a single word" in the White Paper "implying the prohibition or stoppage of any of the nine official categories of Jewish immigrants. Only one of these categories is so much as mentioned in the White Paper, namely the so-called Labor schedule which is determined each half year according to the absorptive capacity of the country at the time. The machinery for estimating the absorptive capacity is to be

"Meanwhile the Labor schedule is actually being settled for the ensuing half year, due note being taken of existing unemployment, but also with full credit being given for prospective vacancies due to enlarging enterprises." Lord Passfield concludes by saying that the inferences drawn by Sir John Simon and Viscount Hailsham are unfounded and based upon a misconception of the declared intentions of the government.

# Subhi Khadra's Appeal from Exile Disallowed by Court

(Jewish Telegraphic Agency) Jerusalem, Nov. 6 - The Palestine supreme court, composed of the chief justice and two Arab judges, today disallowed an appeal from the sentence against Subhi Al Khadra, former man-ager of the office of the Arab Execu-tive, who was exiled to Safed for one year and ordered to deposit \$2,000 as a guarantee of good behavior.
