Mexican Congress Unlikely to Approve Proposed Restrictive Legislation Against Jews

(Jewish Telegraphic Agency)

Mexico City, Nov. 11—While the reports that have been cabled from Mexico City to the effect that measures to be considered shortly by the Federal Congress, would, if passed, seriously prejudice the status of Jews, as regards business and by prohibiting them from marrying native Mexicans, have aroused tremendous interest among the Jewish population the facts in the case thus far hardly warrant the sensation that has been made.

Although it is true that nationalist organizations, and even the National Chamber of Commerce, have proposed measures that would deprive Jews and Chinese of their licenses to operate places of business and would make it illegal for them to marry Mexicans well-informed quarters here consider it entirely unlikely that Congress would enact legislation giving effect to such proposals.

Only a few days ago President Rubio stated that his administration would not permit persecution of the stranger within the gates of Mexico, this statement being the result of an inquiry made by Chinese societies in the Federal district.

Meanwhile the closing of a synagogue here has heightened the impression that Mexico is rapidly becoming anti-Semitic, although according to an official statement made this morning the closure was due to the congregation's failure to pay attention to the laws and requirements that make it necessary for a permit to be obtained by any group wishing to worship in a public place.

This is in accord with the constitution as well as the laws for the regulation of cults. So far as the situation is surveyable at this moment the Mexican Federal government appears to be uninclined to apply the harsh measures which certain anti-foreign groups would like to see enforced.

Hitlerites Injure Two in Attack on Schochet's House

Berlin, Nov. 11—Two persons were seriously injured when a band of Hitlerites today besieged the home of a Jewish ritual slaughterer in Barkhausen. When the Hitlerites attacked the house the slaughterer and his family barricaded themselves. Two sons of the slaughterer approaching the house unaware of the attack were set upon by the Hitlerites and seriously injured by knife wounds. Two of the National Socialists were later arrested.

Release of Certificates Does Not Change Situation, Agency Says

London, Nov. 11—The release of 1,500 certificates for Jewish immigrants to Palestine under the labor schedule does not change in any way the situation created by the White Paper, says a communique issued here today by the Jewish Agency.

If the White Paper remains unchanged then the grant of the certificates cannot be viewed as anything else but a temporary expedient to allay the indignation of the Jews, leaving the fundamental position unaltered, the communique points out.

Actions Committee Resolutions Endorse Vaad Leumi Decision To Boycott Legislative Council

(Jewish Telegraphic Agency)

London, Nov. 11—Disputing Sir John Simpson's claim that only 5,000,000 dunams of land are still available for agricultural colonization in Palestine and protesting strongly against the White Paper the resolutions adopted by the emergency meeting of the Zionist Actions Committee, which have just been made public, point out that Sir John ignored the large tracts of fertile soil on the Eastern borders of Palestine and in Transjordan and claim that his estimate contradicts that made by former government experts.

The resolutions also emphasize that the Jews have up to the present not received a single dunam of crown lands from the British government despite the fact that the government is obligated under the Mandate to give such lands to them.

Charging that the Passfield White Paper constitutes a violation of England's promises to the Jews and contravenes the Mandate, the Actions Committee (Continued on Page 4)

329 Jewish Immigrants Entered Canada in October

Montreal, Nov. 11—A total of 329 Jewish immigrants entered Canada during the month of October, according to figures made public today by the Jewish Immigrant Aid Society. Of this number five were detained, three were released and one died in the hospital.

Bernard Kahn Sailing for United States Nov. 15

Berlin, Nov. 11—Dr. Bernard Kahn, European director of the Joint Distribution Committee and a member of the Jewish Agency Executive, will sail for America November 15th to discuss with American leaders of the Jewish Agency and the Committee problems of Palestine and Eastern Europe.

Anti-Semitic Attacks Break Out in Austrian, Hungarian and Polish Universities

Lemberg, Nov. 11—Scores of Jewish and non-Jewish students were injured today when nationalist students attempted to break up a gathering of Jewish students on the campus of the University of Lemberg called to lay plans for the organization of a Jewish Academic Union. After almost an hour of fighting the police dispersed the students.

The trouble started when the nationalist students invaded the room in which the Jewish students were meeting and with no provocation attacked them and finally threw them out of the room. After burning proclamations and leaflets the anti-Semitic students launched a verbal attack on the dean of the University for permitting the Jewish students to assemble for the purpose that they did.

Budapest, Nov. 11—While Count Kuno Klebelsburg, Hungarian minister of education, was visiting the Franz Joseph Royal Hungarian University of Science at Szeged today, anti-Semitic students attacked their Jewish classmates and after expelling them from their classes injured three of them.

Not only did the anti-Semitic students demand the withdrawal of the Jewish students from the University but they also insisted on the resignation (Continued on Page 4)

Rabbi Principal Speaker at Capital Armistice Day Rites

Washington, Nov. 11—Rabbi Edward N. Calisch of Richmond, Va., representing the National Jewish Welfare Board of whose Army and Navy Committee he is a member, delivered the principal address today, Armistice Day, at the grave of the Unknown Soldier at Arlington Cemetery. Among other things Dr. Calisch said:

"Beneath this marble there rests the body of the Unknown Soldier. We know not what was his color, of his creed, or his condition in life. We know not whether there wept for him a solitary widow in an humble cabin, or a proud family in a palatial mansion. We know not whether he prayed to Jehovah or to Christ. We know not whether he came from Puritan or from Cavalier stock, or was an humble stranger, who had been received within these gates of opportunity. But we do know that he is the token of that union of racial and national cultures, in whose fusion is the making of the future of America."

Wants Monument to Haym Salomon in Philadelphia

(Jewish Daily Bulletin)

Philadelphia, Nov. 11—A protest that "Haym Salomon, the greatest Jewish patriot of America and one of the founders of the Republic," has no statue in Philadelphia where he helped finance the Revolution, was made by Rabbi William H. Fishershrider, at Temple Keneseth Israel this week.

Dr. Fishershrider urged that the city's synagogues unite "to perpetuate Salomon's memory." No institution bears his name, said Dr. Fishershrider, and Congress has failed to pass legislation reimbursing Salomon's descendants for the money he advanced to the Government, yet every congressional committee that has reported on the matter has declared the claim just.

"If he had been a general on a horse, waving his sword and killing people, it would have been easy to have him honored," said Rabbi Fishershrider. "But he was only a financier. He gave only his money and his life. What would the Allies have done if the United States had not loaned them—if you can call it a loan—\$10,000,000,000?"

"There are innumerable other men in our history who were the equals of Washington and Lincoln who are forgotten—others even more forceful. Haym Salomon is a man who ought to be known as one of the great heroes and martyrs of America."

Synagogue Broadline in Newark Deferred

Newark, Nov. 11—Rabbi Julius Silberfeld, spiritual leader of Temple B'nai Abraham, announced today that the plans for the inauguration of a broadline to aid the unemployed have been deferred. The broad line is to be operated under direct synagogue auspices.

Reorganize Child Welfare Work, Federation of Jewish Charities of San Francisco

San Francisco, Nov. 11—Beginning this month, the service to dependent Jewish children in San Francisco will operate under a plan designed to effect a practical division and coordination of function among the agencies concerned in child care, and to provide specialized and centralized supervision for dependent children who must be cared for away from their own homes.

Under the new plan, all applications for the community care of children must be made to the Eureka Benevolent Society, which shall conduct the necessary social and financial investigations. Children who require placement away from their own families shall be assigned for care to the Pacific Hebrew Orphan Asylum and Home Society, which will now conduct both the institution proper (Homewood Terrace) and a Foster Home Department for the boarding of children in private family homes.

The Children's Welfare Bureau, constituted of representatives of the Eureka Benevolent Society, the Pacific Hebrew Orphan Asylum and Home Society and the Federation of Jewish Charities, will act as the controlling body to pass upon applications for the placement of children in the light of the investigations made by the Eureka Benevolent Society. In the event the child requires community care, the Children's Welfare Bureau will determine whether such care shall be in an institution, in a boarding home, or in any other type of facility. The Children's Welfare Bureau too will maintain close contact with all children, whether under care of the Pacific Hebrew Orphan Asylum and Home Society or the Eureka Benevolent Society, with the object of making readjustments for the best interests of the individual child.

Newark Plans First Jewish-Gentile Good-Will Dinner

Paterson, N. J., Nov. 11—The first good-will dinner ever held in this city, will take place November 24, under the auspices of Barnet Temple Brotherhood. Each member of the Brotherhood will be asked to bring at least one Gentile friend. There will be a prominent speaker to represent each of the three predominant faiths. Harry B. Haines, editor of the Paterson Evening News will be toastmaster. M. Metz Cohn, president of the Brotherhood, heads the committee in charge of arrangements.

In Elizabeth, next Thursday night, there will be a community good-will rally under the auspices of the Elizabeth Section of the National Council of Jewish Women and the Council of Jewish Juniors. Dr. Sidney E. Goldstein, associate rabbi of the Free Synagogue of New York, will be the principal speaker.

Pick Washington Site for Oscar Straus Memorial

One of the most desirable sites in Washington has been offered the Oscar S. Straus Memorial Association by the Treasury Department as a site for the memorial to the memory of the late Oscar S. Straus, according to an announcement yesterday by William Loeb, president of the association. This site is at the entrance to the Great Plaza, facing the new Commerce Building, which has been described by President Hoover as "the noblest governmental building in the world."

The directors of the association at their meeting yesterday formally accepted the offer of this site, which was proffered them in accordance with the Act of Congress signed by President Coolidge on March 4, 1929. The Executive Committee was directed to secure the services of John Russell Pope to draft some tentative design for the memorial.

The following were elected to the board of directors of the association: Dr. Mary Mills Patrick, former president of the Constantinople College for Women; Hon. Simon W. Rosendale of Albany, formerly Attorney General of New York; and Dr. Albert Shaw, editor of Review of Reviews. All of these were close personal friends of Mr. Straus.

Oscar S. Straus served under four presidents. He was Minister to Turkey under Cleveland and McKinley; Ambassador to Turkey under Taft; and Secretary of Commerce and Labor in President Roosevelt's Cabinet. President Roosevelt also appointed him as a member of The Hague Court, which appointment was renewed by President Wilson.

Guild for Jewish Blind Is Planning New Home

Yonkers, N. Y., Nov. 11—The New York Guild for the Jewish Blind has just apprised city officials of its intention to erect a modern home, school and infirmary on about 11 acres of land it acquired in 1928 on the Saw Mill River Parkway here.

This was disclosed in connection with a formal application for tax exemption on the property, which is assessed at \$47,600, and which cost the guild \$54,500. The Guild has its present home on St. John's Avenue, carried on the tax exempt list for \$87,900.

Louis Lipsky Testimonial Dinner Set for December 7

The testimonial dinner to Louis Lipsky, former president of the Zionist Organization of America, on the occasion of his completion of thirty years of service in the American Jewish community, has been definitely set for Sunday evening, December 7, at the Astor Hotel, New York, according to an announcement issued by Bernard S. Deutsch, chairman of the testimonial committee.

Plan to Expend \$10,000 for Religious Folk Music Research in Palestine

Proceeds of a recital given by Ossip Gabrilowitsch and Mischa Elman, amounting to over \$10,000 will be expended in Palestine for research in religious folk-music, lectures on musical appreciation, training of choruses and classes in chamber and other music, according to a report delivered at a meeting of the Society for the Advancement of Music in Palestine by Sidney Matz. Mr. Matz, who is vice-president of the Ex-Latz Company of Brooklyn, recently returned from Palestine, where he investigated the possibilities of promoting musical activities in Palestine at the request of the Society, which is headed by Felix M. Warburg, honorary chairman; Laurence N. Levine, chairman and Mrs. Jonah J. Goldstein, treasurer.

Committees will be organized immediately in twenty cities of the United States for the purpose of raising funds in support of the Society's work, according to Mr. Matz. For the present year the Society will subsidize lectures in musical appreciation, to be given by Professor David Schorr, formerly of the Conservatory in Moscow. Professor Schorr, who was engaged by Mr. Gabrilowitsch, who is an adviser of the society, gave a course of lectures in music under the auspices of the Hebrew University, Jerusalem, last year. They will be repeated in Jerusalem, Tel Aviv, Haifa, and in three rural settlements in Palestine.

A special problem in the interpretation of "Tropes" or musical signs in the Bible will also be provided for through funds expended by the society this year. S. Rosovsky, formerly of the Conservatory of Riga, who was engaged in Biblical musical research last year at the Hebrew University, will undertake to translate into modern musical notes the signs in the Bibles which represent the musical melody which should accompany the reading of the text. Mr. Matz stated that this work, which is considered of the utmost importance by musical experts, had never been undertaken before. Mr. Rosovsky will endeavor to examine all available musical manuscripts.

Modern Jewish folk music will be recorded on special phonographic records by Mr. Rosovsky, by representatives of the Jews in Palestine who have emigrated from various lands in Europe and Asia, to determine the relationship between the folk-music of the Dispersion, covering the last two thousand years, and the modern folk-songs of Palestine.

Crounse Elected to Nebraska Legislature from Omaha (Jewish Daily Bulletin)

Omaha, Neb., Nov. 11—J. Crounse was chosen a member of the Nebraska state legislature at the elections which were held last week. Mr. Crounse, who will be the only Jewish member of the coming legislature, defeated Herbert White, a veteran legislator.

Telegram Deplores Possibility of Brandeis Quitting Supreme Court

In view of the rumors that Justice Louis D. Brandeis may resign from the United States Supreme Court to take over the leadership of the World Zionist Organization in connection with the present crisis, an editorial in Monday's New York Evening Telegram deplores the possibility, saying that the withdrawal of Mr. Justice Brandeis from the Supreme Court would be "a national calamity."

Justice Brandeis is praised in the editorial for his liberal interpretation of American law and for his brilliant juridical ability. The editorial calls attention to a book which has just been issued on the social and economic views of Mr. Justice Brandeis. Thirty important legal interpretations are noted in the book, twenty-six of which dissent from the views held by the majority of the justices of the United States Supreme Court.

"A reading of this book convinces one that Justice Brandeis has always fought for justice for the workingman, has supported organized labor in its struggles with capitalism, has upheld laws which were created for the purpose of fighting unemployment, long working hours and unsanitary working conditions," declares the editorial.

"Justice Brandeis," continues the editorial, "has always been a fervent advocate of individual liberty, upholding the right of every man to think and speak as he pleases. The dissenting opinions of Mr. Justice Brandeis," says the Telegram, "will live in history after the opinions of his colleagues will have been long forgotten."

More Than Half of B'nai Brith Expenditures in Five Years Devoted to Cultural Work (Jewish Telegraphic Agency)

Cincinnati, Nov. 11—The Constitution Grand Lodge of the B'nai Brith has spent \$364,000 on its eight Hillel Foundations during the past five years. These Foundations are located at Ohio State University, Cornell, Illinois, Wisconsin, Michigan, Texas, California and West Virginia universities.

Altogether the Constitution Grand Lodge spent during the period 1925-29 the sum of \$728,000, or 54.6% of its total expenditures, on cultural activities, according to charts which have just been issued showing the distribution of receipts and expenditures of \$1,322,000 during that period.

Included also in the cultural activities are the work of the Anti-Defamation League; the subvention to the budget of the Aleph Zadek Aleph, junior B'nai Brith Order; and various educational activities including the publication and distribution of the B'nai Brith Manual and the publication of the B'nai Brith Magazine. Philanthropies of the Order include appropriations to hospitals; the work of the Mexican Bureau, organized in 1924 to aid recent Jewish immigrants to Mexico; payment for the maintenance of some 600 war orphans in various European countries; and various appropriations for emergencies.

Jews Named on Body to Reply to Charges of Anti-Semitism Levied on Lake Placid Club

Lake Placid, N. Y., Nov. 11—Statements made by the National Council of the Jewish Tribune in its protest to Governor Franklin D. Roosevelt against the use of state funds to aid preparations for the Third Winter Olympic Games to be held at Lake Placid, N. Y., in 1932, were denied in a statement issued today by Judge Thomas A. Leahy, president of the Lake Placid Chamber of Commerce, who said:

"The statement of the National Council of the Jewish Tribune regarding the relation of the Lake Placid Club to the Winter Olympic Games is altogether erroneous. The Games were awarded by the International Olympic Committee to Lake Placid Village, not Lake Placid Club, and are organized by the Third Winter Olympic Games Committee appointed by the American Olympic Association.

"Lake Placid Club has also cooperated by furnishing the Intervals Ski Jumping Hill to the Olympic Committee, both without cost and wholly independent of club control. The Olympic Stadium which has just been built in the heart of the village at a cost of \$150,000 is likewise wholly independent of the Lake Placid Club."

The Olympic Committee contend that the bob run had to be built on this site owned by Lake Placid Club, because there was no other site on private land available in this region.

Following publication of the Jewish Tribune's statement in New York newspapers, the Chamber of Commerce president appointed a committee of five local men to draft a reply to the Governor. On this committee are: Willis Wells, town supervisor and member of the Olympic Games Committee; Mayor Martin Ryan; Rollie Kennedy, member of the State Olympic Commission appointed by the Governor and chairman of the North Elba Park Commission; Sol Feinberg, Postmaster of Lake Placid; and S. J. Volpert, village trustee. Mr. Volpert is now in New York and his son, Dr. Samuel Volpert, was asked to represent him.

Although this committee's letter to the Governor answering the Tribune's charges was not made public, it is understood to claim that the Governor has been misinformed as to the facts and assures its support and assistance in any investigation he may make.

Zemurray Gives \$15,000 to New Orleans Community Chest

New Orleans, Nov. 11—Samuel Zemurray, president of the Cuyamel Fruit Company, one of the largest owners of banana plantations in Central America, has announced a contribution of \$15,000 to the New Orleans Community Chest. This is one of the largest contributions ever made to local charities.

Vienna, Nov. 11—Violating their pledge of safe conduct to the Jewish students at the Vienna High School of Commerce who acceded to a request to vacate their classrooms, a band of Heimwehr students yesterday attacked their Jewish classmates, injuring seven, one seriously.

The trouble began when the students entered the lecture rooms and informed the professors that the Jewish students would have to be ousted. Putting up no resistance the Jewish students left on the promise of the Heimwehr students that safe conduct would be guaranteed. On the way out the Jewish students were set upon and badly beaten.

The school authorities maintain that they are powerless to do anything and instead of making it possible for the Jewish students to attend classes they have removed all Jewish students. Minor anti-Semitic disturbances also occurred at the Vienna University today.

Largest Jewish Meeting Held in Davenport Condemns White Paper; Boston Jews Join Protest

Davenport, Iowa, Nov. 11—Several thousand Jews from this city and Rock Island and Moline, Illinois, attended a meeting in protest against the British White Paper on Palestine. Among the non-Jews who addressed the meeting were Father Martin O'Connell, Rev. J. Vance, Rev. F. Rohlf and School Superintendent J. Hagan. Among the Jewish speakers were Rabbi Aaron Lefkowitz, Rabbi Sholom Bozman and Bernard Krusa of Chicago. Rabbi David Graubart was chairman of the meeting, which was the largest Jewish meeting ever held in this city.

Boston, Nov. 11—Before an audience that represented every section of Boston Jewry, leaders in government and civic life, Jews and non-Jews, Zionists and non-Zionists, joined in condemning the British Government for its latest White Paper at an enthusiastic, spirited meeting held at Faneuil Hall. Dr. Hyman Morrison opened the meeting and introduced as chairman of the afternoon Judge J. J. Kaplan, who presented the following speakers: Attorney-General Joseph E. Warner, Congressman F. W. Dallinger, Samuel Kalesky, who represented the Mayor; Congressman John McCormick, Alexander Brin, Hon. Elihu D. Stone, J. Committee's resolutions express the opinion that the White Paper makes impossible any further cooperation of the Jewish Agency and the British government, renders more difficult any improvement in the relations between Jews and Arabs and threatens the very foundation of the Jewish National Home.

The Actions Committee hints that political motives rather than any consideration of the welfare of Palestine played a large role in the determination of the British government to issue the White Paper in its present form. The resolutions point to the fact that the White Paper only declared that one of the reasons for limiting Jewish immigration to Palestine was to allay any suspicions that the Arabs might have harbored, though the White Paper does not say that they had any real grounds for their suspicions.

The resolutions endorse the decision of the Jewish National Council not to participate in the proposed legislative council and protest against the White Paper for mentioning only the duties of the government toward the "inhabitants of Palestine," pointing out that the Balfour Declaration was an obligation assumed by the British government toward the entire Jewish people.

Philadelphia Clothing Workers to Raise \$50,000 for Unemployed

Philadelphia, Nov. 11—The Amalgamated Clothing Workers in Philadelphia will raise \$50,000 for relief of unemployed members of the union. The sum will be forthcoming within five weeks, union officials announced, through assessments on the employed garment makers.

By action of the executive and joint boards of the union, all members earning \$21 a week or less will pay \$5 into the unemployed fund in five weekly installments. Members earning more than \$21 a week will pay in \$10 in a similar manner.

Charles Weinstein, manager of the Philadelphia branch of the union, said the assessment would raise among its 8,000 members here the \$50,000 required for immediate use. He estimated the number of unemployed members of the union at "about 1,000."

Lay Cornerstone for Detroit Children's, Infants' Home

Detroit, Mich., Nov. 11—Work on a new institution for dependent children and infants was begun with cornerstone laying ceremonies Sunday afternoon, for the new Jewish Children's Home.

The erection of the building has been entrusted to I. M. Lewis, architect. The building committee consists of Herman Cohen, chairman; Fred M. Butzel, Louis Duscoff and Irvin Yarrows. Samuel B. Kahn is president of the home.

Reform Jews Should Not Seek to Convert Orthodox, Says Dr. Solomon Freehof

Cincinnati, Nov. 11—Reform Jews, by missionary effort among the Orthodox, open themselves to the same criticism which the Reform Jews themselves level against Christians who seek to convert Jews. Thus declares Dr. Solomon B. Freehof, contributing editor of The American Israelite and Rabbi of Temple Anshe Mayriv, Chicago, in an editorial, entitled "Mark The Missionary," in The Israelite.

He deals particularly with the present efforts of Rabbi Jerome Mark, a Hebrew Union College graduate, on leave of absence from his Selma, Ala., pulpit and engaged in work for Reform Judaism in Melbourne, Australia.

"We ought to leave Orthodoxy alone!" Dr. Freehof declares. "It has problems enough without our adding to them. We ought to treat Orthodoxy as we would like all religions to treat each other. If, for example, Christians are confident that Christianity has the exclusive truth, we would like them to content themselves with the confidence that some day that truth will prevail everywhere."

"We, of course, would have our own opinions about that. So with regard to Orthodox Judaism, Reform Jews are convinced that the principles of Reform are essentially right. Let us then rely upon that rightness to find its way."

"Orthodox Judaism all over the world is staggering under heavy blows. Let us not give it another enemy to fight. If Reform is as right as we believe it to be it will come, as it has come, out of Orthodoxy. Let time be our only missionary."

Dr. Freehof says that "Rabbi Mark is doing heroic work, but I wish he were not doing it at all."

"He is an understanding and spiritually-minded man," the editorial adds. "None of his preachments will be brutally scornful of other men's belief. He has known Orthodoxy and has loved it. He will be gentle in his discussion of it. No better man could be chosen for the task. But the task is a wrong one."
