Anniversary of Anti-Semitic Student Organization Quiet as Roumanian Police Keep Order (Jewish Telegraphic Agency)

Bucharest, Dec. 10—Today's celebrations of the anniversary of the establishment of the anti-Semitie student movement passed without disorder in Bucharest and in the provinces. Everywhere the police succeeded in maintaining order. Inquiries at the ministry of the interior indicated that special precautions had been taken throughout the country to preserve peace.

Bucharest, Dec. 10—A near panic broken out today among the Jews of Platra when they received word that Professor Alexander Cuza, leader of the anti-Semitic movement, was coming to the town with a group of his fellowers in connection with the suit of a Christian worker against his Jewish employer.

The hasty intervention of a delegation of Jews with the police prefect of Platra led to the intervention of the central authorities in Bucharest who sent word that Professor Cuza would not come to Platra. It was recalled that when Professor Cuza and his followers passed through Targu-Fromos hast summer anti-Jewish riots took

place.

Meanwhile the Bucharest police have granted permission to the nationalist students to hold a mass meeting in Bucharest tomorrow in connection with the anniversary of the students' movement. The permit was granted not-withstanding the protests of Jewish leaders in an out-of-permission of the students had promised to maintain order and to see to it that there were no disturbances.

The workmen, part of a Jewish labor battalion, uncovered a number of ossuaries with Greek or Hebrew inscriptions, a mosaic and a large vase containing many antiques. The location of the objects which when found faced towards the Temple area impel archaeologists who examined them to believe them the property of the inhabitants of a city more than 2000 years old.

Palestine Grants Concessions for Manganese Copper Exploitation (Jewish Telegraphic Agency)

The Seminar began its sessions in the morning and lasted all day. It was held under the auspices of the National Conference of Jews and Christians and its purpose was to "acquire a better understanding, more intelligent appreciation and friendlier cooperation of cultural groups living creatively in a descenting."

The first morning session, at which Felix M. Warburg presided, heard addresses on the problems of religious prejudices and their elimination by Chancellor Elmer E. Brown of New York University, Dr. Ralph W. Sockman, president of the New York Federation of Churches, and 'Mrs. 'Estelle M. Sternberger, executive secretary of the National Council of Jewish Women.

See Departure from Ideals

The second morning session was devoted to a round table discussion of the particular "sore spots" which developed as a result of religious prejudices. The discussion was preceded by an introductory talk by Professor William H. Kilpatrick of Columbia University who presided. What may be termed the worst "sore spot" was indicated by one of the speakers to be "a departure from the original American ideals," as voiced in the Declaration of Independence, that all men were born free and equal and that Church separated from the State made religion the private affair of the individuals. man is thus considered a good man, irrespective of his religious beliefs, if he abides by the laws of the land.

American Zionists Designate Days for Shekel Campaign

The need of having a large and representative American delegation at the World Zionist Congress which will meet to Carlshad, Czechoślowkath beginning next February 18th, is the substance of a message issued by Robert Szód, Zionist Organization of America, urging the participation of American Jewry in the forthcoming elections for the Congress.

Head of Separate School Body Takes Issue with Secretary of Jewish School Commission

(Jewish Telegraphic Agency)

Montreal, Dec. 10-Refuting yester-day's statement by Nathan Gordon, secretary of the Jewish School Commission, in which he defended the Commission from attacks on it by those leaders who favored a separate Jewish school system, H. M. Caiserman, chairman of the Separate School Committee, today made a number of allegations against the members of the Jewish School Commission and against the agreement they concluded with the Protestant School Board.

Referring to that part of the contract that gives the Jewish children the same rights they enjoyed under the 1903 agreement, Mr. Caiserman says that means the right "to receive a Protestant education on the same basis as Protestant children" and charges that the Jewish Commission has "entirely failed to pro-vide for any element of Jewish education in its unfortunate settlement.'

As to Mr. Gordon's statement that the Senarate School Committee knew of the Jewish Commission's meetings six months before, Mr. Caiserman terms it "untrue and misleading in every sense. Commissioner Garber reported confidentially to our Committee about four weeks ago about a certain state of the negotiations but counselled against calling any public meetings until he informed us. And when he did so the agreement was already concluded. House Immigration Committee Approves 2 Year Alien Stoppage (Jewish Telegraphic Agency)

Washington, Dec. 10-The House Immigration Committee voted vesterday to suspend all immigration for a period of only two years, instead of five years as was originally suggested in the Johnson Bill. This makes the House bill in accord with the Reed bill introduced in the

Wives and minor children of alien residents who are legally in the United States will be excepted from the suspension clause and will be allowed to remain in the present category of quota preference immigrants, provided they have registered with American consuls for visas before midnight of yesterday. Those who have not done so would under this vote be barred under the two years' suspension clause.

The clause prohibiting the admission of Russian subjects was stricken from the bill. This clause was aimed against Communists and would have prohibited the admission of immigrants who are citizens of any country with which no diplomatic relations exist.

Representative Dickstein of New York was mainly instrumental in carrying out these amendments. Regarding the proposal to suspend immigration for five years, which on motion of Mr. Dicksstein was reduced to two years, the New York Congressman said:

"The five-year suspension would imply we expected the depression to last five years. If it lasted that long, we would have a revolution."

16 Jewish Laborers Arrested for Unemployment Demonstration at Ness Ziona: Others Detained

(Jewish Telegraphic Agency) Jerusalem, Dec. 10-Sixteen Jewish

laborers at Ness Ziona, including two secretaries, were arrested and 12 others detained today at the Ramleh jail for participating in vesterday's demonstration of unemployed workers at Ness Ziona where a number of hot heads smashed windows in the colonists' houses and did not retreat until the police fired in the air.

The secretariat of the Ness Ziona workers adopted a resolution today regretting that the unemployed had resorted to violence and calling on the workers to submit to discipline. Meanwhile at Hedera the colonists are seeking to solve the unemployment problem in the orange groves by peaceable means. They have prepared a list of all planters capable of furnishing work. At Petach Tikvah the colonists reaffirmed their demand for a wage reduction to three shillings a day after a conference with a joint delegation of the Vaad Leumi and the Jewish Agency.

The trouble between the workers and the colonists in the orange-growing belt is an almost annual affair coinciding with the beginning of the orange-picking season. The Jewish laborers claim that not enough Jews are employed in the Jewish-owned groves. The planters at Petach Tikvah have agreed to assure the employment of a larger number of Jews if the Jewish Federation of Labor will agree to cut the daily wage scale

The protests against All Quiet on the Western Front show no sign of ending and have taken on a definite anti-Semitic character. While the Hitlerite demonstration was in progress vesterday. passing Jews were insulted and threats were made to "hang and kill them all." The police had a difficult time in breaking up the crowd. Many of the National Socialists were arrested, among them Deputy Fabricus.

Zionist Deputies in Seim Form Parliamentary Club; Jewish Government Deputies Organize

Warsaw. Dec. 10-The six Zionist deputies who were elected to the new Polish Sejm yesterday organized them-selves into a Jewish Parliamentary Club. Dr. Joshua Thon was elected president of the club, which consists of four Zionist deputies from Galicia and two from Old Poland Deputy Henry Rosmarin of Galicia was elected vice-president. Deputy Isaac Gruenbaum, former president of the club, promised loyal support to the decisions of the Club.

The three Jewish deputies who were elected on the government ticket have organized themselvs in a "Progressive Club." Only the deputy of the ultra-Orthodox Agudath Israel, Rabbi Levin, has not joined with any other lewish

parliament members.

Although the members of the club wil have no opportunity to participate in the parliamentary committees, because they number less than ten, it is stated here however, that the government party will appoint the Jewish deputy, Wishlicki, as a member of the commerce committee, and that Deputy Minczberg will be appointed to the education committee.

The lack of unity among Polish Jewry was well reflected at the opening session of parliament yesterday. The ten Jewish deputies were divided into three parties. While in the former Sejm all the Jewish deputies belonged to one club and together occupied a prominent place in the Sejm, the six Zionist deputies vesterday sat behind the Ukrainians, and Deputy Gruenbaum, who formerly sat near the platform, yesterday occupied the last row among the minority groups. The three Jewish deputies who were elected on the government ticket were scattered among the non-Tewish deputies belonging to that party, while the Agu-dath deputy, Rabbi Levin, sat alone.

Jewish Fraternities to Give Hebrew University Scholarships

Scholarship funds for needy students at the Hebrew University, Jerusalem, were announced Tuesday at a meeting of representatives of Jewish fraternities, called by Harold Riegelman, former chairman of the Inter-Fraternity Conference. Scholarships amounting to \$300, the amount necessary to cover a student's minimum living expenses, will be awarded by Sigma Alpha Mu and Kappa Nu Fraternities. Mr. Riegelman, speaking on behalf of Zeta Beta Tau Fraternity, stated that at its convention in late December, Zeta Beta Tau would undoubtedly renew the scholarship awarded last year to a student at the Hebrew University

Judge and Jury Sample Matzos in Federal Court Trust Case

The U. S. District Court became the scene of a matzo-eating match vesterday as Judge Knox and the members of the jury proceeded to taste several brands of matzo in order to determine whether they were all alike. The question arose in the case brought by the Rabbi Weinberger Matzo Company against the Manischewitz Company and the Horowitz-Margareten Company in which Rabbi Weinberger charges the other companies with using trust methods to control the matzo market.

Philip Halperson, for fifteen years a matzo dealer who admits who worked for a year helping Rabbi Weinberger prepare the case against the "trust," asserted that all matzos are alike in qual-"Various matzo bakers have told me that all matzo bakers in America buy the same flour from the same firms. They say there is only one grade of Passover flour.'

Judge Hyman I. Reit, attorney for the Manischewitz' interests, cross-examining Mr. Halpersen, brought out that Halperson was not aware of the fact that the Manischewitz Company bought no flour at all from the dealer Halperson had named. "As a matter of fact," said Judge Reit, "you know that there are several grades of flour for Passover baking." At this point, Judge Knox reached for one of the score of packages of matzo, matzo crackers, matzo meal and matzo cake, spread on a table before him. He got out his pen knife and cut open the package. Attorney G. A. Rogers, for Rabbi Weinberger, said "why don't you try some of our product too, Judge." The Judge bit off a piece too, Judge." One juror announced that his father had been a rabbi and wanted to know whether matzo made by machine was kosher as oil is used in oiling the machinery. He was reassured when told that all matzo factories employ rabbis to see that the matzos are baked according to ritual. The judge, it was observed, did not stop eating after he had nibbled a few samples, but continued and consumed several cakes of matzo. He would not, however, say which brand he preferred.

Philadelphia, Dec. 10-In twenty Jewish communities throughout the State of Connecticut and in seventeen communities in Eastern Pennsylvania, an effort is now being made by the National Committee of One Thousand to expound the program of the United Synagogue of America, and to increase its membership, according to a statement given out today by A. B. Cohen, national chairman.

The National Committee of One Thousand was organized several months ago for the purpose of stimulating interest in traditional Judaism throughout the country, and more particularly to lend aid and encouragement to the smaller communities in the furtherance of their Jewish religious endeavor. In the course of the past several months regional conferences were held in Phila-delphia for the Jewish communities of Eastern Pennsylvania and in Hartford for the Jewish communities of Connecticut

Rabbi Charles I. Hoffman of Newark is arranging a conference for the lewish communities in New Iersey to take place in Newark all day Sunday, December 28th. Out of this conference it is hoped will come a state-wide organization, given over to a study of the more immediate religious needs of the smaller Jewish communities in New Jersey, and also to carry out the general gogue stands.

Vice-President Hopes Zionist Difficulties Will Be Settled

The hope that the difficulties that today face the Zionists in regard to Pales tine as a result of the issuance of the recent new declaration of British policy would be satisfactorily settled was expressed in a message by Vice-President Charles Curtis to the New York Zionist Region, made public here today by Jonah J. Goldstein, to whom it was addressed.

It had been expected that the vice-

president would be able to attend the Maccabean festival which will be held by the New York Zionist Region at Madison Square Garden on Saturday night, December 13th as "a demonstra-tion of Zionist sentiment and solidarity" combined with a celebration of the traditional Chanukah festival.

The message, addressed to Mr. Goldstein, chairman of the Maccabean Festival, of which Nathan Straus is honorary chairman, reads as follows:
"I have your kind invitation of recent

date and regret very deeply a previous engagement prevents me from attending the Maccabean Festival to be held on

Saturday evening, December 13th. "I wish you would extend to those who attend my best wishes for their

success in rebuilding the Tewish National "Hoping all difficulties in regard to Palestine will be satisfactorily settled,
