#### Einstein Sees Unity of Jews Not Political But Resting Only on Moral Tradition

The unity of Jews the world over is no wise a political unity and should never become such but rests exclusively on a meral tradition, declared Prof. Abelian Company of the professional control of the professional control of the professional professional production of the professional production of the production of the productional hookup of the National Broadcasting Company under the auspices of Avukah, the American Student Zionist Federation.

Professor Einstein was introduced to the radio audience by Gorge M. Hyman, executive secretary of Avukah, who recently returned from Palestine where he acted as registrar of the Hebrew original manuscript of the Professor Giginal manuscript of the Professor Einstein's Theory of Relativity. December 24th to 28th Earlier in the day Professor Einstein Was officially welcomed at City Hall by Mayor Walker, a repetition of the honor visit to America in 1921. A special reception committee consisting of 60 leaders in science, education, journalism, religion, philinathropy and Jewish communal life headed by Nicholas Murray Butler, was named by Mayor Walker.

The full text of Professor Einstein's radio address follows:
"My dear friends:
"I am very happy to have the oppor-

tunity to speak a few words directly to the youth of this land which has remained true to Jewish ideals.

"Do not, I ask of you, allow yourselves to be discouraged by the difficulties which seem to face us at present in Palestine. Such experiences are the tests of the Jewish people's will to live.

"Undoubtedly certain statements and measures, taken and pronounced by British officials have been just subject for criticism. We can not, however, be satisfied with this, but we must learn the lesson of what has recently happened.

#### Sejm Rejects Jewish Deputies' Committee Assignment Plea

Warsaw, Dec. 13—The rules committee of the Polish Sejm today rejected the demand of the Jewish parliamentary clan to give the Jewish club representation on the Sejm committees despite the fact that the club has not the ten members required for such representation. This means that Jewish participation in the work of the Sejm's committees is dependent on the good-will of the chairman of each committee.

#### German Censor Board Bans Play by Jewish Author (lewish Telegraphic Agency)

Berlin, ec. 13—The play Marriage, by the well-known Jewish author, Arthur Doeblin, was prohibited today by the board of censors, which appears to be falling under the influence of the National Socialists. Their disturbances promptled the suppression of the American film, All Quiet on the Western Front.

The play itself is not objectionable, treating marriage from the moral point of view and recognizing family life. The only objection appears to be that its author is a Jew. Thomas Mann, Nobel Prize winner for literature, when informed of the ban, declared that the censors' act "could be considered comical if it were not so shanneful."

#### Meyer Named Under-Secretary of Commerce in Steeg Cabinet (Jewish Telegraphic Agency)

#### Deputy Blames Government for Galatz Disturbances; Charges Police Inactive (Jewish felegraphic Agency)

Bucharest, Dec 13—The Rommanian government was charged with direct responsibility today for the recent anti-semite student disturbances at Galatz and Braila. In an interpellation to Premier Mironescu in Parliament to-day, Michael Landau, Jewish deputy, blamed the government for the troubles to the student congress by granting free railway fare.

Deputy Landau accused the police of remaining inactive during the riots while the students' leaders who organized the disturbances have gone unpunished. Pointing to the growth of anti-Semitic agitation in the last fortnight, Deputy Landau asked the Premote of the word of the step of the state of the sta

# High Reich Official Condemns Hitlerite Attack on Jews; Denies Capitulation to Nazis (Iewish Telegraphic Agency)

Berlin, Dec. 13—Condemning the attacks on Jews during the demonstrations against the American-made talking picture, All Quiet on the Western Front, one of the highest officials in the German foreign office today denied to the Jewish Telegraphic Agency that the government had capitulated to the Hillerites by ordering the picture withdrawn from the Hollendorplatz theater.

The official, who preferred to remain anonymous, pointed out that as one who had seen four years of war in the front line, he does not find the film version of Remarque's book a pacifistic influence. "It displays only the raw sides of war but omits the heroism of the participants and hence those who took part in the war feel insulted.

# 1,923 Jewish Immigrants Entered Canada in 5 Months (Jewish Telegraphic Agency)

Montreal, Dec. 13—In the last five months 1923 Jewish immigrants were admitted to Canada, according to figures made public today by the Jewish Immigrant Aid Society of Canada. During this period the Society was instrumental in obtaining favorable decisions in 74 cases of rejections at overseas ports and at Canadian ports. Seven Jews were deported during this period.

Few immigrants of other nationalities are now coming to Canada because of the new restrictive regulation. Jewish immigrants are still permitted to enter under permits granted them before the restrictions became operative. This permit will expire in February.

The 1923 Jewish immigrants were

distributed in the Canadian provinces as follows: Quebec, 845; Ontario, 708; Manitoba, 228; Saskatchewan, 61; Alberta, 37; Nova Scotia, 17; New Brunswick, 9; British Columbia, 18.

#### Berditchev, Once 100 Percent Jewish City, Now Russified

Moscow, Dec. 13-Berditchev, once almost a hundred percent Jewish city, is now completely Russified, the Charkoy Viddish Communist daily. Shtern. complains today. The paper discloses that the Berditchev Soviet has ceased to publish its orders in Yiddish as hitherto, the Jewish court which handled 200 cases a month in Yiddish is now practically dissolved because the judge says he understands no Yiddish and conducts the sessions through an interpreter.

The Shtern points out that the Iewish stafe attorney has been replaced by a non-lew and the militia which formerly conducted its activities chiefly in Yiddish now uses Russian. Even the facers, are managed in Russian instead of in Yiddish.

Voicing concern at this assimilationist policy, the Shtern blames the Jewish Communists for it, saying that Berdit-Communists from Moscow and Charkoy who are ashamed of Yiddish. Brazilian Immigration Ban (Jewish Telegraphic Agency)

Rio de Janeiro, Dec. 13-The exact effect of the Brazilian government's announcement of vesterday, that it was planning to bar all immigration from Europe for six months to solve the unemployment crisis, on Jewish immigration is not yet known. It is not expected, however, that the gates will be closed to relatives of immigrants already here and to those with sufficient capital to maintain themselves.

Between 1,500 and 2,000 Jewish immigrants are coming to Brazil every six months. The total Jewish population of the country is about 40,000

#### Hitler's Aide Attacks Him for Preaching Racial Anti-Semitism (Jewish Telegraphic Agency)

Berlin, Dec. 13-An attack on Adolf Hitler, National Socialist party leader, by Captain Ehrhardt, one of his chief lieutenants, in today's Boersen Zeitung, created a sensation here. Ehrhardt's vigorous attack on the Fascist chieftain has aroused particular interest not only because he was the military leader of the abortive Munich putsch but because his anti-Hitler stand marks a further split in the Nazis' ranks and indicates that Hitler is losing some of his effec-

Ehrhardt describes Hitler as "an unscrupulous demagogue who bases his teachings on anti-Semitic and racial hatred while members of his own party are radically inferior. On the one hand Hitler preaches high morals and on the other he declares that if the Nazis de-mand morality then they will be unable to attain favor with the masses."
