ANNUAL ANTI-PASSOVER CAMPAIGN ANNOUNCED IN MOSCOW: MORE MODERATE THAN EXPECT TO BE PACKED FOR PURIM SERVICES.

Noscow, Feb. 28th. (Jewish Telegraphic Agency).

The annual anti-Passover campaign in the Soviet countries, the commencement of which is announced to-day by the Yiddish Commun-Cist daily "Emess" here, looks like being much more moderate than in previous years, aiming rather at utilising the campaign period for the intensification of the Jewish land-settlement and industrialisation movement than at militant anti-religious activity.

The anti-religious Jewish youth is urged by the "Emess" to-day to make use of the month still left till passover for the purpose of carrying on with greater vigour the Jewish colonisation: campaign and other campaigns directed towards the migration of Jews from the small towns to the areas of Jowish agricultural settlement in the Crimes and Bureya and the placing of Jows in industry. The "Emess" links up the compaign with the anti-Rassover activity by accusing the Jewish clergy of sabotaging the transmigration and productivisation movement among the Jews, but no definite onslaught is made so far on the religious institutions as such.

Meanwhile, Jews in Mescow are baking matzeth from flour which they have saved up for the purpose through the entire winter-The bakeries are charging 40 roubles for baking a pood of matzeth, and official licences have been issued to the bakeries which are working in day and night shifts to enable them to cope with the demand.

There is every indication also of the synagogues being filled for the Purim services and big Purim concerts are being arranged.

Last year the anti-Passover campaign coincided with the storm created all over the world in connection with the arrest of the Minsk Rabbis, and the League of the Godless pointed to this fact in the instructions which it issued to its members with regard to the method of conducting the anti-Passover campaign, urging that on this account the fight against religious sentiments among the Jews in the Soviet countries should be made more aggressive than ever in retaliation for the anti-Soviet campaign of the Rabbis abroad. The "Emess" called upon the Jews to give up voluntarily all objects in their possession intended for religious purposes to the Industrialisation Fund and to resign collectively from membership of the Jewish religious communities in all places where such communities still exist.

"bout that time, however, influenced by the world-wide protest movement against the persecution of religion in the Soviet Union, it is believed, the Central Committee of the Communist Party ordered the discontinuation of the practice of closing down places of worship under the pretext of a fictitious voluntarily-expressed desire of the local population and a slowing-down of the anti-religious movement generally. The Jewish Communists thereupon suddenly dropped their previous aggressive anti-Passover agitation, and the "Emess" for instance suggested that it would be advisable to stop going about collecting religious articles and to leave it to the owners of these articles to bring them along themselves if they wish. Make no noise read the headline over an article appearing at the same time in the Bezhozhnik! (the Godless), the chief organ of the League of the Godless, instructing its members to refrain from holding anti-religious carnivals, demonstrations or meetings outside the synargogues or churches during Fassover or Easter, and to abandon them

If they had already been arranged. When Passover came, the synagogues in Mosdow and other towns were peaked, and the Seder was celebrated in many homes without being disturbed in eary way by anti-religious obstructions or street demonstrations. Hundreds of people stood in quaeues outside the offices of the Moscow Synagogue during the last few days before Passover to obtain metzoth, which were sold at two roubles a pound to those who could pay and were given away free to those who could not. The "Oktiabr", the Jewish Communist organ in Kinsk, published a list of Jewish members of the Communist party, who had been discovered to have secretly bought metzoth. Reports from Minsk, Charkoff, and other cities stated that not only Jewish artisans but also Jewish factory workers and even members of the Communist Party had boucht metzoth and were observing Passover.

BUNDIST LEADER ABRAMOVITCH CENTRE OF SOVIET ATTACK IN CONNECTION WITH NEW SOVIET STATE TREASON TRIAL IN MOSCOW.

New York, Feb. 28th. (Jewish Telegraphic Agency).

The Bundist leader Raphael Abramovitch is the centre to-day of the furious denunciations of the agents of the Second International and of world bourgeoisie, which are appearing in the Soviet papers, particularly the "Fravda" and the "Emess", in connection with the big State trial which opens here on Sunday against fourteen persons (six of them Jows) accused of Menshevik counter-revolutionary activity.

ABRAMOVITCH SWEARS HE WAS NOT IN RUSSIA IN 1929 AS ALLEGED IN ACT OF INDICTMENT: NOT PUT MY FOOT ON RUSSIAN SOIL SINCE NOVEMBER

ROUMANIAN ANTISEMITISM ON TRIAL: WHY PROSECUTE CODESANU AND HIS FRIENDS FOR ACTS AND IDEAS WHICH ALMOST ENTIRE ROUMANIAN YOUTH SHARE COUNSEL FOR DEFENCE ASK.

We are leading a patrictic national revival movement by legal methods and not by meens of terrorism and amerchy, Codreanu, Danila, Totu, Motza, Lofter (said to be a natural son of Professor Cuza), and the other leaders of the antisemitic organisations, the Iron Guard and the Archangel Michael insisted to-day, when the trial was opened against them here, on a charge of plotting to overthrow the Government by force of arms and to establish an antisemitic dictatoriships It is possible, they admitted, that exaggerated language is used in some of our pamphlets, but we repudiate the accusation of anarchy brought against us.

Constantin Dumitresou, the student who is under arrest for attempting to murder M. Socor, the editor of the "Adeverul", was

called as a witness and made a similar declaration.

The Public Prosecutor, M. Procop Dumitrescu, contended

in the course of a long statement, however, that there is no ground whatever for doubting the guilt of the accused. They had committed a breach of the Eureseou Law (known as such because it was enacted by M. Marzescu when he was Minister of Justice in the Eratianu Government), which makes it a punishable offence to engage in incitement likely to lead to a breach of the peace, thus endangering the security of the State. He demanded that the court should find them \$\$11187, and sentence them according to the gravity of their orimes.

JEWICH MACCABEANS ALSO WEAR UNIFORMS AND WORK FOR REVIVAL OF JEWISH
NATION SAYS PROFESSOR ANTONESCU: WHY SHOULD ROUMANIAN STUDENTS
BE PROSECUTED FOR SAME THING:

Profesor Antonesou, a well known jurist who has not been known as sympathetic to the antisemitic movement, appealed to the court to-day for an acquitted, unging that the accused are idealists, and should therefore be given exceptional treatment. Referring to the charge against them that they were uniform and regarded themselves as a militarist organisation, he said that the members of the Jewish Sports Organisation, laccabes, also wear uniforms. Fe had nothing against these Jews working for the renaissance of the Jewish nation and he could not understand why Roumanians should be presecuted for wanting to do the same thing for the Roumanian nation. Profesor intensecu complained of the activities of the Jewish Préss abroad, which is spreading alarm without any real reason, he said.

On leaving the court, Professor Antonescu was cheered by a crowd of students, but a number of other people attending the trial eanted to know how it was that a reputed sympathiser with the Jews !

should come to defend Codreanu.

The trial has been adjourned till next week, when the verdict will be announced.

CUZIST CONGRESS PASSES OFF QUIETLY.

Bucharest, Feb. 27th. (Jewish Telegraphic Agency).

The Congress of the League of Christian National Defence, of which Professor Cuza is President, was held to-day at Suoro-Jinetz, a large number of peasants from neighbouring villages being present, including many Ukrainians and Germans. George Cuza, son, a priest named Iliutz, and other speakers appealed to the members of the Christian minorities in Roumania tenter the Cuzist League. Trey did not intend to kill or rob the Jews, they said. They only wanted an opportunity of free development for the Christians, and they wanted capital to be distributed among the peasants in the same way as the land was distributed omong them after the agrartan reforms.

No incidents have occurred in connection with the Congress. Professor Cuza and the other leaders of the League had pledged themselves that order would be maintained, and in addition the Government had provided for all eventualities by drafting strong forces of police and gendarmerie into the district to show that they were prepared and were strong enough to put down any disturbances.

Warsaw, Feb. 27th. (Jewish Telegraphic Agency).

The Senate, as was anticipated, passed to-day in plenary session the Government Bill for the abolition of the Czerist restrictions. Owing to the fact that a few slight changes have been made by the Senate in the text of the bill, it cannot enter into force immediately, as it would have done had the bill been passed without amendment. It will now go again to the Seym to obtain the approval of the Lower House to the Bill as it now stands. This is expected to be done in the next few days, and no difficulty is looked for in this quarter, so that probably by next week the Czarist restrictions in Foland will have ceased to exist.

Senator Mendelsohn, a prominent member of the agudath Isrcel, who was elected as a member of the Government Farty, and is the only Jew-in the present Senate, delivered a speech in which he thanked the Government for its energetic action in proceeding immediately it had obtained an independent majority to bring about the abolition of the Czarist restrictions against the Jews;

BRITISH POLICY IN PALESTINE: PRIME MINISTER'S LETTER TO DR. WEIZMANN INTERPRETING WHITE PAPER RECEIVED BY INTERPRETING WHITE PAPER P

Geneva, Feb. 28th. (Jewish Telegraphic Agency). The League of Nations Secretariat has received from the British Government copies of the letter addressed on the 13th. inst. by Mr. Ramsay MacDonald to Dr. Weizmenn constituting the official British interpretation of the Palestine Unite Paper issued in October, of the British policy in Felsetine, for distribution among the members of the Permanent Mandates Commission of the League of Nations and of the League of Nations and of the League of Nations Council, the J.T.A. representative here learns.

There will be no doubt of the official character of the letter, Mr. MacDonald said in the House of Commons on the eve of its publication. It will be communicated to the League of Nations and embodied in the dispatch as an instruction to the High Commissioner.

In consequence of the decision of the last session of the League of Nations Council held in January not to summon an extraordinary meeting of the Mandates Commission, the White Paper and the Hope-Simpson Report will not come up before the Mandates Commission until its next ordinary meeting in June, and the members will by then have had ample time to study the new Government letter of interpretation, where in the case of the White Paper itself it had to postpone its consideration because it had been received by the members of the Commission only "a few days before the opening of the session, too late for their perusal".

The fact that the Government letter of authoritative interpretation of the White Paper will already be available for the members of the Mandates Commission at the same time that the Commission will be considering the White Paper relieves the members of the Commission of the task of interpreting the White Paper for themselves.

EMIR ABDULLAH OF TRANSJORDAN PLEASED WITH PROCRESS OF DEAD SEA WORKS.

BLFTISED HUNG-RIAN JEW EDITING HITLER'S CHIEF ORGAN "VOELKISCHER BEDEACHTER": DISCOVERED BY HUNGARIAN JOURNALISTS VISITING MUNICH: THE MAN WIGGE ALLEGED INVERVIEW ONCE CAUSED ARREST OF CHIEF RABEI LOEW OF SZEGEDIN.

Adolf Hollaender, a Bungarian Jew, who some years ago became baptised, adopting the name of Alexander Hollosi, has been discovered by a party of Eungarian journalists visiting bunich acting as one of the editors of the chief Hitlerist organ there, the "Voelkischer Beobachter".

Hollosi came into notoriety about ten years ago, when he published an alleged interview with Chief Rabbi Emanuel Loew of Szegedin, who is now one of the two representatives of the Jewish Faith in the Eungarian Upper Chamber, in which he reported the Rabbi to have made treasonable statements against the Hungarian State, as a result of which Chief Rabbi Loew was kept for some months a prisoner in his home. It was finally proved, however, that Hollosi had invented these statements, and he soon afterwards disappeared from the country.

The Hungarian papers are making a good deal now of his discovery as one of the chief editors of the leading organ of Hitler-
