Details of \$12.500,000 Palestine Development Scheme Made Public: Includes Register of Displaced Arabs and Inquiry Into What Lands Available for Close Settlement of Jews

(Jewish Telegraphic Agency)

LONDON, July 20—The details of tain inter alia what state and other the \$12,500,000 Palestine land settle- lands are, or properly can be made, ment and land development scheme were made public today simultaneously in London and in Jerusalem. In London the scheme was outlined to the House of Commons by Dr. Drummond Shiels, under-secretary of state for the colonies, while in Jerusalem the plan was promulgated through the publication of the scheme itself together with a covering letter from Lord Passfield, colonial secretary, to High Commissioner Chancellor.

In brief, the scheme provides for the preparation of a register of such Arabs as can be shown to have been displaced from the lands which they occupied in consequence of the land passing into the hands of the Jews, and who have not obtained other holdings on which they can establish themselves, or other equally satisfactory occupation. In preparing the register the director is to have the assistance of the legal assessor, whose duty it will be to scrutinize claims and to advise the director as to the sufficiency of evidence in each case before the claim is admitted.

On the basis of this register, the di-rector of development is to draw up a scheme for the resettlement of the registered, displaced Arab families, together with an estimate of the cost of such resettlement, which is to be carried out as quickly as possible, after the High Commissioner of Palestine

has approved the scheme. Follows MacDonald Letter

The director of development is also empowered to investigate the methods to be adopted to give effect, within the limits of the funds available, to the British government's intention, (as promised in Premier MacDonald's letter to Dr. Chaim Weizmann on February 13, as soon as possible to ascer-

Roumanian Jewry Anxious at Appointment of 2 Anti-Semites (Jewish Telegraphic Agency)

BUCHAREST, July 20—The appoint-ment of Nichifor Robu, anti-Semitic member of parliament, as the government investigator of peasant conditions in Bukowina, and the naming of the anti-Semitic Deputy Valeriu Popp as minister for Transylvania, today created considerable anxiety in Jewish circles throughout Roumania.

The Jewish press voices anxiety lest Robu utilize his position for spreading anti-Jewish agitation while the same fear is manifested with regard to Popp since conditions in both Bukowina and Transylvania, centers of large Jewish populations, are especially unsettled.

Commons to Debate Development Plan When Report Is Submitted (Tewish Telegraphic Agency)

LONDON, July 20-A special bill will have to be passed by the House of Commons before the Palestine development scheme, details of which were announced today in Jerusalem and London, can be put into effect in order to guarantee the loan of \$12,500,000 which will finance the scheme. This became clear today from questions and answers exchanged in the House of Commons between Ormsby Gore, M.P., and Dr. Drummond Shiels, under-secretary of state for the Colonies, after the latter had given the details of the scheme to the House of Commons.

This means that Parliament will be given an opportunity to debate the scheme. When Michael Marcus, Labor M.P., pointed out that the scheme which was to be published in Palestine on July 9 had been temporarily suspended and asked whether the government still intended to submit the scheme to Parliament before proceeding with it, Dr. Shiels at first avoided answering the latter part of the query. Later, however, it became clear that only when the director of development has submitted his report would an opportunity be given for a parliamentary debate.

Early Visit of Sokolow To United States Possible (Tewish Telegraphic Agency)

BASLE, July 20-The likelihood of an early visit to the United States by Nahum Sokolow, the newly-elected president of the World Zionist Organization, became a distinct possibility today when the American delegates to the Zionist Congress, which has just concluded, conferred with him regarding a trip to America.

At the conference it was decided that as soon as the American delegates re-turned to the United States they should immediately consult the administrative committee of the Zionist Organization of America in order to make the necessary preparations for the visit of Mr. Sokolow. The American delegates assured Mr. Sokolow of their energetic support of him as well as of the entire Zionist Executive.

Meanwhile Mr. Sokolow has been flooded with congratulations from all parts of the world. Today he received cabled congratulations from Justice Louis D. Brandeis of the United States Supreme Court, James de Rothschild, son of Baron Edmond de Rothschild, the nestor of Palestinian work, the Jewish National Council of Palestine, Col. Frederick Kisch, chairman of the outgoing Zionist Executive, numerous university professors and the Polish and Czecho-Slovakian governments.

Rabbi Noach Zaludkowski Noted Cantor and Scholar, Dead

(Jewish Telegraphic Agency) DETROIT, July 20-Rabbi Noach "Lider" Zaludkowski, famous cantor, Talmudist and for more than 40 years chief cantor of the main synagogue at Kalisz, Poland, is dead at the home of his son here at the age of 72. Born in Dvoretz, Grodno district, Lithuania (formerly Russia) Rabbi Zaludkowski

was the son and grandson of rabbis.

At the age of 13 he received his rabbinical degree from the Volozin rabbinical seminary. Gifted with a marvelous voice he turned his attention to hazonuth (liturgical singing). Not only is he known as one of the greatest of cantors but he was also the teacher of scores of other cantors and choir leaders. Hundreds of his compositions are now sung in the greatest Orthodox synagogues of Europe and America. Rabbi Zaludkowski's entire family is

intimately connected with the synagogue. intimately connected with the synagogue, and Baychester Road, the Brot His widow is the only daughter of Rabbii Joseph Moshe of Metshet, the financial control of rabbis. The name "Lider" came to Rabbi Za-Judkowski as a result of his having been cantor in the town of Lida. He was also cantor in the leading synagogues of Vilna, Brest-Litovsk and Wolkowysk.

Former Supreme Court Judge Newburger Dies at 78 (Tewish Daily Bulletin)

PLATTSBURG, N. Y., July 20-Former Supreme Court Justice Joseph E. Newburger died here yesterday in his seventieth-eighth year. His death was due to heart disease, for which he had been undergoing treatment in a local hospital during the past month.

Justice Newburger was born on the East Side of New York, the son of Emanuel and Lottta Newburger. was graduated from the Columbia Law School in 1874, was admitted to the bar the same year and practiced in New York until 1890. After joining Tammany Hall and running unsuccessfully for the assembly, he was elected to the city court in 1890. From then on he served on the bench without interruption until 1924, when he retired on reaching the 70-year old age limit

In 1895 Judge Newburger was elected for a ten-year term as Judge of the court of general sessions, being subsequently nominated by three parties and elected Supreme Court Justice. His first term as Supreme Court Justice ran

until 1919 At the conclusion of that term, Jus-

tice Newburger found himself at odds with Charles F. Murphy, then leader of Tammany Hall, which refused to give him a renomination, nominating Irwin Untermyer instead. This aroused protests from Justice Newburger's friends. from the Bar Association and from the newspapers. He was then nominated by an independent group and by the Republicans and was re-elected Supreme Court Justice, getting 80,000 more votes than his Democratic rival

Justice Newburger was active in Jewish philanthropic work, having served for many years as a director and later as president of the Hebrew Orphan Asylum. During his presidency the Hebrew Orphan Asylum purchased a 193-acre site at 233rd Street and Baychester Road, the Bronx, to replace the home at Amsterdam Avenue and 137th Street, which then cared for more than 1,000 children. He was also active in Masonic and Odd Fellow

To Make Burials on Sunday (Jewish Telegraphic Agency)

LONDON, July 20-After a good deal of protest on the part of members of the city council, the Jews of Sunderland, a city in northern England, were today granted permission to make burials on Sundays. Although the city council's cemetery committee had recommended that the request be granted some members of the council objected on the ground that it was an attack on Christian principles. Morris Sigman, Jewish Labor Leader, Dies Suddenly at 51 (Jewish Daily Bulletin)

STORM LAKE, Iowa, July 20—Mor-ris Sigman, former president of the In-ternational Ladies' Garment Workers Union, died suddenly of heart disease at his home here yesterday. Mr. Sigman was 51 years old.

Mr. Sigman was one of the leading

figures in the development of the Jewish labor movement in this country. having played a prominent part in the organization of the Jewish needle workers in trade unions. He came to America in 1903 and started his career as a presser in East Side sweat shops. After a few years he became active in the Cloakmakers' Union and in 1910 he was one of the leaders of the cloakmakers strike, being chairman of the picketing committee

After occupying various important offices in the Cloakmakers' Union, Mr. Sigman became president of the Inter-national Ladies' Garment Workers Union, which includes the cloakmakers. For six years he was president of the I. L. G. W. U. During that time he was the storm center of the fight between "rights" and "lefts", or Socialists and Communists, for the control of the Union. He sided with the "rights" and finally succeeded in having the Communist element ousted from the Union In 1928 he resigned as president of the Union, retiring to his farm in Iowa

(Jewish Telegraphic Agency) PRAGUE, July 20-Czecho-Slovakian Jewry has been tremendously aroused by reports in the leading Prague papers that it was the Jews who attacked the Greeks in Saloniki instead of the other way around. Ceske Slovo, the organ of Eduard Benes, foreign minister, and the Prager Presse, semi-official spokesman for the foreign office, are the papers that published the offending re-

Under the headline "Jews Make a Pogrom Upon Christians," the Ceske Slovo declared that "in the Jewish suburb of Solun there occurred last jured on both sides. Governor Gonatas of Macedonia declares that the conflict was caused by Jews and that most of the injured are Christians."

In similar vein the Prager Presse reported that "Jews in the Kalmaria quarter attacked a soldier who was forced to call for aid from his col-leagues. German Tennis Federation's Disciplinary Board Upholds Daniel Prenn's Suspension

(Jewish Telegraphic Agency) BERLIN, July 20-The disciplinary board of the German Tennis Union today confirmed the action of the Union in suspending Daniel Prenn, Germany's outstanding net star, for six months on the chage that he had demanded money from Hammer & Co., racket manufacturers, for using their rackets. The action of the disciplinary board is considered especially surprising in view of the fact that in Prenn's libel action against Hammer & Co. the charge against him was found to be untrue.

The Democratic press and Jewish sporting circles are convinced that the disciplinary action against Prenn based on nothing but anti-Semitic malice and is part of an effort to expel him from the ranks of tennis amateurs because he is a Polish-born Iew. claimed that the charge against him was the result of his preference for rackets other than those made by the Hammer

As a result of his suspension Prenn has lost all of his titles as well as his amateur standing. He was also prevented from representing Germany in the Davis Cup tournament in which he had previously scored victories for Germany.

Harry Meissner Heads School Board of Milwaukee (Jewish Daily Bulletin)

MILWAUKEE, July 20-Harry V. Meissner, local attorney and vice-president of Temple Emanu-El B'ne Jeshurun, has been elected president of the Milwaukee school board. Mr. Meissner, who has been a member of the board since 1925, has been a director of the Federated Jewish Charities, an officer of the county Red Cross and active in other civic movements.

Mr. Meissner is to rule over a board Mr. Meissner is to rule over a poard divided between seven non-partisans and seven Socialists. Possessing the strategic vote, Mr. Meissner has an-nounced he will disregard political distinetions and vote for the general good of the school system.

Seminary Creates Graduate College of Jewish Studies

Plans have been perfected for the establishment of the Seminary College of Jewish Studies at the Jewish Theo-logical Seminary of America, according to an announcement made today. The College is authorized to grant the de-gree of Bachelor of Hebrew Literature, which will be granted to those attendwhich will be granted to those attend-ing the College for four years, taking the prescribed courses in Bible, His-tory, Hebrew, Talmed, Religion and Jewish Philosophy. The College will be open only to those who are graduates of both a those who are graduates of both a Bebrew and a secular high school or

French Named Director
Yesterday, the Colonial Office announced that Lewis French, a retired official of the Indian Civil Service and former Chief-Secretary of the Punjab, India, has been appointed director of the Palestine development scheme. The scheme, which has been the subject of long negotiations between the Tewish Agency and the British government, was supposed to become operative on July 9, a despatch to this effect having been sent to High Commis-sioner Chancellor on July 8 by the Colonial Office, together with a covering letter from Lord Passfield, colonial At the last minute the promulgation of the scheme was postnoned.

The first announcement of the scheme was made in the House of Commons on November 17, 1930 by Dr. Shiels, in the course of the parliamentary debate on Palestine. In his statement Dr. Shiels declared that the scheme would provide for the settlement of approximately 10,000 families at an expenditure of not more than \$12,500,000 for works of a productive nature, such as irrigation and drainage. He further said that the plan was intended to provide for landless Arabs who may have been dispossessed "as the result of land passing to the Jews' while the balance of the fund to be provided was to be made available for the settlement of both Jews and Arabs.

In a statement to the Mandates
Commission of the League of Nations on June 16, 1931, Dr. Shiels gave further details of the development scheme, saying that "a comprehensive scheme of development is called for both in the interests of the Arab and Jewish communities and in fulfilment of the responsibilities which His Majesty's Government has for the general welfare of Palestine.

New Probe Planned

Subject to the necessary provisions for control, consultation and advice, the administration of the scheme will be placed in the hands of an officer to be appointed under the title of director of development, Dr. Shiels told the Man-dates Commission. He further stated that in carrying out the policy of de-velopment the British government had no intention of governing its procedure by any assumptions based on existing estimates of facts and figures but on the basis of a new investigation to be made on the spot by the development authority whose recommendations would be framed in the light of the facts so ascertained.

Two Jewish Agricultural

(Tewish Telegraphic Agency) OMSK, Siberia, July 20-Two Jewish Thomashefsky Touring Jewish agricultural collectives have been organized near Omsk by former Jewish traders. One collective, called "Liberty and Fraternity," is located about 25 miles from Omsk. It includes some 45 Tewish families, all of them former nepmen in Omsk. In 1927 they were granted a considerable tract of land. Each family has contributed 600 roubles to the collective which now

owns four tractors. The second collec-tive, known as the "First of May," consists of twenty families. Both collectives consist of former

traders who turned to agriculture after wearving of the burdensome taxes and restrictions of the Soviet government. The Ozet, the society for settling the Jews on the land, has aided the two collectives.

First Reform Congregation Organized in South Africa (Tewish Telegraphic Agency)

BERLIN, July 20-The first Reform Jewish congregation has been organized in South Africa, Miss Lily Mon-tagu, secretary of the World Union for Progressive Judaism, reported to the executive committee of the Union here. About a year a go the initial Reform congregation was established in Melbourne, Australia under the ministry of Rabbi Jerome Mark, formerly of Selma, Alabama. The first confirmation in the Melbourne congregation was recently held, Miss Montagu reported.
