"I deeply deplore the loss of a highly valued colleague who throughout life rendered great and distinguished ser-vice to American and world Jewry." Mr. Goldsmid said.

Seek Probe in Disappearance Of Two Palestine Jews

(Jewish Telegraphic Agency) IERUSALEM, July 27-The Polish and German consuls here were urged today by relatives of the two missing young Jews, Johannan Stahl and Saliah Zohar, German and Polish citizens respectively, to intervene with the Palestine government for more effective search for the young Jews. Stahl and Zohar disappeared about a month ago in Tel Aviv while on an excursion.

Shaw Sees Intermarriage as Solution to Jewish Problem (Jewish Telegraphic Agency)

MOSCOW, July 27-The conviction that ultimately intermarriage will end the distinction between Iew and Christian was expressed here today by George Bernard Shaw, world famous critic and playwright, in an interview with the Jewish Telegraphic Agency, his first public expression of his views on the ultimate solution of the Iewish problem.

Mr. Shaw made his statement after a week of observation, among other things, of race matters in Moscow. Having said that much in all seriousness, Mr. Shaw added jestingly that of the Jewish question is for the Jews to lose their superiority complex. "The Jews must discontinue believing themselves superior to other races, even if sometimes they have justification for thinking themselves so," he declared.

Rabbi Fineshriber said: "Dr. Frankel Ludwig Singer, President of Czech Jewish National Council, Parliament Member, Dead (Jewish Telegraphic Agency)

PRAGUE, July 27-Dr. Ludwig Singer, member of the Czecho-Slovakian parliament, president of the Jewish National Council of Czecho-Slovakia and one of the outstanding Jews of Czecho-Slovakia, died here today of a heart attack. He was 55 years old

Born in Kolin, Bohemia, Dr. Singer was educated at the Universities of Prague and Jena. Shortly after his graduation he entered the service of the Austro-Hungarian government, being stationed at Reichenberg, Hohenelbe and Prague. He left the government service in 1909 to open a law office. Two years earlier he had associated himself with the Zionist movement.

As chairman of the Zionist district As chairman of the Zionist district committee, Dr. Singer led the negotia-tions in 1917 with the leaders of the newly-formed Czecho-Slovakian govern-ment, including Dr. Thomas Masaryk and Dr. Eduard Benes, regarding the regulation of Jewish national questions in the future Czecho-Slovak republic. As the outcome of these negotiations Jewish minority rights became an inte-gral part of the Czecho-Slovakian constitution following the break-up of the

Austro-Hungarian Empire.

was formed in 1918, Dr. Singer was

Weizmann Chair of Peace And International Law to Be Founded at Hebrew U.

(Tewish Telegraphic Agency) ZURICH, Switzerland, July 27-The Chaim Weizmann chair of international law and peace is to be estab-lished at the Hebrew University in Jerusalem, according to a decision reached today at the closing session of the annual conference of the board of governors and the academic council of the Hebrew University held here under the chairmanship of Prof. Leonard S. Ornstein, rector of the University of Utrecht.

The chair, which is named for Dr. Chaim Weizmann, former president of the World Zionist Organization, has been endowed to the extent of \$75,000 by Sir Montague Burton, prominent British Zionist and merchant, Sir Montague, who was recently knighted, has also established an endowment fund of \$375,000 for five chairs of peace in English universities.

Dr. Judah L. Magnes, chancellor of the Hebrew University, in submitting his report on the University's development in the last two years, declared that the institution had been hampered by a lack of funds. He submitted to the board of governors a budget of \$175,000, as compared with last year's budget of \$215,000.

The conference resolved to request Dr. Magnes, in cooperation with the Jewish Agency, to make representa-tions to the Palestine government, to facilitate the entry of Jewish students into Palestine.

Dr. Cyrus Adler, president of the Jewish Theological Seminary of America and of the American Jewish Com-mittee; Judge Julian W. Montreal Moves to Repatriate

Its Unemployed Foreigners (Jewish Telegraphic Agency)

MONTREAL, July 27 - The City Council today adopted a motion by Alderman B. Schwartz for the voluntary repatriation of unemployed foreigners and asked the federal government to make the plan effective.

Among the reasons given by Alderman Schwartz for the scheme was a desire to avoid a recurrence of last year's protest against giving work to foreigners. It is therefore better to give the latter a chance to go home at the government's expense if they wish, Mr. Schwartz said.

Mid-West Orthodox Rabbis Urge Orthodox Congregations Union

(Jewish Daily Bulletin) CHICAGO, July 27-"American Jewry is divided not as the result of varying intellectual convictions, but on grounds of social standing and personal con-venience. This is a passing phase, the result of the unstable condition exist-ing in our midst. It is unthinkable that this condition should crystallize into permanency. The battle for supremacy will eventually be fought on the intellectual battlefield. Traditional Morris Rothenberg, national chairman Jewry and its leaders must therefore of the American Palestine Campaign, continue to place greater and greater emphasis on scholarship and intellectual attainments."

This was the statement made by Rabbi Uri Miller of Terre Haute, Indiana, president of the Rabbinical Association of the Hebrew Theological College, at the seventh annual conference of the association, which took place at the Hebrew Theological College building in Chicago. Rabbi Miller deplored the prevalence of the "quackrabbi" and suggested a federation of Orthodox congregations as a means of curbing this evil. The creation of an endowment and pension fund was also recommended.

The convention was addressed by Rabbi Ch. Korb, head of the Talmudic department, who spoke concerning in-terpretations of various Talmudic con-ceptions. Dr. Meyer Waxman deliv-ered a lecture on "Types of Schisms in Judaism." A paper was read by Rabbi Jacob Greenberg, dean of the Hebrew Theological College, on "The Lunar Calendar in Jewish Law." Current vital problems confronting world Jewry were discussed by Rabbi Saul Silber, president of the college.

Resolutions were passed endorsing the five-day week; all movements promoting world peace; the organization of federated charities; condemning racial discrimination and prejudice in employment and educational institutions; against any change in the calendar affecting the fixity of the Sabbath, States, havi tion.

In urging the convention to support the Jewish Agency drive, Mr. Rothenberg declared that in spite of all obstacles placed in the path of the Palestine upbuilding work, Jews must be "steadfast in their purpose and give the pioneers who have shown such unconquerable spirit that loyal support in their labors which they so richly deserve."

City Registrar Jack Gross extended reetings to the convention on behalf of Iayor Miller. Rabbi C. H. Epstein, Mayor Miller. Leon Gellman, Dr. Alex, S. Wolf, Prof. Gustave Klausner and Mendel N. Fisher also greeted the convention. A dinner was given in honor of the delegates on Sunday night.

The convention voted to carry on an intensive membership in the future and a large sum was included in the budget for the Order's propaganda work. William H. Goldman of St. Louis reported on behalf of the credential committee. Louis Jaffie of Chicago was named chairman of the resolutions committee; Emil Friedman of Chicago, chairman of the nominations committee and A. D. Part of Arab Press Urges Development Plan Boycott (Jewish Telegraphic Agency)

JERUSALEM, July 27-One section of the Palestine Arab press today came out with a call for an Arab boycott of the Palestine land development scheme, alleging that it is a device to fructify the land for Jewish immigration. The scheme provides for a registry of Arabs made landless by their holdings passing to the Jews and on the basis of this registry a scheme for the resettlement of these Arabs is to be drawn up. The plan also provides for an investigation into methods of making available state or other lands for close settlement of Jews within the funds available.

In the meantime keen competition has developed between the two Arab factions, the Husseinis and the Nashashibis, for the position of Arab advisor to Lewis French, the director of development. The Husseinis are boosting Jamal Husseini, secretary of the Arab Executive and former director general of the Moslem Wagf, while the Nashashibis favor Elias Moghannem, prominent attorney.

Cantor Blumenfield Found Dead in Montreal Cemetery (Jewish Telegraphic Agency)

MONTREAL, July 27-Missing for two days, Cantor Mendel Blumenfield was found dead today among the graves of the local Jewish cemetery, a victim of suicide by poison. Cantor Blu-menfield was well known in Montreal, having officiated at numerous births and marriages and having conducted high holiday services for a number of years.

His suicide was attributed to failing health and straightened circumstances. He was 64 years old.

ST. LOUIS, July 27—Dr. Lee K. Frankel was mourned here today by the delegates to the 27th biennial convention of the Progressive Order of the West.

The death of Dr. Lee K. Frankel was characterized yesterday as "overwhelming" by Leroy A. Lincoln, vice-president of the Metropolitan Life Insurance Company, who had been an associate of Dr. Frankel. "Dr. Frankel was an international figure in health work and disease prevention," Mr. Lincoln declared.

Julius Simon, president of the Palestine Economic Corporation, of which Dr. Frankel was one of the founders, wired Mrs. Mark Rafalsky, Dr. Frankel's daughter, that he was "shocked and grieved over the death of your dear father. His fine public spirit, his great experience and his deep interest in the affairs of one own leaves and his untimely death will leave a gap which will be painfully felt?"

In a statement issued yesterday by the Zionist Organization of America, the passing of Dr. Frankel was mourned "as a severe blow to the manifold endeavors in Jewish communal life in which he was a leading spirit. Trained as a chemist and endowed with the vision of the tree social worker, it was perhaps inevitable that he became vitally concerned with the synthesis in Jewish life that is arising out of the recreation of the Jewish National Home in Pales-

"He was chairman of the American section of the Joint Palestine Survey Commission and was a leading factor in the acceptance of that commission's report which led directly to the creation of the Council of the enlarged Jewish Agency for Palestine in Zurich two years ago. Only eight days before his death he was elected co-chairman of that Council at its second meeting, held in

"His vision, his wisdom and his great ability will be sorely missed."

Dr. Lee Kaufer Frankel who died Saturday after a sudden heart attack at the Hotel Bristol, Paris, achieved world-wide distinction as a health authority and a leader in social service. In the Jewish world he was known for a lifetime of devotion to activities that culminated in his vigorous association

culminated in his vigorous sociation with the Jewish Ageacy for Palestine.
Dr. Frankel was born in Philadelphia on August 13, 1867, the son of Louis and Aurelia Lobenburg Frankel. He studied at the University of Pennsylvania where he obtained his degree of bachelor of science and, in 1891, the degree of doctor of philosophy. From (Cottimed on Pare 9)

1888 until 1893 he also taught at his alma mater as an instructor in the department of chemistry. For the following six years he was a consulting chemist and an associate (and later president) of the chemical section of the Franklin

Health Authority Subsequently his activities in charity organization and with the Russell Sage Foundation led to his connection with the Metropolitan Life Insurance Company. His widespread educational campaigns for the promotion of health and the extension of the life span won him a general recognition as an outstanding authority in the field. By the time he became second vice-president of the Metropolitan Life Insurance Co. his fame as an international authority was Dr. Frankel participated in numerous

activities of a public character. In 1903 he was appointed by President Roose velt to membership in the Ellis Island Commission. Another official appointment came to him as commissioner of the State Board of Charities; and still another as welfare director of the Post Office Department. Recently President Hoover selected him for the White House Conference on Child Health and

Welfare.

Dr. Frankel was a leading figure and frequently an officer in numerous health welfare associations such as the National Association for the Study and Prevention of Tuberculosis, the American Public Health Association, the Life Extension Institute, the New York Extension Institute, the New York State Conference of Charities and Correction, the Survey Associates, the National Health Council and the National Conference of Social Work. These were in addition to his activities in Jewish welfare work that constitute a chapter of special distinction in his life story.

Dr. Frankel wrote several books and numerous brochures on welfare work and health promotion. He was the au-thor of an Encyclopedia of Health, and books on The Health of the Worker, The Human Factor in Industry and Workingmen's Insurance in Europe. On his trip to Europe which was destined to be his last, he was engaged in a study of social insurance for the Metropolitan Life Insurance Company.

Active in Jewish Welfare Work

Dr. Frankel's first important as-

sociation with the Jewish world came in 1899 when he was called to act as manager of the United Hebrew Chari-ties of New York. In 1912 he was president of the National Conference of Iewish Charities. After the War when the American Jewish Relief Committee was carrying on its heroic program of rehabilitation for the Tewish sufferers in the war-ravaged districts of Eastern

ber of the Committee of Jewish Delegations in Paris. Dr. Singer was also president of the Jewish Welfare Federation, a member of the Prague city coun-cil and president of the Prague Jewish community.

Two years ago he was elected to par-liament on a combined Jewish and Polish ticket. It was at his behest that the government took prompt steps to suppress the anti-Jewish and anti-German riots which broke out in Prague last September. When a sensational blood ritual libel against the Jews of Carpatho-Russia rose, it was Dr. Singer who raised the question in parliament and fought for a government investigation which eventually cleared the Jew Dr. Singer also played a leading role

in the fight for an amendment to the new citizenship law which solved the naturalization problem of thousands of Jewish war refugees in Slovakia and Carpatho-Russia. When the National Jewish Party was founded recently, he pledged it his support, but preferred to remain a member of the Social Democratic party.

Europe, Dr. Frankel was made chairman of a special European Commission. Be-fore leaving for Europe on his last trip Dr. Frankel concluded a review of the medical work of the American Jewish Joint Distribution Committee that had saved untold lives in the Jewish com-

munities in Central and Eastern Europe. Dr. Frankel's most important as-Jewish endeavors came when he was drawn into the group cooperating with Dr. Chaim Weizmann, at that time President of the World Zionist Organization, in an effort to establish a union of Zionists and non-Zionists in a Tewish Agency for Palestine. In 1927 he was chairman of a commission of experts sent to report on Palestine conditions and opportunities to the leaders of the Jewish Agency. At the Zurich meeting that launched the Jewish Agency he emerged as a spokesman and leader of the American non-Zionists. He therefore participated in proposals for the economic development of Palestine and was one of the founders of the Palestine Economic Corporation. Last year he was one of the leaders of the Allied Jewish Campaign. In July of this year, he was elected Joint Chairman of the Council of the Jewish Agency, then in convention in Basle. In 1928 the Hebrew Union College

conferred upon him the honorary degree of Doctor of Hebrew Laws in recognition of his considerable services to Jewish causes.

Dr. Frankel is survived by his widow the former Miss Alice Reizenstein of Philadelphia, his daughter, Mrs. Richard Rafalsky and his son Lee K. Frankel, Jr. The body is being brought to this country on the S.S. Olympic which leaves Cherbourg tomorrow

Kisch, Retiring from Zionist Executive, Feted by Yishub (Jewish Telegraphic Agency)

JERUSALEM, July 27-Col. Frederick Kisch retired today as a member of the Zionist Executive and the Jewish Agency Executive after nine years of service. His retirement was marked by a reception tendered him by the Jewish National Council over which Miss Henrietta Szold, American member of the Council's administration, presided.

In his farewell address, Colonel Kisch said that in his nine years in Palestine he had seen "the Jewish community double, shared with it grief and danger, had witnessed the large immigration of 1926, the rise of the Emek settlements. and the opening of the Hebrew University.'

Pointing out that while he had not always fully agreed with the Jewish community, he declared he had always found its instincts sound. He thanked Miss Szold and Isaac Ben Zwi, secretary of the Jewish Federation of Labor, for their cooperation. Speakers at the reception included Meyer Dizengoff, mayor of Tel Aviv, M. Levin of the Haifa Jewish community, M. Golum of the Jewish Federation of Labor, M. Melt-zer of the Mizrachi and M. Schtempfer-of Petach Tikvah, one of the pioneer colonies

Shortly after the opening of the re-cent Zionist Congress, Colonel Kisch in-formed the Congress' steering committee that he did not want to be a candidate, although he hoped it would be possible for him to serve the Zionist cause in a private capacity. Colonel Kisch, who has had a distinguished career in the British military and diplocareer in the British miniary and diplo-matic service beginning in 1907, resigned from the British army in 1922 in order-to devote himself to Zionist work in Palestine where he has made his permanent home. Elected to the Zionist Executive by

the 13th Congress in 1923, he has been reelected at each biennial Congress ex-cept the last. When the enlarged Jewish Agency was created in August, 1929, he was elected a member of the Agency's Executive. In his nine years of service-he has been in charge of the Executive's relations with the Palestine government:

Colonel Kisch, who is 43, is a nephew by marriage of Sir Herbert Samuel, the first High Commissioner of Palestine.
