PALESTINE JEWS FEAR NEW POGROMS: JEWISH DELEGATION WARNS HIGH COMMISSIONER OF VIOLENT ARAB INCITEMENT: ASKS FOR SECURITY: POLICE AND MILITARY FORCES WILL SUPPRESS ANY ANTI-JEWISH ATTEMPT HIGH COMMISSIONER ASSURES DELEGATION.

Jerusalem, Aug. 5th. (Jewish Telegraphic Agency).

Arab incitement in Palestine is becoming violent, like the agitation which led to the anti-Jewish pogroms in 1929.

A Jewish delegation consisting of Colonel Kisch, Mr. Ben Zvi. Mr. Almalah, Mr. Smilansky, and Mr. Golumb, appeared to-day before Sir John Chancellor, the High Commissioner of Palestine and warned him regarding the apprehensions of the Jewish population in connection with the Arab agitation. In an interview which lasted for 90 minutes, the delegation discussed with the High Commissioner the question of general security in Palestine, and also touched upon the impending cab-drivers' strike. In reply to the arguments presented by the delegation,

the High Commissioner stated that the Palestine Government will deal with the anti-Jewish incitement carried on by the Arab press, and the military and police forces will deal adequately with any attempt which may be made in Palestine to create a dis-

turbance of the peace in the country.

In connection with the proclaimed general strike of cab-drivers, a communique was issued by the Government to-day saying that picketing will be prohibited. The Government will protect those who will pursue their normal occupations, the communique says, adding that the Government trusts that the motor-car owners and drivers will not persist in their decision to come out on strike to-morrow.

Palestine Government Warns Against Strike Of Cab-Drivers: Says It May Lead To Disturbances.

This strike, the communique says, can achieve no useful purpose and is bound to cause economic loss. It will also incur the risk of leading to disturbances of the peace.

There is no prospect of the Government granting further remission of taxation to the cab-owners as a result of the strike, it is felt here. Efforts are therefore being made by the Palestine Chamber of Commerce to influence the Union to call off the strike. Negotiations were carried on during the whole of the day between representatives of the Chamber of Commerce and the leaders of the Union with a view to avoiding the strike decision from being carried into effect.

Fear is expressed that if the strike is not called off, it may lead to serious consequences, the Arabs utilising the complete stoppage of vehicular traffic in order to carry out their threats of creating trouble in connection with their protests against the alleged arming of the Jewish Colonies by the Government.

PALESTINE GOVERNMENT WARNS JEWISH AND ARAB PRESS TO DISCONTINUE PUBLICATION OF INCITING ARTICLES: SAYS SITUATION WELL IN HAND: EMPHASIGES THAT IT IS MUCH ENTER EQUIPPED THAN IN 1929 FOR SUPPRESSION OF DISTURBANCES: DECLARS THAT IT WILL NOT ALTER ITS POLICY WITH REGARD TO THE SEALED ARMOURIES IN THE JEWISH SETTLEMENTS.

Jerusalem, Aug. 5th. (Jewish Telegraphic Agency). In connection with the tense atmosphere created in Palestine by the anti-Jawish agitation conducted in the Arab press, the Chief Secretary to the Palestine Government received to-day Arab and Jewish journalists and warned them all against publishing inciting articles in the future.

The Jewish journalists were received separately after the Chief Seoretary had concluded his conference with the Arab journalists. Addressing the Jewish pressmen, the Chief Seoretary made it clear to them that he forbade them to make any accusations in the future against the Felestine Government, that it helps the Arabs in their efforts of incidement against the Sews and in their preparations for anti-Jewish attacks. All this is not true, the Chief Seoretary stated. He then authorised the Jewish journalists to publish a statement saying that the "Government has the situation well in hand and is now equipped much better than in 1929 for the suppression of disturbances".

An official communique was also issued this morning by the Palestine Government giving the history of the sealed armouries in the Jewish settlements and declaring that the Palestine Government considers the sealed armouries as the propor measure for security. "The Government will not alter its policy with regard to the sealed armouries," the statement says. The Government requires the Arab press to discontinue its agitation in this connection, otherwise other heasures will be taken against the press, the statement warns.

CENSUS QUESTIONMAIRE PUBLISHED IN PALESTINE: CONTAINS 18 QUESTIONS.

The questionnaire for the forthcoming census in Palestine is published to-day in Jerusalem, containing 18 questions.

The 18 questions include those on religion, sect, country of origin, language, and economic status.

LORD READING TO BE MARRIED IN LONDON TO-DAY: BFIDE HAS BEEN HIS PERSONAL SECRETARY FOR MANY YEARS: SHE WAS FORMERLY A HUMBER OF THE VICEREGAL STAFF IN INDIA: IS CONSIDERED AN EXPERT ON INDIAN AFFAIRS: WEDDING TO BE A QUIET AFFAIR.

The marriage of the Marquia of Reading, formerly
Vicercy and Governor-General of India, to Miss Stella Charnaud,
formerly a member of the Vicercgal staff in India, was announced here to-day to take place in London to-morrow. The marriage
earemony will be a quiet affair, it is announced. Immediately
after the wedding the Marquis and Marchioness of Reading will
leave for Paris.

Miss Stella Charnaud, who is 37 years of age, has been for many years Lord Reading's personal secretary and chief of his staff of all his political and business interests. She first became associated with Lord Reading when she was a member of the Viceregal Staff in India and he was the Viceroy. Since his return to England, Miss Charnaud has acted as Lord Reading's "right-hand man", and afforded him invaluable assistance in matters relating to India and the Round Table Conference.

Miss Charnaud is known in diplomatic circles as a person who has a wide and intimate knowledge of Indian affairs. She has mastered many languages. She is the daughter of the late Mr. Charles Charnaud, who represented Great Britain on the International Public Debt Organisation which was set up by the Great Powers in Turkey in connection with the loan granted to that country after the Crimean War. Miss Charnaud is one of a family of four, having two brothers and one sister. One of her brothers was an officer in the Royal Navy and now holds a post in the Colonial Service.

Lord Reading Married For 43 Years To His First Wife: The Late Lady Reading: The Remarkable Career Of Lord Reading.

Lord Reading was 70 years of age last October. lost his first wife 18 months ago, after 45 years of age last october. He lost his first wife 18 months ago, after 45 years of married life. Lady Reading died on March 30th, 1930. She was Alice Edith, third daughter of the late Albert Cohen, and her marriage to Lord Reading (then Mr. Rufus Isaacs) took place in 1887 soon after he was called to the Bar.

Lord Reading's career has been one of the most brill-

iant of modern times.

Starting as a ship's boy, he has been clerk, barrister, Solicitor-General, Attorney-General, Lord Chief Justice, and finally Vicercy of India.

Each step in this climb of the ladder of fame has been made possible by a rare combination of unlimited patience, hard work and remarkable brain-power. These characteristics he retained to the full when, at the age of 70 in October last year, he accepted membership on behalf of the Liberal Party of the Round Table Conference on India.

It is with India that his name will always be most prominently associated. He first saw the country as a cabin-

boy on the Hoogli River.

At the age of 27 he was called to the Bar, and within eleven years - in 1898 - he had taken silk. Mr. Rufus Isaacs, K.C. - later Sir Rufus - became a name associated with most of the leading cases.

He afterwards entered politics with the same enthusiasm he had shown for the law. He was elected to Parliament for Reading as a Liberal in 1904. Six years later he was appointed Solicitor-General and a few months afterwards promot-

ed to Attorney-General. His appointment as Lord Chief Justice followed in 1913, and 1921 saw the opening of his memorable term as Vicercy of India at a time when the situation in that country was delicate and often dangerous. He came home in 1926.

He was the only ex-Viceroy on the India Round Table

Conference.

HITLER ORGAN SUSPENDED FOR URGING TO KILL GERMAN JEWISH WRITERS.

Berlin, Aug. 5th. (Jewish Telegraphic Agency).
For calling upon the Hitlerists to kill a number of famous German Jewish novelists and journalists, the "Angriff", the Hitlerist daily organ, was suspended to-day for three days by the President of Police.

The article for which the Hitlerist organ was forbidden to appear, named Herr Lion Feuchtwanger, Herr Heinrich Mann, Dr. Arnold Zweig, Herr Arthur Helitscher, Dr. Alfred Kerr, and a number of other world-famous German novelists as "people who ought to be shot. These Jewish intellectuals", the paper said, "are supporting the Communists in their fight against the Hitlerists, and therefore they ought to be killed".

BERLIN MUNICIPALITY APPOINTS COMMITTEE TO ADMINISTER MR. JULIUS ROSENWALD MILLION DOLLAR FUND.

A Committee has been appointed to-day by the Municipality of Berlin to administer the million dollar fund, which Mr. Julius Rosenwald, the famous Jewish philanthropist of the United States, has offered to the City of Berlin for creating a children's Gental clinic.

The Committee consists of Professor von Drigalski, Medical Advisor to the Municipality of Berlin, Professor C.

Adam. Dr. Conrad Cohn. and Professor H. J. Mamlok.

PARENTS AND CHILDREN DECIDE TO DEMONSTRATE BEFORE WARSAW MUNI-CIPALITY AGAINST WITHDRAWAL OF SUBSIDIES FROM JEWISH SUMMER COLONIES.

Warsaw, Aug. 5th. (Jewish Telegraphic Agency).
A street demonstration has been decided upon to-day
at a meeting held by the parents of the 500 Jewish school
children who will be deprived of fresh air and sushine because
of the decision of the Warsaw Municipality to discontinue the
subsidies to the summer colonies in which the children are main-

tained.

The meeting of the parents which was held to-day in warsaw decided to demonstrate before the Municipality and to submit a protest to the Municipality against the withdrawal of the submidles.

The parents have also considered a suggestion to arrange a children's demonstration as a protest against the liquidation of the summer colonies in which the poor Jewish school children of Warsaw are being maintained.

JEWS LEAVE POLAND: IMPOSSIBLE TO REMAIN THERE ANY LONGER THEY SAY CROSSING LATVIAN FRONTIER.

Riga, Aug. 5th. (Jewish Telegraphic Agency).

Several hundred Jews have crossed the borderline from Poland into Lattia during the last two weeks, stating that in view of the extremely critical economic situation in Poland, they find it impossible to remain in the country any longer.

The migrants consist mostly of Jews who resided in the townships in the Vilna and neighbouring districts. The economic situation in Latvia may be bad, they say, but the

position in Poland is very much worse.

Most of these Jewish migrants are now in Dwinsk.

Their position is very complicated, since the Government refuses
to issue labour permits to them, without which they are unable
to obtain employment in Latvia.

NEW LAWS FOR NATIONAL MINORITIES IN TURKEY: STATUS OF JEWS TO BE CHANGED.

Istanbul, Aug. 5th. (Jewish Telegraphic Agency).
The legal status of the Jews as a national minority
will be changed in Turkey, in accordance with a new law which
is now being prepared by the Turkish Ministry of the Interior,
it became known to-day.

According to an announcement made to-day by the Ministry of the Interior, the law will have to establish the actual rights of the national minorities in Turkey and of their institutions. This is the first time in the history of Turkey that such a law is being considered. Hitherto there were no laws in the country regulating the national minority question.

In connection with the promulgation of the new law, the status of the Jaws, it is foreseen, will be changed for the better. Up till now the religious interests of the Jaws were guided exclusively by the law which was issued in 1864 by Sultan Abdul Medjid. This law dealt with the functions of the Chief Rabbinate of Turkey and is not at all applicable to the present stuation in Turkey.

LIBERAL AMERICAN WEEKLY ANALYSES PRESENT STAGE OF ZIONISM:

LEONARD STEIN RE-ELECTED HONORARY COUNSEL OF JEWISH AGENCY.

London, Aug. 5th. (Jewish Telegraphic Agency).

Mr. Leonard Stein, formerly Folitical Secretary of the World Zionist Organisation and the Honorary Counsel of the Jewish Agency, has been re-elected as Honorary Counsel

of the Jewish Agency Council.

Mr. Stein has played a very important role at the Seventeenth Zionist-Congress in Basle as intermediary between the Weizmann group and the anti-Weizmann group. Although no longer officially the Political Secretary of the World Zionist Organisation, he nevertheless has played a prominent role during the negotiations between the Jewish Agency and the Government as political advisor and as the author of a number of Zionist memoranda.

"MANCHESTER GUARDLAN" TAKES A HAND IN JEWISH SHECHTIA QUESTION: SA'S MANCHESTER JEWISH GOMNORTY IS MORE CONCERNED ABOUT IT THAN ANY OTHER GOMONITY IN ENGLAND.

London, Aug. 4th. (Jewish Telegraphic Agency).

Stating that it reflects the opinion of Manchester Jewry, the "Manchester Guardian" takes a hand to-day in the much-discussed amendment to the Slaughter of Animals Bill, which is now before Parliament. In its editorial on this question, the "Manchester Guardian" explains that the Jews of Manchester do not agree with the views expressed by the Orthodox Jews of London.

The Manchester Jewish community, the paper writes, is more intimately concerned than any other in the country in the attempt that is being made to amend the Slaughter of Animals Bill now before Parliament. In its original form the measure contains a clause that confirms a by-law which the Manchester City Council instituted some years ago in consultation with representatives of local Jewry. It provides that slaughterers licensed by the Chief Rabbi, on the recommendation of the Manchester Beth Din - the ecclesiastical court, comprised of a number of rabbis - are recognised in the Manchester abattoir as qualified to kill beasts according to Jewish method. Other cities outside London have since accepted similar conditions.

Now hat the bill before Parliament seeks, however, to make such a condition general, the paper continues a section of the community in London - regarded in Manchester as more than orthodox - is trying, by an amendment, to restore the older arrangement, which recognised no rabbis as chief and gave every such spiritual leader licensing power.
