SCHNITZLER BURIED WITH SIMPLE FITES IN VIENNA JEWISH CEMETERY: COFFIN OF UNPLANED BOARDS: STIPULATED IN WILL FOR CHEAP-EST FUNERAL DESIRING MONEY THUS SAVED TO GO TO HOSPITALS: BOTH VIENNA CITY AND JEWISH COMMUNITY OF FERED GRAVE OF HONOUR FAMILY ACCEPTING JEWISH COMMUNITY'S OFFER: AUSTRIA'S GREATEST AUTHOR GONE TO HIS GRAVE WITHOUT EVER RECEIVING RECOGNITION OF STATE UNDER MONARCHY OR REPUBLIC STEPHAN ZWEIG COMPLAINS: WAS SELLING LITTLE OF LATE BECAUSE BOOKSELLERS FEARED TO DISPLAY HIS BOOKS LEST ANTISEMITES SMASH THEIR WINDOWS.

Vienna, Oct. 23rd. (Jewish Telegraphic Agency).

Arthur Schnitlzer was buried to-day in the Jewish cometery here, with very simple rites. The ordinary Jewish burial service was used, including the reciting of the Kadish, but it was by his own wish, expressed in his will, kept as brief and simple as possible. The coffin was of the simplest. just unplaned boards nailed together.

In his will, Schnitzler particularly asked that there should be no fuss made about his funeral, that no notifications of his death should be sent out, that there should be no wreaths, and that the funeral should be the cheapest obtainable, the money saved in this way to be distributed among the Vienna hospitals. He also asked that there should be no speeches at the funeral. Both the Vienna City Council and the Vienna Jewish

Community offered graves of honour for Schnitzler's interment, the family accepting the offer of the Jewish Community. Although no notifications of his death were sent out by the family, out of respect for his wishes, the news of his death published on the front pages of all the Vienna papers, together with the details of the funeral, nevertheless, brought huge crowds to the cemetery, including hundreds of famous people, writers, artists, and doctors, the intellectual elite The Government and the City Council, were official ly represented, and all the members of the Presidium of the Jewish Community were present.

Thousands of telegrams of condolence have arrived at the house from all parts of the world, including messages from the Societies of Authors in England, America, and France, from the International Pen Club, of which he was an honorary member, and from Mr. Shalom Ash, the famous Yiddish novelist, in the

name of the Yiddish Pen Glub.

The famous Burg Theatre here, where many of Schnitzler's plays were produced, is flying its flag at half-mast in sign of mourning.

Among Schnitzler's papers found after his death there is a diary on Jewish questions, and an unfinished play and novel.

The entire press here, including the Catholic papers, is to-day giving a great deal of space to discussing Schnitzler's place in literature, which they all rank very high. The famous Jewish author, Stephan Zweig, publishes an article in which he complains that Austria's greatest author has been allowed to go to his grave without any sign of recognition by the State, either under the monarchy or under the Republic. Of late years, it is disclosed, Schnitzler's earn-

ings had greatly diminished, because most of the Vienna booksellers were afraid to display his books in their shop windows lest they should be smashed by the antisemites.

LESSER URY FUNERAL BRINGS BIG GATHERING OF PAINTERS AND ART LOVERS TO BERLIN JEWISH CEMETERY: RABBI LEHMANN A CLOSE PRIZNO DESCRIBES MASTER'S LONGLY LIFE AND EMBITTERMENT.

Berlin, Oct. 22nd. (Jewish Telegraphic Agency).

The Jewish cemetery at Weissensee was the scene of a great gathering to-day for the funeral of the famous Jewish painter, Lesser Ury. The Berlin Jewish Community provided a grave of honour, and the service was conducted by Rabbi Dr. Joseph Lehmann, who was a close personal friend of Ury's. The Berlin National Gallery was represented by the Director, Privy Councillor Dr. Ludwig Justi, and the Curator, Dr. Thormaelen, and the Secessionist Art Group was represented by all the members of the Committee, and the President, Eugen Spiro, who in an address at the graveside said that Lesser Ury's work was a milestone in the history of modern German painting.

Rabbi Lehmann spoke in his graveside address of the lonely life which the master had led, and the embitterment which had grown up in his heart because of his constant struggling for a livelihood and the means to be able to continue his Nevertheless, as one who had been his friend and had known him well, he said, he could only pay a tribute to his fine character as a man and as a Jew, who in spite of adversity, had refused to be beaten, and had gone on to the end producing great works of art and had remained true to his ideals as a Jew, and as a painter of the highest idealism of the Jewish faith and the Jewish character as revealed in the Bible.

TALMUD AND SHULCHAN ARUCH FAVE BEEN PRONOUNCED BY LAW COURT AS NOT BEING WORKS OF RELIGION HITLERIST ORGAN TRIUMPHS OVER VEPDICT ACCUITTING HITLERIST EDITOR: HUMAN SACRIFICE DOC-TRINE IN ZOHAR WHICH JEWS HOLD SACRED TESTIFIED TO ON OATH.

Berlin, Oct. 23rd. (Jewish Telegraphic Agency). The news of the acquittal of Deputy Holz, the editor of the Hitlerist "Stuermer" by the Nuremberg law court on the charge of insulting the Talmud and the Shulchan Aruch, is printed to-day in big type by the chief Hitlerist organ, the "Voelkischer Beobachter" under the heading "The Race War of the National Socialist Party Recognised by the Law Court".

The Talmud and the Shulchan Aruch have been pronounc'ed-by the court, it says, as not being religious works in the sense in which we understand religion, and the fact that Jews practise human sacrifice according to the command of the Zohar, which the Jews hold sacred, has been testified to on oath by Dr. Erich Bischoff.

DEPUTY GOEBBELS BERLIN HITLERIST CHIEF ACQUITTED ON CHARGE OF INSULTING JEWICH RELIGION: SENTENCE OF IMPRISONMENT IM-POSED BY LOWER COURT FOR INSULTING JEWISH VIGE-PRESIDENT OF BERLIN POLICE ANNULLED BY COURT OF REVISION.

Berlin, Oct. 23rd. (Jewish Telegraphic Agency).

The Court of Revision here heard to-day the appeal brought by Deputy Goebbels, the Bitterist chief in Berlin, against the sentence of a month's imprisonment and a fine of 1,500 Marks passed on him by the lower court for insulting Dr. Weiss, the Jewish Vice-President of the Berlin Police Force, and ordered him to pay a fine of 1,200 Marks, annulling the sentence of imprisonment.

The Court of Revision confirmed at the same time the verdict of the lower court, acquitting Deputy Goebbels of the charge of insulting the Jewish faith, which was brought

against him.

This was the verdict handed down by the West Berlin Listrict Court last May, when it acquitted Deputy Goebbels of the charge of insulting the Jewish faith by publishing an article in the "Angriff", of which he is editor, in which he said that Jews commit ritual murder. It had not been established, the court said, that the article was an insult to the Jewish religion, since it spoke only of fanatical adherents of the Jawish religion, and not of all who practise Judeism.

The ritual murder accusation is not an insult to the Jews, it added, but a historical fact, since many churches in Germany, Austria, and other countries are dedicated to Christian saints who were martyred for ritual purposes by the enemies of the Christian faith.

NO JEWS IN NEW ECONOMIC COUNCIL APPOINTED BY PRESIDENT HINDEN-BERG JEWS POINT OUT FEATING NEW LISCRIMINATION: STRANGE SINCE SEVERAL JEWS AMONG GREATEST FINANCIAL AND ECONOMIC AUTHORITIES IN GERMANY.

Berlin, Oct. 22nd. (Jewish Telegraphic Agency).

The new Supreme Economic Council which has been appointed by President Hindenburg, under his own Chairmanship, does not dontain a single Jew, although there are several Jews in Germany who are recognised as being among the most important economic and financial authorities in Germany, it is pointed out in Jewish circles here, where some anxiety is being expressed lest this should prove to be a new instance of anti-Jewish discrimination.

DEATH SENTENCE FOR HITLERIST WHO SAYS HE MURDERED JEW FOR ABUS-ING HITLER.

Berlin, Oct. 22nd. (Jewish Telegraphic Agency).

Edmund Thomas, a Hitlerist storm trooper, was sentenced to death to-day by the law court at Glogau for murdering a Jowish merchant named Herbert Walter. Thomas told the court that he had killed Walter because he had abused Hitler. His deed was apparently one that he had boasted about, Judging by a letter from his sweetheart read out to the court, in which she began by addressing him as "my dear belowed murderer".

OBLITERATING CENSUS POSTERS IN PALESTINE DOWS NOT INTERFERE WITH TAKING OF CENSUS: PIER BY COUNSEL FOR DEFENCE UPHELD BY COURT ACQUITTING YOUNG JEWS ARPESTED FOR DEFACING

Jerusalem, Oct. 22nd. (Jewish Telegraphic Agency)

Four of the seven young men who were arrested in Jerusalem at the beginning of this month for obliterating census notices posted on the walls were acquitted to-day on the plea of their Counsel that the obliteration did not interfere with the taking of the census.

The other three were discharged some time back without trial.

RE-FSTABLISHING PEACE IN AMERICAN ZIONIST ORGANISATION: TERMS PEACE AGREEMENT BET EEN CONTENDING PARTIES.

New York, Oct. 22nd. (Jewish Telegraphic Agency).

Virtual agreement has been reached between the two contending groups in the American Zionist movement, the J.T.A. learns, on the following basis proposed by Mr. Emanuel Neuman, the American member of the Zionist World Executive.

(1) That both sides accept the decisions of the last Congress as final, pledging full and loyal support to the Zionist Forld Executive and carrying out the programme adopted by Congress: (2) that the new Administration in the United States of America is to be created by increasing the number of members from 18 to 30; (3) that neither side will insist on the elimination of any of the present members of the National Executive Committee of the Organisation; (4) that an inner directing committee of five to seven members will be selected by agreement, and will be placed in direct charge of the work of the Zionist Organisation of America; (5) that the controversy will be ended at once and all efforts until the Convention of the American Zionist Organisation opens on November 8th. will be concentrated upon preparations for constructive work, particularly for the new Palestine campaign, and for carrying into effect Mr. Israel Brodie's plan, which was adopted by Congress, for the organisation of private initiative in Palestime.

Meetings of the Joint Committee of six appointed by the last session of the National Executive Committee are being held almost daily, with the participation of Mr. Emanuel Neuman as representing the World Executive, and simultaneously. er. Neuman, Mr. Morris Rothenberg and Mr. Robert Szold are carrying on conversations with the non-Zionist leaders and with the representatives of the Zionist funds in order to establish a United Palestine Campaign to begin functioning at the earliest possible date. It is expected that the plans for the campaign will be ready for announcement at the american Zionist Convention on November 8th.

The Zionists here confidently expect that the Zionist Organisation of America will continue to have the active leadership of Judge Julian W. Mack, Rabbi Dr. Stephen S. Wise, and their associates, as in past years, with the added strength of Mr. Louis Lipsky and his followers, participating actively in the actual leadership of the Organisation.

The J.T.A. learns from a reliable source that the

London Zionist Executive, particularly Mr. Nahum Sokolov, the President, exercised strong pressure with a view to putting an end to the controversy. Mr. Emanuel Neuman, acting in concert with the London Executive, postponed his departure from emerical in order to devote himself to this task, and working for weeks behind the scenes, he exercised his personal in-fluence with the leaders of both parties at informal conferences, and negotiations were continued until the last meetJ.T.A. THE EFFORTS OF THE LONION ZIONIST EXECUTIVE TO BRING ABOUT AMICABLE UNDERSTANDING IN AMERICAN ZIONIST MOVEMENT.

London, Oct. 22nd. (Jewish Telegraphic Agency). Confirmation that in addition to the efforts made in Zionist quarters in America to bring about an amicable understanding between the two contending groups in the American Zionist movement, the Zionist Executive in London has also been taking action in this direction, has been obtained by the J.T.A. here.

Mr. Nahum Sokolov and the other members of the London Executive have made a strong appeal to the contending parties to come to an arrangement, the J.T.A. learns, and Mr. Emanuel Neuman, being on the spot in America, exercised in particular every possible effort to bring about agreement.

By ag ment with his colleagues in London, Mr. Neu-ned in the ted States, where, in addition to occupyman remained in t. ing himself with various political and financial questions affecting Palestine, he was able to exercise his influence and his knowledge of American Zionist affairs to help to bring

about a satisfactory arrangement.

According to the agreement, all controversy about the Congress and its various issues will come to an end, and an immediate and close union for constructive Zionist work will come into effect. At the American Zionist Convention which is to take place on November 8th. a new and intensive campaign will be launched for the Keren Hayesod and the Jewish National Fund, and an effort will be made for the organisation of private initiative in Palestine on the lines of Mr. Israel Brodie's plan as adopted by Congress. Full support and loyalty in America is to be given to Mr. Sokolov and the present Zionist Executive by the united American Zionist Organisation.

YIDDISH ACTOR DROPS DEAD ON NEW YORK STAGE. New York, Oct. 22nd. (Jewish Telegraphic Agency).

Mr. David Baratz, a well-known Yiddish actor, dropped

dead on the stage to-day while he was reciting "The Hunchback", by the famous Yiddish dramatist, J. L. Gordin.

Mr. Bayast, who was 52 years of age, was born in Jassy, in Roumania, and came to America when he was ten to join his sisters who had been for some time in America. He attended the American public elementary schools. When he left school, he went back to Roumenia to see his perents, and there joined a Yiddish theatrical touring company. He went on tour in Galicia, Germany, and Hungary, playing for some time in Berlin and Budapest. At the age of 21 he returned to America, where he played with Boris "Gomaschewski, and other leading Yiddish actor-managers. He also made several tours in Europe, and when the war broke out he was playing in Lemberg. He managed, however, still to make his way back to America, and in the years which followed he played important parts on the Yiddish stage in New York and other American cities.
