Jerusalem, D.c. 12th. (Jewish Telegraphic agency).

The Grand Mufti of Jerusalem, as President of the Conference, has been empowered to-day by the Moslem "ord to Conference now meeting in Jarusalem, to protest to the League Of Nations against the docision of the International Wailing "all Commission which was appointed by the British Government with the approval of the League of Nations to determine the rights and claims of Jows and Moselsms at the Wailing Wall. The Grand Mufti has also been empowered to inform

all Moslem rulers and notables that the Conference regards with execration the present position of the Moslem shrines in Palestine under the terms of the Mandate.

A boycott in all Moslem countries against Palestine Jawish products as a means of protecting the Mosque of Aqsa (Kosque of Cmar) from Jawish encreachment was proclaimed by the Conference to-day in adopting a resolution moved by hohamed Ali, former Egyptian minister of Wakfs. If the Jews in Palestine succeed in developing their industry, the resolu-tion argues, they will be able to acquire more land in the country, and thus may even menace the Mosque itself, so that the boycott weapon must be used as a check to further Jewish progress.

The Wailing Wall as being an integral part of the Faram - esh-Sherif is manifestly Moslem property, but it is not a Moslem sacred shrine, and so far as it is known the pavement in front of the Wall has never been a place for moslem prayers, the League of Nations International Wailing Wall Commission declared in its report published in June, adding a note in which it stated that it was "unanimous in its pronouncements and decisions".

According to the terms of its appointment, the verdict of the Wailing Wall Commission was to be final and to

admit of no appeal.

Before the Moslems oppose the verdict, they may usefully reflect that whatever their views as to the competence of the Commission, they have in all essentials won their case, the Jondon "Times" wrote in an editorial when the verdict was published, and the "Mannhester Guardiam" in an editorial, likewise found that as "it happens the decisions of the wailing 'all Commission are mostly in favour of the Loslem contentions". Jerusalem, Dec. 11th. (Jewish Telegraphic Agency).

Grand Mufti held at the King Levid Hotel here this afternoon was attended by about 1,000 notables from all parts of the country, including the Mayors of Jerusalem, Jaffa, Haifa, Gaza, Ramleh, and Nablus, and two of the five members of the koslem Supreme Council. The Mayor of Jerusalem, Ragheb Bey Nashashibi, presided.

The Conference decided to communicate with Loslem bodies throughout the world with a view to convening a general Moslem World Congress to be held in some Moslem kingdom, and meanwhile refusing to recognise the present Conference meeting in Jerusalem under the chairmenship of the Grand wufti.

We are not an opposition: we are the nation, one of

the leaders of the movement, Omar Selah, declared.

In accordance with his declaration, the first resolution adopted by the Conference affirms that "this gathering of the Opposition is the Congress of the Falestine weslem mation".

Fakhri Nashashibi and Bookhaun Effendi who appeared

as Counsel for the Palestine Arab Executive before the Shaw Inquiry Commission, received press representatives, including the correspondents of the London "Times", the "Daily Telegraph", Retters, and the Jewish Telegraphic Agency, and read out to them ten resolutions which have been adopted by the Conference, which, after declaring that the participants are determined to dethrons the Grand Eurit, proceed to reiterate the demands which were presented by the last Palestine Arab Delegation to London, claiming that these will lead to the independence of Palestine, the protection of the Acelem Holy Places, and the protection of Euclem Palestine from the Zionist mense.

The Moslem Congress in Jerusalem can have no effect upon the development of the Jewish National Home, Mr. Winston Churchill, former British Colonial Secretary, said to a J.T.A. representative to-day on arriving in the United States.

Great Britain is not worrying about this Congress, he said, and there is no reason why the Jews should be concerned with it.

The unfortunate Passfield White Paper has been righted, Mr. Churchill added, and at present all the leaders of the Government are in favour of the Jewish National Home, and there is no disagreement among them with regard to the Prikrish duties towards the establishment of the Jewish National lome.

JEWISF SETTLEMENT ORK IN FALESTINE GOES ON: THOUSAND FALLLY PLAN BEING CARRIED THROUGH: GREENERT FOR SELECTION OF FIRST 200 SETTLERS CONCLUEDD.

The thousand family settlement scheme is sufficiently advanced for an agreement to be concluded yesterday, providing for the selection of the settlers.

200 families will be fully colonised. and simultaneously between 500 and 600 houses will be erected for further prospect-

ive settlers.

The unity of the Zionist Organisation, based on national solidarity, and its position within the Jewish people and in the external world, built up by more than thirty years of persistent effort, must be protected against disruptive tendencies, the Executive of the Zionist Organisation says in a statement issued here to-day on the resolutions adopted at the Calais meeting of the Revisionist World Union.

Consolous of their responsibility for the preservation of this unity, the statement proceeds, the Executive of the Zionist Organisation, while disclaiming any intention of suppressing opposing views within the Organisation, find themwelves commelled to utter the warning that the Zionist Organisation will combat with every means at its command the invasion of amarchy into the spheres of organisation and politics.

sation will compare whom every means are communication and politics.

The Executive regard it as their duty to point out the consequences which would have to follow upon the realisation of the Calais resolutions. They reserve the right to take such action as will appear necessary, and to submit proposals to the General Council with a view to protecting the unity and integrity of the Zionist Organisation against all attacks.

Membership of the Zionist Organisation involves compliance with its rules and decisions, the statement says, and is incompatible with membership of an outside body requiring acceptance of a discipline which may conflict with and take precedence over the duty of allegiance to the Zionist Organisation.

ist Organisation adheres to the principle that separate negotiations with Governments and the Lesque of Nations may be conducted by Zionist individuals or groups only with the consent of the Executive, and that in specific cases, where desired by the Executive, and that in specific cases, where desired by the Executive, external political activities of other character may also not be undertaken without previous consultation with them. The responsible Executive elected by the majority of Congress are always prepared to grant to individual Zionist groups a certain latitude in regard to political activities as far as this is compatible with the general interest; they must, however, reserve the right to guard vital interests of the Jewish people from being jeopardized by deliberate disregard of these principles.

The increasingly acute political situation of the last few weeks and the growing spirit of enmity and of brutality compel us to issue this appeal, says a statement issued by the Central Union of German Citizens of Jewish Faith signed by Er. Julius Frodnitz, the Fresident, and Dr. Ludwig Follaender. the Director.

We are threatened, it says, with political and economic annihilation. The boycott slogan is being invoked against us both in the cities and the small towns. cemeteries are being laid waste and our Houses of God are desecrated. At public meetings and in the newspapers people are openly incited to violence against Jews. The Boxheim documents reveal a mentality which hesitates at no vileness.

The Central Union of German Citizens of Jewish Faith has for years past been directing attention to these dangerous developments, the statement goes on, but short-sighted people pretending to know better tried to move the uncomfortable truth out of the way.

In spite of everything, the statement concludes, we do not lose hope for one instant. The justness of our cause is our strongest weapon. Millions of Germans are fighting at our side against the incitement and violence that are the unholy alliance of our time. We are confident of the support of our friends in all parts of the Republic, and we are endeavouring to be worthy of this confidence. To the last breath we shall do our utmost to keep the evil thing from German Jewry.

Berlin, Dec. 11th. (Jewish Telegraphic agency). In these last few days German citizens have left their native towns in Mecklenburg, in which they and their families have been living for generations, says a call to the Cerman people published in the "C. V. Zeitung", the organ of the Central Union of German Citizens of Jewish Faith. Mecklenburg State Museum hangs the uniform of one of the ancestors of these Germans, a man who fought as a volunteer in the German liberation wars. Is there any fault in them that they have been compelled to uproot themselves, to leave the soil to which they have been attached for centuries? The only reason is that they are Jews, and it is this fact that has made reason is that they are seen, and it is find that has made that they are their lives unbearable. The masses of the people are looking for a scapegoat to blame for their present misery, and the Jew has been fixed on as the scapegoat. Ever since the Revolution, groups, leagues and parties have been engaged in defaming the formen Jews. The gamut has been run from the lie of the ritual murder right up to cultural antisemitism.

Part of the blame for this state of affairs must be placed at the door of those millions of our Jorman fellow citizons who for entirely different reasons than antisemitism have ranged themselves beneath the Swastika banner. They are seeking a way out of our economic and national misery, and they do not mind that the milestones alone this road soll the donial to 600,000 'erman prople of their claim to existence and to equality of rights.

It still seems possible to us to form a united front of decent-minded people extending beyond the party boundaries, which will be potent to save Germany from the horrors of civil war and of barbarism. As for those others who are deaf and war and of barbarism. As for those others who are deaf and dumb to all the claims of morality, let them at least reflect on what will happen when once the brutal instincts of the mobare let loose. It is my wish that baptised Je's should be admitted to the Jewish student nation, the Minister of Education, Ir. Czermak, said in a public address delivered here to-day, making Caprimax, said in a public undress delivered here to-cay, making it clear that he identifies national citizenship, on which his new student rights bill in Parliament is based (restoring the system of student "nations" which existed in the medieval universities), with the race-principle.

The Minister of Education took the opportunity in

the course of his speech to assail the Liberal and Socialist press, which is opposing his bill, dubbing it a German-language but not a German press.

I highly esteem the Jewish nationality, which has stood firm by the Jewish people in spite of its loss of its own land end language, the kinister said, and that is why I went to establish also a Jewish student nation, which will comprise all those students who belong to the Jewish people, Zionists, Jewish Democrats and Jewish Socialists, and I desire that the Jewish student nation should admit as members also Jews who belong to other religious faiths.

In any case, he said, the German student nation can be no place of refuge for Jews who are not admitted into the Jawish student nation because they have changed their religion. Posides, it is for the student nation itself to decide whom it will admit to membership.

The Liberal press makes a furious attack on the minister for thes speech, pointing out that by his definition of a Jaw he excludes Disraeli from membership of the British people and Fains from membership of the German people.

AMOTISE JETTSH APPAIR IN CZECHO-SLOVAKIA: HORAK ACOUTTULL FOLLOWED BY LEREST OF JEWISH GENEARMS ACCUSED OF HAVING SKOT TWO CHRISTIAN PERSANTS IN SAME PERIOD OF 1918 BOISHEVIK INVASION.

Prague, Doc. 12th. (Jewish Telegraphic Agency).

A Jewish shopkeeper named Samuel Weissberger has been arrested by the gendarmerie at Michalovce, in Slovakia, on suspicion of having shot two Christian peasants in 1918, during the time of the Bolshevik invasion, when he was serving as an ássistant gendarme.

In Jewish quarters the impression has gained ground that the charge has been manufactured as a sort of counterblast to damp down the Jewish protests against the acquittal of Corporal Horak who was accused of having shot seven Jews during

the same period.

TIE "AY OF JUSTICE IN VILNA: JEW ACCUSED OF INCITING JEWS TO REVENCE AGAINST PARTICIPANTS IN EXCESSES SENT TO PRISON FOR TWO KONTHS AND MUNICIPAL OFFICIAL WHO SHASHED JEWISH WINDOWS ACQUITTED: OVERTURE TO 40 TRIALS ARISING OUT OF NOVEMBER EXCESSES.

Warsaw, Dec. 11th. (Jewish Telegraphic Agency). The first two trials in connection with the anti-Jewish excesses which occurred in Vilna on November 10th. were held to-day, the accused being a 24 year old Jewish shopkeeper named Karpel Gelfer, who was charged with having incited Jews on the day of the excesses to take revenge on the hooligans who had attacked them, and a municipal official named Ignacy Karpowicz, who was charged with smashing three windows in a Jewish shop.

Gelfer was sentenced to two months! imprisonment less three weeks, which he has already served while awaiting * trial, and Karpowicz was acquitted.

There are about 40 trials pending, arising out of the Vilna excesses.

ANTISEMITIC DEPUTY AND POLISH EX-MINISTER FIGHT DUEL OVER ANTI-JEWISH EXCESSES.

Warsaw, Dec. 11th. (Jewish Telegraphic Agency). The duel between Deputy Stypulkowski, the National Democratic spokesman who defended the action of the National Democratic students in attacking the Jews during the sitting of the Seym on November 8th., and ex-Winister Miedzinski, the Covernment Farty spokesman who replied to his speech, denouncing him and his Barty as "wild and irresponsible degenerates, who stand for things done only by the soum of the people and in no way reflect the feeling of the Folish nation", was fought to-day.

Deputy Stypulkowski, who is himself married to the daughter of a converted Jow, felt himself insulted by Deputy kledzinski's demunciation, and sent his seconds to him the next day to challenge him to a duel. Pistols were used. Neither of the duellists was hit.

SETTENCES IN WARSAW WHITE SLAVE TRAFFICKING AFFAIR: BASKIN AND HIS ACCOMPLICES OF TO PRISON: FIGTTFIOUS MARRIAGES TO EMBELE ALLENS TO EMTER UNITED STATES.

Warsaw, Dec. 11th. (Jewish Telegraphic Agency).

The Baskin trial which has been dragging since 1929, when Maurice Baskin, a United States citizen was arrested, largely as the result of the investigations of the London Jewish Association for the Protection of Cirls and Women, on the charge of going through fictitious marriages with women to enable them to enter the United States, was concluded here to-day.

Baskin was sentenced to three months' imprisonment. Fis accomplices, with the exception of one, Altschuler, who was adquitted, were given more severe sentences, Moses Iglicki being sent to prison for three years, Natanson for 2½ years, and Fishbein for one year, and the rest for three months.

UNITED STATES CONGRESS ASKED BY IMMIGRATION COMMISSIONER TO TAKE ACTION TO PREVENT COLLUSIVE MARRIAGES FOR PURFOSE OF ENTREING U.S.

"ashington, Dec. 11th. (Jewish Telegraphic Agency).
The United States Congress was requested to-day by kr. Hull, the Commissioner General of Immigration, to declare as a felony the collusive marriage of aliens to American citizens for the purpose of enabling the aliens to enter the United States. Under his proposal aliens who are parties to such marriages will be deported from the country.

The Jewish Association for the Protection of Girls and Tomen receives a large bequest under the will of the late Lady Battgrses, daughter of Sir Anthony de Rothschild, who died at the end of last month. Lady Batterses, who was Vice-President and Honorary Secretary of the Association, left £10,000 between Cromer Hospital (she lived in Cromer), the ketropolitan Pospital, the Jewish Association for the Protection of Girls and Tomen, and the Jewish Board of Guardians. She left another £3,000 to the Jewish Association for the Protection of Girls and Tomen, and £500 to the Jewish Board of Guardians.

The Pleasuance and her North property is left in trust for Rose Marie de Rothschild on attaining 25 years of age.

The residue of the property is left between Lady Battersea's cousins, Lional Nathan de Rothschild and Anthony Gustave Rothschild, who have been granted probate of the will.
