The cry of "International Jewish Finance" was
raised in the United States House of Representatives to-day
when President Hoover was accused by Congressman Louis T.
KacFadden, Republican Representative for Fermsylvania and
former Chairman of the Congress Banking Committee, of having
"sold cut" the United States in putting forward his "infamous
war-debt moratorium proposal" at the bidding of the International bankers, Mr. Faul K. Warburg, Messrs. Kuhn Loob and
Company, of which Mr. Felix M. Warburg is one of the principal
partners, and Mr. W. Seligman, who, he alleged, "have been
bleeding the country white for the benefit of Germany and

Mrs. Florence Kahn, the only Jewish Congresswoman, who succeeded her late husband as Republican Representative for California, shouted "shame!" when Congressman MacFadden made his allegation

Congressman Chiperfield, Republican Representative from Illinois, demanded that Congressman MacFadden should produce proof of his charges. If Fresident Hoover has done this thing, he cried, he is a Juias, and he should be impeached, and if Congressman MacFadden does not do this he is a foul traducer.

In the Senate, Senator Reed, Republican from Pennsylvania, also attacked the war-debt moratorium proposal, describing all debt cancellation proposals as propaganda by international bankers for their own selfish interests.

Senator Hiram Johnson, Republican from California and Chairman of the Senate Immigration Committee, joined in denouncing the cancellation proposals as having been made at "the dictation of the international bankers".

There is a good deal of resentment being expressed in the House of Representatives at Congressman MacFadden's outburst. 26 of the 35 Congress Representatives from Congressman MacFadden's State, Pennsylvania, have signed a statement repudiating his accusations.

Congressman MacFadden And Senator Reed: Congressman Mac-Appointing Jewish Banker Eugene Meyer Fead of United States Federal Reserve Bank: Senabor Reed Upholder Of Nordic Theory For Which Louis Marshall Rebuked Him As "One Of The Leaders Of Immigration Laws Amendment With Deliberate Purpose Of Lifferentiating Between Immigrants On Basis Of Racial Stock A La Houston Chamberlain".

Congressman MacFadden has appeared in Congress at least once before in the role of accuser of "international financiers". This was almost exactly a year ago, on December 17th., when he attacked President Hoover's appointment of Mr. Eugene Meyer as Chairman of the United States Federal Reserve Svs tem.

If you want to turn the "ederal Reserve System over to international financiers, place Eugene Meyer in that particular post at this time, Representative MacFadden, who was then still Chairman of the Banking and Currency Committee of the House of Representatives, said attacking Mr. Meyer as an 'international banker', and demanding that the House should re-ject his nomination. Mr. Meyer has been closely connected Jouring his whole financial career with banking houses of inter-national reputation, he declared, adding he had a very close connection with J. P. Morgan and Company, and as head of the War Finance Corporation, and in carrying on its activities, those close relationships were actively disclosed. He is a Wall Street man".

Mr. MacFadden also said that Mr. Mever is a brotherin-law of Mr. George Blumenthal, the Jewish banker who lives in Paris, and, as he was given to understand, represents the Rothschild interests and is a liaison officer between the French Government and the Morgan Company.

Senator David A. Reed, of Pennsylvania, who, too, has alleged dictation by "international bankers", is one of the chief advocates of alien registration in America, and in this connection the late Louis Marshall engaged in a lengthy correspondence with him in 1926, when there was an alien re-

gistration bill in Congress.

You have been one of the leaders of the movement to amend our immigration laws with the deliberate purpose not only of cutting off immigration, but of differentiating between immigrants on the basis of the lands of their nativity, or of their so-called racial stock. Mr. Marshall wrote to him. have tried to put into our legislation a division of mankind into Nordics and non-Nordics. It is only pseudo-anthropologists who recognise that there ever was any such race as the Nordics, and leading authorities have demonstrated that the whole Nordic idea is a myth. Unit1 1916 nobody had ever heard of that race. At that time Madison Grant invented it as a substitute for the Teutonic stock, which had been apothec-sised by the unspeakable Stuart Houston Chamberlain.

There is another Senator Reed in the Senate, Senator James A. Reed, of Missouri, who, too, has had some connection with the allegation of a Jewish international conspiracy. This was when he appeared in 1927 as Chief Counsel for Mr. Benry Ford, to uphold his antisemitic charges made in his book The international Jew", in the libel action brought by Jr. Aeron Sapiro, which resulted in Mr. Ford's restraction of

his antisemitism.

"DAILY EXPRESS" FINDS "INTERNATIONAL FINANCIERS" IN LONDON.

All the London dallies carry to-day long reports of

after stating that "the sampaign against international financiers, which has been going on for some time in America, reached its climax in Congress yesterday, when they were accused of being the authors of most of the world's present ills! he proceeds to say:

What has been going on in New York has been going on in varying degrees in other capitals. financiers of London have not escaped. The international There is a feeling that they have exerted too powerful an influence on Govern-ment financial policy. They advised and urged the return to the gold standard in 1925. This proved a terrible blow

for British industry.

The only "international financier" mentioned by name in the "Express", however, is not a Jew, Mr. Ivan Kreuger, the Swedish match king.

ACCUSATION THAT JEWS HAVE DESIGNS ON MOSQUE OF OMAR AREA MADE AGAIN AT JERUSALEM MOSIEME CONFERENCE: PAMPHLET CIRCULATED AMONG MEMBERS DEFICTING AS PROOF MIZERAGHS AMD SIMOPAT TORAH FLAGS; SAME EVIDENCE THAT WAS LAUGHED OUT OF COURT BY SHAW ENQUIRY COMMISSION.

Jerusalem, Dec. 16th. (Jewish Telegraphic Agency). Reproductions of Mizrachs, flags carried by Jewish children in the Simchat Torah processions in the synagogues and other objects which were produced by the Arab side before the Shaw Enquiry Commission into the 1929 massacres when it was sitting in Jerusalem two years ago, in November 1929, as evidence that the Jews have designs on the Mosque of Omar area because they show pictures of the Temple, and which were laughed out of court at the time (What is the point of these pictures? the Chairman, Sir John Shaw, asked), and which were produced again with the same intention before the International Wailing Wall Commission of the League of Nations, are contained in a pamphlet which is to-day being distributed among the members of the Moslem World Conference meeting here, to show them that the Jews have designs on the Mosque of Omar to rebuild the Temple there.

The pamphlet appears to be intended mainly as a counterblast to Dr. Arlossoroff's speech repudiating the allegations about Jewish designs on the Moslem Holy Places, which he delivered shortly before the Conference opened (it was given in the J.T.A. Bulletin of the 8th. inst.), and has been translated into Arabic and sent to all members of the Conference in order to acquaint them with the facts of the Jewish attitude towards the moslem Holy Places.

Unlike the handbill which was distributed at the Conference last week showing Jows with a machine-gun, alleging that they were being trained in its use against the Arabs and which was imported from outside the country, the present pamphlet has been printed in the moslem Orphanage Press in Jerusalem and is being distributed openly.

"The British in Palestine are arming the Jews". "The British in Palestine are teaching the Jews the use of firearms".

These are the titles under the illustrated leaflets distributed on December 8th. among the moslems attending the

Islamic Conference in Jerusalem.

Under one of the photographs (showing the Athlit
Quarry Drill) the text reads, "A group of Jews in Palestine
with a machine-gun, one of the machine guns with which the
Government of Palestine had atmed the Jews against the Arabs.
Near the group is a box of ammunition".

And the text under the title to the lower picture (a mounted photograph of a man with a kind of a drill) explains

"this is a Jew in one of the Jewish colonies practising the use of machine guns, part of the arms which the Palestine Gov-ernment has supplied to the Jewish inhabitants to be used

against the Arabs".

When the Mizrachs were produced before the Shaw Enquiry Commission, the Grand Bufti, in his evidence, in the course of which he declared his belief in the "Protocols of the Elders of Zion" said: These Mizrachs are my authority for saying that the Jews are plotting to encroach on the Moslem Holy Places.

ARABIC PAMPHLET APPEARING TO HAVE BEEN ISSUED BY PALESTINE
MOSIEM OFFOSITION TO GRAID MUFTI DENIES HIS ALLEGATIONS
ABOUT JEWISH DESIGNS ON MOSQUE OF OMAR: OFFORENTS ALSO DECIDE NOT TO CONCENTRATE ON SPECIAL CAMPAIGN AGAINST ZIONISM REFERRING TO PURSUE POSITIVE RATHER THAN NEGATIVE

Jerusalem, Dec. 17th. (Jewish Telegraphic Agency). An anonymous Arabic pamphlet issued here to-day, which bears signs of having been prepared by the strong Pelestine Moslem mayement of opposition to the Grand Mufti, denies the Grand Mufti's allegations about Jewish designs on the Moslem strines, and accuses the Murti of transferring Wakf land to his relatives for them to sell to Jews.
The J.T.A. here understands that a series of secret

meetings of the Young Men's Moslem Associations have been held during the period of the Conference, the moving spirit being Auni Bey Abdul Hadi, one of the Secretaries of the Falestine Arab Executive, who was one of the Counsel for the Arab side

before the Shaw Commission of Enquiry, and that it has been decided to fight for the independence of Moslems everywhere, but not to concentrate on any special campaign against Zionism, because it is desirable in the view of the participants in the meetings to pursue a positive policy rather than engage in a negative programme.

GRAND AUFTI ELECTED PRESIDENT OF EXECUTIVE APPOINTED BY MOSLEM CONFERENCE TO CONDUCT ITS AFFAIRS FOR NEXT TWO YEARS: CONFERENCE CONCLUDED.

Jerusalem, Dec. 17th. (Jewish Telegraphic Agency).

The Grand Mufti of Jerusalem has been elected President of the Executive appointed by the Moslem World Conference, which concluded in the early hours of this morning after an allnight sitting. The Executive consists of 25 members, three of whom are Palestinians, including Auni Bey Abdul Hadi and Sheikh Mouzzafar, (one of the agitators whose names appeared on the Government Black List after the 1929 massacros).

The Conference also elected an Administrative The Conference also elected an Administrative committee of seven members, with Tabat Ablah, ex-Premier of Persia, as General Secretary, Riadh Bey, of Syria, who is an active member of the Falsstine-Syrian Committee in Geneva, as Assistant Secretary, Mohamed Ali Pasha, former kinister of Wakf's in Egypt, as Treasurer, and Said Samil, Nabhi Eddin, and Thaala Bey, Eufti of Tunis, as members. The list is still subject to confirmation, the

ballot having been in secret, and the results have not yet been officially published. If the list of members of the Administrative Committee is correct, the Persian ex-Premier and the other non-Palestinian members would become residents in Jerusalem, which will be the headquarters of the movement for the next two years.

The 25 members of the Executive include Shaukat Ali, the Indian Moslem leader, who is said, however, to have de-clined to serve, because he is dissatisfied with the way in which the Conference was conducted, especially the refusal of the Grand Mufti to accept his compromise proposals to enable his opponents in Palestine to take part in the Conference, 3ir Mohamed Iqubal and Shafi Daudi, two leading Indian Koslems, Abdul Rachman Bey Azzan, of Egypt, and Iyad Ishaki of the Urals.

EGYPTIAN MEMBER OF EXECUTIVE OF MOSLEM WORLD CONFERENCE DEPORTED FROM PALESTING FOR SPEECH ATTACKING ITALIAN POLICY IN TRIPOLITANA.

Jerusalem, Dec. 17th. (Jewish Telegraphic Agency). Abdul Rachman Bey Azzan, one of the Egyptian delegates, who is eleventh on the list of the 25 members of the Executive elected by the Moslem World Conference here, has been deported from Palestine, states an official communique which has been telephoned to-day to the J.T.A. here.

The reason for the deportation is a speech which he delivered at the Moslem Conference attacking the policy of the Italian Government and officials towards the Moslem Arab population of the Italian colony, Tripolitana, which the communique states is calculated to embitter relations between the Government of Italy and the British Mandatory Government in Palestine.

.. Abdul Rachman Bey al Azzan, of Cairo, was one of the central figures in the clash which occurred at the opening session of the moslem Conference last week. It was he who brought up the question of Egyptian politics, in conveying greetings from Nahas Pasha, the leader of the Egyptian Wafd Party. This brought another Egyptian Wafd This brought another Egyptian delegate, Suleiman Bey Farety. This prought another Egyptian delegate, Sufamen bey Fawzi, to his feet, shouting "there is only one man in Egypt, Ling Fuad". A tremendous furore followed and enraged dele-gates beat him with sticks until he dropped. The Grand Mufti of Jerusalem ren forward and stood over Suleiman Bey Fawzi with outstretched arms, protecting him as far as he could until the police arrived and carried him off.

The Under-Secretary of State for the Colonies, Sir Robert Hamilton, declared in the House of Commons when the Moslem Conference was opened in Jerusalem, that an undertaking had been obtained from the Grand mufti and the organisers of the Conference to avoid incitement from any visitors to Palestine attend-

ing the Conference.

Riadh Bey, enother member of the Executive, attacked Britain, with her Imperialistic mandates, during the Conference, being reproved by Shaukat Ali, who said Moslems should oppose Jows, but not broak thoir friendly relations with Britain.

Following the action of Bedouins trespassing on Jewish National Fund lands in the Wady Havarith area, obstructing the Jewish ploughers and squatting down with their tents and belongings and women and children, the Government has requested the Jewish authorities to suspend ploughing, pending urgent action in the matter.

Dr. Arlossoroff, on behalf of the Jewish Agency, has agreed to do this, on condition that the land is vacated. Action by the Government is expected to be taken at any moment. The Government action is in accordance with the

method adopted several times by Sir John Chancellor, when similar trespassing on Jewish land occurred during his Figh Similar trespective for the was one such case in Hederah, where Bedouins encamped on the Jewish land, and police officers arrived with orders from the High Commissioner to the effect that until the dispute regarding the land was decided by the law court, the lands which were uncultivated should be left uncultivated. . 54

I believe England will remain true to her pledge, and help the Jewish people to upbuild their country. same time, England will see to it that the rights of the Arabs to which they are entitled will not be compromised in any way, Sir John Hope Simpson, the author of the Simpson Report, on which the Passfield White Paper was based, and who is now in Shanghai as head of the Chinese National Flood Relief Commission, said in an interview here with Mr. N. E. B. Ezra, the editor of "Israel's Messenger".

There is no truth whatsover in the report that England will ultimately repudiate the Balfour Declaration and leave Palestine to its fate, Sir John declared.

T have no desire to discuss the merit or demerit of the Thite Paper, he went on. It was not submitted to me for approval, and I had nothing whatever to do with its properation. There are points in the White Paper which might, in my opinion, have been more in consonance with the report submitted by me.

I stand by my report, he continued, and reiterate my views no matter how harshly they are criticised. I still believe that it was a mistake to oust the Arab labourers from being employed in Jewish colonies, although I fully understand the Jewish viewpoint and appreciate it. To my mind, this the dewish viewpoint and appreciate it. To my mind, this felerimination edds to the difficulty of the whole situation and aggravates the Arab-Jewish position, for it gives a chance for unnecessary agitation. I repeat again that I am not unnindful of the Jewish attitude in the matter which is enxious not to lay itself open to the charge that it is exploiting Arab labour for the upbuilding of the country, instead of Jewish workers on whom the burden of reviving the country should fall. Views may differ on this point, but I adhere to mine and think the Zionist policy is a mistaken one.

I do not wish to suggest that if this point is waived, and Arab labourers are given employment, there will be no more friction between the Jews and the Arabs. Sir John added, but I do say it gives a weapon to the Arabs to dislike

the Zionist policy and keep their agitation open.

It is true, he said further, that no Arabs employ The Arab population is very backward. They are poverty-stricken people, and besides, it is cheaper to engage Arabs than Jews, since the standard of living of the latter is higher.

The Rothschild colonies which engage Arab labourers have done remarkably well, and thereby killed the spirit of dissension in a country which needs peace and harmony.

I See No Reason To Revise My Views In Light Of Jewish Agency keply Except In One Point In Regard To Cost Of Colonisa-

I see no reason to revise my views in the light of r. Leonard Stein's reply to my conclusions published by the Jewish Agency, Sir John said, except in one point in regard to the cost of colonisation. This was quite unintentional, and corrected in an errata slip printed in the book of maps which was published as a supplement to the report.

Questioned about Mr. Kaplansky's pamphlet claiming that Palestine is capable of maintaining an agricultural population of over two million people, Sir John admitted the possibility of Felestine feeding a much larger population in future, provided development of the country is undertaken on a greater scale. He, however, felt that the tendency of the

Jews is towards urban population which is growing rapidly.

Tiscussing the genesis of the Balfour Declaration, Sir John said that it was issued at a time when the world believed that Palestine was a country without a people, but to-day they hold just the opposite view. The Arabs were becoming landless owing to Jewish land purchases, and in this way they are feeling the acute position and the possibility of being driven away from the country. He felt that a serious situation was developing which required careful handling. The Arabs will not tolerate Jewish conquest of the soil, he said, and the tendency to resist it is bound to stiffen.

oir John was inclined to concede the rights of the Jews to colonise Palestine and live there in accordance with their rights conceded to them, but he felt that progress must be slow and should not be accomplished at the risk of incurring the displeasure of those who were seeking to intensify points of disagreement rather than points of agreement.

Sir John Says Though to Did Not Raise It In His Report He Is In Favour of Legislative Council In Palestine Although Country Light Not Be Ripe For It At The Moment: Jewish Intellect Should Conquer Even A Hajority.

The question of the Legislative Council was also discussed, and Sir John said that although he did not raise it in his report, he was in favour of a Constitution, although the country might not be ripe for it at the moment! was such a thing as Jewish intellect, he remarked, which may conquer even a majority, and there should be no ground for

opposition and apprehension. It is not a remote possibility to bring about an frab-Jawish reconciliation, Sir John suggested. I foresee no conflict ahead, and one hopes that differences may be ironed out and the country settle down to peace and progress. wuch depends upon both sides being able to give and take

and settle their differences in a becoming manner.

Sir John expressed admiration of the progress made by the Jewish Colonies in turning marshes into flourishing gardens and in cultivating land which had been lying idle for centuries. That was something of which the Zionist movement may well be proud. He characterised Tel Aviv as a "de luxe" colony, "a jewel on the neck of Palestine", expressing the hope that within the next decade or so, there would be great progress made which will make the Holy Land a great centre of art, culture and civilisation, provided the Jewish people did not relax in their support of the cause for which their movement stands. Sir John also hoped that his proposal regarding the development of Palestine with a view to providing more land for colonisation would be supported by all those who were interested in the upbuilding of the Jewish National Home.

I wish to make it perfectly clear, Sir John concluded, that I am not hostile to Jewish national aspirations, whose viewpoint I understand well, having discussed the matter with Dr. Ruppin and Dr. Arlossoroff in Falestins. Both are remarkable men and oreditable to the Jewish people whom they represent. I wish the venture in Palestine well, both in the interests of the Jews and Arabs alike.

East Important State Lands "sere Distributed To Arabs By Sir Ferbert Samuel And He Was A Jew Sir John Sirpson points 3ut.

In confirming the draft interview after having read it. Sir John wrote to Mr. Ezra:

As to State land, what I said was that I had examined the position of every single State property in Palestine, and had found that there was really very little State land still available for settlement. The Beisan lands, which were the most important of the State lands in Palestine, had been distributed to the Arabs by Sir Herbert Samuel when he was Figh Commissioner, and it must be remembered that he, himself, was a Jew.

There is a survey and settlement in progress, he added, and it may well be that when the whole of Palestine is actually measured a considerable area will emerge on which the State only will have a claim. If that should be so, there will of course be further properties to distribute, and the Government will doubtless observe the terms of the kandate in respect of them. No one knows the area of Palestine accourately; there have been guesses varying in size. When I was in Palestine I had a test aerial survey made which showed a considerable reduction of land in the hills. The results of that were attacked, but I still hold that they are the most reliable estimate that is possible at present.

MET YORK JETS HAISE 27,000 DOLLARS FOR JETISH LAND PURCHASE IN PALESTINE.

The Cabinet is reconsidering to-day the draft bill for providing student rights at the Austrian Universities, in consequence of a demand put by the Christian Socialist Ferliament-ary Farty, which is the strongest Party in the Government Coalition and the Royalist People's Party that all Nazi tendencies should be eradicated from the bill before they can give it their support. The Royalist People's Party has protested to the Prims Minister against the enactment of a law granting student rights which would bur from these rights any Austrian citizen, whatever his faith or racial origin.

Bela Angel, a Jewish girl who is a third-year medical student, has been besten by Turkish students, and warned that if she did not give up her studies at the University they would beat her so that she would not be able to leave her bed again.
