DEFRIVING POLISH JEWS OF THEIR LIVELIHOOD: ANNULMENT OF THEFTEN THAN ING LICENCES GOES ON: YIDDISH DALLY THE PREDICTED AUTOMATIC TENEMAL OF LICENCES THIS YEAR ANNOUNCES NOT ON CONTRARY 600 OF REMAINING 1,300 ANNULLED TITH-NEW YEAR AND REST ONLY PROLONGED TILL JULY.

"arsaw, Jan. 3rd. (Jewish Telegraphic Agency). The Polish Government is proceeding as ruthlessly as before to deprive Polish Jews of their means of livelihood by cancelling their trading licences, the Yiddish daily hajnt" here declares to-day, repudiating its own report published on the eve of Christmas (quoted in the J.T.A. Bulletin of Dec. 28th.) in which it predicted that the Ministry of Finance would give the Jews of Poland a Christmas gift by agreeing on the intervention of the Jewish representatives not to withdraw any tobacco or spirit trading licences from Jewish holders with the coming of the New Year, but would automatically renew all licences on payment of the licence fees.

On the contrary, we now learn, the paper writes, that of the 1,300 licences for selling alcohol or tobacco which have still remained in Jewish hands, no less than 600 have been cancelled, and the rest have been prolonged only till July 1932. All our expectations have thus been disappointed, the "Hajnt" concludes, and the Government seems determined to clear all Jews out of the Government monopoly enterpaises, and in these desperate times to add hundreds more of Jewish families to the already large numbers of those who have lost all means of sustenance.

The withdrawal from Polish Jews of trading licences in Government monopoly articles was one of the grounds of complaint in Dr. Cyrus Adler's presidential address to the 25th.

when Poland in line with its Socialist policy, he said launched its campaign of etatism, or Government monopoly of industry, thousands of Jews who had been engaged in these industries, like salt, tobacco, and alcohol, were dismissed, and non-Jews are employed in their places.

Discrimination has been generally complained of, Dr. Adler added, in the collection of taxes, in the granting of bleeness for the operation of all kinds of businesses, in the letting of public contracts, and in the operation of laws which handicap Jewish artisans.

POLISH RABBIS MEET IN CONFERENCE TO DISCUSS ECONOMIC DISTRESS OF POLISH JERRY.

The economic distress of Polish Jewry is one of the principal questions on the agenda of the Third All-Polish Con-ference of the Union of Rabbis (Agudath Harabonim) which is opening here to-night. Other questions on the agenda include Compulsory

Sunday Clesing, Sabbath Observance, religious persecution in the Boviet countries, and the raising of funds for the maintonance of the Yeshiboth, whose existence is menaced by the lack of sufficient means.

Senator MacGradden's cry of "International Jewish Finance" raised in the Finance Comfusion of the United States (reported in the J.T.A. Bulletin of Dec. 18th.) is taken up to day by the Hitlerist daily "Amgriff" here, the Berlin organ of the Hazi Party, edited by Deputy Geebbels, the Hitlerist leader in Berlin. Ignoring that part of Senator MacGradden's attack in which he alleged that the "international Jewish bankers, like Lessrs. Kuhn, Loeb am Company, have been bleeding the country (America) white for the benefit of Germany and themselves", the "Amgriff" tells its readers that the proceedings in the Finance Commission of the United States have revealed to the workers of Germany how the Euper-State structure of international Jewish finance is exploiting the misery of the nations.

The Jewish bankers, Mosers. Kuhn, Loob and Company, it says, have been shown in these discussions, to have made a profit of half a milliard dollars out of the last crists by pushing less shares on to provincial institutions and private persons who have thus lost everything they

possessed.

The Nazi State, the "Angriff" concludes, will smash all loan and finance capital, which is destroying

productive industrial life.

CHTIDREN OF JULIUS ROSENVALD FORM "FAMILY ASSOCIATION" TO SUPPLEMENT HIS TORK.

New York, Jan. 3rd. (Jewish Telegraphic Agency).

Signifying their intention of continuing the beneficent traditions initiated by their father, the five children of hr. Julius Rosenwald, who is lying critically ill at his home in Chicago, have filed notice with the Cook County Recorder of the incorporation of the "Rosenwald Femily Association" for philanthropic, educational, scientific, and charitable purposes.

The new organisation is to be separate from the Rosenwald Foundation and other benevolent activities of involution Rosenwald. The Association has been formed by Mr. Lessing J. Rosenwald and Mr. William Rosenwald of Philadelphia, the two sons, and the three daughters irrs. Adele R. Lovy, if New York, Mrs. Edith R. Stern, of New Orleans, and Mrs. Verlan R. Stern, of Chicago.

No funds have been set aside for the Association and no programme has been agreed upon, but Mr. Rosenwald's children expect to give it the same scope which characterises their father's phichthropy but will devote themselves to matters too small for the Rosenwald Foundation to take care of.

The Resenwald Family Association will follow the example set by Mr. Julius Rosenwald and will spend the capital of the fund within a neriod of twenty-five years.

TEN MILLION DOLLAR ART BEQUEST BY JEWISH HERCHANT ACCEPTED BY NEW YORK DEPROPOLITIAN MUSEUM.

New York, Jan. 3rd. (Jewish Telegraphic Agency). The Metropolitan Museum of Art has announced its

acceptance of the ten million dollar art collection bequeathed to it by the late Colonel Michael Friedsam, the head of the famous Altman Department Stores in New York. The collection, which consists of 135 paintings.

mostly old Masters, and 200 other important objects of art. including valuable sculptures, will be kept intact by the huseum in accordance with the wishes expressed by Colonel

Friedsam in his will.

The Friedsam collection, as it will be known, will be placed on view in the Museum in November 1932. .. Colonel Michael Friedsam, who died on April 7th .. . was outside the great business founded by his uncle. B. Altman. into the name of which he did not even incorporate his own name. although he was responsible for the great position which it had built up, practically unknown. retiring man who did not take any active part in organisa-tions or committees. Behind the scenes he did a good deal on behalf of education, art, and commerce in New York and in the country generally. He was greatly interested, however. in art, and was a director of many art museums and academies. He was the founder of the Art Department of New York University, and the French Government conferred on him a decoration for his contributions to the Louvre. During the whole of his life he built up a wonderful collection of art. which was reputed to be one of the greatest private-owned collections of Old Easters in the world, including Durer's "Saviour". Vermeer's "Allegory of the New Testament", the first privately-owned Vermoer in the United States, and many Rembrandts, Fals, and Etalian, French and Flemish primitives.

Colonel Friedsam was believed to be 71 years of age at the time he died, but it was one of his peculiarities that he never divulged his real age. None of the biographical notes contained in the reference books gave the date of his birth and none of his associates were ever told exactly how old he was. He lived a modest and quiet life in a big house in New York which he had built for himself and for his

art collection. Ho had never married.
In Jewish affaire Colonel Friedsam was active in the Federation for the Support of Jewish Philanthropic Societies of New York, and was Chairman of one of its "Killion Dollar Days". He was also a large contributor to the Jewish Education Association.
