THE SOROCA SHOOTING AFFAIR: DEPUTY LANDAU ASKS FOR INTERVIEW
VITH KIND: ACCUSED INVESTIGATING COMMITTEE OF IGNORING
HIS SYIDENGE AGAINST OFFICERS OF PRONTIER GUARD: ASKS
HOW VICTIMS CAN BE ACCUSED OF COMMINISM WHEN ONE OF THEM
WAS A HEBREW TEACHER AND COMMUNISTS PERSECUTE AND EXILE
LEGRALITY.

Bucharest, Jan. 20th. (Jewish Telegraphic Agency).

Deputy Lendau has asked the King for an audience, in order to place before him the facts in his possession with regard to the shooting of the six young laws by the frontier guard at Scroca; showing that the facts contradict the statement made in the official communitue, exomerating the frontier guard, to the effect that the victims were Communists.

There is an outburst of indignation in wide circles in Roumanian Jewry and in the democratio press of the country against the official report excuerating the Sorona frontier guard. The democratic papers publish a letter to-day from Deputy Landau, in which he accuses the investigating commission of having ignored the evidence which he produced showing that the officers and non-commissioned officers of the frontier guard were guilty of having leid a trap for the victims.

Deputy Lendau points out that one of the girl viotims, Zolda Frendman, was a Hebrew teacher at-the Soroca Hebrew High School of the Tarbuth Organisation, and a keen Rebraist, and she could therefore not have had any Communist leanings, begause the Communist regime persecutes Hebrew

exiles Hebraists to Siberia.

The Hebrew High School of the Tarbuth Organisation at Soroca was in the news about a year ago, in February 1931, when the Minister of Education ordered it to be closed down, on the charge that there was a Communist cell discovered among the students.

The Jewish Deputies protested against the closing of the school, and the matter was raised several times in Perliament. Deputy Lendau and Senator Rosenhaupt of Soroca visited the Minister of Education and obtained a promise from him to conduct an investigation into the charges, as a result of which the school was later reopened.

RABBI CHAIM ÖZER GRODZENSKI REPORTED ELECTED CHIEF RABBI OF WARSAW.

The Yiddish daily "Major Hajim" carries a report to-day that the Executive of the Warsaw Jewish Community, which has an Aguidst majority, has invited Rabbi Chaim Ozer Grodzenski, of Vilna, known as the Gaon of Vilna, to accept the office of Chief Rabbi of Warsaw.

Rabbi Crodzenski, who was elected last week by the Conference of Polish Rabbis as Fonorary President of the Federation of Polish Rabbis, is regarded as one of the great-scholars in Israel, and the águdists in Vilha have locked up to him for years as the virtual Chief Rabbi of Vilna. The Vina Jowish Community, however, against the Agudist claims, elected in 1929 ex-Senator Rabbi Rubinstein, one of the Mizrachist leaders, as Chief Rabbi of Vilna, and since the Agudists obtainedtheir mejority in the Warsaw Jowish Community they have made efforts to induce Rabbi Crodzenski to accept the post in Wersaw.

When Rabbi Rubinstein was elected, Chief Rabbi of Vilna, the Agudists in Vilna appealed to the Government, contending that Vilna has no need of an official Chief Rabbi and that the Jews of Vilna regard Chaim Ozer Grodzenski, the head of the Vilna Beth Din, as being in effect the Chief Rabbi of The Ministry of Education and Public Worship nevertheless overruled the objection and issued a decree confirming the election of Rabbi Rubinstein to the Chief Rabbinate. When the matter came up before the Board of the Vilna Jewish Community in March 1929 for ratification, seventeen members voted in favour and five members of the Agudath Israel voted against, and three other members abstained. For a time it was understood that the Agudist members of the Vilna Jewish Community intended to secode from the Community as a protest, and to form a separatist Community. The Vilna Rabbinate at the time also lodged a protest with the Jewish Community of Vilna against its action in ratifying Rabbi Rubinstein's election to the Chief Rabbinate.

Before Senator Rubinstein's election there was no Chief Rabbi in Vilna since the time of Rabbi Samuel, (1747) the last officially recognised head of the Beth Din. From Rabbi Samuel's time the title "Rosh Beth Din" was discarded, no Rabbi subsequently elected being authorised to assume that title. Rabbi Dr. Pinchas Cohn, the President of the Agudath

Fabbl Dr. Pinchas Cohn, the President of the Agudath Israel World Organisation, speaking at the time of the situation created in Vilna by the Government's ratification of Rabbi Rubinstein's election as Chief Rabbi of Vilna, said: The posttion can be properly understood only by bearing in mind the place occupied by Rabbi Rubinstein as Rabbi in Vilna as against the great authority exercised by the Gaon Rabbi Chaim Ozer Crodzonski. When Vilna was part of the Czarist Empire, the Russian Government required that in every town a person should be appointed who had a thorough knowledge of the Russian language, for the purpose of keeping the registers of the Jewish Community. These people bore the title of Rabbi only to the outside world. To the Jewish population, the Government Rabbi was a matter of complete indifference: Rabbi Rubinstein held the post of Government Rabbi in Vilna, but Rebbi Grodzenski was the sole peligious authority, not only to Vilna, but to half the Jewish world.

There is no official Chief Rebbi in Warsaw, but Rabti Professor Schorr, the preacher of the Warsaw Great Synagogue, which is a "Gorman" or "modernised" congregation, is regarded in many quarters as Chief Rabbi, as was his predecessor, Rabbi Professor Samuel Rozenskie.

GERER REBBE ON TAY TO PALESTINE DISCUSSES IN VINNA PALESTINE JETTSP AFFAIRS TIT FANOUS RABBIS OF CHONTROV AND SADAQURA.

The Gerer Rebbe who has arrived here from Warsaw on his way to Palestine, met here the famous Hassidic Rabbis of Chortkov, Sadagura and Kopyczyn, and discussed with them various matters affecting the position of the Jewish settlement in Palestine.

The Rabbi left to-day for Constantinople, on his way to Palestine.

THE BOMB OUTRAGES IN PALESTINE: POLICE FEEL THEY ARE NOT ISOLATED CASES BUT PLANIAD BY SINISTER ORGANISATION: STATEMENT BY HATPA DYSTRICT COMMISSIONER TO HEND OF JEVISH COMMUNITY.

The police feel that the bomb outrages in Haifa are not isolated cases, but planned by an organisation prompted by sinister motives, kr. Keith-Roach, the District Commissioner of Haifa, is understood to have agreed with Mr. G. Levin, the President of the Jewish Community of Haifa, when he called on the District Commissioner yesterday to express to him the anxiety of the Jewish population in connection with the repeated bomb

explosions, and to press for urgent police action.

The police are doing everything possible, Mr. Keith-Roach further stated, in order to discover the persons responsible for the outrages, but it is too early yet to disclose the results which have been obtained. Mr. Keith-Roach also assured Mr. Levin that he is in permanent contact with the police, and is personally watching all developments-

BLOW TO PALESTINE MATCH INDUSTRY: NUR FACTORY MAY CLOSE . .

Jenusalem, Jan. 10th. (J.T.A. Mail Service). The order of January 1st. under the Matches Excise Ordinance of 1929 greatly warying the duty on matches manufactured and sold in Falestine may lead, it is stated, to the almost immediate closing of the well-known "Nur" Match factory

The manufacturers claim that the duty has been virtually doubled, from £3.750 to £6.250.

for permission to weep and wall at the Walling Tall for the restitution of the Patriarchal throne to the Palestine Arabs, Mr. Nakhla Kattan, a Palestine Christian Arab, proposes to his co-religionists as a protest against the Government's decision authorising the Patriarchal election. On to the Wailing Wall every Cunday to wall and cry, he says, don sacksloth and ashes, boycott the Greek Patriarch and demand from the Government an rab Patriarch.

2,624 ILLEGALLY-ENTERED IMMIGRANTS IN PALESTINE HAVE THUTR STAY

Jorusalem, Jan. 11th. (J.T.A. Mail Service).

A 2,624 immigrants registered officially with the Falestine police up to the middle of December 1931, when the amnesty granted by the Palestine Government in connection with the recent censure for the legalisation of the stay of immigrants who entered the country illegally lapsed. 1,030 immigrants registered in Jorusalem, 1,135 in Tel Aviv and the neighbouring colonies, and 411 in Faffa, Tiberies and the vicinity. Many of them are to also of families and the bebrew Labour daily "Daver" estimates that between 5,500 and 6,000 people have thus had their position legalised.

## 1,756 JEWISH ALIENS DEPORTED FROM UNITED STATES IN LAST TEN YEARS: LESS THAN HALF PER CENT. OF TOTAL NUMBER OF JEWISH IMMIGRANTS ADMITTED.

of the total number of 359,054 Jewish immigrants who were admitted to the United States during the ten years between M921 and 1930 were deported during that period from the United States, according to figures collected by Mrs. Cecilia Razovsky Lavidson, the Director of the Department of Service to the Romaign Rorn of the National Council of Jewish Women. Alto-Foreign Born of the National Council of Jewish Women. gether 92,157 aliens were deported in the course of the ten years, out of the total of 4,107,209 immigrants, of all races and nationalities admitted, making a total of 2.2 per cent. of deportations, four times the proportion of Jewish deportations. Eight hundred and eighty-nine Jews were deported in

the last five years, 72.3 per cent. being sent out of the country on charges of illegal entry in comparison with 57 per cent. for the same reason for all deportations. Seventeen per cent. of the Jewish deportees were sent out of the country either because they had become public charges from conditions arising prior to their attry or because they were likely to become public charges. Only 9-2 per cent. of the Jews were deported for criminal offences as compared with 14.2 per cent. in the case of the total number of deportations.

AMERICAN JEWS GAVE FIVE NEEDION DOLLARS TO JEWISH NATIONAL FUND OUT OF TOTAL OF 16 MILLION CONTRIBUTED DURING 30 YEARS

New York, Jan. 11th. (J.T.A. Mail Service).

The Jewish National Fund has raised a total sum of 16 million dollars during the 30 years since its foundation, with which it has redeemed 320,000 dunum of lend in Pelestine, and American Jews have contributed five million dollars, simost and third towards this total, Mr. Nelson Rutenberg, the President of the Jewish National Fund in America, said at a dinner held here last night at the Edison Hotel, to celebrate the thirtieth anniversary of the Jewish National Fund. 800 guests attended the dinner, and Mr. Nahum Sokolov, the President of the Jewish Agency, was the principal speaker. 20,000 dollars were raised at the dinner, each guest contributing 25 dollars, the price of one dunam of land in Palestine, to purchase another 800 dunam.

Despite the depression in America, Mr. Rutenberg said, the Jewish National Fund has during the three months in which he has been President, shown a slight increase in its receipts, as compared with Tast year .

JEW SUPPLIES FREE MEALS TO UNEMPLOYED IN DETROIT: NO QUESTIONS ASKED: ONLY REQUIPEMENT IS HEALTHY APPETITE.

New York, Jan. 11th. (J.T.A. Mail Service). For the second year in succession, a Detroit Jew, lerman Radner, opened yesterday his free lunch room at Walkerville, Ontario, providing 1,200 unemployed with as much food as they can eat.

Representatives of the city administrations of all the Border Cities, including Windsor, Walkerville, and Sandwich, and of civic and industrial organisations in Detroit and the Canadian cities, were present at the opening.

JEWISH GROOM AND HIS HIPE PROSECURED FOR USING THERE SAVINGS GOAL CORPORATION THIS GOVERNMENT COLLISSION LAWS THEIR GENEROSITY.

Fow a Jewish grocer, Farry Appleman, and his wife, of Everts, in Farlan County, Kentucky, used up their savings to supply flour to the starying miners of Harlan County who have been dismissed for joining the union, and fed forty and fifty children deily, until they were prosecuted through the instigation of the Black Mountain Coel Corporation, was revealed at a hearing held at Frankfort, Kentucky before the Commission appointed by former Governor Sampson to investigate conditions in Farlan County.

br. and brs. Farry Appleman have for twelve years concucted a general store in Evarts. The Applemans, immigrants from Poland, had saved up some money to buy a motor-car, and this money they used last Passover to purchase a carload of flour, which was given away in 24 pound bags, regardless of creed on colour, to needy families in (Evarts and the surround-

ings, so long as the supply lasted. As soon as the flour was distributed the Applemans were

arrested, and indicted for criminal syndicalism. was forced to go into hiding.

Ers. Appleman testified that when she asked the prosecuting attorney what he had against her and her husband. he said that he had nothing against them, only the Black Mountain Coal Corporation did not like the fact that the Applemans were feeding the starving miners and their children. the indictment was dismissed.

Commenting on the case, the Governor's Commission

states: Here it seems that the finest trait and virtue charity, was ill rewarded by the authorities. Mrs. Appleman's testimony should be read in full for its probative value lies. in the detail of circumstances she relates. The Commissioners taking her testimony were greatly-impressed by her sincerity. It is the testimony of a good and truthful woman.

10,000 JEWISH SABBATH OBSERVERS IN NEW YORK PETITION STATE PARLIAMENT TO BE ALLOWED TO CONDUCT BUSINESS ON SUNDAYS

New York, Jan. 11th. (J.T.A. Mail Service).

Ten thousand signatures have been obtained to a petition requesting the New York State Legislature to allow thousands of Jewish businessmen in New York who observe the Sabbath to conduct their business on Sundays unmolested.

The petition has been drawn up by retail storekeepers who observe the Sabbath, at the instance of the Jewish Sabbath Allance. Under the existing laws, Sabbath observers are compalled to be idle two days in the week.
