EINDENBURG DENOUNCED IN REICHSTAG AS JEWS! CANDIDATE: HYSTER-IGAL OUTBURST BY HITCHSRIST DEFORTY GOEBBERS: SITTING SUSPENDED BECAUSE OF UPHOAR AND GOEBBERS: SITTING REALINDER OF SITTING: GOEBBERS! FAPER PRINTS FULL PAGE CARTON SHOWING HOOK-MOSED JEWS CARRYING BOARDS WITH "WOTE FOR HINDERBURG" SICHS.

Berlin, Feb. 24th. (Jewish Telegraphic Agency).
A long hysterical outburst against the Jews and

against president Hindenburg as "the candidate of the Jews" was made in the Federal Parliament to-day by Deputy Goebbels, the leader of the Hitlerists in Berlin, after General Groener, the Minister for Defence, had made a formal amouncement that the first bellot in the presidential elections would take place on March 13th.

"Tell me what company you keep, and I will tell you what you are", Deputy Goebbels said, quoting an old German saw. Seven years ago, we elected Hindenburg as the representative of German nationalism, he complained, but instead of standing with us and serving the German Nationalist cause, he deserted to the enemy, and now the Jews are his great supporters.

The Scoinlist Deputies raised such a storm of protess against Deputy Goebbels' speech, that he could not make himself heard above the uproar, and the President of the Reichstag, Ferr Loebe, suspended the sitting. When it was reopened, Ferr Loebe announced that Deputy Goebbels had insulted the President of the Republic, and he would therefore be excluded for the Femminder of the sitting.

There will be four candidates standing for the presidential election, President Hindenburg, Hitler, Colonel Duesterberg, the candidate of the Steel Helm Brigade, and Thaelmann, the Communist candidate.

In order to make him a German subject so that he should be eligible as a candidate, Hitler has been appointed by the Coalition Government of the State of Brunswick, in which the Fitlerists have a representative as Minister of the Interior, to be Professor of "Political Instruction", a purely formal appointment, which would, however, make him automatically a German citizen, by virtue of the fact that he holds a Government appointment.

Some important legal authorities, on the other hand, contend that the appointment will not be valid, and that the Reichstag Electoral Commission will therefore refuse to recognise Wither as a German subject, and will rule his candidature out of corder.

The fact that the Steel Helm are putting up a candidate of their own and are not supporting Hitler, shows that the much-advertised united front effected last October at the big opposition parade of Hitlerists, Steel Helm and

Hugenbergists has already broken down.

FOREIGN JES IN GEFMANY TO BAVE VOTE TO JEWISH COMMUNITIES: PRUSSIAN GOVERNMENT BOWS TO JETISH DEMAND.

Berlin, Feb. 23rd. (Jewish Telegraphic Agency).

The Prussian Government has agreed, the J.T.A. understands, to give foreign Jews living in Germany the right to vote in the elections to the Jewish Communities in Prussia under the new Jewish Communities Law and to stand for election to the Jewish Communities.

With the exception of the clause depriving Jews who are not German citizens of the right to elect and be Delected to the Jewish Communities, the new Jewish Communities Bill drafted by the Prussian Government has the full support of the Federation of Jewish Communities in Prussia, but on this point it was adament, and had announced its intention of fighting the Government by bringing up the matter in the Prussian Parliament. The Government's withdrawal of the ban on foreign Jews removes all Jewish opposition to the Government measure, which replaces the fourteen different Jew-laws that at present regulate the affairs of the Jewish Communities in the various parts of Prussia by one unified Jewish Communities Law.

JEWISH BOXER ARRESTED IN DEMBERG IN CONNECTION WITH DEATH OF POLISH BOXER DURING BOXING TOURNAMENT.

"arsaw, Feb. 23rd. (Jewish Telegraphic Agency). The Jewish boxer Grosz has been arrested to-day in Lemberg in connection with the death of the non-Jewish boxer Godlewski, who fainted during a boxing tournament between the Jewish sports club Hasmonea and the Polish sports

club Pogon, and cled soon after in hospital. The Jewish population of Lemberg is in a state of great anxiety over the affair.

TWO JEWISH AUSDIMENTS ACCEPTED TO POLISH GOVERNMENT'S NEW EDUCATIONAL LAW: REMOVING SOME OF THE DANGERS TO JEWISH FRIVATE SCHOOL SYSTEM.

Warsaw, Feb. 23rd. (Jawish Telegraphic Agency). Two amendments proposed by Deputy Sommerstein on behalf of the Club of Jewish Deputies, to the Government Educational Bill tending to remove some of the dangers which the Jewish representatives saw in it to the continued existence of the Jewish provides along it to the continued existence of the Jewish provides school system (as reported in yesterday)'s J.T.A. Bulletin) have been adopted by the Education

Commission of the Seym. The first amendment provides that instead of having a right of control over the private schools, as the bill originally contemplated, the Government should have only the right of supervision, as is provided by the Constitution. This was agreed to by the Government Rapporteur on the bill, and passed

by the Commission. The second amendment concerns the language

of instruction in the private schools. As originally provided under the Government bill, the language of instruction would have had to be in accordance with the local conditions, which would have placed the right of deciding what the language of instruction should be in the hands of the local officials, who would thus, as Deputy Sommerstein said, be given arbitrary powers over the schools. The Government Rapporteur on the bill said that he would consent to this provision being struck out, and this was agreed to by the Commission.

PUNISHMENT FOR GUILTY IN SALONICA ANTI-JEWISH OUTBREAK LAST SUMMER; 29 ACCUSED TO BE PUT ON TRIAL IN APRIL: EDITOR OF GOVERNMENT PAPER AND PRESTDENT AND SECRETARY OF HELLERIC UNION CHAFGED TITH MORAL INSTIGATION: TRIAL NOT TO HE WELD IN SALONICA TO AVOID DANGER OF ANTI-JEWISH DEMONSTRATIONS

Salonica, Feb. 23rd. (Jewish Telegraphic Agency). 29 people will be put on trial on Saturday; April 2nd., for being concerned in the antisemitic outbreak which cocurred in Salonica last July, in which the Campbell quarter inhabited elacost exclusively by Jews, was burned down. Among the accused are N. Bloc Fardis, the editor-inchiof of the Salonica Government paper, "Hayedonia", M. Kosmidis, President of the National Hellonic Union, a body with strong antisemitic tendencies, and M. Haritopoulas, the Sacretawy of the Union, who are hairs charged.

Secretary of the Union, who are being charged with moral instigation leading to the anti-Jewish cutbreak.

In order to avoid anti-Jewish demonstrations, the trial will not take place in Salonica, but in Verria, a small town in the Salonica district, which has a population of 40,000, including 400 Jews. .

POSITION OF JEWS IN ROUMANIA RAISED'IN HOUSE OF COMMONS:

BRITISH KINISTER IN BUCHAREST ASKED TO REPORT ON ANTIJEPISH EXCESSES COLONEL WEDGWOOD IS TOLD BY UNDER-SECRETARY FOR FOREIGN AFFAIRS.

London, Feb. 24th. (Jewish Telegraphic Agency). Colonel Josiah Wedgwood asked the Secretary of State

for Foreign Affairs in the House of Commons to-day whether he had any information from Fis Hajesty's Minister at Bucharest as to the antisemitic excesses in Moldavia, near Jassy (reported in the J.T.A. Bulletin of the 19th. inst.), and whether he was aware of the growing danger to this minority in Roumania.

Captain Eden, the Under-Secretary of State for For-eign Affairs, said that His Majesty's Minister at Bucharest had been requested to report whether there had been any developmonts of the nature indicated.

THE DRINK QUESTION IN PARESTINE: COLONIAL SECRETARY SAYS REGULA-TIONS GOVERNING ISSUE OF LICENCES TOO DIVERSE TO SUMMARISE.

London, Feb. 24th. (Jewish Telegraphic Agency). Mr. Mallalieu (National Liberal) asked the Secretary of State for the Colonies in the House of Commons to-day if he would state what authority was responsible for the granting of licences for spirituous liquors in Palestine, and what regulations if any were imposed by the Government on the granting of such licences.

Sir Philip Cunliffe-Lister, the Colonial Secretary, said in reply that licences for the manufacture of spirituous liquors are issued by the Director of Customs after the appli-cant has obtained a certificate from the police and health authorities. A retail or wholesale dealer in spirituous liquors requires two licences, one of which is issued either by a municipal council or a district commissioner, subject to the authorisation of the police authorities, and the other is issued by the Director of Customs.

The regulations on this subject, the Colonial Secretary added, are too diverse to summarise within the compass of this reply, but if Mr. kallalieu wishes to see them. I shall be glad to arrange for them to be shown to him.

DR. "EIZMANN GIVEN BIG RECEPTION ON ARRIVAL IN JOHANNESBURG.

Johannesburg, Feb. 23rd. (Jewish Telegraphic Agency). A crowd of 10,000 people welcomed Dr. Weizmann on his arrival in Johannesburg to-day from Cape Town.

THE CITRUS FOUIT TRADE IN PALESTINE: GROWERS PROTEST AGAINST PROPOSED GOVERNMENT LEVY.

Jerusalem, Feb. 12th. (J.T.A. hail Service).

The citrus growers in Palestine are up in arms against a Government proposal to impose a levy of 7 mils a box to defray the cost of eradicating the black scale.

frond Tazi, Nohammed Effendi Abdul Rahoum, ir. Kenyon, ir. Rokach, ir. Rabinovitch and kr. Riklis, has been elected by the citrus growers and authorised to submit to the authorities

the objections of the trade.

The committee has had an interview with Lr. Pollack. the Assistant District Commissioner at Jaffa, in which it was pointed out that the Government expected-from the proposed tax an amount of money equivalent to the entire revenue from the Mr. Tazi urged that the High Commissioner should be urged not to take a final decision in the matter until he had been in consultation with the Citus Fruit Committee.

The citrus growers' case is that the progressive and careful grower treats his grove without waiting for the Govern-ment to do it and the levy would therefore result in his paying twice: once for his own voluntary cleansing, and a second time under compulsion in the form of the levy on his exported boxes; that a levy per exported box would throw the whole burden on the bearing groves only, at a time when only about one-third of the area under citrus fruit in the country is of bearing age, so that one third of the growers would pay for the whole Community, and this although it is known that the young non-bearing groves of the country are much more seriously infested with scales than the bearing groves.

e hold, the growers contend, that the cost of fighting insect pests ought to be borne by the grower who has allowed

his grove to become infested.
