ANTISEMITIC OUBREAKS AGAIN IN ROUMANIA: JASSY SYMAGOGUE

Bucharest, Mar. 24th. (Jewish Telegraphic Agency).
Anti-Jewish disturbances have broken out again in Roumania, following student demonstrations held in Bucharest and Jassy.

The police in Buchareat were unable to control the crowd of thousands of students who in defiance of the Government prohibition, marched in procession through the streets, and the authorities called out the troops, who charged the students with fixed bayonets. Many casualties occurred on both sides, and a number of students have been arrested. Professor Jorgs, the Prime Minister, who is also Rector of Bucharest University, has ordered the University to be closed.

In Jassy the Cuzist student demonstrators attacked Jews, and the Jassy Synagogue was devastated.

When Deputy Dr. Singer, member of the Jewish Parliamentary Party, ascended the tribune in Parliament and began to address an interpsilation to the Government complaining of the renewed anti-fewish demonstrations, and demanding that the Government should protect the Jewish population, two of the Curist Deputtes, Deputy George Cuza, son of Deputy Professor Cuza, the leader of the antisemitic Party, and Deputy Pools unushed on to the tribune, and knocked him down and best him. 'Uproarious scenes followed, and the sitting of Rarliamont was suspended.

King Carol has had an interview with the leader of the students' organisation, M. Cotiga, who has in response to the King's demand given him an assurance that the student de-

monstrations will be stopped.

of the last week the Jewish Deputies Joséph Fischer and Michael Landau visited the President of the Roumanian Chamber, to complain to him that they were being terrorised in Parliament by the Guzist Deputies, some of whom, especially Deputy Robu, had actually begun to molest the Jewish Deputies and threaten to thresh them. The President of the Chamber, Professor Pompeiu, promised the Jowish Deputies in his reply that he would ask Deputy Guza and Deputy Robu to visit him, and he would warn them that they must stop molesting or threatening the Jewish Deputies.

The confiscation to-cay by the police of copies of the Austrian Hitlerist paper, the "Kampfruf", for containing a cartoon showing Jews dangling from the lamp-posts in one of the principal Vienna streets, the Ringstrassenableo, declaring that this is what will happen when the Fitlerist Government is formed, nearly resulted in anti-Jewish outbreaks in the streets of Vienna. When the police seized copies of the paper in the possession of the street vendors, Jews walking in the streets were set upon and only the energetic action of the police saved them and prevented serious trouble.

Perish Judes! hang the Jews from the lamnposts I so one of the slogans of the Hitlerists in Germany and Austria, and cartoons showing Jaws dangling from the lamp-posts have appeared in numbers of Hitlerist papers in both countries. At the time of the demonstrations agains the "All Cuiet" film, crowds of Hitlerists marched through At the time of the demonstrations against the streets of Perlin and Vienna shouting the slogen. extent of the anti-Jewish feeling in Vienna was demonstrated at that time by the vast crowds of Fitlerists who tried to invade the Jewish quarter where the film was being shown. and required about three thousand police, mounted and on foot, and bearing arms, to disperse them.

JETISH STATE OFFICIAL APPEARS FOR PRUSSIAN GOVERNMENT AGAINST HITLER BEFORE SUPREME COURT FOR PROTECTION OF GERMAN

REPUBLIC . Berlin, war. 24th (Jewish Telegraphic Agency).

Ministerial Director Dr. Badt, who is a prominent worker in Jewish affairs in Germany, and an active Zionist, and in his official capacity is the representative of the Prussian Government on the German Federal Council. is appearing for the Prussian State before the Leipzig Supreme Court for the Protection of the Republic to answer the charge brought against it by Adolf Fitler, that it acted unconstitutionally in raiding the Fitlerist headquarters in Prussia recently and demanding the return of all the documents which were seized during the raids.

Dr. Badt showed in/his evidence that Messrs. Goebbels. Frick and Roehm, three prominent leaders of the Eitlerist Party, had declared publicly in the form of an ultimatum, that Fitler was standing as candidate in the presidential elections only as a last attempt to obtain power by legal means, and if that failed the Nazi stormtroopers would move to bring about the capture of power by force of arms, so that the Prussian State had been completely justified in seizing documents containing proof of the Hitlerist plans for a violent revolution, to enable it to counter these plans in the interests of public safety.

SUECRITA SAFEGUARDED IN NE GERMAN PENAL CODE.

Berlin, Mar. 23rd. (Jewish Telegraphic Agency).

The Central Office for affairs relating to the slaughtering of animals in the German Republic announces that the Reichstag Commission on the Penal Code has added to Furagraph 412 of the new Penal Gode on which it is now working, the following clause: There shall be no penalty attached to the treatment of animals, insofar as it is

done for the prosecution of serious scientific purposes, or for fulfilling the requirements of a religious community which enjoys public rights.

The same clause was adopted by the Penal Code Commission in the last Reichstag, and has been taken over by the new Commission without any change.

NUMERUS CLAUSUS.

Berlin, Mar. 23rd. (Jewish Telegraphic Agency).

Considerable apprehension exists in Jewish circles here over a move which the Government is believed to be contemplating to enforce a numerus clausus at the German Universities to keep down the number of students because the universities are at present seriously overcrouded. It is not feared that the Government has any intention to enact a numerus clausus on religious lines, having the effect of a percentage norm for Jews, but there is anxiety because the application of the numerus clausus law may result in discrimination against Jewish students.

As a self-protection move, it is suggested in Jewish quarters that Jewish professors should set a much higher standard of qualification in selecting students to help to reduce the overcrowding at the universities, and thus obviate the need for the Government to take the matter in hand.

'INTERNATIONAL JEW" PUBLISHED IN SPANISH TRANSLATION: USED BY SPANISH RIGHT AS WEAPON IN FIGHT AGAINST REPUBLIC.

Madrid, Lar. 24th. (Jewish Telegraphic Agency). "The International Jew" by Henry Ford, which was withdrawn by Mr. Ford from circulation when he made his public apology to the Jews in 1927, and retracted his previous antisemitic views, hee just appeared in Barcelona in a Spanish translation, despite Mr. Ford's instructions to his publishers that the book must not appear in any language.

The parties of the Right are using the book

together with other antisemitic material as one of their weapons in the fight against the Republican form of Government in Spain.

THE NOVEMBER ANTI-JETISH DISTURBANCES IN POLAND: TRIAL OF FIVE JETISH STUDENTS ARRESTED IN CONNECTION TITH OUT BREAK POSTPONED: NO DATE OF OPENING FIXED YET.

Warsaw, Lar. 24th. (Jewish Telegraphic Agency).
The trial which was to have opened this week of five Jewish students accused of having attacked non-Jewish students during the anti-Jewish disturbances which occurred in Poland last November, has been postponed for technical reasons. No fresh date for the opening of the trial has yet been fixed.

Warsaw, Ker. 23rd. (Jewish Telegraphic Agency).
The twelfth hour has begun to strike for the
Jewish merchant class in Poland, Deputy Igneci Jaeger, the
Jewish Deputy for Lemborg, complained in speaking at a
Conference held at the kinistry of Trade under the chairmanship of the Minister of Commerce and Trade, M. Zaszicki, to consider possibilities for reviving Polish trade, which is at present in a very precarious position. The Linis of Finance, the Linister of Egroulture, the Minister of Social Welfare, and delegations from the Chembers of The Linister Commerce, the merchants! organisations, and other bodies took part in the Conference.

If the State does not come to the assistance of the merchant class, it will be completely wiped out, Deputy Jaegor said. And the result will be one fraught with very serious danger to the entire Polish State.

The Jewish merchants are engaged in a life and death struggle, he went on, and the Compulsory Sunday Closing Law which forces them to abstain from all activities for 22 days in the week, but to pay taxes for the full working week, makes it a foregone conclusion what the end of the struggle will be. "hatever measures the Government takes to save Polish trade, it must include among them the alleviation of the hardships caused by the Compulsory Sunday Closing Law, so that Jews should be permitted to work and conduct their businesses on Sundays and Christian festivals from 7 till 10 in the morning and from 3 till 6 in the afternoon.

The Director of the Chamber of Commerce in Posen, M. Szikorski, delivered a speech in which he vigorously opposed Deputy Jaeger's demand for a modification of the Compulsory Sunday Closing Law, and asserted that Christian opinion is firmly against any tampering with the law as it exists at present.

2,200 POLISH JE"S HAVE GONE TO PALESTINE FOR PASSOVER PIL-GFIMAGE.

Warsaw, Mar. 23rd. (Jewish Telagraphic Agency). A third group consisting of about 300 tourists left to-day for Palestine for the Passover pilgrimage and to attend the Levant Fair and the Maccabeade in Tel Aviv. 2,200 Polish Jews have already gone to Palestine from Poland for this year's Passover pilgrimage, and more may go in the next few days.

Jerusalem, Kar. 23rd. (Jewish Telegraphic Agency). Tel Aviv was to-day one of the most populous cities in the whole of the Middle East, when the entire population of 50,000, tens of thousands of Jews from all parts of Polestine, thousands of Arabs from the Jaffa vicin-ity, and hundreds of tourists from all parts of the world, were out in the streets for the Purim cernival.

There was not a single accident or arrest despite the crowds.

The carnival included a procession depicting the verious Jewish migration movements into Palestine from the days of Abraham down to the days of Lord Passfield. were many tableaux satirising the present position of the immigration problem in Palestine,

Jamusalem was practically empty, great numbers of its Jewish inhabitants having gone to Tel Aviv for the carnival. The members of the Oriental Jewish Communities in Jerusalem turned out, however, in the Jaffa Road, wear-ing their traditional Purim masks and with various Purim

The methods of pressure employed by the Palestine
Covernment in the affair of Vadi Favarith constitute an action contrary to the Landate, the law of Palestine, and the moral foundations of State and Society: and furthermore. constitute an encouragement to the lawless elements in the country to continue invading lands belonging by rightful purchase to the Jewish people, says a resolution adopted by the Executive Committee of the World Union of Zionist Pevisionists.

Even the pretence of taking away Jewish lands as a "temporary" measure only is no more than a sham, the re-solution proceeds, it being evident both from the declara-tion of the invaders and the practice of the Palestine Cov-ernment that the occupation of Vadi Havarith by Bedouins will in effect, under one or another pretext, be made permanent. It was the clear duty of the Jewish National Fund

Directorium, the resolution says further, to refuse its consent and let the Government either restore the Vadi Favarith land to its rightful owner, the Jewish National Fund, or stand revealed before the world as aiders and abettors of lawless violence. The Jewish National Fund Directorium, by consenting instead to the so-called lease of Vadi Havarith has sanctioned the action of the Government and the provoca-tive precedent created, and has violated the Articles of the Jewish National Fund by alienating the possessions of the Fund from Jewish occupation. While maintaining its support of the Jewish National Fund, the resolution concludes, the Executive Committee, therefore, demands the resignation of the directorium of the Fund to re-establish public confidence in the administration of the Fund and its possessions.

HEAVY CITRUS FRUIT EXPORT FROM PALESTINE: 400,000 CASES SHIPPED FROM HAIPA

Jerusalem, har. 13th. (J.T.A. Lail Service). march promises to be the bumper month for orange shipments from Haifa, a total of 180,600 cases of fruit having left from that port for various parts of Europe in the first ten days of the present month.

During Fobruary 215,254 cases of citrus fruit

were shipped from Haifa.

JETISH LAND-SETTLEMENT IN CRIMIA TO BE CONCENTRATED NOW IN JEWISH REGION FREILORF: DECISION BY SUPREME ORGAN OF CRIMEAN GOVERNMENT.

Moscow, Mar. 23rd. (Jewish Telegraphic Agency).

The migration movement of working-class Jews to the Crimea is in future to be directed meinly towards the Jewish Region of Freidorf, the Central Executive Committee of the Crimea has decided in a resolution soopted after hearing a report from the Executive Committee of the Freidorf Region on the position in this Jewish region.

This decision adopted by the highest legislative body of the Crimean Republic is diametrically opposed to the line of action adhered to by the previous administration of the Central Comzet, before Messrs. Mereszin, Tchemerisky

and the rest were removed from their posts.

The policy of the previous leaders of the Comzet was to distribute the migrants in as many places as possible, so as to retain all the land reserves which were allocated for Jewish settlement in the Crimea. They took the view that if the various tracts of land allocated for Jewish settlement were not settled by at least a small number of settlers, it would be difficult to retain this land for Jews. The result was that the number of Jewish settlements in the Or imea grew, but they were not economically stable.

In the opinion of the Crimean Central Executive Committee and of the new leaders of the Commet this had the effect of retarding the growth of the Jewish region of Freidorf, and the new policy aims at directing more transmigration to the Freidorf region to provide the Jewish collective farms there with the workers of whom they stand in need.

1,300 Jewish families are to be settled in the Crimea this spring, it was further decided. The position the Jewish settlements in the Crimea is such that the The position number could have been doubled or trebled, it is explained. The harvest was excellent this year in the Crimes. The provision of bread in the Crimean Jewish colonies proceeded formally, without any of the difficulties which occurred in some of the Jewish colonies in the Ukraine. The Crimean settlers are therefore not only provided with bread for themselves, and fodder for their horses and cattle till the new harvest, but they have also the possibility of selling some of their produce to settlers in other districts, mainly in the Ukraine, who come to the Crimea specially to buy their bread.

The Comzet decided, however, to fix the number for this year at only 1,300 families, firstly, because this is the number of working hands required to fill the existing vacancies in the collective farms of the Freidorf Jewish region, and secondly because it does not wish to hinder the recruiting of the nearly 19,000 families required for the transmigration work for this year to Bureya, and for the three Jewish regions in the Ukraine.

The fact is, the paper proceeds, that there has been no unemployment and no distress in the Soviet Union for a long time, and in the matter of economic opportunities there is no distinction whatever between peoples of different nationalities. Every Jew who is at work must express his incignation at the action of the Rabbis and the Jewish communal workers abroad by refusing to accept their gifts. and hurling them back into their faces across the frontier.
