Shows £108.188 Surplus (Tewish Telegraphic Agency)

JERUSALEM, July 6—The government expenditures for the fiscal year ending March, 1932 amounted to 2,403,-235 pounds, while the revenue was in the amount of 2,442,083, pounds, according to an announcement in the official gazette yesterday.

The announcement points out that the revenue exceeds by the sum of 108,188 pounds its revenue in 1931.

On the first of April, the government surplus was 739,772 pounds.

The expenditures of the government

were in the following directions: Development Department, £6701; Transjordan Frontier force, £183,405; police, £457,737; Defence, £102,000; Education, £158,742; Health, £115,002.

The revenue includes Britain's grant in aid for the Transjordan force which amounts to £143,00.

World Executive of Agudath Israel Refuses to Participate In World Jewish Conference

> States That Its Effects Would Be Harmful to Position of Jews in Many Lands of Diaspora

(Jewish Telegraphic Agency) VIENNA, July 6-The World Executive of the Agudath Israel, meeting here, today declined to accept the invitation of the American Jewish Congress to participate in the forthcoming world Iewish conference in Geneva on August 14th, to discuss the advisability and the feasibility of constituting a

world Iewish congress. The Executive voted against par-ticipating in this conference on the ground that the Jewish position is most difficult in any case and a Congress will only have an adverse effect and will make the Jewish position less tenable in various countries of the Diaspora.

"We do not oppose the idea when a suitable occasion arises," the Executive stated, "which will permit various Jewish organizations to meet in order to discuss quietly various measures de-signed to ease the Jewish position with-(Continued on Page 4)

Warszawska, tic national Democratic Party, and the "Slowo Pomorskie," broadcast an alarm today against what they call the threatened invasion of German Jewish intruders.

The papers point "to the danger to Poland of an invasion of German Jews, who frightened by Hitler, may seek refuge in Poland," and demand that the government take steps to protect Pol-ish interests from "the prospective intruders."

The papers complain against "the fatal error" on the part of the government in naturalizing six hundred thousand Jews of the Russian provinces. They warn against a similar government mistake should German Jews decide to settle in Polish provinces.

B'nai Brith Plans \$40,000 Wider Scope Campaign (Jewish Daily Bulletin)

MILWAUKEE, July 6-A \$40,000 wider scope campaign the forthcoming year was announced here by the B'nai Brith District Grand Lodge

No. 6 at its annual convention.

Spokesmen for every delegation pledged to contribute to the quota which will be used for the work of the Hillel Foundation, the Anti-Defamation League and the Aleph Zadek Aleph.

The pledges were received from eight states and three provinces of the district after Henry Monsky of the Omaha National Executive Committee warned that the three organizations will have to shut down if the goal is

not reached. "We face stark bankruptcy this year," he said, "and we do not know whether we will be able to carry on the Hillel Foundation or the A.Z.A. or the Anti-Defamation League if we do not raise this money," Mr. Monsky

said. A strong attack on race prejudice in this country and other countries of the world was delivered by Sigmund Liv-ingston of Chicago, Chairman of the Anti-Defamation League at the annual banquet of the district last night.

He urged that the B'nai Brith "appeal to the powers of the civilized world in the name of humanity to take the necessary measures to guar-antee the rights of all minority groups in every country swayed by passion and hatred"

Governor LaFollette welcomed the convention at the banquet session and cited the leading positions held by the Jews and the contributions of the ews to public welfare.

Four hundred delegates and visitors from eight states and three Canadian provinces attended the convention which is the sixty-fourth in the history of the Grand Lodge.

Methods of promoting good will between Jews and Christians were discussed at a meeting of the General Committee.

An appeal to members to support the humanitarian work of the Order despite a curtailment in finances was issued by Otto G. Felton, secretary, in his annual report.

Senate Passes Amended Bill On Immigration Status of

U. S. Citizens' Husbands Exemption to Be Granted Only to Husbands Married Up Until July 1,

1932; Preference Status for Others (Tewish Daily Bulletin)

WASHINGTON, July 6-Following an agreement reached earlier in the day between the Senate and the House joint conferees, the Senate yesterday passed the conferees report on the Dickstein bill for the exemption from the quota of the husbands of American citizens.

The bill as passed no longer carries the provision which would place American citizen wives on the same status as American citizen husbands, but leaves them in the previous status of unqualified exemption.

The amendment offered by Senator Reed restricting exemption from the quota to husbands of those married prior to July 1, 1932, remains.

Preference within the quota is the only provision made for those married subsequently to July 1, 1932.

The House is expected to adopt the bill in its present form and send it to the President for signature within a day or so before adjournment which may take place on Saturday.

The bill granting exemption from the quota to parents of American citizens, is expected to come up for consideration by the Senate Immigration Committee today.
